Back to the farm

City council approves property rezoning request from single family to agriculture, but plans to tighten guidelines

A small section of property within the city limits has been zoned for agriculture use, but residents aren't likely to see a bunch of cows or horses grazing there anytime

During their Tuesday meeting, the Big Spring City Council gave final approval to a rezoning request from property owner Ann Sanders to change the designation of nine acres along Wasson Road from Single Family 2 to Agriculture.

The property, in the general vicinity of Wasson and Parkway, was used for agriculture purposes before it was annexed into the city in the 1960s, City Manager Todd Darden said. Tuesday's move by the council opens up the possibility of that sort of usage again, if the property owners receive further clearances from city officials. Darden said there are sev-

eral further steps Sanders or her designees must take before the property is open to agriculture use again.

"The agriculture zoning designation is the most the


"Cross-examination is a bit different from most events," coach Jennifer Adams said. "Only two teams in the district qualify for the State Meet."

different event. "I've placed at state in journalism events the past two years. Debate is new for me, but I'm hoping that we will be


successful at the state meet," she said. will be attending second state meet for the year.

Trump announces 'major' voter fraud investigation

WASHINGTON (AP) President Donald Trump tweeted early Wednesday that he is ordering a "major investigation" into voter fraud, revisiting unsubstantiated claims he's made repeatedly about a rigged voting system. The investigation, he said,

will look at those registered to vote in more than one state, "those who are illegal and ... even, those registered to vote who are dead (and many for a long time)."

Depending on results, Trump tweeted, "we will strengthen up voting proce-

Trump has been fixated on his loss of the popular vote in the election and a concern that the legitimacy of his presidency is being challenged by Democrats and the media, aides and associates

Trump's own attorneys dismissed claims of voter fraud in a legal filing responding to Green Party candidate Jill Stein's demand for a recount in Michigan late last year.

"On what basis does Stein seek to disenfranchise Michigan citizens? None really, save for speculation," the attorneys wrote. "All available evidence suggests that the 2016 general election was not tainted by fraud or mistake."

Secretaries of state across the country have dismissed Trump's voter fraud claims as baseless. After the president's morning tweets, Ohio Secretary of State Jon Husted wrote on Twitter, "We conducted a review 4 years ago in Ohio & already have a statewide review of 2016 election underway. Easy to vote, hard to cheat."

Trump's exaggerations about inauguration crowds and assertions about illegal balloting have been distractions as advisers' have tried to launch his presidency with a flurry of actions on the

His spokesman, Sean Spicer, has twice stepped into the fray himself, including on Tuesday, when he doubled down on Trump's false claim that he lost the popular vote because 3 million to 5 million people living in the U.S. illegally cast ballots.

If the president's claim were true it would mark the most significant election fraud in U.S. history — and ironically, would raise the same questions about Trump's legitimacy that he's trying to

Rep. Elijah Cummings, ranking Democrat on the House Oversight and Government Reform Committee, said Wednesday his panel has already sent letters to the attorneys general in all 50 states asking for reports of any election irregularities. "The president can join me

and my staff," Cummings said on MSNBC. He also said he wants Congress to restore voting protections, citing a Supreme Court ruling that "gutted" key sections of the Voting Rights Act, particularly the provision requiring southern states to get clearance in advance from the Justice Department before legislating changes in voting laws and procedures.

Some Trump allies say he is justified in using his platform to defend his standing. They point to Georgia Democratic Rep. John Lewis' pre-inauguration statement that he did not see Trump as a legitimate president, as well as U.S. intelligence agencies' assess-

ment that Russia meddled in the election in order to help Trump win.

"Segments of his own government keep driving this narrative," said Roger Stone, a longtime confidant. "I don't think it hurts to point it out." Key advisers in Trump's in-

ner circle concede the focus on crowd claims and alleged voter fraud have been a distraction. After Friday's inaugural

festivities, the new president grew increasingly upset the next day by what he felt was "biased" media coverage of women's marches across the globe protesting his election, according to a person familiar with his thinking. Trump was particularly enraged with CNN, which he thought was "gloating" by continually running photos of the women's march alongside the smaller crowds that attended his inauguration the day before, according to this person, one of several White House aides and associates who spoke on the condition of anonymity because they were not authorized to speak publicly about private conversations.

Tuesday night on Twitter, Trump slammed CNN again, referring to the network as "FAKE NEWS @CNN" while praising rival Fox News Channel.

Trump has had a tumultuous relationship with the press, frequently calling the media dishonest and insulting individual reporters by name at his rallies and on Twitter. Still, two people close to Trump said he expected his coverage to turn more favorable once he took office. Instead, he's told people he believes it's gotten worse.

The bad press over the weekend has not allowed Trump to "enjoy" the White House as he feels he deserves, according to one person who has spoken with him.

The result has been a full display of Trump's propensity for exaggeration and more. During an appearance at the CIA Saturday, he wrongly said the inaugural crowds gathered on the National Mall stretched to the Washington Monument, despite clear photo evidence to the contrary. And during a reception with lawmakers from both parties Monday night, he repeated his false assertion that millions of illegal immigrants provided Hillary Clinton's margin in the popular vote.



2 suspects charged with capital murder after mall shooting

SAN ANTONIO (AP) — The two men police say attempted to rob a jewelry store at a San Antonio mall have been charged with capital murder in the death of a Samaritan who attempted to intervene.

San Antonio police said in a statement Tuesday that Jose Luis Rojas and Jason Matthew Prieto, both 34, each is being held on a \$1.5 million bond.

Rojas is hospitalized in critical condition after being shot multiple times Sunday by another Samaritan at the Rolling Oaks Mall. The first Samaritan, 42-year-old Jonathan Mur-

phy, was not armed when he confronted the suspects and was fatally shot. It's not known whether Rojas and Prieto have at-

torneys to speak on their behalf. Police say another shooting occurred Tuesday

just outside a different mall. No one was hurt in that incident.

Texas woman who claimed to be 'voice of God' gets 6 years

FORT WORTH, Texas (AP) — Prosecutors say a North Texas woman who claimed to be the "voice of God" must serve six years in prison for forcing two immigrants to work for years without pay. Olga Sandra Murra of Fort Worth was sentenced

Monday and ordered to pay the immigrants \$795,000. Murra was convicted of two counts of forced labor and two counts of harboring an illegal immigrant.

Authorities say Murra in the 1990s helped smuggle the two Mexicans into the U.S. She forced them to work in her cleaning business, kept them in Fort Worth and El Paso, and withheld pay and identification documents.

Officials say Murra represented herself as the "voice of God on earth," made both women sleep on a floor and forced them to listen to recordings of her Bible readings.

Bush recovering from pneumonia, doing physical therapy

HOUSTON (AP) — Former President George H.W. Bush is increasing his activity as he recovers from pneumonia at a Houston hospital.

Bush spokesman Jim McGrath said Tuesday that the 92-year-old Bush is sitting up, talking with physicians, staff and visitors, and returning phone calls. The nation's 41st president also is working with physical therapists to help him regain strength.

Bush was admitted to Houston Methodist Hospital on Jan. 14 for breathing difficulties blamed on pneumonia. He later was moved to intensive care when doctors inserted a breathing tube.

He was moved from the ICU on Monday after-

Texas GOP stars push school choice, but will it be enough?

AUSTIN, Texas (AP) — The governor of Texas and the Bush family's rising star added political muscle Tuesday to a rally supporting school vouchers, which have stalled repeatedly in the country's largest Republican state despite steadfast support from top conservatives.

Marching bands with thundering drumlines and hundreds of students and teachers — many in yellow-and-black "National School Choice Week" scarfs converged outside the Texas Capitol. Gov. Greg Abbott made a relatively rare appearance with Lt. Gov. Dan Patrick, a tea party favorite who has long been Texas' leading advocate for vouchers where families get state money to remove children from public schools and send them to private and religious alternatives.

"This is not a Republican issue, it's not a Democrat issue," Abbott said. "This is a civil rights issue."

Thirteen states and the District of Columbia offer some form of vouchers, according to the National Conference of State Legislators, and academic studies show mixed classroom results that can be similar to those of traditional public schools.

The rally came as Texas Senate budget writers discussed how

much funding will be needed to educate the state's 5.3 million public school students. Texas currently spends about \$2,700 per-pupil under the national average, ranking 38th in funding nationwide, according to the Texas State Teachers Associa-

Kathy Miller, president of the education watchdog group Texas Freedom Network said Tuesday that vouchers "are a scheme that strips critical funds from public schools and gives a discount to individuals who can already afford private school."

In 2013, Texas expanded its number of public charter schools, though advocates say waitlists of children wanting to attend them still exceeds 100,000 — and suggest that vouchers could fill that void. Many students at the Capitol rally attended charter schools or were on waitlists for them, just like at similar "School Choice Week" events nationwide.

"This is not a war on public education," Patrick said. He said vouchers don't "take money from the education system" because public schools will cut costs by no longer having to educate students who transfer to private alternatives.

Texas Land Commissioner George P. Bush also is a longtime school choice supporter. The grandson of one former president, nephew of another and son of failed 2016 White House hopeful Jeb Bush, George P. once served on the board of one of Texas' largest charter school operators. He applauded other speakers but didn't address the crowd himself Tuesday — unlike during past rallies.

Last session, a sweeping voucher plan passed the Texas Senate, but died in the House, where Democrats have long teamed with rural Republicans wary of hurting schools that are the lifeblood of their small communities to keep public money in public schools. The Senate this year is promoting "educational savings accounts" letting families use public money for private schooling, as well as tax breaks for businesses that sponsor private school scholarships.

So far, though, there is little indication such plans will be any better received in Texas' lower chamber than in the past.

"Traditionally, the members of the House have not supported spending taxpayer dollars at private schools," Jason Embry, a spokesman for Republican Texas House Speaker Joe Straus, said Tuesday "and there are many questions to be answered on this issue in the months ahead."

Trump admin orders EPA contract freeze and media blackout

WASHINGTON (AP) — The Trump administration has instituted what it described as a temporary media blackout at the Environmental Protection Agency and barred staff from awarding any new contracts or grants, part of a broader communications clampdown within the executive branch.

Emails sent to EPA staff since President Donald Trump's inauguration Friday and reviewed by The Associated Press detailed specific prohibitions banning press releases, blog updates or posts to the agency's social media accounts.

The Trump administration has also ordered what it called a temporary suspension of all new business activities at the department, including issuing task orders or work assignments to EPA contractors. The orders were expected to have a significant and immediate impact on EPA activities nationwide.

Similar orders barring external communications have been issued in recent days by the Trump administration at other federal agencies, including the Agriculture and Interior departments. Staffers in EPA's public affairs office are instructed to forward all inquiries from reporters to the Office of Administration and Resources Management.

"Incoming media requests will be carefully screened," one directive said. "Only send out critical messages, as messages can be shared broadly and end up in the press."

A review of EPA websites and social media accounts, which typically include numerous new posts each day, showed no new activity since Friday.

White House spokesman Sean Spicer said Tuesday he had no information on the blackout. He said aides were looking into the circumstances.

Doug Ericksen, the communications director for Trump's transition team at EPA, said he expects the communications ban to be lifted by the end of this week.

"We're just trying to get a handle on everything and make sure what goes out reflects the priorities of the new administration," Ericksen said.

Beyond what was stated in the internal email, Ericksen clarified that the freeze on EPA contracts and grants won't apply to pollution cleanup efforts or infrastructure construction activities.

Officials at state and local agencies that rely on EPA for funding said they were left in the dark, saying they had received no information from EPA about the freeze.

"We are actively seeking additional information so we can understand the impact of this action on our ability to administer critical programs," said Alan Matheson, executive director of Utah Department of Environmental Quality. The executive director for the advocacy group Public Employees for Environmental Responsibility, Jeff Ruch, said the orders go beyond what has occurred in prior presidential transitions.

"We're watching the dark cloud of Mordor extend over federal service," Ruch said Tuesday, referring to the evil kingdom in the epic fantasy "The Lord of the Rings."

Ruch noted that key posts at EPA have not yet been filled with Republican appointees, including Trump's

Environmentalists said the orders were having a chilling effect on EPA staff, many of whom were suffering from low morale. Trump and Pruitt have both been frequent critics of the agency and have questioned the validity of climate science showing that the Earth is warming and man-made carbon emissions are to blame.

Liz Perera, climate policy director for the Sierra Club, said Trump's move to freeze all EPA communications and contracts should be "a major red flag for all Americans."

"EPA was created to ensure that all Americans can enjoy clean air to breathe, clean water to drink and have their health protected from environmental and climate threats," Perera said.

Some staff at the Agriculture Department also received orders not to release any documents to the public.

"This includes, but is not limited to, news releases, photos, fact sheets, news feeds and social media content,' read an email to staff at the agency's Agricultural Research Service, which was obtained by the AP.

ARS spokesman Christopher Bentley said the ban would not include scientific publications released through peer-reviewed professional journals.

"As the U.S. Department of Agriculture's chief scientific in-house research agency, ARS values and is committed to maintaining the free flow of information between our scientists and the American public as we strive to find solutions to agricultural problems affecting America," Bentley

said, according to a statement. It was not immediately clear whether similar instructions were given to others within the department. The AP reported over the weekend that staff at the Interior Department were temporarily ordered to stop making posts to its Twitter account. The prohibition came after the official account of the National Park Service, a bureau of the department, retweeted a pair of posts to its 315,000 followers that seemed to be a swipe at Trump on his initial day in office. On December 30, 2016, as required by order of the Public Utility Commission of Texas ("PUCT" or "Commission") in Docket No. 45414, Sharyland Utilities, L.P. ("Sharyland") and Sharyland Distribution & Transmission Services, L.L.C. ("SDTS") (collectively "Applicants"), regulated electric utility companies, filed an application with the PUCT titled Amended Application of Sharyland Utilities, L.P. and Sharyland Distribution & Transmission Services, L.L.C., Statement of Intent to Change Rates, and Request for Grant of a Certificate of Convenience and Necessity and Transfer of Certificate Rights ("Amended Application").

The Amended Application requests: (1) the setting of new wholesale and retail rates that Sharyland will charge its customers; (2) the establishment of rates that SDTS will charge its only customer, Sharyland; and (3) the grant of a certificate of convenience and necessity ("CCN") and transfer of CCN rights to SDTS. This proceeding is the first in which Sharyland's rates will be set on a system-wide basis.

The Amended Application is based on a twelve-month test year ending December 31, 2015. The Amended Application supports an increase in Sharyland's adjusted test-year retail base rate revenues of approximately \$1.4 million or 1.4 percent, exclusive of riders. Sharyland's system-wide cost-based retail base rate revenue requirement is \$101.2 million, plus an additional \$2.23 million that Sharyland is seeking to recover on an annual basis through certain riders. This includes a proposal to recover \$30 million for deferred costs associated with construction of the electric system in the McAllen division during its initial years of operation. As proposed, monthly delivery rates for an average residential customer consuming 1,333 kWh in the Stanton, Brady, and Celeste divisions will decrease by approximately \$3.14 per month, exclusive of riders, but in McAllen and Mission they will increase by approximately \$35.69 per month, exclusive of riders. The Amended Application also supports a total wholesale transmission cost of service of \$147.6 million, plus an additional \$3.7 million that Sharyland is seeking to recover on an annual basis through certain riders.

The Amended Application also supports a total revenue requirement for SDTS of approximately \$170 million. SDTS' proposed rates are lease payments that SDTS will charge only to Sharyland for leasing its transmission and distribution assets. In a new tariff for SDTS, separate rates will be provided for the leasing of transmission assets and for the leasing of distribution assets.

The Amended Application also requests that the PUCT grant a CCN to SDTS and transfer rights under Sharyland's CCNs to SDTS authorizing SDTS to own transmission and distribution assets and lease those assets to Sharyland for the provision of electric service, along with any other rights as necessary. No new facilities are being sought in the Amended Application.

The Amended Application potentially affects all customers and classes of customers in Sharyland's Stanton, Brady, Celeste, and McAllen divisions. The Amended Application also affects all customers taking service under Sharyland's Tariff for Wholesale Transmission Service. In addition, the result could be a change in Sharyland's transmission cost of service rates, which would impact all load serving entities in the Electric Reliability Council of Texas. The Applicants have proposed that the requested rates be made effective February 3, 2017.

Water lead-level falls below federal limit in Flint

LANSING, Mich. (AP) — Flint's water system no longer has levels of lead exceeding the federal limit, a key finding that Michigan state environmental officials said Tuesday is good news for a city whose 100,000 residents have been grappling with the man-made water crisis.

The 90th percentile of lead concentrations in Flint was 12 parts per billion from July through December — below the "action level" of 15 ppb, according to a letter from the Michigan Department of Environmental Quality to Flint's mayor. It was 20 ppb in the prior six-month period.

Based on the sample of 368 residential sites, Flint's lead levels are again comparable to other similarly sized U.S. cities with older infrastructure, state officials told The Associated Press ahead of an official announcement.

"This is good news and the result of many part-

ners on the local, county, state and federal levels working together to restore the water quality in the City of Flint," the department's director, Heidi Grether, said in a statement. "The Flint water system is one of the most monitored systems in the country for lead and copper, and that commitment will remain to ensure residents continue to have access to clean water."

Residents, whose mistrust in government remains high nearly three years after a fateful switch of the city's water source in April 2014, are being told to continue using faucet filters or bottled water because an ongoing mass replacement of pipes could spike lead levels in individual houses. The replacement of the lines is expected to take years.

Tuesday's announcement drew immediate skepticism from some Flint residents.

Melissa Mays said it "means nothing. There's still lead in the system."

"Especially with disruptions, main breaks —

pieces of lead scale will be breaking off until these pipes are replaced," Mays said. "You cannot tell me the water is safe because you have not tested every

Flint's public health emergency began when of ficials failed to properly treat lead lines for corrosion while the city was under state management.

State officials acknowledged the lead problem in October 2015. Lead from old pipes leached into

the water supply because corrosion-reducing phosphates were not added due to an incorrect reading of federal regulations. Elevated levels of lead, a neurotoxin, were detected in children, and 12 people died in a Legionnaires' disease outbreak that experts suspect was

linked to the improperly treated water. An ongoing investigation has led to charges against 13 current or former government officials, including two managers that Gov. Rick Snyder appointed to run

Snyder has apologized for the crisis that has largely been blamed on his administration.

"The remarkable improvement in water quality over the past year is a testament to all levels of government working together and the resilient people of Flint helping us help them through participation in the flushing programs," he said in a statement. "There is still more work to do in Flint, and I remain committed to helping the residents recover and restore their city."

While it is important for cities to be below the federal limit, experts say there is no safe level of lead and the crisis has exposed gaps in a monitoring system that can mislead individual homeowners and renters into thinking their tap water is safe when only some homes with lead pipes are

Michigan's letter to Flint Mayor Karen Weaver was reviewed by the U.S. Environmental Protection Agency before it was sent. Because the city exceeded the federal limit in the first half of 2016, it must continue replacing at least 7 percent of its lead service lines by June 30.

Though the requirement may be discontinued if the water supply is at or below the limit in the next monitoring period, the state said it would continue supporting Flint's plan to replace more pipes.

A look inside some key numbers for Super Bowl matchup

From Tom Brady looking to become the first quarterback to win five Super Bowl titles to Matt Ryan seeking to give Atlanta its first, there are plenty of numbers that will get a lot of attention leading up to the Big Game.

Here's a look at some others that fans might not be as familiar with:

BEST VS. BEST: This

marks the sixth Super Bowl matching the NFL's highest-scoring team (Atlanta) against the team that allowed the fewest points (New England) during the regular season. The top defense won four of those previous five matchups, including Seattle over Denver three years ago. The only time the top offense came out on top was in the 1989 season when San Francisco topped Denver.

The Falcons have set an NFL record by scoring a touchdown on eight straight opening drives. That figures to be tougher against a Patriots team that was second best in the league this year, allowing just 16 points on opening drives with the only

THIRD TO NONE: Forcing an offense into third down is usually a good step for a defense. Doing it against Brady or Ryan isn't much help. Including the playoffs.

Brady leads the NFL with a 132.8 rating on third down, with Ryan next among starters at 120.6. Brady has converted on 51.8 percent of his third-down passes and Ryan is at 49.7 percent. Ryan has been even better of late, with a 141 rating and first downs on 59.3 percent of his throws the past six

HASHES: Ryan has been nearly unstoppable when targeting the middle of the field in the regular season and playoffs, according to Sportradar. He has completed 86 of 117 passes between the hashes for 1,230 yards, nine TDs and no interceptions and a 132.8 passer rating. Ryan is 13 for 14 for 138 yards throwing down the middle in the playoffs.

GO DEEP: Ryan also was the most efficient deep thrower in the NFL in the regular season and playoffs, according to Sportradar, going 30 for 63 for 1,122 yards, 10 TDs, no interceptions and a leaguebest 133.4 rating on throws at least 21 yards downfield. The Patriots were the second-best defense against the deep pass, allowing just 28.2 percent to be completed with only three TDs, five interceptions and a 47.5 rating that was the second lowest. BEAT THE HEAT:

Teams blitzing the Patriots and Falcons have had little success this season, with Brady leading the NFL with a 124.3



A fine declarer hopes for the best but prepares for the worst. Today's hand is a typical example Assume you're in six hearts and West leads a spade. As soon as

dummy comes down, you see that the only significant threat to the slam is that one defender was dealt four trumps to the A-10, about a 1-in-4 probability. You therefore adjust your thinking to that possibility. If West has the A-10-x-x, you are doomed whatever you do, so you assume East has

Ordinarily, East would score two trump tricks with such a holding, but if you play your cards right, you can limit him to one trump trick From the start you must play to

shorten yourself in trumps, so after winning the spade lead with the ace, you immediately ruff a spade. You then lead a trump to dummy's jack.

Let's say East wins with the ace

and returns a diamond - as good a defense as any. You win in dummy and ruff another spade, then lead the king of trumps, on which West shows Your earlier preparations for a

trump coup are now richly rewarded. You still have the Q-9-7 of trumps left over East's 10-8, and, to coup him, you simply have to equalize your trump length with his. You therefore lead a club to the ten and ruff dummy's last spade as East discards his last diamond.

Next you cross to dummy with a club and then play your club winners. It does not matter whether East ruffs now or later; his 10-8 of trumps either immediately or eventually suc-

In 1915, America's first official transcontinental telephone call took place as Alexander Graham Bell, who was in New York, spoke to his former assistant, Thomas Watson, who was in San Francisco, over a line set up by American Telephone

In 1924, the first Winter Olympic Games opened in Chamonix (SHAH'-moh-nee),

In 1936, former Gov. Al Smith, D-N.Y., delivered a radio address titled "Betrayal of he fiercely criticized the New Deal policies of President Franklin D. Roosevelt. In 1945, the World War II

Five years ago: U.S. military forces flew into Somalia in a nighttime helicopter raid, freeing an American and a Danish hostage and killing nine pirates. U.S. Rep. Gabrielle Giffords of Arizona returned to Congress to officially tender her resignation a year after she was shot and severely wounded in her home district. First lady Michelle Obama Agriculture Secretary Tom Vilsack, along with celebrity chef Rachael Ray, announced new guidelines for more healthful school meals during a visit with elementary students in Alexandria, Virginia.

Brady has led the Patriots on a game-winning, fourth-quarter drive in all four of his Super Bowl wins, rallying from 10 points down to beat Seattle two years ago, overcoming a onepoint deficit against Carolina in 2004 and leading tiebreaking drives against St. Louis (2001) and Philadelphia (2005). Brady came up

short in two last-minute desperation drives in both losses to the Giants, but still has a 50-37 career record in gamewinning and comeback attempts, according to Scott Kacsmar of Football Outsiders. Brady has the best winning percentage among active players with at least 10 attempts, with Ryan not far behind in fourth place with a 34-37

SNEAKY TOM: Brady has been one of the best QBs at converting sneaks in his career, getting first downs on 98 of 108 (90.7 percent) runs on third or fourthand-1 in his career, compared to a league-wide rate of 69.8 percent in that span. After being nearly perfect (66 for 67) from 2004-12, Brady has been more ordinary of late at 21 for 28 the past four years. **BIG-PLAY THREATS:**

It's no surprise that Julio Jones is the NFL's most dangerous bigplay receiver. His 31 catches this season of at least 20 yards lead the NFL. But he hasn't been able to match the far less heralded Chris Hogan in the postseason. Hogan has eight catches of at least 20 yards in New England's two playoff wins and needs just one more in the Super Bowl to tie Larry Fitzgerald

Congressional Republicans gather in Philly to plot course

PHILADELPHIA (AP) — Congressional Republicans are heading to Philadelphia where they will hear from President Donald Trump at their annual policy retreat.

The joint gathering of House and Senate Republicans comes as Trump's presidency gets off to a rocky start. Republicans hope to come together and chart a course forward on a range of policy issues, particularly repealing and replacing former President Barack Obama's health care law. Lawmakers will also hear from British Prime

Minister Theresa May, the first time a foreign head of state has addressed such a gathering. And football star Peyton Manning will appear. The two-day conclave of work sessions, speeches

and schmoozing gets under way Wednesday, with

the high point coming Thursday with Trump's lunchtime speech. Lawmakers hope the gathering will help solidify their agenda for the year.

Clinic in Rochester to determine what caused the

collapse. In a statement Tuesday evening, Clinic spokesman Karl Oestreich said the governor's fall was not related to the cancer diagnosis. "Mayo Clinic believes this episode was situational and related to standing for a long time while

giving his speech and possible dehydration," Oestreich said. Dayton was encouraged to stay hydrated. The governor will return to Mayo next week to determine treatment for the prostate cancer.

'1984' sales soar after Trump claims, 'alternative facts'

NEW YORK (AP) — After incorrect or unprovable statements made by Republican President Donald Trump and some White House aides, one truth is undeniable: Sales of George Orwell's "1984" are

First published in 1949, Orwell's classic dystopian tale of a society in which facts are distorted and suppressed in a cloud of "newspeak" topped the best-seller list of Amazon.com as of Tuesday evening. The sales bump comes after the Trump administration's assertions his inauguration had record attendance and his unfounded allegation that millions of illegal votes were cast against him last fall.

Trump adviser Kellyanne Conway coined an instant catchphrase Sunday when she called his claims about crowd size "alternative facts," bringing comparisons on social media to "1984."

Orwell's book isn't the only cautionary tale on the Amazon list. Sinclair Lewis' 1935 novel about the election of an authoritarian president, "It Can't Happen Here," was at No. 46. Aldous Huxley's "Brave New World" was at No. 71. Sales also were up for Hannah Arendt's seminal nonfiction analysis "The Origins of Totalitarianism."

terrorist group and researched travel to the Middle East to join Islamic State fighters, prosecutors have said. Kareem also inquired

about explosives to blow up the Arizona stadium where the 2015 Super Bowl was held, but later set his sights on the cartoon contest after the stadium plan fell through, the prosecutors said.

The verdicts against Kareem 10 months ago marked the second conviction of someone within the United States on charges of supporting the Islamic State.

Kareem was convicted of conspiring to support a foreign terrorist organization, interstate transportation of firearms and other charges. His brother has said

Kareem was a Muslim throughout his adulthood, but that his faith deepened over the last five years after he was jailed on a drunken driving conviction.

His friends, Elton Simpson and Nadir Soofi, were killed in the May 2015 police shootout outside the cartoon contest in Garland, Texas. A security guard was wounded, but no one else was injured. The contest featured cartoons that are offensive to Muslims.

It is unknown whether the Texas attack was inspired by the Islamic State or carried out in response to an order
