

Rojo trial to begin second day of testimony

The trial of a former Big Spring police officer charged with multiple sex crimes was expected to resume this morning in the 118th District.

On Tuesday, the trial began around 9 a.m. when Joel Rojo, a former Big Spring detective, pleaded not guilty to four indictments — indecency with a child by sexual conduct, sexual performance by a child, indecency with a child

by exposure, and attempted indecency with a child by exposure.

It was a long and sometimes emotional day in the courtroom, as jury members heard testimony from eight witnesses for the prosecution, including two of the three alleged minor victims. As the prosecutor presented his case Tuesday, District Attorney Hardy Wilkerson attempted to paint Rojo as someone who used his power and authority as a police officer to take advantage

of troubled children to place them into compromising and revealing po-

Specifically, during their testimony Tuesday, the two minor victims alleged that Rojo asked them to expose their private parts so he could take pictures of them. According to the victims, Rojo used an investigation as a pretext for the request. Rojo is also accused of

allegedly transporting the girls on separate occasions to an isolated

area, where he told them he needed to take photos of their private parts for his investigation, they said individually during their testimony.

The first day of the trial ended during the testimony of Texas Ranger Jeffery Strain, who conducted the investigation after the first allegations of Rojo's misconduct arose in August 2015. Strain was expected to retake the stand when the trial resumed this morning at 9 a.m.

Chinese competitors — in fields ranging from medical equipment to renewable energy to electric cars — by requiring foreign firms to hand over proprietary technologies in exchange for being allowed to operate in China.

China's Ministry of Commerce did not immediately respond to a faxed request for comment.

These deliberations come as the administration signals a harsher stance on trade than it took in the first six months

of Trump's presidency.

Trump temporarily set aside complaints about market access and currency when he met with Chinese President Xi Jinping in April in hopes Beijing would help pressure North Korea to end its nuclear weapons develop-

But tensions bubbled up last month at a U.S.-Chinese dialogue where U.S. Treasury Secretary Steve Mnuchin blamed China's \$347 billion trade surplus with the United States last year on "government intervention in its economy."

The Wall Street Journal

and New York Times also reported that U.S. trade officials are discussing ways to counter piracy of copyrights and patents and other intellectual property in China.

U.S. Commerce Secretary Wilbur Ross, in a commentary in Tuesday's Wall Street Journal, outlined a slew of grievances against both China and the European Union that he said contributed to the global U.S. trade deficit in goods of \$725.5 billion in 2016.

"Both China and Europe also bankroll their exports through grants, low-cost loans, energy subsidies, special value-added tax refunds

and below-market real estate sales, among other means," Ross wrote.

The Wall Street Journal and New York Times stories also said U.S. officials were looking into using Section 301 of the 1974 Trade Act.

Another possibility would be to invoke the "International Emergency Economic Powers Act," a law also enacted during the 1970s that gives the president wide powers to take action after declaring a national emergency, the Wall Street Journal report said.

The administration also was considering how to resist technology-sharing demands from Beijing as part of its ambitious Made in China 2025 program, a blueprint for making China a leader in advanced technologies such as autonomous driving, artificial intelligence, robotics and

other industries. Foreign companies have long complained over rampant piracy and technology theft by Chinese companies. Though he has at times sought a more conciliatory approach, Trump also has lambasted China over such problems and over the massive U.S. trade deficit.

Lawsuit: Investigator claims Fox News made up quotes

NEW YORK (AP) - Anew lawsuit lays out an explosive tale of Trump allies, the White House and Fox News Channel conspiring to push a false story about Democratic leaks and an unsolved killing in order to distract attention from the Russia investigation that has been swirling around the president

The lawsuit was filed Tuesday against Fox by an investigator who had been looking into the killing of Seth Rich, a former Democratic National Committee staff member who died in 2016 in what police say was a botched robbery. The investigator alleges that Fox quoted him as saying things he never said and was willing to show President Donald Trump its story before it was posted online.

It's the second time in two days that Trump has been accused of being actively involved in pushing a public narrative to lower the heat of the Russia story. The Washington Post reported that the president had written a misleading statement for his son to give to The New York Times about Donald Trump Jr.'s meeting last summer with a Russian who promised dirt on Democrat Hillary Clinton's presidential

campaign.

Rich's death has become fodder for conspiracy theorists, deeply angering the 27-year-old's family. In May, the story was thrust into the headlines again when Fox posted a story on its website in which investigator Rod Wheeler said there had been contact between Rich and WikiLeaks, the organization that posted a trove of DNC emails last year. The story was heavily promoted by Fox News host Sean Hannity, who has informally advised the presi-

In the lawsuit, Wheeler now says that he never made that statement. He also contends he was told his false comments were put in the story because Trump wanted it that way.

Rich's family released a statement Tuesday night supporting the lawsuit. "While we can't speak to the evidence that you now have, we are hopeful that this brings an end to what has been the most emotionally difficult time in our lives and an end to conspiracy theories surrounding our beloved Seth," the family wrote.

Fox says it's "completely erroneous" to suggest it pushed the story to distract from the Russia investigation. Wheeler has made contradictory statements regarding the case and is simultaneously filing a racial discrimination lawsuit against the network, represented by a lawyer who has other lawsuits against Fox.

White House press secretary Sarah Huckabee Sanders said Trump had no knowledge of the false story before it was posted and that it was "completely untrue" that the White House had any role in shaping

Wheeler, a Fox contributor on law enforcement issues, said he was brought into the Rich case by donor and Trump supporter Ed Butowsky. He says Butowsky, who has also made occasional appearances on Fox News, was intent on establishing a link between Rich and

WikiLeaks. Two days before the Fox article was published, Wheeler said he got a text message from Butowsky: "Not to add any more pressure but the president just read the article. He wants the article out immediately. It's now all up to you. But don't feel the pressure."

Butowsky said in a phone interview Tuesday he has never met Trump and his text message to Wheeler about the president reading the article was "tonguein-cheek."

Fox removed the story from its website a week after it was published, saying "it was not initially subjected to the high degree of editorial scrutiny we require for all of our reporting." Hannity ultimately backed away, saying he was acting out of re-

spect for Rich's family. Wheeler also said that he and Butowsky had met with outgoing White House press secretary Sean Spicer and showed Spicer notes on Wheeler's investiga-

"Ed is a longtime supporter of the president's agenda who often appears in the media," Spicer said Tuesday. "He asked for a 10-minute meeting, with no specified topic, to catch up and said he would be bringing along a contributor to Fox News. As Ed himself has noted, he has never met the president and the White House had nothing to do with his story."

On the day the Fox story was posted, Spicer was asked about the report that Rich had emailed WikiLeaks. He said, "I'm not aware of that" and did not mention that he had met with Butowsky Wheeler a month ear-

lier. One of Trump's attorneys, Jay Sekulow, also devoted attention to the Rich story during several Hannity appearances in May, before his hiring by Trump was an-

nounced. "There's a lot more to this, I would suspect,' Sekulow said on the May 18 show, which Hannity devoted almost entirely to a discussion about Rich. "You can't ignore the fact that it was a DNC staffer. You can't ignore the fact that there was nothing taken from the individual's

He said that while he hadn't seen "the files" on Rich, the incident "undercuts" the argument that Russians interfered in the election.

At the time, Trump was facing news stories about the investigations into Russian meddling in the 2016 campaign and possible ties between his campaign aides and Moscow. He continues to blast the inquiries as a "witch hunt" aimed at discrediting his election win and tries to focus attention on Clinton, who has largely faded from the headlines.

Jay Wallace, Fox News president, says, "The accusation that FoxNews.com published Malia Zimmerman's story to help detract from coverage of the Russia collusion issue is completely erroneous." Malia Zimmerman was a Fox producer on the story.

"The retraction of this story is still being investigated internally and we have no evidence that Rod Wheeler was misquoted by Zimmerman," Wallace said.

In May, Wheeler told Fox's local affiliate in Washington that he "absolutely" had sources at the FBI saying that there was information that could link Rich to WikiLeaks. But the station noted that Wheeler subsequently said contradictory things to other news organizations, and the station could

not contact him again. Fox News Channel's

Climate change before your eyes: Seas rise and trees die

change. The process has happened naturally for thousands of years, but it has accelerated in recent decades as polar ice melts and raises sea levels, scientists say, pushing salt water farther inland and killing trees in what used to be thriving freshwater plains.

Efforts are underway worldwide to determine exactly how quickly the creation of ghost forests

"I think ghost forests are the most obvious indicator of climate change anywhere the Eastern coast of the U.S.," said Matthew Kirwan, a professor at Virginia Institute of Marine Science who is studying ghost forests in his state and Maryland. "It was dry, usable land 50 years ago; now it's marshes with dead stumps and dead trees."

It is happening around the world, but researchers say new ghost forests are particularly apparent in North America,

But the conversion of forest into marshland produces "extremely productive" wetlands that feed and shelter

fish and shellfish. The Atlantic croaker fish, for instance, was rare 15 years ago in southern New Jersey waters but now is abundant, said Ken Able, a Rutgers University professor. "There is a lot of change going on," said Greg Noe, a research ecologist with the U.S. Geological Survey. "It's dramatic and it's changing faster than it has before in human history."

Wife, mother of man who died in Dallas jail lobby sue county

DALLAS (AP) — The wife and mother of a Texas man who died after a struggle with deputies in the Dallas County jail lobby filed a lawsuit alleging excessive force by four deputies and lack of training by the Dallas County Sheriff's Office.

A Dallas County grand jury declined to indict deputies involved in the August 2015 death of Joseph Hutcheson when it convened last year. The lawsuit filed Monday by Nicole Hutcheson, the man's wife, and Ruth Boatner, his mother, alleges the deputies used excessive force in subduing the 48-year-old Arlington, Texas, man, who had entered the lobby seeking help. The lawsuit, which names the deputies — Fernando Reyes, Trenton Smith, Betty Stevens and Elvin Hayes— as well as Dallas County, also alleges the Sheriff's Office failed to train the deputies and security of ficers correctly in use of force. The lawsuit cites an autopsy report in which a medical examiner noted a 6-inch (15-centimeter) bruise on the back of Hutcheson's neck. "Joseph Hutcheson came to the Dallas County Jail scared and begging for help," family attorney Scott Palmer said in a statement. "Instead, Dallas County officers needlessly assaulted him, ignored his pleas and left him to die on the floor of the jail." The deputies had said Hutcheson entered the jail lobby proclaiming that his wife was chasing him and was going to kill him. They said he was forced to the ground and handcuffed after pacing in the lobby because he posed a threat to himself and others Palmer wrote in the lawsuit that surveillance video shows Hutcheson did not act aggressively or have any weapons.

The medical iner's office ruled the death a homicide. A report from the office said he died from the combined toxic fects of cocaine and methamphetamine, compounded by heart problems due to high blood pressure and the stress to his body associated with a struggle with sheriff's deputies and being restrained by handcuffs. Melinda Urbina, a spokeswoman for the Sheriff's Office, said sheriff's officials had not seen the lawsuit as of late Monday, but the office does not typically comment on pending litigation.







Ageless Witten's Hall visit begs question: Will he make it?

OXNARD, Calif. - Jason Witten isn't thinking about life after football as he goes through another training camp with the Cowboys, and one of his fellow tight ends hasn't stopped to ponder a Dallas locker room without the 35-year-old on the verge of becoming the franchise leader in games.

None of this keeps Geoff Swaim from smiling in the middle of an answer when he realizes what he is saying about the first time he had a chance to be around one of just four players to reach 15 seasons with the storied Dallas franchise.

"I had been watching Witt since ... since I was in like junior high," said the 23-year-old Swaim, pausing with that sheepish grin, as if he knew he might be in trouble for finishing the thought.

"Watching a guy like that play for such a long time at a high level, it is a little overwhelming when vou first get in the room and you're talking football and you're being coached up next to a guy that's been doing it the right way."

Well, at least Witten can AP photo consider himself part of get inducted into the Pro Football Hall of Fame. After all, Witten will have a pretty strong case for that honor five years after he retires.

"I try not to let that creep in," Witten said. "But I think I'd be lying to say that's not one of the things that you hope as a player. That's the highest honor, individually. Obviously we don't play it for that. But individually, that's what you hope you can be a part of."

Witten will open the season needing two games to become the franchise leader with 225, topping pass rusher Ed "Too Tall" Jones from the 1970s and '80s.

He's already the club leader in consecutive games, starts, consecutive starts and catches — surpassing the likes of Bob Lilly, Lee Roy Jordan and Michael Irvin. Lilly and Irvin are Hall of Famers.

With 11,888 yards receiving, Witten needs just 17 to top Irvin's franchise record and is one of just two tight ends with at least 1,000 catches and 10,000 yards receiving (he has 1,089 catches). Tony Gonzalez, eligible for enshrinement in 2019, is the other.

"I don't think there is any doubt in my mind that he's a Hall of Fame tight end," coach Jason Garrett said.

"And he's one of the best



An artful deception

The bidding:

North West South East Pass Pass Opening lead — ten of diamonds. While deception may be frowned upon in everyday life, it has a very definite place in the game of bridge.

Indeed, a player who succeeds in pulling the wool over the eyes of an opponent is often roundly congratulated, even by his victim.

Consider this deal from a pairs tournament, which places a premium

on getting the maximum out of every deal. South leaped to four hearts after East's three-diamond opening, and West led his singleton diamond. Declarer covered the ten with

dummy's jack, ruffed East's king and drew four rounds of trumps, discarding a club and two diamonds from dummy. The queen of spades was then led, and West took the ace and returned a spade.

South quite properly finessed the nine, realizing that even if this lost to the jack, the contract was safe, since he could later return to dummy with a spade to discard a club on the fourth spade. This plan would have worked perfectly except for one thing: When the nine was played from dummy, East followed smoothly with the six! This naturally convinced declarer

that West had the jack of spades, giving him a chance to make two overtricks. So South next led the queen of diamonds from dummy, forcing East to cover with the ace and establishing dummy's nine. After ruffing, South then led his last spade to dummy's ten, planning to discard one club on the king of spades and another on the nine of diamonds. One can only imagine declarer's

chagrin when East produced the jack of spades and returned the ten of clubs. South now had to lose two clubs plus the two spades already lost, so he finished down one. After recovering his composure,

South did the only thing one can do in these circumstances: He congratulated East wholeheartedly for his fine deceptive play, while secretly wishing he'd had the opportunity to do the very same thing himself.

Case dropped against Texas jailers over inmate in dirty cell

HOUSTON (AP) — Charges have been dropped against two former Texas jail sergeants in connection with a mentally ill prisoner who was ignored for weeks in his filthy cell.

Ricky Pickens-Wilson and John Figaroa were indicted in 2015 on allegations that they manipulated cell check records related to the Harris County jail inmate. The two subsequently were fired.

Harris County prosecutors asked that the case be dropped after a two-year statute of limitations expired. A judge agreed to the request Monday.

The inmate, Terry Goodwin, had been arrested on a marijuana charge while on probation.

Figaroa's lawyer, Tommy Lafon, tells the Houston Chronicle he believes the two jailers were scapegoats. They initially were charged with a felony, but that was reduced to a misdemeanor because of problems with language in the indictment.

Jury finds unhappy couple defamed

Texas wedding photographer DALLAS (AP) — A Texas jury has awarded a wedding photographer more than \$1 million after determining a newly married couple unhappy with her work launched a social media campaign to post falsehoods about her.

The Dallas County jury found Friday that the campaign against Andrea Polito amounted to defamation. The campaign included the couple taking their complaint to Dallas news stations.

The jury unanimously found the couple acted of

out malice in targeting Polito in 2015.

Polito said in her lawsuit that the couple repeatedly asked that their wedding photos be forwarded to them but the contract stipulated that they first submit an order form for their wedding album. The cover photo for the album can cost in excess of \$125.

Police: Body of Texas woman found in hole on Maryland beach

OCEAN CITY, Md. (AP) — Police say the body of a 30-year-old woman has been found on a Maryland beach.

Local news outlets report that Ocean City police were notified about the body Monday morning after beachgoers discovered it in a hole in the sand. City communications manager Jessica Waters says the remains have been identified as belonging to Plano, Texas resident Ashley O'Connor.

Waters says O'Connor got separated from her family around 2 a.m. and that her death appears to be accidental, although they have not yet ruled out anything. City officials say the body was removed from the sand around 4:15 p.m. and that state police crime scene technicians assisted Ocean City police's Forensics Services Unit. Maryland's Office of the Chief Medical Examiner will determine a cause and manner of death.

a man suffering a "mental crisis" struck about 10 vehicles with his pickup truck, injuring 12 people and only coming to a stop after striking a home.

Police Sgt. Douglas Greene told the San Antonio Express-News that the man somehow hurt himself before driving erratically along a half-mile stretch of road Tuesday in the southwestern part of the

The 12 people who were taken to hospitals included seven children.

The unidentified man was being held under an emergency detention at San Antonio Military Medical Center.

Greene says witnesses told officers that it appeared the man was purposefully striking the vehicles on Loop 13 near Kelly Field.

The suspect was pinned inside his pickup after striking the home but was combative with emergency personnel.

Ex-Texas Border Patrol agent gets 11 years in child sex case

LAREDO, Texas (AP) — An ex-Border Patrol agent in South Texas who was caught in a law enforcement sting must serve 11 years in prison for trying to arrange sexual encounters with two girls.

Federal prosecutors say 50-year-old Salvador Contreras was sentenced Tuesday in Laredo. The former senior Border Patrol agent in Del Rio pleaded guilty in March to attempting to entice a minor to engage in sexual activity.

Investigators have said Contreras was communicating online with someone he thought was a woman with two daughters, ages 8 and 14, and he sought to have sex with the girls. The woman was an undercover officer. Contreras was arrested in December when he traveled about 140 miles (225 kilometers) to Cotulla to meet the juvenile sisters. He resigned following his arrest.
