

AARP to offer | Honoring MLK's dream

tax assistance for local seniors

American Association of Retired Persons Incorporated (AARP Inc) coordinator for Big Spring's tax aide program, Ray Alexander, says that now is the time to start preparing for your 2017 federal income taxes.

"We offer a free tax aid program for everyone, but our target is seniors who may need help getting their taxes prepared," said Alexander. "Last year, we prepared about 200 returns and saved a total of \$40,000 for Big Spring residents."

For those who dread pouring through all those numbers and IRS forms, volunteers with the AARP Tax Assistance Program will be offering a helping hand beginning the first Monday in February. Alexander said the program will run from Feb 5 to April 2 at Big Spring's Senior Center located inside Dora Roberts Community Center at 100 Whipkey Dr. Volunteers will noon every Monday until the last date in April.

"We have about ten people helping out this year and volunteers are not trained to assist with more complex tax issues such as rental property, debt forgiveness, or foreclosures," said Alexander. "People need to have social security cards, a picture ID, tax information they received for all income, and any royalty income. If they have any dependents, they need a picture ID and a social security cards for them as well."

Japan public TV sends mistaken North Korean missile alert

TOKYO (AP) — Japan's public broadcaster mistakenly sent an alert due to Tuesday warning citizens of a North Korean missile launch and urging them to seek immediate shelter, then minutes later corrected it, days after a similar error in Hawaii.

NHK television issued the message on its internet and mobile news sites as well as on Twitter, saying North Korea appeared to have fired a missile at Japan. It said the government was telling people to evacuate and take shelter.

"North Korea appears to have fired a missile," NHK said, adding that a government warning had been issued. "The government: Seek shelter inside buildings and basements."

The false alarm came just days after Hawaii's Emergency Management Agency sent a mistaken warn-



ing of a North Korean missile attack to mobile phones across the state, triggering

panic.

NHK said the mistake was the result of an error by a staff member who was operating the alert system for online news, but did not elaborate. NHK deleted the tweet and

text warning after several minutes, issued a correction and apologized several times on air and on other formats.

"The flash was a mistake," NHK said. "We are very sorry.

Tension has grown in Japan over North Korean missile tests as they have flown closer to Japanese coasts.

NHK and other Japanese media generally alert each missile test, and the government has issued emergency notices when the missiles flew over Japan

Japan is also stepping up its missile intercepting capabilities and conducting missile drills across the country in which residents, including

schoolchildren and elderly people, rush to community centers, cover their heads and duck down to the floor. A major drill is planned in downtown Tokyo next week.

Unlike the mistaken Hawaii warning, the NHK alert did not contain the statement, "This is not a drill." NHK was able to correct its error in a

few minutes, far faster than the nearly 40 minutes that lapsed before the Hawaii alert was withdrawn.

The Hawaii agency has now changed its protocols to require that two people send an alert and made it easier to cancel a false alarm.

Chinese Foreign Ministry spokesman Lu Kang told reporters that a meeting that "doesn't include important parties to the Korean peninsula nuclear issue" cannot help resolve it.

Hook said China and Russia would be briefed afterward, and said the inter-Korean talks won't change Tuesday's agenda.

"We believe that this pressure campaign remains the best avenue to force change in Kim Jong Un's behavior and to get him to the negotiating table for meaningful discussions," he said.

The latest U.N. Security Council resolution against North Korea, adopted in December in response to an intercontinental ballistic missile test, calls on member states to impound vessels suspect-

ed of illicit trade with the North, and authorizes interdictions in a member state's territorial waters.

also It restricts North Korean imports of crude oil and refined petroleum products, and further cuts into its ability to raise revenue for its weapons programs. Combined with previous U.N resolutions, more than 90 percent of North Korea's publicly reported exports as of 2016 are now banned.

VANCOUVER, British Columbia (AP) — Secretary of State Rex Tillerson huddles Tuesday with nations that fought on America's side in the Korean War, looking to tighten the economic noose around North Korea over its nuclear weapons even as hopes rise for diplomacy.

The 20-nation gathering on Canada's western coast comes days after a mistaken missile alert caused panic on Hawaii, a stark reminder of the fears of conflict with the North after a year of escalating tension.

The meeting in Vancouver, hosted by Tillerson and his Canadian counterpart Chrystia Freeland, was called before the recent start of talks between North and South Korea, the first in two years. The North restored a military hotline and agreed to participate in the Winter Olympics being hosted in February by the South, a close U.S. ally.

President Donald Trump has also signaled openness to talks with North Korea under the right circumstances. Despite the insults and blood-curdling threats he's traded with its leader Kim Jong Un, he suggested in an interview that the two leaders could have a positive relationship.

But Kim, widely viewed as seeking to drive a wedge between the U.S. and South Korea, shows no his totalitarian government comes close to perfecting a nuclear-tipped missile that could strike the United States.

The Vancouver meeting is intended to boost the campaign of "maximum pressure" that the Trump administration has championed to deprive the North of revenue for weapons development. Officials will discuss cooperation on sanctions, preventing the spread of weapons by North Korea, and diplomacy.

Brian Hook, Tillerson's senior policy adviser, said more needs to be done to interdict ships conducting illicit trade with North Korea. He said the U.S. wants the United Nations to mandate a port entry ban for such vessels.

The meeting is being attended by foreign ministers and senior diplomats of nations that sent troops or humanitarian aid to the U.N. Command that supported South Korea in the fight against the communist North and its allies during the 1950-53 Korean War. It's a diverse gathering of mostly European and Asian nations, as well as Australia, New Zealand and Columbia. Japan and South Korea are also taking part.

Defense Secretary Jim Mattis was to join a welcoming dinner for the delegates on Monday night.

China and Russia, which fought on the communist side in the war, oppose the meeting. They were

California teen leads deputies to parents' house of horrors

PERRIS, Calif. (AP) - A 17-year-old girl called police after escaping from her family's home where she and her 12 brothers and sisters were locked up in filthy conditions, some so malnourished officers at first believed all were children even though seven are adults.

The girl, who was so small officers initially believed she was only 10, called 911 and was met by police who interviewed her and then went to the family home in Perris, about 70 miles southeast of Los Angeles. They found several children shackled to their beds with chains and padlocks in dark, foul-smelling surroundings, according to the Riverside County Sheriff's Department.

The children, ages 2 to 29, "appeared to be malnourished and very dirty," accord-



souciance about such inaccuracies. "If it rings true, it is true," he told NBC News' Katy Tur. She responded, "Congratulations on the book and congratulations on the president hating it."

The other reason Wolff's ambitions may prove to be as unfulfilled as those of the former Trump aide who appears to have been his chief source, Steve Bannon, is that the gist of his indictment — to the extent it's not fake news — is simply not news. Americans today, like American voters in November 2016, are aware that Trump makes outrageous and inaccurate statements.

They know that his White House, like his campaign, is often in shambles, as have been many other presidential campaigns (read Jonathan Allen and Amie Parnes' "Shattered," on Hillary Clinton's 2016 campaign) and first-year White Houses (go back and read about the Bill Clinton White House in 1993). No one supposes Trump has the discipline and gravitas of Dwight Eisenhower. But neither have most of his successors.


"Fire and Fury" can be seen as the latest attempt to overturn the result of the 2016 election. Others have not fared well. Entertainers' attempts to persuade presidential electors not to vote for

And the charges that Trump secured his victory by collusion with Vladimir Putin's Russia seem to be fizzling out. Instead, evidence suggests that the Obama FBI used Christopher Steele's dossier — commissioned by Fusion GPS, which was hired by the Clinton campaign for opposition research — to undermine Trump.

As Hillary Clinton said before her defeat, acquiescence in the peaceful transfer of power is one of the strengths of a representative democracy. Yet the impulse of many Democrats and never-Trumpers is to style themselves the "Resistance" and to attempt to overturn an election result they consider deplorable.

The Wolff book is the latest example — and perhaps one that discredits the enterprise. "The anti-Trump movement, of which I'm a proud member, seems to be getting dumber," writes New York Times columnist David Brooks in response. It suffers from "insularity," he goes on, and from "lowbrowism."

It's not clear that his administration is coming up with an infrastructure proposal in line with his campaign rhetoric or that it's producing nominees for many important administrative positions. There's plenty of room for criticism — which is likely to be more productive than attempting somehow to overturn an election.

Federalists can't support a cannabis crackdown

last Thursday, efore state-licensed marijuana merchants operated in a highly uncertain legal environment, subject to the whims of federal prosecutors who could at any moment decide to shut them down, take their property, and send them to

prison. Now that Attorney General Jeff Sessions has clarified the Justice Department's policy regarding the cannabis industry, state-licensed marijuana merchants operate in a highly uncertain legal envi-

ronment, subject to the whims of federal prosecutors who could at any moment decide to shut them down, take their property, and send them to prison.

Sessions calls this "a return to the rule of law." The description is dubious, not only because the situation for state-legal marijuana growers and distributors is fundamentally unchanged but also because the cannabis crackdown threatened by Sessions offends a basic principle of constitutional law: The federal government may not exercise powers it was never granted.

U.S. attorneys prosecute a minuscule percentage of marijuana violations, and they have very broad discretion to decide which ones are worth their time. Sessions rescinded Justice Department guidelines that said a violator's compliance with state

law was one factor prosecutors should consider.

The reasoning, as explained in a 2013 memo from James Cole, then the deputy attorney general, was that state-regulated marijuana businesses are less likely to impinge on "federal enforcement priorities" such as stopping interstate smuggling and sales to minors. Cole did not tell U.S. attorneys to leave state-legal canna-businesses alone, but since 2013 they generally have.

It's not clear whether Sessions' memo will change that. Sessions called the marijuana-specific guidelines "unnecessary" and said prosecutors should be guided by "the Department's wellestablished general principles." Last week the interim U.S. attorneys in Colorado and the Southern District of California, both Sessions appointees, said they would continue as before.

But given Sessions' well-known opposition to marijuana legalization, his memo was widely seen as portending more aggressive enforcement of the federal ban. That prospect provoked bipartisan criticism from state officials and members of Congress, uniting Democrats who support drug policy reform with Republicans who support federalism.

Sessions' boss counts himself in the latter group, and he has repeatedly applied the principle of state autonomy to marijuana. In July 2016, for instance, a TV reporter in Colorado Springs asked Donald Trump what he thought about using federal power to shut down the state-authorized cannabis industry in states such as Colorado

"I wouldn't do that, no," Trump replied. "I'm a states person. I think it should be up to the states, absolutely."

That position is broadly popular. Last summer, a Quinnipiac University poll found that 75 percent of Americans, including 59 percent of Republicans, opposed "enforcing federal laws against marijuana" in the 29 states that "have already legalized medical or recreational marijuana."

Refraining from such interference also happens to be what the Constitution requires. Under the 10th Amendment, "the powers not delegated to the United States by the Constitution, nor prohibited by it to the states, are reserved to the states respectively, or to the people."

In 2005 the Supreme Court said the Commerce Clause covers every last speck of cannabis in the country, even if it never crosses state lines, down to the plant in a cancer patient's closet or the bag of buds in her nightstand. "If Congress can regulate this under the Commerce Clause," noted dissenting Justice Clarence Thomas, "then it can regulate virtually anything — and the Federal Government is no longer one of limited and enumerated powers."

Republican critics of Sessions' marijuana memo echo Thomas's concerns about an overreaching federal government. If they join forces with legalization-friendly Democrats, they can pass a bill that protects canna-businesses from DOJ harassment and challenges the president to act on his avowed support for the 10th Amendment

DALLAS (AP) — Thousands of Texans have saluted the Rev. Martin Luther King Jr. with parades, music and speeches honoring the slain civil rights leader.

MLK Day Parades were being held Monday in numerous Texas cities, including Houston, Dallas, Fort Worth and San Antonio. An MLK march, rally and cultural festival was scheduled on the campus of the University of Texas in Austin.

The Children's Museum of Houston's 22nd annual MLK Day Celebration on Monday featured artwork, recitations and spiritual songs. A Gospel Night community choir program was planned in Lubbock.

Some communities honored King, who was assassinated 50 years ago, with public service and church programs. The University of Texas Rio Grande Valley urged volunteers to do projects for "a more beloved community."

An MLK unity barbecue was held Sunday in Tyler.

Gunfire in Garland leaves 1 man dead, 2 teens wounded

GARLAND, Texas (AP) — Police say gunfire at a Dallas-area residence has one man dead and two teens wounded.

Garland police are trying to determine what sparked the shootings before dawn Monday. Police didn't immediately announce any arrests.

Officers responded to a call about someone being shot at a home and that people in a fleeing red car possibly were involved.

A Garland police statement says officers stopped a vehicle, driving without the headlights off, matching the description of the car. Four people were inside, including a 13-yearold boy who'd been shot. He's hospitalized in stable condition.

Officers who arrived at a Garland home found two people shot. Police say a 22-year-old man was pronounced dead at a hospital. A 15-yearold boy was listed as stable.

Further details weren't immediately released.

Storm could dump up to 4 inches of snow on southern Arkansas

LITTLE ROCK, Ark. (AP) — Much of Arkansas will be under a winter storm warning or advisory later Monday as a blast of Arctic air could dump up to 4 inches of snow in parts of the state and send temperatures plummeting.

The National Weather Service issued the warning for Monday evening through Tuesday, when bands of snow will develop behind the front.

About half the state could see snowfall totals between 2 and 3 inches, with up to 4 inches to the south.

Forecasters also included northeast Texas and northwest Louisiana in the warning.

Counties in northeast Oklahoma and northwest Arkansas will be under a winter weather advisory, with up to 2 inches of snow possible by Monday night.

Temperatures in parts of Arkansas and Oklahoma are expected to fall into the 20s.

Texas father charged with murder in death of Indian orphan

DALLAS (AP) — The father of a 3-year-old girl adopted from an Indian orphanage was indicted on a capital murder charge Friday, nearly three months after the girl's body was found in a culvert near their suburban Dallas home. Wesley Mathews, 37, has been

jailed on a lesser charge in Dallas County since shortly after his daughter, Sherin, was found dead. Prosecutors said the murder charge, which could carry the death penalty, was filed after an autopsy determined the girl died from "homicidal violence." Mathews initially said his daughter disappeared after he sent her outside as punishment for not drinking milk around 3 a.m. on Oct. 7. But after her body was found, he told police she choked to death and that he removed her body from the family's home in Richardson, about 15 miles (24 kilometers) north of Dallas. Authorities haven't said what they believe happened to the girl, and court documents only allege that Mathews caused his daughter's death using a deadly weapon "by a manner and means unknown to the grand jury." "We have some information in terms of what might have happened, but we are still investigating," District Attorney Faith

Johnson said during a Friday news conference, adding that her office had not decided whether it would seek the death penalty.

A phone message left by The Associated Press seeking comment from Mathews' attorney wasn't returned Friday.

The girl's mother, Sini Mathews, hasn't been charged in the death but is jailed on a separate child abandonment charge stemming from when she and her husband left Sherin home alone — the day before the girl was reported missing. Her attorney has previously said she played no role in Sherin's death. Johnson said evidence in the case was still unfolding but that there was no indication anyone outside of Sherin's parents was involved in the death. Wesley Mathews was also indicted Friday on charges of abandoning a child and tampering with evidence. He was initially charged in late October with felony injury to a child and his bond was set at \$1 million. He reported his daughter missing on Oct. 7, sparking a broad search involving numerous law enforcement agencies before her body was found on Oct. 22. The local police chief said it's been an intense case for his officers.

In his initial report to police Wesley Mathews said he waited several hours to report the gir missing and had done laundry as he waited for her to come home He told investigators the girl had developmental disabilities and was malnourished.

He described a special die regimen in which she had to ear whenever she was awake in order to gain weight. Workers at the or phanage where the girl had beer living before her adoption in June 2016 disputed the child was mal nourished. Weeks later, when a search dog found the girl's body in a pipe that runs under a roadway, Mathews came to the police station in Rich ardson to change his account. Ac cording to court records, he told police he had been helping the gir drink milk when she choked, and when he eventually felt no pulse he believed the child had died. In vestigators wrote that he "then ad mitted to removing the body from the home." The affidavit does not say wheth er Mathews administered any medical aid to his daughter.

Authorities identify man killed by Fort Worth police in raid

FORT WORTH, Texas (AP) — Authorities have identified a man Fort Worth SWAT officers shot and killed during a drug raid.

The Fort Worth Star-Telegram reported Saturday that the Tarrant County medical examiner's office said 60-year-old Jose Arroyo-Rosales Sr. died from multiple gunshot wounds about 1:40 a.m. Thursday.

Authorities say tactical officers were serving a search warrant for drugs at the home, where they say narcotics were found in plain view.

They say a door to a room was closed and when officers entered they saw the man pointing the weapon at them.

At least two officers fired at Arroyo-Rosales, striking him several times.

Later Thursday, 24-year-old Jose Rosales Jr. was arrested on drug possession charges. Police spokesman Tracy Carter said the two men were father and son.

Booty and books: New evidence of pirates' interest in both

RALEIGH, N.C. (AP) – Dead men tell no tales, but there's new evidence that somebody aboard the pirate Blackbeard's flagship harbored books among the booty.

In an unusual find, researchers have discovered shreds of paper bearing legible printing that somehow survived three centuries underwater on the sunken vessel. And after more than a year of research that ranged as far as Scotland, they managed to identify them as fragments of a book about nautical voyages published in the early 1700s.

Conservators for Blackbeard's ship the Queen Anne's Revenge found the 16 fragments of paper wedged inside the chamber for a breech-loading cannon, with the largest piece being the size of a quarter.

The Queen Anne's Revenge had been a French slave ship when Blackbeard captured it in 1717 and renamed it. The vessel ran aground in Beaufort, in what was then the colony of North Carolina, in June 1718. Volunteers with the Royal Navy killed Blackbeard in Ocracoke Inlet that same year.

Tens of thousands of artifacts have been recovered since Florida-based research firm Intersal Inc. located the shipwreck off the North Carolina coast in 1996 but few, if any, are as surprising as pieces of paper. To find paper in a 300-year-old shipwreck in warm waters is "almost unheard of," said Erik Farrell, a conservator at the QAR Conservation Lab in Greenville.

Eventually, the conservators determined that the words "south" and "fathom" were in the text, suggesting a maritime or navigational book. But one word, Hilo, stood out because it was both capitalized and in italics, said Kimberly Kenyon, also a conservator at the lab.

They turned to Johanna Green, a specialist in the history of printed text at the University of Glasgow, who pointed them to the Spanish settlement of Ilo – or Hilo – on the coast of Peru. The fragments eventually were determined to be from a 1712 first edition of a book by Capt. Edward Cooke titled "A Voyage to the South Seas, and Round the World, Peform'd in the years 1708, 1709, 1710 and 1711."

It's impossible to say who aboard Blackbeard's ship would have been

reading the voyage narrative а form popular in England in the 17th and 18th century – or whether it belonged to a pirate or some terrified captive. But some pirates were known to be literate, Kenyon said.

For example, Stede Bonnett, the "gentleman pirate" who joined Blackbeard in 1717, had his own library. It's not known if he brought his books on the Queen Anne's Revenge.

A history of pirates written in 1724 mentions a journal belonging to Blackbeard that was taken when he was killed. And when Blackbeard captured a ship called the Margaret in December 1717, the list of items taken from the ship included books, Farrell said.

"They were literate men," Kenyon said. "People always assume pirates are ruffians from bad backgrounds, and that wasn't always the case.'

The survival of the paper fragments is perhaps even more unusual than their existence aboard the pirate vessel.

The chamber in which they were found was a separate piece of a breach-loading swivel gun that was likely kept on the top deck because it was used as an anti-personnel weapon, Farrell said. Conservators don't have the cannon itself, which likely was salvaged or stolen when the Queen Anne's Revenge ran aground. In cannons of that period, "wadding" material such as cloth or paper would usually be stuffed behind a cannonball. So it's also possible someone just tore up the book without reading it to use it for firepower.

Conservators had removed a wooden plug from the chamber so they could clean it when they discovered the paper fragments stuffed in there. along with pieces of fabric in May 2016, Farrell said. That mass was removed easily enough, but prying the fragments from the fabric was more tedious and time-consuming, he said.

The combination of fabric and the plug likely protected the paper, which normally would have disintegrated in water, Farrell said.

But the ability to read doesn't change the evil character of pirates, who ransacked, raped and killed.

"The fact that they're literate doesn't mean they're not terrible, marauding people," Farrell said. "It just adds some nuance."

Cranberries singer Dolores **O'Riordan dead** at 46

Associated Press LONDON (AP) – Dolores O'Riordan, lead singer of Irish rock band The Cranberries, died suddenly on Monday. She was 46.

O'Riordan died in London, where she was recording, publicist Lindsey Holmes said.

"No further details are available at this time." Holmes said. adding that the singer's family was "devastated" by the news.

Formed in Limerick, Ireland at the end of the 1980s, The Cranberries became international stars in the 90s with hits including "Zombie" and "Linger" that fused the alternative rock edge with Celtic-infused pop tunefulness. Irish President Michael D. Higgins said O'Riordan and the band "had an immense influence on rock and pop music in Ireland and internationally." "To all those who follow and support Irish music, Irish musicians and the performing arts, her death will be a big loss," he said in a statement. O'Riordan was The Cranberries' chief lyricist and co-songwriter, and her powerful, sometimes wailing, voice was key to the band's distinctive sound. The group's 1993 debut album "Everybody Else Is Doing It, So Why Can't We?" sold millions of copies and produced the hit single "Linger."

The follow-up, "No Need to Argue," sold in even greater numbers and contained "Zombie," a howl against Northern Ireland's violent Troubles that topped singles charts in several countries.

The band released three more studio albums before splitting up in 2003. O'Riordan released a solo album, "Are You Listening." in 2007, and another, "No Baggage," in 2009. The members of The Cranberries reunited that year, releasing the album "Roses" in 2012.

The Cranberries released the acoustic album "Something Else" in 2017 and had been due to tour Europe and North America. The tour was cut short because O'Riordan was suffering from back problems. In 2014, O'Riordan was accused of assaulting three police officers and a flight attendant during a flight from New York to Ireland. She pleaded guilty and was fined 6,000 euros (\$6,600). Medical records given to the court indicated she was mentally ill at the time of the altercation. After her court hearing O'Riordan urged other people suffering mental illness to seek help. O'Riordan is survived by her exhusband, the former Duran Duran tour manager Don Burton, and their three children.

Trump defends himself anew against charges that he is racist

WEST PALM BEACH, Fla. (AP) — President Donald Trump is defending himself anew against accusations that he is racist, this time after recent disparaging comments about Haiti and African nations.

"No, No. I'm not a racist," Trump said Sunday, after reporters asked him to respond to those who think he is. "I am the least racist person you have ever interviewed. That I can tell you."

Trump also denied making the statements attributed to him. but avoided the details of what he did or did not sav.

"Did you see what various senators in the room said about my comments?" he asked, referring to lawmakers who were meeting with him in the Oval Office on Thursday when Trump is said to have made the comments. "They weren't made." Trump stands accused of using "shithole" to describe African countries during an immigration meeting with a bipartisan group of six senators. The president, in the meeting, also questioned the need to admit more Haitians to the U.S., according to people who were briefed on the conversation but were not authorized to describe the meeting publicly. Trump said in the meeting that he would prefer immigrants from countries like Norway instead. The White House has not denied that Trump said "shithole" though Trump has already pushed back on some depictions of the meeting. A confidant of Trump's The Associated told Press that the president spent Thursday evening calling friends and outside advisers to judge their reaction to his remarks. Trump wasn't apologetic and denied he was racist, instead blaming the media for distorting his meaning, said the confidant, who wasn't authorized to disclose a private conversation and spoke on condition of anonymity.

Sen. Dick Durbin of Illinois, the only Democrat at Thursday's meeting, said Trump had indeed said what he was reported to have said. Durbin said the "vile, remarks were hate-filled and clearly racial in their content." He said Trump used the most vulgar term "more than once." Trump commented as Durbin was presenting details of a compromise immigration plan that included providing \$1.6 billion for a first installment of the president's long-sought border wall. Trump took particular issue with the idea that people who'd fled to the U.S. after disasters hit their homes in places such as El Salvador, Guatemala and Haiti would be allowed to stay as part of the deal, according to the people, who spoke on condition of anonymity because

they weren't authorized to publicly describe the discussion.

When it came to talk of extending protections for Haitians, Durbin said Trump replied, "We don't need more Haitians."

"He said, 'Put me down for wanting more Europeans to come to this country. Why don't we get more people from Norway?" Durbin said.

Republican Sens. David Perdue of Georgia and Tom Cotton of Arkansas, who also attended the meeting, initially said in a statement Friday that they "do not recall the president saying these comments specifically." On Sunday, they backtracked and challenged other senators' descriptions of the remarks.

Trump insisted in a tweet on Friday that he "never said anything derogatory about Haitians other than Haiti is, obviously, a very poor and troubled country. Never said 'take them out.' Made up by Dems." Trump wrote, "I have a wonderful relationship with Haitians. Probably should record future meetings - unfortunately, no trust!"

Trump has defended himself against accusations of being a racist on numerous occasions, including during his insistence that President Barack Obama was not American-born and after he opened his presidential campaign in 2015 by describing Mexicans as rapists and drug ped dlers. Word of Trump's comthreatened to ments upend delicate negotiations over resolving the status of hundreds of thousands of immigrants who were brought to the country illegally as children.

Perdue described as a "gross misrepresentation" reports that Trump used the vulgarity. He said Durbin and Republican Sen. Lindsey Graham of South Carolina were mistaken in indicating that was the case. Graham also attended the meeting.

"I am telling you that he did not use that word. And I'm telling you it's a gross misrepresentation," Perdue said on ABC's "This Week."



NBA opens investigation into Rockets-Clippers events

LOS ANGELES (AP) – The NBA is planning to speak with players from both the Houston Rockets and Los Angeles Clippers to determine the specifics of late-game and postgame events involving the teams.

NBA spokesman Tim Frank said Tuesday that the league would look into the matter. Tempers boiled over Monday night late in the Clippers' 113-102 victory, to the point where several security guards were needed outside the Houston locker room postgame.

Citing anonymous NBA sources, ESPN reported several Rockets

players headed toward the Clippers' locker room afterward, seeking a confrontation, but were escorted away by security before anything got physical.

There were late-game incidents as well in Chris Paul's first game in Los Angeles since he was traded to the Rockets this past summer. **Clippers star Blake Grif**fin appeared to bump Houston coach Mike D'Antoni, and they exchanged words. Griffin and Houston's Trevor Ariza were later ejected after another incident.

Postgame, neither team offered specifics on what happened, if anything, in the Clip-

pers' locker room.

"We were where we were supposed to be," Griffin said. "We were in our locker room."

Paul was asked postgame about what happened, and dodged the question.

"I don't know," Paul said. "We took our loss. Tough loss."

It seems almost inevitable that the NBA will have to take some disciplinary action against players. Paul is also the president of the National Basketball Players Association, which did not immediately respond to a request for comment Tuesday







Today's Highlight in History: On Jan. 16, 1978, NASA named 35 candidates to fly on the space shuttle, including Sally K. Ride, who became America's first woman in space, and Guion S. Bluford Jr., who became America's first black astronaut in space. On this date:

In 27 B.C., Caesar Augustus was declared the first Emperor American to orbit the Earth, would fly aboard the space shuttle later in the year.

In 2003, the space shuttle Columbia blasted off for what turned out to be its last flight: on board was Israel's first astronaut, Ilan Ramon (ee-LAHN' rah-MOHN'). (The mission ended in tragedy on Feb. 1, when the shuttle broke up during its return descent, killing all seven crew members.)

Ten years ago: President George W. Bush closed out his Mideast trip with a brief visit to Egypt, where he was welcomed by President Hosni Mubarak (HOHS'-nee moo-BAH'-rahk). Archbishop Earl Paulk, the 80-year-old leader of William Kennedy is 90. Authoreditor Norman Podhoretz is 88. Opera singer Marilyn Horne is 84. Hall of Fame auto racer A.J. Foyt is 83. Singer Barbara Lvnn is 76. Country singer Ronnie Milsap is 75. Singer Katherine Anderson Schaffner (The Marvelettes) is 74. Country singer Jim Stafford is 74. Talk show host Dr. Laura Schlessinger is 71. Movie director John Carpenter is 70.

Actress-dancer-choreographer Debbie Allen is 68. Rhythmand-blues singer Maxine Jones (En Vogue) is 59. Singer Sade (shah-DAY') is 59. Pop/rock singer-songwriter Jill Sobule is 59. Rock musician Paul Webb (Talk Talk) is 56. Actor David Chokachi (CHOH'-kuh-chee) is 50. Labor Secretary Alexander Acosta is 49. Actor-writerdirector Josh Evans is 47. Actor-comedian Jonathan

In 1547, Ivan IV of Russia (popularly known as "Ivan the Terrible") was crowned Czar.

In 1865, Union Maj. Gen. William T. Sherman decreed that 400,000 acres of land in the South would be divided into 40-acre lots and given to former slaves. (The order, later revoked by President Andrew Johnson, is believed to have inspired the expression, "Forty acres and a mule.")

In 1920, Prohibition began in the United States as the 18th Amendment to the U.S. Constitution took effect, one year to the day after its ratification. (It was later repealed by the 21st Amendment.)

In 1935, fugitive gangster Fred Barker and his mother, Kate "Ma" Barker, were killed in a shootout with the FBI at Lake Weir, Florida.

In 1942, actress Carole Lombard, 33, her mother, Elizabeth, and 20 other people were killed when their plane crashed near Las Vegas, Nevada, while en route to California from a war-bond promotion tour.

In 1957, three B-52's took off from Castle Air Force Base in California on the first non-stop, round-the-world flight by jet planes, which lasted 45 hours and 19 minutes. Classical music conductor Arturo Toscanini died in New York at age 89.

In 1967, Alan S. Boyd was sworn in as the first U.S. secretary of transportation.

In 1988, Jimmy "The Greek" Snyder was fired as a CBS Sports commentator, one day after telling a reporter for WRC-TV in Washington, D.C. that, during the era of slavery, blacks had been bred to produce stronger offspring.

In 1991, the White House announced the start Operation Desert Storm to drive Iraqi forces out of Kuwait. (Allied forces prevailed on Feb. 28, 1991.)

In 1998, NASA announced that John Glenn, the first a megachurch, pleaded guilty in Atlanta to lying under oath about his sexual affairs and was sentenced to 10 years' probation. (Paulk died in March 2009.)

Five years ago: President Barack Obama unveiled the most sweeping proposals for curbing gun violence in two decades, pressing a reluctant Congress to pass universal background checks and bans on military-style assault weapons and high-capacity ammunition magazines like the ones in the Newtown, used Connecticut, school shooting. (Both proposals went down to defeat.) The federal government temporarily grounded Boeing's newest and most technologically advanced jetliner, declaring that U.S. carriers could not fly the 787 Dreamliner again until the risk of battery fires was addressed. (The grounding order was lifted three months later.) Pauline Friedman Phillips, better known as advice columnist Dear Abby, died in Minneapolis at age 94.

One year ago: Turkish authorities captured an Uzbek national suspected of killing 39 people during an attack on an Istanbul nightclub during New Year's celebrations. A shooting attack at an electronic music festival in Mexico's Caribbean coastal resort of Playa del Carmen left five people dead, including three foreigners. Former NASA astronaut Eugene Cernan, to date the last man to walk on the moon, died in Houston at age 82.

### Pope begs forgiveness for 'irreparable' harm from sex abuse

EdsSANTIAGO, Chile (AP) Pope Francis begged for forgiveness Tuesday for the "irreparable damage" done to children who were raped and molested by priests, opening his visit to Chile by diving head-first into a scandal that has greatly hurt the Catholic Church's credibility here and cast a cloud over his visit.

Francis faced controversy on another front as well: Overnight three more Catholic churches were torched, including one burned to the ground in the southern Araucania region where Francis will visit on Wednesday to meet with Chile's indigenous peoples. While not causing any injuries, the nine church firebombings in the past few days have marked an unprecedented level of protest against history's first Latin American pope on his home turf.

In Santiago, though, an estimated 400,000 jubilant Chileans turned out in droves for his first public Mass, a massive gathering in the capital's O'Higgins park where St. John Paul II celebrated Mass three decades ago. Before the service began, Francis took a long, looping ride in his popemobile through the grounds to greet well-wishers, some of whom had camped out overnight to secure a spot.

In his first event of the day, Francis met privately with Chilean President Michelle Bachelet and addressed lawmakers, judges and other authorities at La Moneda palace. They interrupted him with applause when he said he felt "bound to express my pain and shame" that some of Chile's pastors had sexually abused children in their care.

"I am one with my brother bishops, for it is right to ask forgiveness and make every effort to support the victims, even as we commit ourselves to ensuring that such things do not happen again," he said.

Francis didn't refer by name to Chile's most notorious pedophile priest, the Rev. Fernando Karadima, who was sanctioned in 2011 by the Vatican to a lifetime of "penance and prayer" for sexually molesting minors. Nor did he refer to the fact that

the emeritus archbishop of Santiago, a top papal adviser, has acknowledged he knew of complaints against Karadima but didn't remove him from ministry.

Karadima had been a politically connected, charismatic and powerful priest who ministered to a wealthy Santiago community and produced dozens of priestly vocations and five bishops.

Victims went public with their accusations in 2010, after complaining for years to church authorities that Karadima would kiss and fondle them when they were teenagers.

While the scandal rocked the church, many Chileans are still furious over Francis' subsequent decision, in 2015, to appoint a Karadima protege as bishop of the southern city of Osorno.

Bishop Juan Barros has denied knowing about Karadima's abuse but many Chileans don't believe him, and his appointment has badly split the diocese.

"Sex abuse is Pope Francis' weakest spot in terms of his credibility," said Massimo Faggioli, a Vatican expert and theology professor at Villanova University in Philadelphia. "It is surprising that the pope and his entourage don't understand that they need to be more forthcoming on this issue."

Anne Barrett Doyle, of the online abuse database BishopAccountability.org, praised Francis for opening his visit with the apology, but said Chileans expect him to take action against complicit church leaders.

"This is a crucial opportunity for Francis: With luck. he will not make the mistake of his brother bishops in underestimating the savviness and moral outrage of the Chilean people," said Barrett Dovle. who last week released research showing nearly 80 Chilean priests have been credibly accused or convicted of abuse.

The Karadima scandal and a long cover-up has caused a crisis for the church in Chile. with a recent Latinbarometro survey saying the case was responsible for a significant drop in the number of Chileans who call themselves Catholic, as well as a fall in confidence in the church as an institution.

That distrust extends to Francis, who is making his first visit as pope to this country of 17 million people.

The Argentine pope is nearly a native son, having studied in Chile during his Jesuit novitiate and he knows the country well, but Chileans give him the lowest approval rating among the 18 Latin American nations in the survev.

"People are leaving the church because they don't find a protective space there," said Juan Carlos Claret, spokesman for a group of church members in Osorno that has opposed Barros' appointment as bishop. "The pastors are eating the flock."

At a protest Tuesday near O'Higgins park where Francis celebrated Mass, police fired tear gas and water cannons before detaining several dozen demonstrators, according to an Associated Press photographer at the scene. Protesters carried signs with messages reading "Burn, pope!" and "We don't care about the pope!"

Other groups also called for demonstrations against the pontiff.

Victor Hugo Robles, an activist in Chile's lesbian and gay community, said the Vatican tries to paint an image of the pope as being close to the people, particularly those with the most needs.

"We are the ones who need help," said Robles. "Gay people, people living with AIDS. When it comes to those things, the church has an attitude of intolerance, of disgust."

Felipe Morales, from a group called the Workers' Socialist Front, said many were unhappy with the pope and the church's historical influence in Chile. They planned to protest outside while Francis celebrated Mass.

"The role of the church has been nefarious," said Morales. "Sex abuse cases have been covered up and people are unhappy with many other issues.'

To be sure, many are excited to see the pope. Thousands lined the streets of Santiago to get a glimpse of Francis after he arrived Monday night, though the crowds were notably thin compared to previous visits to other Latin American capitals. O'Higgins Park, though, was teeming with faithful attending the pope's Mass.

"It was amazing to see him," said Luis Salazar, a young boy who came out with his family to see Francis pass by in his popemobile.

The pope will try to inject new energy into the church during his visit, which includes sessions with migrants, members of Chile's Mapuche indigenous group and victims of the 1973-1990 military dictatorship. It remains to be seen if he will meet with sex abuse survivors. A meeting wasn't on the agenda, but such encounters never are.

### **Danish man charged** with killing reporter on his submarine

COPENHAGEN, Denmark (AP) — Inventor Peter Madsen was charged Tuesday with killing Swedish journalist Kim Wall during a trip on his private submarine, with prosecutors saying he either cut her throat or strangled her before dismembering her body and dumping it into the sea.

Prosecutor Jakob Buch-Jepsen called the case "very unusual and extremely disturbing."

Madsen, 47, is charged with murder, dismemberment and indecent handling of a corpse for the way he disposed of Wall's body. He is also charged with having sexual relations with Wall, 30, of a "particularly dangerous nature" before she was killed.

The charges were made public by the Danish prosecution authority.

Buch-Jepsen said the killing was premeditated. Prosecutors will urge that Madsen be sentenced to life in prison, or be locked up in a secure mental facility if deemed necessary by psychiatrists for as long as he's considered sick and dangerous to oth-

"There is much technical evidence but I won't go into details right now," Buch-Jepsen told a brief news conference. He also declined to comment on Madsen's motive.

"Evidence must be presented in court and not in the media," he said, adding he also didn't want to comment out of respect for Wall's family.

Madsen's defense lawyer Betina Hald Engmark had no immediate comment in reaction to the charges, adding her client still denies murdering Wall.

Madsen and Wall had gone on a trip in Madsen's submarine on Aug. 10. Wall, who was working on a story about Madsen, was last seen aboard the vessel as it left Copenhagen. The next day, Madsen — an entrepreneur who once dreamed of launching a manned space mission — was rescued from the sinking submarine without Wall.

Police believe he deliberately sank the vessel.

Madsen has offered a shifting variety of explanations for Wall's death.
