## LIONS CLUB TO SPONSOR SWIM AND BEAUTY CONTEST

The Dimmitt Lion's Club, at its weekly meeting, May 27, 1947 voted to sponsor a beauty contest and swimming meet. The Arrangements Committee has selected the night of Friday, June 13, 1947, as the date for this colorful event. Who's superstitious?

Beginning promptly at eight o'clock the starter's pistol will send the first participants into the water in the racing events. The schedule for this splash your way to victory part of the program is as follows:

After the races, and before anyone has a chance to dry off, (including the spectators) the high and low board fancy divers will begin to demonstrate their versions of the 1947 "belly-flopper." This contest is open to all ages of boys and girls up to 92.

The first and second place winners of all racing events and low and high board diving will receive medals in order to protect their amateur standing. Since all the gold has been locked up at Ft. Knox the medals will be made of baser metal, but will make up in beauty what they lack in monetary value. So all you swimmers and divers register with either Harold Stephens or Earl Harrison and get your swim trunks out of the moth balls.

And for the evening's finale, and the event that has kept the male spectators waiting so long—the Bathing Beauty Contest. The entrants to this event must be females who reside in Castro County and are between the ages of 15 and 92 inclusive, single or married, and each girl shall be sponsored by a Dimmitt merchant; so merchants find your girl and girls hope you will all do your best for the glory of your sponsor. The merchant should promptly select his entrant and advise either Harold Stephens or Earl Harrison.

## CASTRO COUNTY PIONEER DIES

Mr. J. L. Crum, 85 years old, pioneer Panhandle farmer-stockman, died in an Amarillo hospital Wednesday morning following an extended illness.

Funeral services will be held at 2:00 o'clock Friday at the First Methodist Church in Tulsa with the pastor, Rev. James E. Harrell, officiating. Interment will be in the Tulsa cemetery, under the direction of the Wallace Funeral Home.

Mr. Crum was born July 16, 1861 at Gilmer. He was married to Miss Clara Electra Bourland on Thanksgiving day of 1884. Eleven children were born to them, seven of whom survive. Mrs. Crum died December 7, 1942.

Mr. Crum, with his wife, moved to the present site of Floyd county in 1889. He drove cattle along the Chisholm Trail from Abilene, to Kansas.

In 1889, he homesteaded in Castro county, and at various times since then had lived here and in Randall and Swisher counties.

He is survived by five sons, John, Scott, and Homer Crum, all of Dimmitt, Wilmer Crum, Tulsa; and Paul Crum, Chicago; two daughters, Mrs. Loucille Brown and Mrs. Ruby Norris, both of Amarillo; one brother, George Crum, Wichita Falls; and ten grandchildren and five great grandchildren.

## COUNTY TO WAGE WAR ON WEEDS

Stressing the need for a complete weed control program with special emphasis on the control of Bindweeds, Blueweeds and Johnson grass the Castro County Commissioners Court authorized the purchase of 100 drums of Atalacide and 5 drums of 2-4-D, that will be sold at cost plus handling charges to the farmers.

The Commissioners also purchased a power sprayer to be used on roads and also to be rented to farmers at a nominal fee.

According to R. L. King, County Agent, the atalacide is used to control Johnson grass and should be applied according to the manufacturers instructions about the time the plant begins to bloom and should be thoroughly sprayed. One application should control the Johnson grass.

The Bindweed is a perennial plant with white or pinkish blooms and resembles a small morning glory. The leaves have an arrow like base and are variable in size and shape. Bindweed is spreading rapidly and many farms in Castro county are known to be infested with this weed. The people who do have bindweed should be more interested than anyone in the control of this weed.

The 2-4-D spray is used to control bindweed and blue weed and should be applied, when the plant is growing vigorously. A second and third application is sometimes necessary to control these weeds.

The atalacide may be purchased at the Dimmitt Wheat Growers and 2-4-D may be received at the Consumers Fuel Association. Before getting the 2-4-D farmers must go to the office of the County Judge or County Agent and make the purchase, and receive an order that may be taken to the Consumers for the 2-4-D.

The Castro county Weed Control Committee and the Commissioners Court urge all farmers to use these poisons to control the weeds on their farms.

## COUNTY AGT. TO HANDLE FARM LABOR SITUATION

As in the past the County Agent's office will be a clearing place for farm labor during the harvest season. Farmers who will need farm labor, combines or trucks are urged to make application as soon as possible. Those wishing to work during harvest or need combining or hauling to do should also make application.

This does not necessarily mean that this labor will be immediately available but it does mean all necessary contacts will be made to secure some labor, if possible.

The local office will be in contact with the State Farm Labor office at Plainview for wheat harvest. This office is a central clearing house for farm labor for the wheat belt.

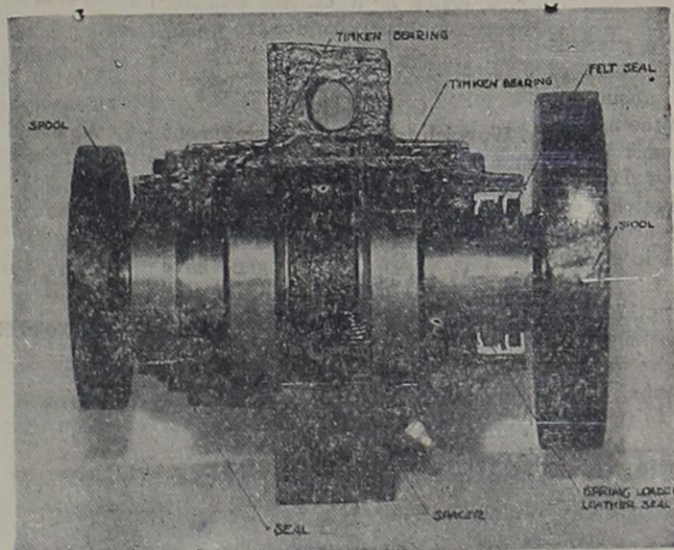

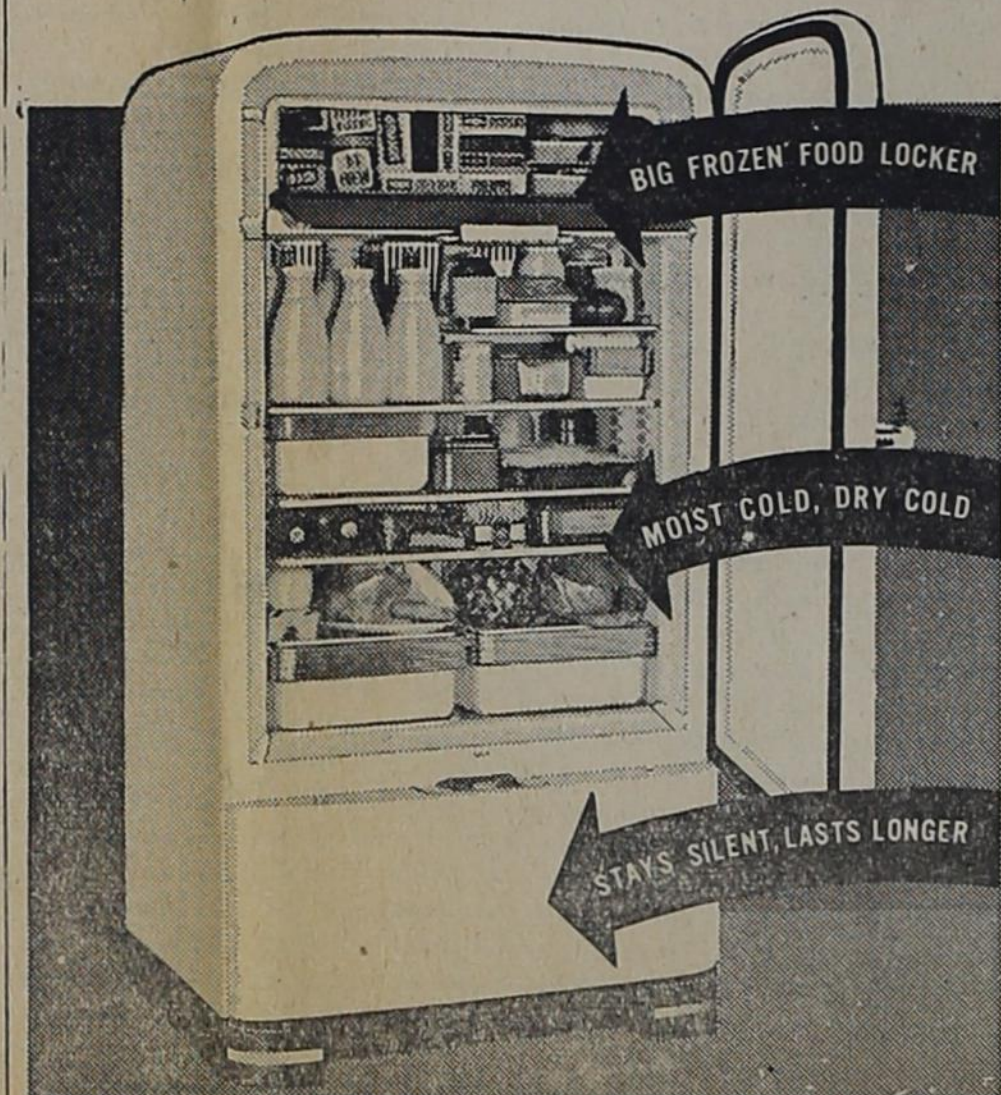
