

BSISD, HC partnership plan scrapped

A partnership under consideration between Big Spring Independent School District and Howard College will not happen, according to a press release received Friday from BSISD.

The partnership was being mulled by the

two entities to comply with Texas Education Agency requirements for Washington and Goliad elementary schools, which are in danger of TEA action for substandard scores on stu-

dent performance tests.

"For the past several weeks, Dr.

(Cheryl) Sparks, president of Howard College, and Johnny Tubb, interim superintendent of BSISD, have been researching all aspects of the needed requirements to make a valid partnership," said the

release. "Together, they

have reached the conclusion that the partnership is not attainable at this time."

The release cites slow response to requests for information from TEA as

the primary reason for calling off continued work on the partnership.

"Currently, there are simply too many questions and not enough answers from the Texas Education Agency to continue down this path," Tubb said in the press release. "I want to thank Dr. Sparks and Howard College for considering us as a partner and we look forward to future arrangements with them."

Sparks expressed continued willingness to work with BSISD in the future.

"Partnering with the Big Spring ISD on many opportunities through the years has been beneficial to all concerned," she said. "Although together we have determined this partnership option is one that we should not pursue, we stand ready to assist the Big Spring ISD as we can. Those students are our future students. Howard College wants to encourage the students, teachers, board and administration as they address these challenges. We remain confident that the Big Spring ISD will attain its goals for these campuses."

Tubb said that, should Washington and Goliad not manage to improve their scores, some sort of

FMH Foundation gives \$250K grant for Historic Spring

goals for Phase 2," said Big Spring Community Services Director Debbie Wegman.

Wegman explained the naming rights included in the contract for the FMH grant.

"It will be the Marie Hall Plaza," said Wegman after the meeting. "That will be on the stage area. Then the new pedestrian bridge that will connect the plaza to the pavilion, Phase 2, will be called 'The Hall's Way."

While the spring itself will not be part of the naming rights package, other features will bear monikers chosen by donors.

"It's kind of hard to put the name on the actual spring," Wegman said. "There are some other naming rights that will be out there. This is probably the biggest one. SM Energy has asked that we name the pavilion 'SM Energy Pavilion.' There are some other minor ones that we're going to be putting donations on. Some of the story boards, people donated money and we'll be doing that while we're working on Phase 2 so by the time that's finished, all the names will be where they

need to be."

City Councilman Terry McDaniel asked about the naming rights during the meeting; when Wegman told him about the stipulation transferring naming rights to FMH, McDaniel had an additional offer for the foundation.

"If Marie would give me \$250,000, I'd name my house after her," the councilman quipped.

\$50,000 of the FMH donation is set aside and earmarked to fund a concert series at the spring, Wegman said.

"(FMH) were very impressed with the site and they loved the plaza and stage area, so they want to make sure that's utilized," Wegman said. "They gave us that seed money to get started. We've already started doing some work on that. We'll probably wait until after Phase 2 is completed so we'll have the use of the pavilion, but we're going to work on getting some kind of concert series started. We'll probably do a summertime series. I think

Council members decided at their Tuesday evening meeting to sign the contract with FMH, which is the philanthropic organization founded by long-time Howard College supporter Florence Marie Hall.

The FMH gift was the largest of several grants accepted by council members for the

project, including \$2,245 from the Big Spring High School Class of '55-'57; \$5,000 from SM Energy; and \$25,000 from Occidental Petroleum. SM Energy has previously donated \$160,000 to the project; while Occidental Petroleum has donated an additional \$25,000 previously.

"With these contributions, we have now met our funding

Stephen Hawking, best-known physicist of his time, has died

LONDON (AP) — Stephen Hawking, whose brilliant mind ranged across time and space though his body was paralyzed by disease, has died. He was 76.

Hawking died at his home in Cambridge, England, according to a statement by the University of Cambridge.

The best-known theoretical physicist of his time, Hawking wrote so lucidly of the mysteries of space, time and black

pus and we've got a fourth-grade campus. Clearly the fourth graders aren't going to be there next year, it's going to be a whole new set of kids. And coming from the K-2 elementaries will be a whole new group of third graders.'

While the students are the biggest hurdle to reorganizing the schools, other problems exist as well.

"So that being the biggest obstacle, we've cleared that already," Tubb said. "Now, we are researching what we have to do with staff and obviously the principals, the leadership at the campuses. We're looking into it, and there's no more. This would be our last option, some type of repurposing or reconfiguration of those two campuses, if we had to."

Any required repurposing of the schools shouldn't be as difficult as when Big Spring's elementary schools were transitioned to grade-level campuses, Tubb said.

"It was a fruit-basket turnover when this reconfiguration was done the first time with transportation, bus routes, parents, neighborhood schools, all of that," he said. "This won't involve any of that, because basically a different group of kids will be at the school, but it will be the same grade as it was the previous year."

Tubb expressed displeasure with the slow flow of information about the process coming from TEA.

"It has been very disappointing concerning the information we've been getting from the Texas Education Agency," he said. "We have many questions, we need answers, and the information is getting to us in a very slow manner.'

holes that his book, "A Brief History of Time," became an international best-seller, making him one of science's biggest celebrities since Albert Einstein.

"He was a great scientist and an extraordinary man whose work and legacy will live on for many years, his children Lucy. Robert and Tim said in a statement. His courage and persistence with his brilliance and humour inspired people across the world. He once said, 'It would not be much of a universe if it wasn't home to the people you love.' We will miss him forever.'

Even though his body was attacked by amyotrophic lateral sclerosis, or ALS, when Hawking was 21, he stunned doctors by living with the normally fatal illness for more than 50 years. A severe attack of pneumonia in 1985 left him breathing through a tube, forcing him to communicate through an electronic voice synthesizer that gave him his distinctive robotic monotone. But he continued his scientific work, appeared on television and married for a second time. As one of Isaac Newton's successors as Lucasian Professor of Mathematics at Cambridge University, Hawking was involved in the search for the great goal of physics — a "unified theory." Such a theory would resolve the contradictions between Einstein's theory of relativity, which describes the laws of gravity that govern the motion of large objects like planets, and the quantum mechanics theory, which deals with the world of subatomic particles. For Hawking, the search was almost a religious quest — he said finding a "theory of everything" would allow mankind to "know the mind of God." "A complete, consistent unified theory is only the first step: our goal is a complete understanding of the events around us, and of our own existence," he wrote in "A Brief History of Time."

In later years, though, he suggested a unified theory might not exist.

He followed up "A Brief History of Time" in 2001 with the more accessible sequel "The Universe in a Nutshell," updating readers on concepts like super gravity, naked singularities and the possibility of an 11-dimensional universe.

Hawking said belief in a God who intervenes in the universe "to make sure the good guys win or get rewarded in the next life" was wishful thinking

"But one can't help asking the question: Why does the universe exist?" he said in 1991. "I don't know an operational way to give the question or the answer, if there is one, a meaning

ish name for ALS — said Hawking met the classic definition of the disease, as "the perfect mind trapped in an imperfect body." He said Hawking had been an inspiration to people with the disease for many years.

Although it could take him minutes to compose answers to even simple questions Hawking said the disability did not impair his work. It certainly did little to dampen his ambition to physically experience space himself: Hawking savored small bursts of weightlessness in 2007 when he was flown aboard a jet that made repeated dives to simulate zero-gravity.

Hawking had hoped to leave Earth's atmosphere altogether someday, a trip he often recommended to the rest of the planet's inhabitants.

"In the long run the human race should not have all its eggs in one basket, or on one planet,"

Driver killed, Texas students hurt in Disney trip bus plunge

LOXLEY, Ala. — Lulled asleep by the humming of their Texasbound charter bus following a trip to Disney World, members of a high school band were jarred awake before dawn Tuesday when the rig ran off a highway and plunged into a ravine more than 50 feet (15 meters) deep.

One person died, driver Harry Caligone, and about three dozen others were hurt, mostly teenagers, authorities and the bus company said. Interstate 10 was blocked for hours where the accident occurred between Mobile, Alabama, and Pensacola, FloriThe cause of the crash wasn't immediately known, but survivors from Channelview High School in metro Houston described being asleep one moment and tumbling through the air the next.

"Then there was a loud, really huge crash that was presumably when the bus finally came to a stop," Frances Dodson-Benson said after talking to her 15-yearold son DeWayne Benson. "There were students on top of students, the bags, it was just a disarray, a lot of commotion, a lot of panic."

First responders used ropes to rappel down the ravine in the middle of I-10 and then had to cut some of the victims from the wreckage, said Baldwin County Sheriff Huey Hoss Mack.

The Channelview Independent School District said 40 students and six adults from the school were on board the bus. State troopers said the driver was killed, and medical officials said at least 37 people, most of them teenagers, were treated at hospitals or other facilities in Pensacola and southwest Alabama for injuries that ranged from minor to very serious.

The sheriff said it wasn't immediately clear what caused the bus to enter the grassy median,

Texas bathroom bill diverted from school, tax issues

AUSTIN, Texas (AP) — A new report on keeping Texas prosperous says legislators in 2017 unnecessarily diverted attention from topics like education and taxes to concentrate on a failed "bathroom bill."

Tuesday's report from the House Select Committee on Economic Competitiveness was based on public hearings and testimony from more than 40 witnesses in business, law enforcement, education and local communities.

The bathroom bill would have barred transgender people from using public bathrooms of their choice. Some business leaders said the bill could cost Texas billions in boycotts and lost jobs.

The panel's chairman, GOP Rep. Byron Cook of Corsicana, says businesses became involved in the fight against the "divisive and pointless legislation," which faltered during the regular and special sessions.

Cook says the bathroom bill was "ineffectual" and "dangerous" to the Texas economy.

At least 56 kidon-kid sex assault cases at Texas bases

FORT HOOD, Texas (AP) - A decade after the Pentagon began confronting rape in the ranks, the U.S. military frequently fails to provide justice to the children of service members when they are sexually assaulted by other kids on base.

An Associated Press investigation finds that sex assault cases occurring where military kids live and learn often die on the desks of prosecutors. Criminal investigators shelved

an unknown number of reports.

Instead of punishment or rehabilitation, offenders may be shuffled into the civilian world.

The Pentagon doesn't know the problem's extent. In Texas, AP found at least 56 sex assault or rape cases among juveniles on military bases since 2007. Fort Hood showed the most, with 41, followed by Fort Bliss with 10.

Pentagon officials promised to take "appropriate actions."

"outstanding person." She's well respected by intelligence professionals, who have called her a patriot and an exceptional leader who brings creativity, savvy and grit to her job every day.

Yet Haspel also had a front-row seat to the CIA's use of harsh interrogation techniques against terror suspects. Between 2003 and 2005, she oversaw a secret CIA prison in Thailand where terror suspects Abu Zubayadah and Abd al Rahim al-Nashiri were waterboarded, current and former U.S. intelligence officials said. Waterboarding is a process that simulates drowning and is widely considered to be a form of torture.

Haspel, who joined the CIA in 1985, also helped carry out an order to destroy waterboarding videos. The order prompted a lengthy Justice Department investigation that ended without charges.

Sen. Richard Burr, the chairman of the Senate committee that will vote whether to confirm Haspel, said she has the "right skill set, experience and judgment" to lead the CIA.

But one fellow Republican, Sen. John McCain, said Haspel must explain the nature and extent of her involvement in the CIA's interrogation program.

"Current U.S. law is clear in banning enhanced interrogation techniques," said McCain, who was beaten as a prisoner during the Vietnam War. "Any nominee for director of the CIA must pledge without reservation to uphold this prohibition."

Rep. Adam Schiff, the House intelligence committee's top Democrat, cited Haspel's "impressive record," but also said she must outline if she would comply with any presidential order bringing back waterboarding and other such techniques.

Trump has spoken about reintroducing waterboarding and "a lot worse," but would face steep legal and legislative hurdles to do so. The harsh interrogation techniques have been roundly denounced by human rights groups worldwide.

"No one who had a hand in torturing individuals deserves to ever hold public office again, let alone lead an agency," Human Rights First's Raha Wala said Tuesday. "To allow someone who had a direct hand in this illegal, immoral and counterproductive program is to willingly forget our nation's dark history with torture." Haspel may have to overcome some challenges with key U.S. allies. After Haspel was named deputy CIA director, the European Center for Constitutional and Human Rights asked German prosecutors to issue a warrant for her arrest over her role in interrogations. Federal the prosecutors never issued the warrant because the case lacked a connection to Germany. But the rights group's allegations against Haspel remain part of a preliminary investigation that German authorities could revive at a later date if they receive evidence that any of the parties have links to Germany. Haspel has been chief of station at CIA outposts abroad. In Washington, she has held several senior leadership positions, including deputy director of the National Clandestine Service. In her current post, she worked with Pompeo to manage intelligence collection, analysis, covert counterintelliaction, gence and cooperation with the CIA's foreign counterparts.

Florida prosecutors seeking death penalty in school shooting

MIAMI — The former student charged with killing 17 people at Marjory Stoneman Douglas High School last month will face the death penalty, prosecutors said Tuesday.

Nikolas Cruz, 19, is scheduled for formal arraignment Wednesday on a 34-count indictment, including 17 firstdegree murder charges. Cruz's attorneys have said he would plead guilty if the death penalty was not pursued in the Valentine's Day massacre.

The office of Broward County State Attorney Michael Satz filed the formal notice of its intentions Tuesday. The action by prosecutors Tuesday does not necessarily mean a plea deal will not be reached.

The only other penalty option for Cruz, if convicted, is life in prison with no possibility of parole.

which abruptly ends at a steep embankment where the interstate passes over Cowpen Creek. First Class Tours Inc., the bus operator, identified Caligone as a longtime driver with the company.

The crash happened around 5:30 a.m., crunching the bus and leaving the passengers exposed to chilly temperatures.

Channelview High's graduates include University of Alabama quarterback Jalen Hurts, who tweeted: "Wow, praying for everyone involved! #PrayforChannelview."

Josh Torres said his 17-year-old sister, Bianca Torres, was sitting at the rear of the bus when the impact of the wreck tossed her forward several rows. She had pain in her legs and bruising but was otherwise unscathed, and takNorman Haynes of Victoria, Texas, said his daughter, 18-year-old trumpet player Makena Campa, was on the bus with her mother. He spoke with both of them after the crash and was on his way to the hospital.

"My daughter was really groggy because they had her on some very heavy pain medication," he said. "They sounded kind of shook up. I think I'd be shook up as well."

The interstate was closed down in both directions as the injured were flown to hospitals including emergency rooms in Mobile and Pensacola, Florida, plus a free-standing emergency room in rural Baldwin County, said Chris Elliott, a Baldwin County commissioner.

"Everybody is being transferred to a hospital to at least be checked out," said

survived the shooting, said he respects the wishes of the 17 families whose children were killed and that time is better spent finding solutions to the problem of mass school shootings.

"Live forever in jail or die - I don't care," Jaffe said in an email. "Cruz will rot in hell no matter when it is that he arrives there."

Broward County Public Defender Howard Finkelstein, whose office is representing Cruz, has said there were so many warning signs that Cruz was mentally unstable and potentially violent, and that the death penalty might be going too far. Finkelstein said Cruz would plead guilty if prosecutors opt not to seek the death penalty.

"Because that's what this case is about. Not, did he do it? Not, should he go free? Should he live or should he die," Finkelstein told The Associated Press last month.

In an email Tuesday, Finkelstein said Cruz is "immediately ready" to plead guilty in return for 34 consecutive life sentences.

"If not allowed to do that tomorrow (at the hearing), out of respect for the victims' families we will stand mute to the charges at the arraignment. We are not saying he is not guilty but we can't plead guilty while death is still on the table," Finkelstein said.

If Cruz does not enter a plea, a not guilty plea will likely be entered on his behalf by Broward Circuit Judge Elizabeth Scherer to keep the legal process moving along, his attorneys have said. Meanwhile, a student who is credited



Federal Motor Carrier Safety Administration records show that in the last two years, the carrier has been involved in four crashes prior to Tuesday's crash, with one of those one involving one fatality.

Tejeda said he watched four people being removed from the wreckage, and couldn't hear any yelling or sounds of panic. "Thank God they were alive but (they) had to take them on (a) helicop-

ter," he said in an interview conducted by instant messages.





Torres said his brother, also a member of the Channelview band, was on another bus not involved in the accident. That bus stopped after realizing

what happened, but did not allow the students to get off, and eventually continued on toward Channelview, a Houston suburb of about 38,000.

Outside their high school, still closed for spring break, police were stationed at every entrance and no one was available to speak.

Only hours before the crash, the band's Facebook page had been updated to show a large group posing outside Disney World, where the band performed at a music festival Saturday. Channelview Indepenity took place in May 2017 in Houston, when a bus failed to yield the right of way as it turned left and fatally struck a pedestrian in a crosswalk, according to a police report.

Trump examines prototypes for border wall amid protests

SAN DIEGO — President Donald Trump on Tuesday eagerly inspected prototypes on display in California for his "big beautiful border wall" amid peaceful protests but growing tensions between his administration and the state over immigration enforcement.

Chanting "No ban! No wall!" demonstrators were cheered on by honking cars and buses at the San Ysidro port of entry in San Diego, the nation's busiest border crossing.

Trump appeared engaged as he was briefed on eight towering prototypes, including one with blue steel on top. He said he liked a fully concrete wall because it was the hardest to climb, but he noted that it needs see-through capability.

He said certain parts of California are desperate for a wall to break the flow of illegal immigration.

"If you didn't have walls over here, you wouldn't even have a country," Trump said.

The visit — Trump's first to the state

as president — coincided with an escalating battle between his administration and the liberal state, which Democrat Hillary Clinton easily carried in the 2016 presidential election. California officials have defiantly refused to help federal agents detain and deport immigrants in the U.S. illegally, and the Justice Department sued the state last week over three of its immigration laws.

After viewing the wall prototypes in an area of the border heavily cordoned off and far from the rallies on the U.S. side, Trump was then expected to address Marines in San Diego before attending a high-dollar fundraiser in Los Angeles, where he'll stay overnight.

Protests were held on the Mexican side, too, in Tijuana. Semitrucks were parked in between the row of prototypes and the border, blocking the view from Mexico.

Demonstrators said they planned to line up and greet people walking into the United States at the San Ysidro crossing to show Americans welcome immigrants.

José Gonzalez, 21, stopped to snap a photo of the protesters holding signs,

with saving the lives of 20 students by attempting to close and lock a classroom door during the attack was improving at a hospital. Anthony Borges, 15, was shot five times. Weeks after being shot, he fell critically ill of an intestinal infection. After surgeries, his condition was upgraded to fair, his attorney and the hospital said. The boy's intestinal area has been sealed off and he is breathing on his own after being taken off a ventilator, family attorney Alex Arreaza said. Borges' family has filed notice that they will sue Florida authorities to seek money to cover the cost of his recovery. Meanwhile, Florida voters may get a chance to decide whether or not they want to approve new gun control restrictions. While Gov. Rick Scott just signed a new school safety and gun bill into law, the state's Constitution Revision Commission may vote to place gun restrictions on this year's ballot. The commission, a special panel that meets every 20 years, has the power to ask voters to approve changes to the state's constitution.

Tony Montalto, whose daughter was one of the 17 killed at Stoneman Douglas, asked commissioners at a Tuesday public hearing to put the proposals before voters. He said they need to act because the National Rifle Association has filed a lawsuit against the new law approved by the Legislature.

"You can help defeat this challenge," Montalto told commissioners. including one that read: "Wall off Putin!" in reference to Russian President Vladimir Putin, who has a seemingly close relationship with Trump.

"I don't think it's really fair how he has the choice to separate us," said Gonzalez, a dual citizen who lives in Tijuana and crosses the border daily to work at a San Diego ramen restaurant.

Army veteran Mark Prieto, 48, shook his head as he walked by the protest.


"People are so narrow-minded," the Riverside firefighter said as the crowd chanted. "Finally we have someone who is putting America first."

His wife, Corina Prieto, a nurse who has extended family in Mexico, agreed. Both voted for Trump.

"I think he is doing a lot of good, like protecting our Border Patrol," she said.

Trump was expected Tuesday to be briefed on lessons learned from the construction of the prototypes built in San Diego last fall. He also will meet with border agents and officers to ask what they need, Homeland Security spokesman Jonathan Hoffman said.

The president also planned to talk about sanctuary cities, arguing that they are a major threat to public safety and national security, according to a senior administration official, who wasn't authorized to speak publicly



San Diego's Republican mayor criticized Trump's planned short visit, saying the president won't get a full picture of the city. Kevin Faulconer said a popular cross-border airport terminal connecting San Diego and Tijuana shows that "building bridges has worked wonders."

Faulconer, writing in The San Diego Union-Tribune, also said San Diego police work to protect everyone regardless of immigration status, an apparent dig at Trump's push to target illegal immigration.

Trump tweeted about California's immigration policies as he flew to the state aboard Air Force One.

"California's sanctuary policies are illegal and unconstitutional and put the safety and security of our entire nation at risk. Thousands of dangerous & violent criminal aliens are released as a result of sanctuary policies, set free to prey on innocent Americans. THIS MUST STOP!" he wrote.

This isn't Trump's first visit to the border. He traveled to Laredo — one of Texas' safest cities — weeks after declaring his candidacy in June 2015.

Trump told reporters then that he was putting himself "in great danger" by coming to the border. But, he said, "I have to do it. I love this country."

Spurs in a new spot: Fighting for their playoff lives



This month's March Madness a likely bet to be last tournament of innocence

As we well know, the NCAA Men's Basketball Tournament is often called "March Madness."

That name may never ring more true than 2018. This may be known as the last tournament of innocence — well, at least the pretend innocence college sports supporters cling to. It may be aw-

fully hard to watch the games with blinders on if events unfold as expected.

First, this could be the last NCAA Tournament without fans filling up sports books across the country placing legal bets on these young men and women.

It could also be when the other shoes drop in the federal investigation into corruption in college basketball — possibly leading to criminal charges and arrests of some coaches and administrators in the tournament. Oh, March could be mad, all right. The American Gaming Association has put out its annual press release amount of illegal gamlegalized sports betting.

Neighboring West Virginia has already passed the sports lottery wagering act in anticipation of the Supreme Court's ruling. "Nothing can happen until the Supreme Court issues their decision, but we want to be ready when they do." Governor Jim Justice said in a press release.

That decision could come April 2- the day of

the national championship game.

NCAA president Mark Emmert said in December if the Supreme Court rules in favor of legalized sports betting, the association will lobby states to exclude college sports from such wagering. Given the pathetic lack of power the NCAA has, I doubt they will scare any lawmakers into giving special protections for college sports.

Besides, I think the powers that run college sports may have more than enough on their plate to worry about how sports betting will corrupt the games given the possibility tion.

This is the worst season for the San Antonio Spurs in the last 21 years.

They're on pace for only 46 wins.

ONLY 46 wins.

That's a season fans in other many cities would celebrate wildly. Philadelphia hasn't won 46 games since 2002-03, Minnesota not since 2003-04, Sacramento not since 2004-05. Detroit hasn't had a 46-win season in the last decade. The Knicks have one in the last 17 seasons. Milwaukee reached it once in the last 16 seasons entering this year. Charlotte, once in the last 15 seasons. The Nets, once in the last 12 seasons.

But this is San Antonio, the silver-and-black standard for the league, where winning 55 or 60 games and making a deep playoff run is considered as much of an annual rite as the rodeo and the Texas Folklife Festival. And even after a blowout win over Orlando on Tuesday night, the Spurs (38-30) are still on the outside of the playoff picture in the Western Conference.

No need to panic just yet.

The Spurs are a mere one game in the loss column behind Oklahoma City, which is holding the No. 4 seed right now. Still, this is a most unusual situation for San Antonio.

"Everybody tries to be the best they can by playoff time," Spurs coach Gregg Popovich said. "That'll be our goal too, to be in the playoffs and be as good as we can possibly be."

Here's how good the Spurs have been for so long: This will be the first season since 1996-97 where San Antonio won't finish with a winning percentage of at least .600.

This has been such a strange year for the Spurs. Kawhi Leonard has barely played because of a leg injury, and the Spurs still aren't sure when he will return to the court — though there are indications it could be very soon. San Antonio has used 23 different starting lineups, none for more than 12 games, most being used for three or

bling that takes place around the NCAA Tournament. The association claims \$10 billion will be bet — which is likely a number more or less pulled out of the sky. Nobody really knows how much will be wagered illegally, on various levels, on the tournament.

Of that amount, they say about three percent -\$300 million — of that money will be bet legally.

That could change dramatically the next time America reaches for its wallet come tournament time.

In December, the Supreme Court heard arguments on New Jersey's efforts to overturn the Professional and Amateur Sports Protection Act, or PASPA, a 1992 law that said any state that did not legalize sports betting by 1993 was prohibited from doing it. After several failures to pass sports betting laws, state legislators passed a law in 2014 that, while not legalizing sports betting directly, removed the prohibition against it at casinos and race tracks in the state.

The law, as every other effort to allow states to legalize sports betting, has been opposed by all the major sports leagues and the NCAA. But it looks like the odds may be in favor of knocking down this ridiculous federal ban. It appeared that the justices may rule in favor of New Jersey, which would open the door for at least 32 states waiting at the starting line to create some level of

fewer.

It'll be an interesting finish.

"It might look a little odd," Miami coach Erik Spoelstra said. "But we know the Spurs well enough that in these exact type of situations is when they respond the most. When there's the most adversity, when people count them out and it looks bleak their culture, the coaching, the leadership, the veteran experience

they have on that team tends to respond in a way that most organizations don't respond in these type of circumstances."

GOING FOR HISTORY

Portland's win over Miami on Monday night was the Trail Blazers' 10th in a row. That makes Portland the seventh team to have a streak of at least 10 games this season — joining Boston, Cleveland,

In September, four assistant college basketball coaches were indicted on fraud charges in an ongoing investigation into college basketball and illegal payoffs. That is likely just the beginning of what has been reported to be a criminal probe that goes deep into some blue blood college programs.

"This goes a lot deeper in college basketball than four corrupt assistant coaches," one source told Yahoo Sports of the documents, which reportedly contain thousands of wiretaps and bank records from 330 days of investigating. "When this all comes out, Hall of Fame coaches should be scared, lottery picks won't be eligible to play and almost half of the 16 teams the NCAA showed on its initial NCAA tournament show this weekend should worry about their appearance being vacated."

When the indictments were announced in September, federal prosecutor Joon Kim warned that more charges were likely to come. "We have your playbook," Kim said, referring to programs under probe. "The investigation is ongoing."

This is a high profile case with front page headlines. What better time for a federal prosecutor to grab the most headlines with more arrests in an investigation into college basketball corruption than in the middle of the sport's signature event -March Madness?



In most circles, the opening lead of an ace against a notrump contract shows a nearly solid suit missing play that honor on the ace if he holds it.

One purpose of dropping the honor is to clarify its location for the opening leader; another purpose is to unblock the suit so that it can be run. If the leader's partner does not have the honor, he gives count instead, playing his lowest card with an odd

number of cards in the suit, and starting a high-low with an even number. Consider this deal where East

played the heart three on his partner's ace at trick one. Since the deuce was in dummy, it was easy for West to place East with three low hearts and South with the Q-x-x. West now had to decide how to try to reach his partner's hand.

West reasoned that if East had the ace of spades, he would surely gain the lead before declarer could make the contract. The only way South could come to nine tricks without scoring a spade trick would be if he held nine cards in the minors, theoretically impossible on the bidding. It was therefore pointless to lead a spade.

West further reasoned that if declarer needed a diamond finesse to score nine tricks, East would win with the king and make the killing heart return. A diamond shift was therefore also without merit.

And so, by elimination, West found the necessary club shift that quickly scuttled the contract after East took the ace and returned a heart. In shifting to the club, West was guarding against the possibility that declarer might have the ace of spades and four diamonds to the king - as he actually did – – and was duly rewarded for his incisive thinking.

In 1885, the Gilbert and Sullivan comic opera "The Mikado" premiered at the Savoy Theatre in London.

In 1900, Congress ratified the Gold Standard Act.

In 1907, President Theodore Roosevelt signed an executive order designed to prevent Japanese laborers from immigrating to the United States as part of a "gentlemen's agreement" with Japan.

In 1939, the republic of Czechoslovakia was dissolved, opening the way for Nazi occupation of Czech areas and the separation of Slovakia.

In 1951, during the Korean War, United Nations forces recaptured Seoul.

In 1964, a jury in Dallas found Jack Ruby guilty of murdering Lee Harvey Oswald, the accused assassin of President John F. Kennedy, and sentenced him to death. (Both the conviction and death sentence were overturned, but Ruby died before he could be retried.)

In 1967, the body of President John F. Kennedy was moved from a temporary grave to a permanent memorial site at Arlington National Cemetery in Virginia.

In 1975, "Monty Python and the Holy Grail," a sendup of the legend of King Arthur, had its world premiere in Los Angeles. Award-winning Academy actress Susan Hayward, 57, died in Los Angeles.

In 1980, a LOT Polish Airlines jet crashed while attempting to land in Warsaw, killing all 87 people aboard, including 22 members of a U.S. amateur boxing team.

In 1990, the Soviet Congress of People's Deputies held a secret ballot that elected Mikhail S. Gorbachev to a new, powerful presidency.

In 1998, India's Congress party picked Sonia Gandhi, the Italian-born widow of assassinated prime minister Rajiv Gandhi, as its new president.

Ten years ago: Democratic presidential candidate Barack Obama denounced inflammatory remarks from his pastor,

first full day as pontiff, Pope Francis stopped by his Vatican hotel to pick up his luggage and pay the bill himself. Some 10,000 workers from across the European Union protested outside a summit of EU leaders in Brussels, demanding they end years of austerity and focus instead on curbing runaway unemployment with more spending. President Donald Trump earned \$153 million and paid \$36.5 million in income taxes in 2005, according to highly sought-after tax documents disclosed by a reporter. Declaring "enough is enough," Gen. Robert Neller, the Marine Corps commandant, told senators that he intended to fix the problem that led to current and former Corps members sharing nude photos of female Marines online and making lewd or threatening comments about them. Mitch Seavey won his third Iditarod Trail Sled Dog Race, becoming the fastest and oldest champion at age 57. Seavey also set a time record of




