## *Pints* for Polio raises over \$31,000

The party's over, the beer and wine have been imbibed, the music listened to, and the auction items bid on and purchased. And what do we have to show for it? \$31,227.11.

That's the preliminary total raised through ticket sales, sponsorships, and auction receipts by the third annual Pints for Polio event put on Saturday at the Courtyard Event Center in downtown Big Spring by the Greater Big Spring Rotary Club. According to the final tally, 329 people attended the event.

According to Jeff Ward, the Rotary Club treasurer, half that money -\$15,613.56 – will remain in Howard County for use on Rotary Club projects. The other half will be matched two-for-one by the Bill and Melinda Gates Foundation, and the resulting \$46,849.65 will go to "End Polio Now," a nationwide program aimed at eradicating the remnants of polio from the world.

"There about 385,000 cases in 1985, I believe. It was over 1.000 cases a day," said Greater Big Spring Rotary Club President Brent Strande. owner of the Train Car Cigar Bar. "We are now down to just a handful. In 2016, I believe it was in the 20s or 30s. In 2017, I think it was around 22, and this year there have been only five cases reported so far, all in Pakistan. It's found in Pakistan, Afghanistan, and Nigeria. It was worldwide; it was in the United States. My grandfather has polio. So it affects everyone you know."

# GOP-led states back Trump in California 'sanctuary' lawsuit

SAN FRANCISCO — Texas and more than a dozen other states led by Republican governors got behind the Trump administration on Monday in its lawsuit over California's so-called sanctuary laws that protect people in the U.S. illegally. California's laws are designed

to interfere with or block federal immigration enforcement but the state does not have that authority, the other states said in a court filing in the U.S. Department of Justice's lawsuit against California. The filing in federal court in Sacramento supports the Justice Department's attempt to block the


The Justice Department sued California in March over three state laws, including one that requires the state to review detention facilities where immigrants

are held and another that limits the ability of state and local law enforcement officials to turn people over to immigration authorities.

Federal officials have said California officials have prevented them from removing dangerous people who are in the U.S. illegally. California officials have responded that their sanctuary policies increase public safety by promoting trust between immigrant communities and law enforcement. The filing by Texas and the oth-

er states argues that California's laws should be blocked on the same grounds that the U.S. Supreme Court struck down a 2010 Arizona immigra-The Arizona law required police,

while enforcing other laws, to question the immigration status of people

> suspected of being in the country illegally, made it a crime to harbor immigrants here illegally, and banned them from seeking work in public places.

> The U.S. Supreme Court struck down key provisions of the law in 2012. Justice Anthony Kennedy said Arizona may have "understandable frustrations" with immigrants who are in the country illegally, but added that it can't pursue policies that "undermine federal law."

If Arizona's laws are overridden by federal law, then so are California's, the court filing for Texas and the other states said. They cited a legal document signed by California in the fight over Arizona's law that said the removal of people in the country illegally was up to the federal government.

"With a new presidential admin-

istration, however, California has changed its tune," the states said.

California Attorney General Xavier Becerra and legal experts have argued that California's laws are different from Arizona's.

The states also said California's laws could harm them by making it easier for immigrants who have committed crimes to go to other states.

The states joining Texas are: Alabama, Arkansas, Florida, Georgia, Indiana, Kansas, Louisiana, Michigan, Missouri, Nebraska, Nevada, Ohio, Oklahoma, South Carolina and West Virginia. Louisiana's governor, John Bel Edwards, is a Democrat.

The Republican governors of Mississippi and Maine also joined the filing, though their states, which have Democrats as attorneys general, did not."

At about 7:25 on March 16, the police department received a call reporting that individuals in a tan SUV were shooting at two cars, one white and one black, in the KFC parking lot, 1711 S. Gregg St. The two target cars reportedly fled the scene with the SUV in pursuit.

## Man who stuffed Lubbock woman's body into luggage set to die

HUNTSVILLE, Texas (AP) — An employee at the Lubbock city landfill spotted a brand-new piece of luggage amid the mountain of trash, opened the suitcase and discovered the beaten naked body of 29-year-old woman stuffed inside.

Detectives used a barcode label sewn to the luggage to establish it was purchased day earlier at a Walmart. Debit records and store surveillance video identified buyer as Rosen-Rodriguez III, a Marine reservist from San Antonio who'd been in Lubbock for training that included martial arts combat.

On Tuesday, a day after his birthday, Rodriguez is set for execution for the 2005 slaying of Summer Baldwin. She was 10 weeks pregnant. Court records

show Rodriguez was linked to at and confessed to the slaying of a 16-year-old girl

who had been missing for more than a year. Joanna Rogers' mummified remains were found, like Baldwin's, inside a suitcase at the city garbage dump. Rodriguez became known as Lubbock's "suitcase killer."

Lubbock County District Attorney Matt Powell, who prosecuted Rodriguez, described him Monday as "very cold-blooded and very calculated."

"What kind of person does that, just throws them out like the morning trash?" Powell said.

Rodriguez would be the fourth Texas inmate executed this year and the seventh nationally.

Attorneys for Rodriguez appealed Monday to the U.S. Supreme Court as their "last hope" after lower courts rejected appeals that focused on the medical examiner who testified about Baldwin's autopsy at his trial.

Rodriguez's lawyers said the coroner recently settled a whistleblower lawsuit, previously unknown to them, that alleged he delegated some duties to unqualified underlings. The lawsuit "bears directly on the credibility and admissibility of the medical examiner's testimony in this case," attorney Seth Kretzer said.

Assistant Texas Attorney General Tomee Heining said Rodriguez's appeals were "nothing more than a lastditch effort" that were improper, untimely and meritless. The settlement involving a dismissed former em-

ployee, who didn't start work until five years after Rodriguez went to trial, included a statement that there was no reason to question the scientific validity of findings or opinions made by the medical examiner's office. Court records show the medical examiner personally conducted Baldwin's autopsy.

Rodriguez was arrested at his parents' home in San Antonio days after Baldwin's body was

Court records describe Baldwin, the mother of four, as a prostitute. She'd served jail time in Lubbock for a drug conviction.

Three weeks after his arrest, Rodriguez gave Lubbock police a statement saying he killed Baldwin in self-defense when she pulled a knife on him after the two had consensual sex on Sept. 12, 2005, at a hotel room.

Testimony at his 2008 trial showed she had about 50 blunt force wounds and may have been alive when she was folded into the suitcase and tossed into a trash bin. The contents of the bin subsequently wound up at the city dump. Defense attorneys suggested a trash compactor could have killed her.

Jurors who convicted him of capital murder heard during the trial's punishment phase from five women, including his high school girlfriend, who testified he raped them. Jurors also heard about his confession to killing Rogers, the 16-year-old Lubbock girl who evidence showed he initially met in an online chat room.

Prosecutors decided to seek the death penalty after Rodriguez scuttled a deal where he'd plead guilty to killing Baldwin and the teenager in exchange for a life prison term.

## *Underground* tunnels proposed for Houston flooding

HOUSTON (AP) — The flood control district for the Houston area is considering a proposal to build massive underground tunnels to drain floodwaters from bayous across the county.

Harris County Flood Control District officials said the idea could be a bold solution to alleviating the chronic flooding that has plagued the Houston area, including during Hurricane Harvey.

The project could cost several billion dollars and take several years to complete, the Houston Chronicle reported . It would build a network of deep tunnels to carry water from several of Houston's waterways, so that they'd be able to keep a 100-year storm event within their banks.

A 100-year storm event refers to rainfall that has a 1 percent chance of occurring in any given year. It usually ranges from 12 to 14 inches in a 24-hour period. During each of the last three years, Houston has experienced a 500-year flood, which has a 0.2 percent chance of happening in any given year.

'What the flood control district has been doing for decades doesn't occur fast enough or it doesn't have the benefits that the public really wants," said Matthew Zeve, director of operations at the flood control district. "We've been challenged to try to think of new ideas and new strategies and

this is an answer to that challenge." He said the tunnel project would displace and disrupt far fewer people than other methods of reducing the flooding risk, such as widening bayous and buying out homes in especially flood-prone

Commissioners will vote Tuesday on whether to pursue a feasibility study to assess the tunnel proposal. It's estimated that the study would cost

about \$400,000 and be completed by October. Republican Rep. John Culberson, of Houston, said he's "encouraged" that the district "is think-

ing outside the box." "It certainly seems like this type of project could be partially funded by FEMA hazard mitigation grants and, perhaps, through other federal sources, as well," he said.

A spokeswoman for Gov. Greg Abbott said it's too early to comment on the proposal.

# Democrats would need huge wave to win US House

A report released Monday suggests Democrats might have to temper their enthusiasm about climbing back to power during this year's midterm elections.

To win a majority in the U.S. House of Representatives, Democrats would need a tremendous electoral wave not seen in more than 40 years to overcome Republican advantages from gerrymandered districts in key states, according to an analysis from the Brennan Center for Justice.

The report projects that Democrats would need to win the national popular vote for congressional districts by a nearly 11 percentage point margin over Republicans to gain more than the roughly two dozen seats they need to flip control of the Republican-led chamber.

That would take more than the typical Democratic wave that history suggests would occur for the party out of power during a midterm election.

"It would be the equivalent of a tsunami," said Michael Li, a senior counsel who heads up redistricting work for the center, which is based at New York University School of Law. "Democrats would have to win larger than any sort of recent midterm wave — almost double what they got in 2006 — in order to win a narrow majority."

The Brennan Center opposes what it calls "extreme gerrymandering" in which political parties draw legislative districts that virtually ensure they will hold on to power.

The center has filed a court brief in a case to be heard Wednesday by the U.S. Supreme Court supporting a lawsuit by Republicans alleging that Maryland's former Democratic governor and legislature unconstitutionally gerrymandered a congressional district to their advantage.

It also has filed court briefs supporting Democratic lawsuits alleging unconstitutional partisan gerrymandering by Republicans in states such as Wisconsin and Pennsylvania.

The center's analysis notes that Democrats gained 31 seats when they won the national congressional vote by 5.4 percentage points in 2006. Yet under the current districts, which were redrawn after the 2010 Census under GOP control of many state capitols, a similar national victory margin in the November election is projected to net Democrats only about a dozen new seats. The report projects that a 10 percentage point na-

tional margin would gain 21 seats for Democrats — still shy of the 23 or 24 needed to claim a House majority. An 11-point margin is projected to gain 28 seats for Democrats, but they haven't achieved such a large midterm victory since a nearly 14 point margin gained them 49 seats in 1974.

"Even a strong blue wave would crash against a wall of gerrymandered maps," the Brennan Center report says.

The analysis is based on an assumption that as a political party increases its share of the statewide vote, it will see a similar percentage increase in most congressional districts. The report does not account for particular factors at play this year in each district, such as whether incumbents are retiring or whether voter demographics have shifted.

Former U.S. Attorney General Eric Holder, who is chairman of the National Democratic Redistricting Committee, said in a statement that the Brennan Center report "makes clear that Republican gerrymandering has undermined the voting power of Americans and threatens our democracy."

Matt Walter, president of the Republican State Leadership Committee, dismissed it as part of a liberal narrative to diminish previous Republican victories and boost Democratic chances.

"As called for by the Constitution, map-drawing is a political process left to the authority of state legislatures, and this so-called study is another attempt by Democrats to undermine that process and replace it with liberal courts, or cherry-picked experts from liberal faculty rooms to draw maps that rig the system for Democrats," Walter said in a statement.

The report says that for Democrats to achieve an 11 percentage point national victory margin, they would need to increase their vote share by at least 7 percentage points over their 2016 totals in about a dozen states where Republicans generally had fared well, including Texas and Ohio.

Democrats also would need more modest gains in

traditional Democratic strongholds such as California and Illinois.

# Facebook faces scrutiny for pulling Android call, text data

On the same day Facebook bought ads in U.S. and British newspapers to apologize for the Cambridge Analytica scandal, the social media site faced new questions about collecting phone numbers and text messages from Android devices.

The website Ars Technica reported that users who checked data gathered by Facebook on them found that it had years of contact names, telephone numbers, call lengths and text messages.

Facebook said Sunday the information is uploaded to secure servers and comes only from Android users who opt-in to allow it. Spokeswomen say the data is not sold or shared with users' friends or outside apps. They say the data is used "to improve people's experience across Facebook" by helping to connect with others.

The company also says in a website posting that it does not collect the content of text messages or calls. A spokeswoman told the Associated Press that Facebook uses the information to rank contacts in Messenger so they are easier to find, and to suggest people to call.

Users get the option to allow data collection when they sign

up for Messenger or Facebook Lite, the Facebook posting said. "If you chose to turn this feature on, we will begin to continuously log this information," the posting said.

The data collection can be turned off in a user's settings, and all previously collected call and text history shared on the app will be deleted, Facebook said.

The feature was first intro-

duced on Facebook Messenger in 2015 and added later on Facebook Lite. Messages were left Sunday

seeking comment about security from Google officials, who make the Android operating system.

Reports of the data collection came as Facebook CEO Mark

Zuckerberg took out ads in multiple U.S. and British Sunday newspapers to apologize for the Cambridge Analytica scandal.

The ads say the social media platform doesn't deserve to hold

personal information if it can't

protect it.

According to the ads, a quiz app built by a Cambridge University researcher leaked Facebook data of millions of people four years ago. Zuckerberg said this was a "breach of trust" and that Facebook is taking steps to make sure it doesn't happen

again.

Facebook's privacy practices have come under fire after Cambridge Analytica, a Trump-affiliated political consulting firm, got data inappropriately. The social media platform's stock value has dropped over \$70 billion since the revelations were first published.

Among the newspapers with the ads were The New York Times and The Washington Post in the U.S., and The Sunday Times and The Sunday Telegraph in the United King-

The ads said Facebook is limiting the data apps received when users sign in. It's also investigating every app that had access to large amounts of data. "We expect there are others. And when we find them, we will ban them and tell everyone affected," the ads stated.

Cambridge Analytica got the data from a researcher who paid 270,000 Facebook users to complete a psychological profile quiz back in 2014. But the quiz gathered information on their friends as well, bringing the total number of people affected to about 50 million.

The Trump campaign paid the firm \$6 million during the 2016 election, although it has since distanced itself from Cambridge.





## Texas Tech credits culture change for 1st Elite Eight trip

BOSTON — Texas Tech's Chris Beard just has to look at his surroundings to see how far he's come as

Beard and the third-seeded Red Raiders will again play Sunday inside the hallowed confines of the Boston Celtics' TD Garden when they face Villanova in the East Region final.

Surely a long way away from his first head coaching job at Fort Scott Community College in Kansas.

"Arnold Arena, our home arena, was a rodeo barn," Beard recalled Saturday. "It was a metal building with a wall right down the middle and had one single door. Half of it was the rodeo arena, where we had a national championship rodeo team at Fort Scott in Kansas, and the other half was the basketball court.

"That's certainly a pretty cool place." Perhaps. But not as cool as it would be for Beard to take his Texas Tech team to its first Final Four in just his second season as head coach in Lubbock, Texas. And certainly not as gratifying as it would be to see the loose, but player-centered culture he's tried to build during his brief tenure pay off so quickly.

For many it's a mirror of the success he had in his lone season at Arkansas-Little Rock in 2015-16, leading it to a 30-5 record and the second round of the NCAA Tournament. But Beard says it started much earlier

'We've done it more than two places," said Beard, who was originally an assistant at Texas Tech under Bob Knight from 2001 to 2008. "We've done this everywhere we've been. It's not arrogance, but it's confidence. We have a process we believe in. ... We get guys that fit our culture, and we coach them hard.'

Villanova coach Jay Wright said he sees parallels between what Beard is doing and what he went through when he took over as the Wildcats coach.

"You can see the steady growth and the buy-in — he's got seniors coming off the bench that you can tell are very unselfish," Wright said. "You don't do that unless they're really bought in to the program. I believe he said Texas Tech was his dream job, like Villanova for me. When you really love where you are, it's advantageous in selling that to players."

One of the hallmarks of Beard's approach is to be as visible as possible to his players, from being present in workouts, to having private meetings with them, to eating meals with them.

When the team eats meals together back in Lubbock, players are required to bus their own tables.

Beard tells a story about how the team has been staying in "ridiculously nice hotels" during the tournament in which waiters pickup dirty plates of patrons.

One of Texas Tech's staff members left his plate out.

"I don't let that happen. Seriously, we make our guys get up and put their plate on the table, myself included,'

Beard said. As for the offending staff member? "He's still catching grief about it,"

He also allows players to choose music during practice. The players get three song selections for every one for the coaching staff. If the team loses a game, it's reversed.

"It brings energy. It brings life. Even though we probably play a little too much country, it gets the coaches even in a great mood and gets them fired up," senior guard Keenan Evans said. "So just us having music in there brings a little personality and helps us have fun in practice."

## Michigan State official who oversaw Nassar faces charges

LANSING, Mich.— A Michigan State University official who oversaw Larry Nassar is facing criminal charges amid an investigation into the handling of complaints against the former sports doctor, who is in prison for sexually assaulting patients under the guise of treatment.

William Strampel was in jail pending an arraignment Tuesday, Ingham County Sheriff Scott Wriggelsworth told The Associated Press. He declined to say what charges Strampel faces because the probe is being led by the Michigan attorney general's office.

A spokeswoman for Attorney General Bill Schuette declined to comment. A news conference was scheduled for Tuesday, two months after Schuette appointed a special assistant attorney general to investigate.

Strampel, 70, is the first person besides Nassar to be charged in connection with the worst sexual abuse case in sports history. Nassar pleaded guilty to molesting patients and possessing child pornography. Strampel's arrest Monday was first reported by the Detroit Free Press, and WILX-TV earlier reported that state police were seen outside Strampel's home in DeWitt, north of Lansing.

Strampel was the dean of the College of Osteopathic Medicine, which includes the sports medicine clinic, until he announced a leave of absence for medical reasons in December. He told police last year that he never followed up after ordering Nassar in 2014 to have a third person present when providing treatment to "anything close to a sensitive area." In letting Nassar resume seeing patients, he also said any skin-to-skin contact should be minimal and needed to be explained in detail.

Nassar was fired in 2016 for violating the rule. His dismissal came less than a month after former gymnast Rachael Denhollander filed a criminal complaint saying Nassar had sexually assaulted her with his hands while treating her for back pain years earlier.

Strampel told a campus detective and FBI agent in 2017 that he did not check to see if Nassar was following the guidance because Nassar had been "exonerated" in an investigation of a patient's complaint and the imposed guidelines were "health

## This Date In History

Today is Tuesday, March 27, the 86th day of 2018. There are 279 days left in the year.

Today's Highlight in History: On March 27, 1968, Soviet cosmonaut Yuri Gagarin (gah-GAH'-rihn), the first man to orbit the Earth in 1961, died when his MiG-15 iet crashed during a routine training flight near Moscow; he was 34.

On this date:

In 1513, Spanish explorer Juan Ponce de Leon (hwahn pahns duh LEE'-ohn) sighted present-day Florida.

In 1625, Charles I acceded to the English throne upon the death of James I.

In 1794, Congress approved "An Act to provide a Naval Armament" of six armed ships. In 1884, the first telephone line between Boston and New York was inaugurated.

In 1912, first lady Helen Herron Taft and the wife of Japan's ambassador to the United States, Viscountess Chinda, planted the first two of 3,000 cherry trees given to the U.S. as a gift by the mayor of Tokyo

In 1933, Japan officially withdrew from the League of Nations. In 1942, during World War II,

Congress granted American servicemen free first-class mailing privileges.

In 1958, Nikita Khrushchev became Soviet premier in addition to First Secretary of the Communist Party. In 1964, Alaska was hit by a

magnitude 9.2 earthquake (the strongest on record in North America) and tsunamis that together claimed about 130 In 1977, in aviation's worst

disaster, 583 people were killed when a KLM Boeing 747, attempting to take off in heavy fog, crashed into a Pan Am 747 on an airport runway on the Canary Island of Tenerife (tenuh-REEF').

In 1980, 123 workers died when a North Sea floating oil field platform, the Alexander Kielland, capsized during a storm.

In 1998, the Food and Drug Administration approved the drug Viagra, made by Pfizer, saying it had helped about twothirds of impotent men improve their sexual function.

Ten years ago: The Pentagon said Defense Secretary Robert Gates had ordered a full inventory of all nuclear weapons and related materials after the mistaken delivery of ballistic mis-

sile fuses to Taiwan. Five years ago: Lawyers for Colorado theater shooting sus-

pect James Holmes said he would plead guilty to the attack that killed 12 people and serve the rest of his life in prison to avoid the death penalty. (Prosecutors rejected the offer, but Holmes ended up being sentenced to life in prison anyway.) Former South African President Nelson Mandela was admitted to a hospital for pneumonia (he was discharged 10 days later).

One year ago: U.S. Attorney General Jeff Sessions warned so-called "sanctuary cities" they could lose federal money for refusing to cooperate with immigration authorities; city leaders vowed to intensify their fight against the promised crackdown despite the financial risks. NFL owners meeting in Phoenix approved the Oakland Raiders' move to Las Vegas 31-1: Miami was the lone dissenter.

# All 4 No. 1 seeds reach women's Final Four

#### By DOUG FEINBERG

ALBANY, N.Y. (AP) — The women's Final Four is set, and it's one exclusive party.

UConn, Louisville, Mississippi State and Notre Dame are headed to Columbus, Ohio, marking the fourth time in tournament history that four No. 1 seeds made it to the national semifinals. It's the 11th consecutive Final Four

appearance for the Huskies, breaking a tie with John Wooden and the UCLA men's team for the Division I record. UConn is into the national semifinals for the 19th time overall, snapping a tie with Tennessee for the most in women's basketball history.

The Huskies will face former Big East rival Notre Dame on Friday night. The Cardinals will play the Bulldogs in the other game.

UConn's 111-game winning streak was stopped at this point last season when Mississippi State won their semifinal on a last-second shot by Huskies are undefeated again after knocking out defending national champion South Carolina in the Albany Region final.

"Every team starts the season saying that's our goal to go to the Final Four. For us, it's an opportunity to go back to where we felt like we didn't really give our best effort," UConn coach Geno Auriemma said. "We lost to a really good team. Happened in a way that was really, really disappointing. I know that we were anxious to go back and put ourselves in that same

The Irish and Huskies have a storied history on the game's biggest stage. The teams met early in December and UConn had to rally from an 11-point deficit in the fourth quarter to stay unbeaten.

This might be one of the best coaching jobs by Muffet McGraw at Notre Dame. She lost four players over the course of the season to ACL injuries, but the Irish find themselves back in the Final Four after rallying from a

six-point halftime deficit to beat Oregon 84-74 on Monday night. It's Notre Dame's first trip to the na-

tional semifinals since 2015. "This one's just so rewarding be-

cause I think even though we're a No. 1 seed, it's a little unexpected," Mc-Graw said.

The Bulldogs have lost only one game this season, falling to the Gamecocks in the final of the Southeastern Conference Tournament. They are back in the Final Four for the second straight season led virtually by the

same group that got them to their first national semifinal last year.

"They've lived all year with a bull's eye on their backs. That's hard to do, y'all," Mississippi State coach Vic Schaefer said. "These kids are spe-

Louisville has had its own special season, winning the Atlantic Coast Conference regular-season and tournament titles for the first time in school history. They entered the NCAAs as a No. 1 seed for the first time and are back in the Final Four for a third time under coach Jeff

The Cardinals are led by Asia Durr and Myisha Hines-Allen. Louisville also made the Final Four in 2009 and 2013. The team advanced to the title game both times before losing to UCo-





# Trump's lawyer denies intimidating Stormy Daniels

WASHINGTON dent Donald Trump's personal lawyer, Michael Cohen, is challenging porn actress Stormy Daniel's unsubstantiated charge that someone tied to Trump threatened her with physical harm if she went

public with her story about a tryst with Trump years ago.

Daniels said in a "60 Mininterview broadcast Sunday that a man approached her in a Las Vegas parking lot in 2011, when she was with her daughter, and said: "That's a beautiful little girl. It'd be a shame if something happened to her mom." She said the man told her to "leave Trump alone. Forget the story." Michael Avenatti, her lawyer, acknowledged Monday he has no direct evidence tying the threat to

Trump or his lawyer. But he said he was holding back certain details of the alleged affair, including the contents of a CD or DVD he tweeted a picture of last week. "It would make no sense for us to play our hand as to this issue and we're not going to do it right now," he said on NBC's "Today" show Monday.

Cohen's attorney, Brent H. Blakely, demanded that Daniels or Avenatti apologize to his client for alleging intimidation.

"In truth, Mr. Cohen had absolutely nothing whatsoever to do with any such person or incident, and does not even believe that any such person exists, or that such incident ever occurred," he said, asserting that Daniels and Avenatti should "cease and desist from making any further false and defamatory statements about my client."

Daniels told "60 Minutes" she had consensual sex once with the future president, providing a few salacious details but little new evidence of the

She received a \$130,000 payment days before the 2016 presidential election for her silence and has sought to invalidate a nondisclosure agreement. Cohen has said he paid the \$130,000 out of his pocket while asserting Trump never had sex with the porn actress.

"He knows I'm telling the truth," Daniels, whose legal name is Stephanie Clifford, said of Trump. She said she was not coerced to have sex and "I was not a victim." Trump complained Monday about "So much Fake News," but it's unclear whether he was refer-

ring to Daniels. Previously, Cohen has said neither the Trump Organization nor the Trump campaign was a party to the transaction with Daniels and he was not reimbursed for the payment.

However, Avenatti told "60 Minutes" he has documents showing

Cohen using his Trump Organization email address in setting up the payment and that the nondisclosure agreement was sent by FedEx to Cohen at his Trump Organization office in Trump Tower.

Another lawyer for Cohen, David Schwartz, accused Daniels of lying about the affair in his own appearance on ABC's "Good Morning Amer-

"The lying is all over that piece," he said, adding that the suggestion that someone associated with Trump or his organization was behind the alleged threat in the parking lot was "speculation" and "guesswork."

Avenatti countered: "It had to have come from someone associated with Mr. Trump, there is no other place for it to have come from." He spoke on ABC.

In the interview, Daniels described a sexual encounter with Trump that began with him talking about himself and showing her an issue of a

magazine with his picture on the cover. said she asked, "Does this normally work for you?" He was taken aback, she says. "And I was like, 'Someone

magazine and spank you with it." She says she then ordered him to drop his pants and, in a playful manner, "I just gave him a couple swats." She said they talked some more, al-

her again, she said. Daniels said that before they had sex Trump had broached the idea of her being a contestant on "The Apprentice," and she likened it to a

allegations about his sexual exploits long before he ran for president.

Former Playboy model Karen Mc-Dougal told Cooper in a CNN interview broadcast Thursday that her affair with Trump began at a bungalow at the Beverly Hills Hotel in 2006. Mc-Dougal said she ended the relationship in 2007 out of guilt concerning Trump's wife, Melania.

McDougal has filed suit in Los Angeles seeking to invalidate a confidentiality agreement with American Media Inc., the company that owns the supermarket tabloid National Enquirer. It paid her \$150,000 during the 2016 presidential election.

The lawsuit alleges that McDougal was paid for the rights to her story of an affair, but the story never ran. It also alleges that Cohen was secretly involved in her discussions with American Media.

The "60 Minutes" interview gave the show its highest ratings in a decade, according to CBS.
