BSHS choirs claim three Concert and Sight Reading Sweepstakes awards

Big Spring High School's choirs journeyed to Abilene's Wylie High School Wednesday to compete in the regional UIL Concert and Sight Reading contest, and brought home the gold.

The school's three choirs each received highest marks from the judges, said Head Choir Director Gershom Garcia.

"There are two parts to the contest," Garcia explained. "The first part is the concert portion, where the students prepare three songs to sing and there are three judges that judge them. There's a rubric or a scale from 1 to 5, 1 being superior, 5 being horrible. So 1 is the very best. They sing these three songs, then they go to another room, the sight reading room, where they're given a piece of music and they're given six minutes to learn a brand-new song that they've never seen. They have to sing it accurately and with correct pitches and rhythms and all of that. They're given an opportunity to sing that piece, and it's the same thing, 1 through 5, with 1 being superior." And "superior" is what the judges rated each of the three choirs, Garcia said.

"We did great! We took

"Child abuse is an issue that isn't talked about all that often, but that doesn't make it any less of an issue," said Kathy Harmon, CASA Marketing Specialist and Volunteer Recruitment. "The amount of families and number of children affected by child abuse in our county is rather high."

This is the fifth year for these entities to come together in an effort to bring awareness in the community. This time, they are asking for even more

our varsity women's choir, we took our varsity men's choir, and our varsity mixed choir, which we call 'Meistersingers,'" he said. "That's the top choir here. All three got superior ratings on concert and sight reading. They got unanimous superior '1' ratings from all three of the judges. So we came home with three Sweepstakes awards."

Garcia said the choirs have done well in the past, but really stepped up their game this year.

"You're not always sure how the judging is going to go. So you've got to be as prepared as possible. When it happens, it's a great thing," he said. "We've been successful here for the last few years, for sure. Our men, for the last few years, have gotten Sweepstakes; our mixed choir has also gotten Sweepstakes; but our women,

they're the ones who have had the challenge to get Sweepstakes. They were very close last year, but this year, they conquered. So we're really very proud of our women."

Garcia reported that a number of judges and coaches congratulated him and the choir on their outstanding performances. According to Garcia, one judge complimented the Men's Choir by saying "Big spring should consider submitting a recording for the Texas Music Educators Association Convention. Today's performance by the men is worth to be heard by the state." A choir director from Abilene complimented the Women's Choir as well. "Audience members are saying the Big Spring Varsity Women sang with incredible tone and were amazing."

Coming up Monday, you have a chance to hear the BSHS choirs in person.

"We have a concert coming up at First Presbyterian," Gar-

cia said. "This is going to be on Monday, April 9, at 7 o'clock in the evening. It's free to the public, and we would love for them to come and listen. The kids are going to perform their UIL music, and then our pop a cappella group 'Rhapsody' is also going to perform. Then we're going to have a few students – some of our seniors – singing their solos. They have qualified to go sing at the state Solo and Ensemble contest in May, so we're going to have some of them sing their solos."

community involvement.

"We are looking forward to having the community, all ages, come out and join us for this event. This is an opportunity to not only raise awareness

and help put a voice to those who may feel they don't have one, but also to highlight the services available right here in Big Spring. The most important thing to remember is, no child should live in fear and no victim should have to remain silent. We can speak up and put an end to this issue."

Troops await orders for Trump border security deployment

PHOENIX — National Guard contingents in U.S. states bordering Mexico awaited guidance Thursday on the what duties they'll be assigned to help fight illegal immigration and drug smuggling along the border, and a Pentagon official said it has not yet been determined whether the troops will be armed.

The deployment is in "very early planning stages," the National Guard in Texas said in a statement.

In Washington, Marine Lt. Gen. Kenneth F. McKenzie told reporters at the Pentagon that it has not yet been determined how many, if any, of the troops participating in the border security operation will be armed.

With troops in all states, the National Guard has been called on by past presidents and governors to help secure U.S. borders, and the Texas contingent said it had "firsthand knowledge of the mission and operating area" that will allow it to move seamlessly into the new role.

The Republican governors of the border states of Arizona and New Mexico also welcomed deployment of the guard along the southwest border as a matter of public safety, but it was unclear how Democratic California Gov. Jerry Brown would respond to Trump's call.

Trump ordered the deployment because "we are at a crisis point" with illegal immigration, Secretary Kirstjen Nielsen of the Department of Homeland Security said.

"We'd like to stop it before the numbers get even bigger," she said.

Though no specifics were provided, Nielsen said guard members would provide support to border officials, "help look at the technology, the surveillance, in some cases we'll ask for some fleet mechanics" and free up agents trained in law enforcement for other duties.

She said she did not know yet how many guard members would be de-

ployed.

Determining that must "wait until each mission's set, each location and then work with the governor on how many people."

Arrests along the U.S. border with Mexico jumped to 50,308 in March, a 37 percent increase from February, and more than triple the same period last year. Border arrests rose 10 of the last 11 months after falling in April 2017 to the lowest since the Department of Homeland Security was created in 2003.

But Republican Mayor Dee Margo of El Paso, Texas, told NPR's Morning Edition Thursday he was not convinced extra forces are needed for his border city, which he called "the safest" in the United States.

"We already have a fence that was established during the Bush administration that runs through the city," he said.

Instead of more troops, Margo said "what I would love to see is a better understanding of what truly goes on the border."

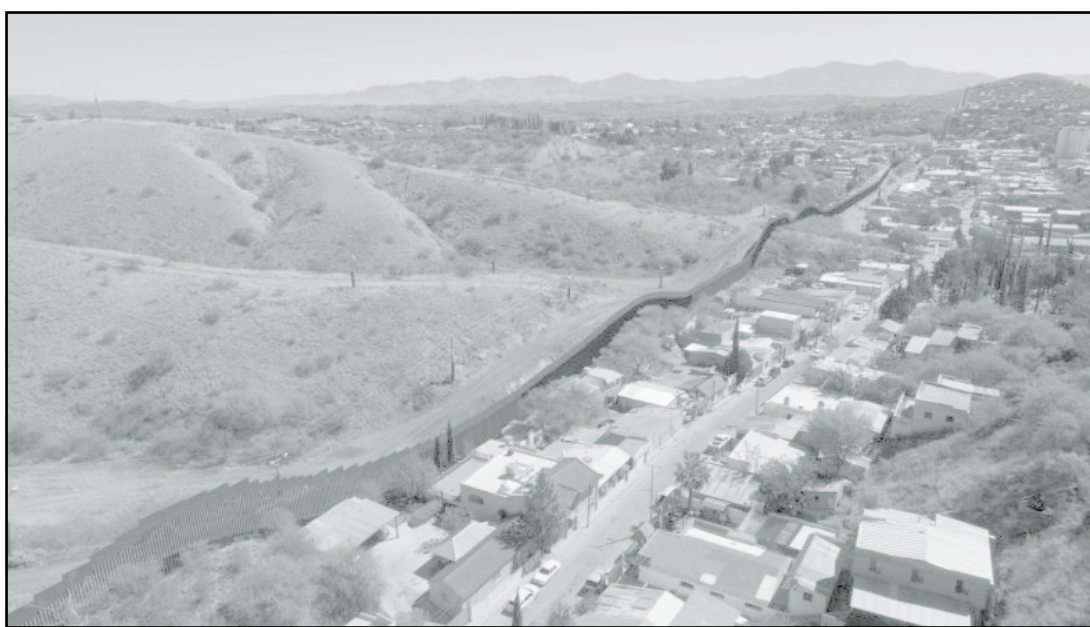
In Mexico, the country's politicians put aside differences to condemn Trump's deployment decision. Mexico's Senate passed a resolution Wednesday calling for the suspension of cooperation on illegal immigration and drug trafficking in retaliation.

U.S. presidents have deployed the military or the National Guard to help the Border Patrol in the past.

In 1997, camouflage-clad U.S. Marines ordered to patrol the border for drugs in West Texas shot and killed 18-year-old Esequiel Hernandez Jr. while he was herding his family's goats near the tiny village of Redford, Texas, along the border.

That shooting sparked anger in the region and ended the President Bill Clinton-era military presence along the international line.

After Sept. 11, President George W. Bush sent unarmed National Guard units to the border to support federal

agents.

Bush sent troops back from June 2006 to July 2008, with guard members performing support duties aimed at freeing up federal agents from routine non-enforcement tasks so they could focus on border security.

They improved lighting at border crossings, extended existing fencing along the international boundary, built roads, monitored remote cameras, operated communications equipment and sat in mobile observation towers watching for people sneaking into the U.S.

Their presence was especially felt in Palomas, Mexico, a smuggling hub south of the village of Columbus, New Mexico, where the increased presence and equipment was credited with easing illegal northbound immigrant travel.

In 2010, President Barack Obama deployed National Guard troops to

the border over fear of increasing drug-trafficking violence.

Those troops worked on intelligence, surveillance and reconnaissance support, analysis and training, and support efforts to block drug trafficking.

They temporarily supplemented Border Patrol agents until Homeland Security could recruit and train additional officers and agents to work on the border. While some were armed for their own self-defense, they were not authorized to make arrests.

During the last two border deployments, the guard's supporting role was criticized by some people who thought they should be more involved in enforcement.

Today, there are more than 20,000 Border Patrol agents along the U.S.-Mexico boundary, and a number of other federal agencies have a presence as well.

Threatened listing for snake found only in Louisiana, Texas

NEW ORLEANS (AP) — The federal government has announced a "threatened" listing for a burrowing snake found only in Louisiana and Texas.

The Louisiana pine snake is a 5-foot-long 5 (1.5-meter-long) constrictor found in a few longleaf pine forests in four Louisiana par-

ishes and five Texas counties.

It eats pocket gophers and lives in their burrows.

The International Union for Conservation of Nature has listed it as endangered since 2007. The U.S. Fish and Wildlife Service announced its listing Thursday, opening a 30-day comment pe-

riod.

Elsie Bennett of an endangered species nonprofit called the Center for Biological Diversity calls it a great first step. The group sued to make the Interior Department decide the snake's status and that of hundreds of other species on the agency's list of candidates for protection.

Reflections: The Light Within

Five years ago the earth shook and a mushroom cloud rose above the small town of West, Texas on April 17, 2013. A devastating chemical explosion leveled a large section of the town killing fifteen and injuring more than 200. Last year a memorial was constructed near the site so that those who were there might never forget.

Two days before the West explosion terrorist bombs ripped through crowds gathered near the finish line of the Boston Marathon. Three were killed and 264 were injured. This year, on April 16 more than 30,000 will participate in the 122nd running.

Authorities eventually determined the West tragedy was the result of arson. The Boston bombing was an act of terror. Both cases are remembered by remarkable stories of courage, faith and determination.

On the first anniversary in West, a choir sang Amazing Grace while surrounded with flickering

candles on which students wrote, "Rise Up West!" CNN reported, "Residents say their faith has been instrumental in understanding and dealing with last April's tragedy. Montgomery Irwin says the anniversary falling so close to Easter -- with its message of resurrection and renewal -- is especially appropriate for the people of West."

When the bombs exploded in Boston, many ran for their lives. Carlos Arrendo did the opposite. Not knowing if another bomb might be set to detonate, he tore through the fences to get to the victims and render aid. He rescued 27 year old John Bauman whose lower leg had been blown away. Carlos, 52, was attending the marathon to honor his son who was killed in Iraq. Perhaps the Apostle John had this kind of human resilience in mind when he wrote, "That was the light which coming into the world, enlightens every man." (John1:9). Every human being is born with a reflection of that light that is at the source of creation. In some way we are like the clouds that reflect the rising sun, streaked with crimson, purple and gold prior to the sun's entrance. Often in our moments of greatest heartache and difficulty we reflect the greater glory. But when the sun rises, its brilliance supersedes every-

thing that has gone before.

This may be what Zecharias meant when he said, "The sunrise from on high has visited us!" (Luke 1:78). Or John, when he wrote, "And the Word became flesh and dwelt among us, and we beheld His glory, glory as the only begotten Son of God." (John 1:14). All of our expressions of courage, faith and determination, mixed as they are with our shortcomings and our sins, are but dim reflections of the perfect light that is found in God.

It seems fitting that before the anniversaries of these two tragic events, the world paused to celebrate Easter and the resurrection of Jesus from the dead. Seeking comfort, consolation and inspiration, we turned our eyes toward that moment in human history when God entered into our suffering through His Son and overcame death and the grave. Our human resilience reflects not on our own glory, but on the glory of Him who made us in His image, Who sent His Son to forgive us our sins and transform us into children of light. He is the source of all comfort and all strength.

Highs and Lows

You've probably heard life described as a roller coaster ride – it has its ups and downs. You may have a period of great joy then it seems as if everything begins to go wrong. You may experience many successes and achievements followed by failures and setbacks.

One great example of this in the Bible is found in 1 Kings 18 and 19. Elijah has a literal “mountaintop” experience. God uses his prophet to show that he is the one, true God and the idols and false gods are nothing. Immediately after this great victory, we find Elijah running for his life because the queen, Jezebel, has sent out her men to hunt him down and kill him.

I also see the apostles go through high and lows. One such occasion is in Matthew 14:22-33. In our previous study, we saw that Jesus had fed 5,000 men (probably several thousand more including women and children) with only five loaves and two fish. I don't know if everyone in the crowd understood what was going on (other than the fact that they were being fed at the end of a long day), but the apostles knew exactly what was happening. They were the ones who saw the amount of food with which Jesus started. They were the ones who saw him divide it up. They were the ones distributing portions to all the people then coming back to Jesus and getting more.

I try to think what that would be like. It would be amazing! Could you imagine going back to Jesus for the 20th time and watching him still break off pieces from those small loaves of bread and continue to pull away pieces of those two fish? They were witnessing a miracle. I am sure that they were truly amazed by this.

They had seen Jesus heal people. Sick people were no longer sick after they encountered Jesus. Blind people were able to see after they were touched by Jesus. Lame people could walk and run and jump when Jesus told them to get up. And now this – the compassion shown to this crowd of tired and hungry people by the Lord performing another miracle.

This was a good moment – a high. How

could they do anything else in that moment other than trust in Jesus – trust that he would lead them, trust that he would care for them, trust that he would provide for all their needs? But, just like most good moments, this one had to end.

Next thing you know, they are on a boat out in the Sea of Galilee in the middle of the night. The winds pick up and are now making waves that threaten the safety of their boat and of them also. And to top it all off, Jesus is not there with them. The roller coaster had crested the high of the previous day and was now plunging rapidly into chaos and trouble. Where was Jesus? We thought he would take care of us. We thought he would

protect us. We thought nothing bad could ever happen to us.

Their faith which had been so strong was now failing. But Jesus had never truly left them alone. He comes to them walking on the sea. They don't recognize him and think he's a ghost (in their defense, it is the middle of the night and people don't usually walk on top of water!).

Maybe you are going through a low point. It may seem as if the Lord is nowhere in sight. However, through his word and the Spirit, he is telling you to “take heart” and “do not be afraid.” Remember fear is the antithesis (the opposite) of faith. When we become so fixated on the bad things in life, we can lose sight of the Lord's presence in our life. He has promised that he would never leave us nor forsake us. Before going up to heaven, he told his disciples that he would be with them until the end.

Trust in God. Don't let fear cause you to doubt. Storms are a part of this life. The low times will come. But, if we remain strong in the Lord and the power of his might, then when this life is over, we will get to be where he is forever and ever – no more lows, no more storms! Thank you, God, for your great and precious promises!

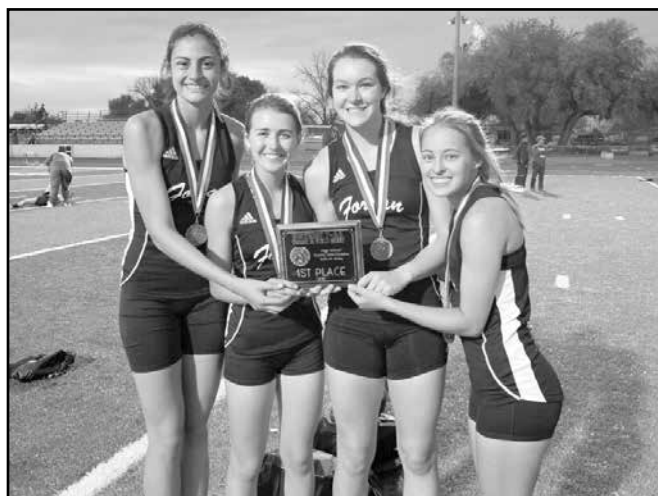

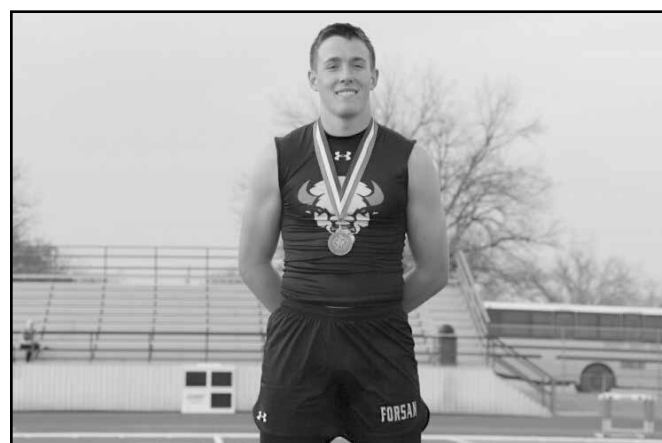

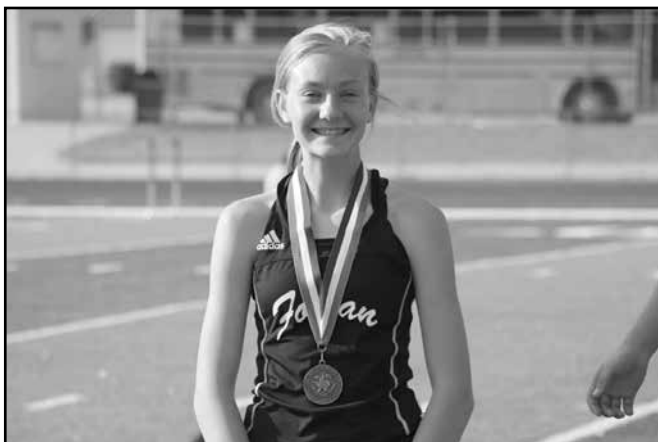

Tim Tebow's Double-A debut a smash hit, homers on 1st pitch

BINGHAMTON, N.Y. (AP) — Tim Tebow sure knows how to rise to the occasion.

Playing his first game in Double-A ball, New York Mets' unique minor leaguer hit a three-run homer on the first pitch he saw. The ex-football star drew a huge ovation after connecting on a frigid Thursday night for the Binghamton Rumble Ponies, who beat Portland 6-0 in their Eastern League opener.

"It's really special and it feels really good," a smiling Tebow said afterward. "It's a great day and it was a fun day, but it's just one day. We've got to be focused on the next day."

Tebow has made that impression before. He also homered last April in his first at-bat with the Class A Columbia Fireflies of the South Atlantic League. This time, the former Heisman Trophy winner at Florida and NFL quarterback sent a liner far over the fence down the right-field line as the announced crowd of 5,247 at NYSEG Stadium stood and cheered the 30-year-old outfielder.

The lefty-swinging Tebow capped a five-run first

inning against righty Teddy Stankiewicz, a second-round draft pick by Boston in 2013. The Sea Dogs are a Red Sox affiliate.

Tebow finished 1 for 4. He grounded into a force

play in the third inning, grounded out to shortstop in the fifth, and struck out swinging in the seventh.

"I'm trying to improve every single day, so to get off to a good start definitely gives you confidence," Tebow said. "But baseball's a game where it's never too high, it's never too low. It's just one at-bat, just one pitch. You've got to stay focused."

"Tomorrow will be another day where I have to improve. I've got to get back in the cage and work ... on all the things that I've been working on to try to improve."

The frigid temperatures sent many fans home after Tebow's third at-bat, apparently satisfied they got what they came to see.

Jeff Kellam and wife Joan, regulars from nearby Owego, stayed put until the end.

"I was pretty cynical," he said. "There was a picture in the paper this morning of Tim Tebow and two other unidentified players. I thought, this is going to be kind of hard for the rest of the guys. The guy that got a two-run homer (Peter Alonso) — nobody's going to talk about that tomorrow."

AUGUSTA, Ga.— Rory McIlroy wanted to get off to a solid start at the Masters, his latest shot at a career Grand Slam.

Saving par on the final three holes in the opening round Thursday helped him keep it in sight.

McIlroy shot a 3-under 69, breaking 70 in the first round at Augusta National for the first time since 2011. He shot a 65 that year and looked like he would win a green jacket before a final-round meltdown.

McIlroy heads into the second round Friday three shots behind Jordan Spieth, who made five consecutive birdies on the back nine to build a two-stroke lead over Tony Finau and Matt Kuchar.

"You look at it and not anyone is really getting away," McIlroy said. "Jordan had a pretty strong finish there. But this is my best start in a few years. And, yeah, it's such a hard golf course to play catch-up on. If you start to chase it around here, that's when you start to make mistakes.

"But to be right up there and

have the ability to stay patient because of the position I'm in, that's a nice luxury I have over the next few days."

He can thank a few timely shots down the stretch.

McIlroy sank an 8-footer for par at No. 16, holed a sweeping, downhill, 13-footer for par on the next green and then chipped to a couple feet to save another par on 18.

"It's not always the birdies that stick out in your mind," McIlroy said, calling those shots the highlights of his round. "Those three holes. Big for momentum. I don't feel like I'm going out trying

to get those two shots or whatever back (Friday) morning. I can just be relaxed going on to the first tee, not being too concerned about trying to get those birdies back. So, yeah, they were huge."

The first time McIlroy had a chance for the Grand Slam at the Masters, he opened 71-71 and found himself 12 shots back because Spieth ran away with it.

"Obviously it was very benign for us coming in the last few holes," McIlroy said. "I'm not surprised about (Spieth) at all. He loves this golf course. He plays well around here. He always has. And he's going to be tough to beat this week."

Some other things to know heading into the second round of golf's first major:

TIGER TALES: Tiger Woods' first Masters appearance since 2015 was a bit of a letdown — he shot a 73, leaving him seven shots off the lead — but the four-time Augusta champion insisted that he's still in the game.

Woods was encouraged by two birdies coming down the stretch.

"I could have easily let the round slip away from me, but I got it back," he said. "And I'm right back in this tourna-

ment."

Well, not exactly.

Only two players have come back from seven shots behind after the opening round to capture the green jacket. But one of them is Woods, who rallied from that daunting deficit to beat Chris DiMarco in a playoff for his last Masters title in 2005.

"I fought hard to get back in there, and I'm back in this championship," Woods insisted. "There's a lot of holes to be played."

TOUGH TONY: Tony Finau may not win the green jacket, but there's no doubt he deserves some sort of award for being the toughest guy on the course.

One day after dislocating his left ankle while celebrating a hole-in-one during the Par 3 Contest — he literally popped it back into place right in the middle of the course — Finau was only two shots off the lead after shooting a 68 in his Masters debut.

"I look at myself as a mentally tough person, and I think I showed that today in my round, just able to put my head down and just play," he said.

Now, it will be interesting to see how the ankle reacts after walking 18 holes in a round that took more than five hours to complete.

"Hopefully I can get some better rest tonight and elevate, ice, have fluid and hopefully feel better," Finau said.

I just want to be fair to the other players that have worked their way here, maybe even harder than he has."

Tebow's performance came far from the warmth of Florida where he became a household name on the gridiron. His Double-A debut came as snowflakes wafted through the evening air and temperatures hovered in the 30s.

All of the field-level box seats at NYSEG Stadium were sold on the blustery night, and although plenty of seats were empty, Tebow's arrival lured Mets chief operating officer Jeff Wilpon north from New York City to take a closer look at the organization's most unusual prospect.

"He's another ballplayer. I understand all the excitement because it's Tim Tebow," Wilpon said. "We look forward to having him perform and move up the system, which he's doing. That's why he's here — moving up the chain.

"He did well last year in A ball. Now, he's got to prove himself here and probably have to go to Triple-A at some point. He's a hard worker. He'll do whatever he has to do to succeed."

Tebow, who was not on the Mets' 40-man major league roster, was reassigned to the Rumble Ponies after going 1 for 18 (.056) with 11 strikeouts in seven big league exhibition games. He was hampered by a left ankle sprain and had been used solely as a designated hitter or pinch hitter.

Tebow started in left field against

Portland and batted seventh. He was greeted with a nice round of applause at pregame introductions. The only glitch in his debut came when he ran into a chain-link fence chasing a fly ball in foul territory along the left field line in the third inning Thursday night, but he quickly shook it off.

When Tebow batted in the fifth, he worked the count full and the crowd began to chant his last name before he grounded out.

"Any time you have support, our entire team is feeling really good," Tebow said. "It's something our team really fed off."

Tebow split last season, his first in the minor leagues, between a pair of Class A teams — Columbia, and St. Lucie in the Florida State League. He hit a combined .226 with eight homers and 52 RBIs in 126 games.

Early in spring training, Mets general manager Sandy Alderson said he thought Tebow had the talent to make it to the big leagues. Alderson said the experiment wouldn't last forever, but he remained optimistic because Tebow had made "meaningful progress."

Joe Pochkar, a season ticket-holder from nearby Endwell, called Tebow's arrival a win-win for an area along New York's Southern Tier that's been among the slowest regions of the state to recover from the financial crash a decade ago.

"He works very hard at his craft, and his passion and work ethic rub off on other players," he said. "It's more than just the ability. So he hits a buck seventy-five, if he gets all the other players with his passion and attitude and desire, it's fantastic."

"A lot of people rag on him for doing what he's doing. This guy's positive, he's a nice guy, good for the community," Pochkar said. "He's 30. He took a long time off. Double-A separates the men from the boys. We'll see."

Binghamton's unusual nickname

comes from an area that bills itself as the "Carousel Capital of the World." George F. Johnson of Endicott Johnson Shoe Co. fame donated several carousels to the area, and the ponies from a handful of carousels that still remain entertain kids today.

First, you have a minimum opening bid, so you don't jump the bidding. Second, you have as-yet undisclosed support for clubs; your partner's first bid suit, plus a singleton spade, so you don't bid notrump. Three clubs pinpoints your shortage in spades, since you've now bid three suits. From here on, the rest is up to partner.

1. **Three notrump.** A sound bidder constantly tries to choose the bid that best reflects the strength and character of his hand. The aim is to make it easy for partner to select the right contract after you've told him what you have.

3. **Four hearts.** Here is still another type of hand. This time you can't support clubs because you haven't any, and you can't support spades because you have only three of them, and partner apparently has a four-card suit.

2. **Three clubs.** Here you're faced with a different type of hand, so you send a different type of message.

4. **Three diamonds.** This is the most illuminating call possible. By bidding three diamonds, you show five of them, and you've already shown at least five hearts. The three-diamond bid puts partner in position to place the final contract, whether it be a game or a slam in a suit or notrump.

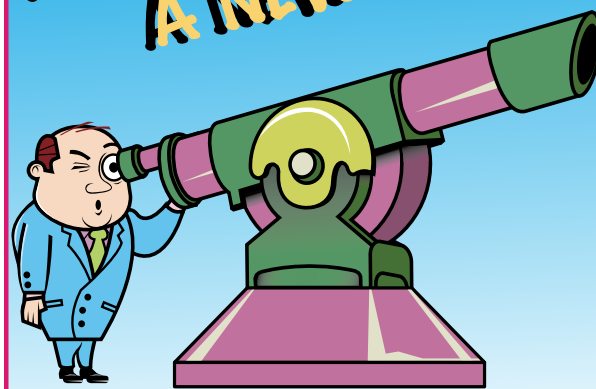

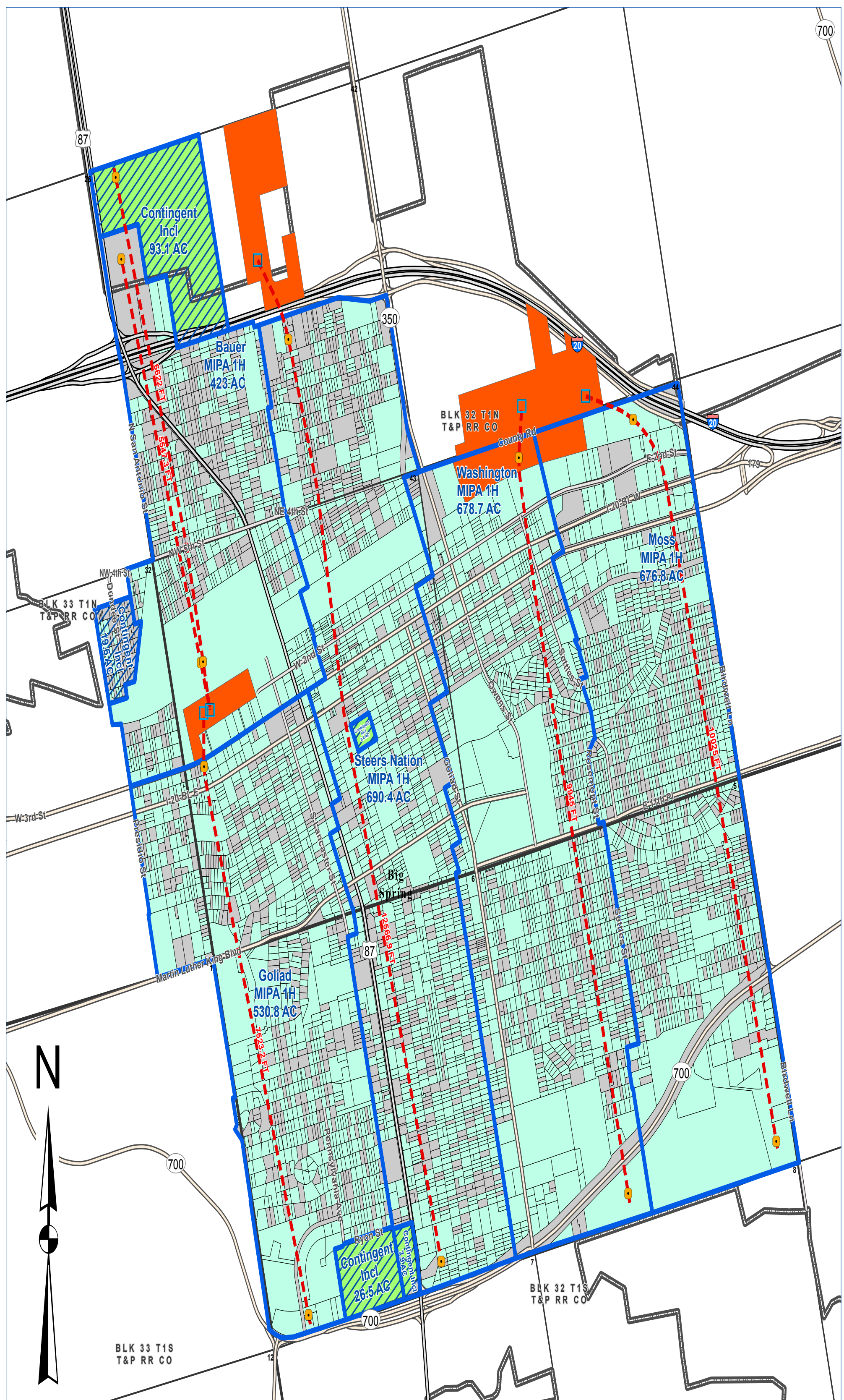

Reference is hereby made to such maps, pending offers and the individual applications for a detailed description of each proposed unit. 
