School board hears good news on STAAR test prep

Trustees of the Big Spring Independent School District heard some encouraging news about student testing progress at their meeting Thursday evening.

BSISD Testing and Curriculum Director Dr. Raemi Thompson told the trustees that scores on the most recent STAAR test practice benchmark are up.

"This week on Tuesday we gave English 1, fourth-grade writing, third-grade writing, and math," Thompson said. "We also tested reading yesterday."

Thompson presented a graph showing that English, reading, and math scores are mostly up. According to the graph, reading and English students in every grade

Ralph Nader, American political activist, and author, once said "When strangers start acting like neighbors, communities are reinvigorated." That's exactly what happened when Garrett Parish, a local young man from Coahoma, was injured in 2015 in a sledding accident. Residents of Howard County and surrounding areas have all come together with fundraisers, events, and other benefits to help this cause and many others.

When Parish was injured on Feb. 27, 2015, he suffered a spinal cord injury. Stem cell treatment, paired with physical

therapy and a lot of hard work, are the steps that the Parish's have had to endure on his road to recovery. The community is coming together, once again, to help him on his journey with the fundraiser event Shells for Cells.

Shells for Cells, which will be held on Saturday, April 14, is a clay shooting benefit at Jake's, located at 13301 FM 1379 in Midland, Texas. Registration for this event is at 8 a.m. and will be \$150 per shooter. There will be door prizes, and the odds are that one in ten will win a gun.

Since stem cell treatment isn't offered in the United States, Parish and his family must travel to Germany for his treatments. All proceeds from this event will go to help with medical and travel expenses.

Ryan's departure sparks unrest, GOP fears losing House

WASHINGTON (AP) — When House Speaker Paul Ryan announced his retirement decision, he did so on his own terms. The political fallout may not be so easy to control.

Ryan's relinquishing of one of the most powerful positions in Washington left Republicans reeling Thursday over not just who will replace him but whether Ryan's lame-duck status will jeopardize the GOP's pitch to voters and donors, and worsen their chance of keeping the majority.

Control of the House was already at risk in a tough midterm election. Voters are fired up amid rising opposition to President Donald Trump and sagging GOP accomplishments. Now some wonder aloud if the GOP grip on the House majority is already lost.

"It's like Eisenhower resigning right before D-Day," said Tom Davis, a former Republican congressman from Virginia who once headed the House GOP's campaign committee.

"Paul Ryan was the franchise," Davis said. "With Paul, this was a Republican Party they could still give to. He's a great brand for the party. He's gone."

On some level the impact is symbolic. Ryan was once viewed as the future of the party, and he currently is a rudder for a party regularly tossed about by Trump's shifting impulses. For Republicans fighting for their political survival, it's hard not to take Ryan's decision as vote of no confidence.

One Republican in the long list of those already

retiring, Rep. Ryan Costello of Pennsylvania, said the speaker didn't try to walk him off his decision, and in fact seemed to identify with his preference for returning home to family. Some four dozen House Republicans — including powerful committee chairmen — are calling it quits.

Add Ryan's retirement to the mix, and donors, lawmakers and strategists are raising red flags about a prolonged period of uncertainty unlike anything ever seen in modern House history.

"It's not confidence building," said Ron Nehring, a former party chairman in California, who says Republicans need to boost their legislative accomplishments, especially after having failed to keep their promise to voters to repeal Obamacare, if they hope to motivate Republicans to the polls. "Democrats are going to walk a mile on broken glass to vote against the president."

On Thursday, Ryan dismissed suggestions from some corners, including lawmakers, that maybe it would be best if he stepped aside rather than stick around until January, when the new Congress is seated, as he intends to do.

"My plan is to stay here and run through the tape," Ryan told reporters, noting he had "shattered" fundraising efforts by previous speakers, more than doubling his \$20 million goal.

"I talked to a lot of members — a lot of members — who think it's in all of our best interest for this leadership team to stay in place," Ryan said. "It makes no sense to take the biggest fundraiser off the field."

Money will be channeled to counter a blue wave of Democrats, who need to pick up 23 seats to flip the majority. The midterm is expected to be tougher, and costlier, than ever, especially amid the expanding battleground of open seats, which usually lack the built-in campaign apparatus of incumbency.

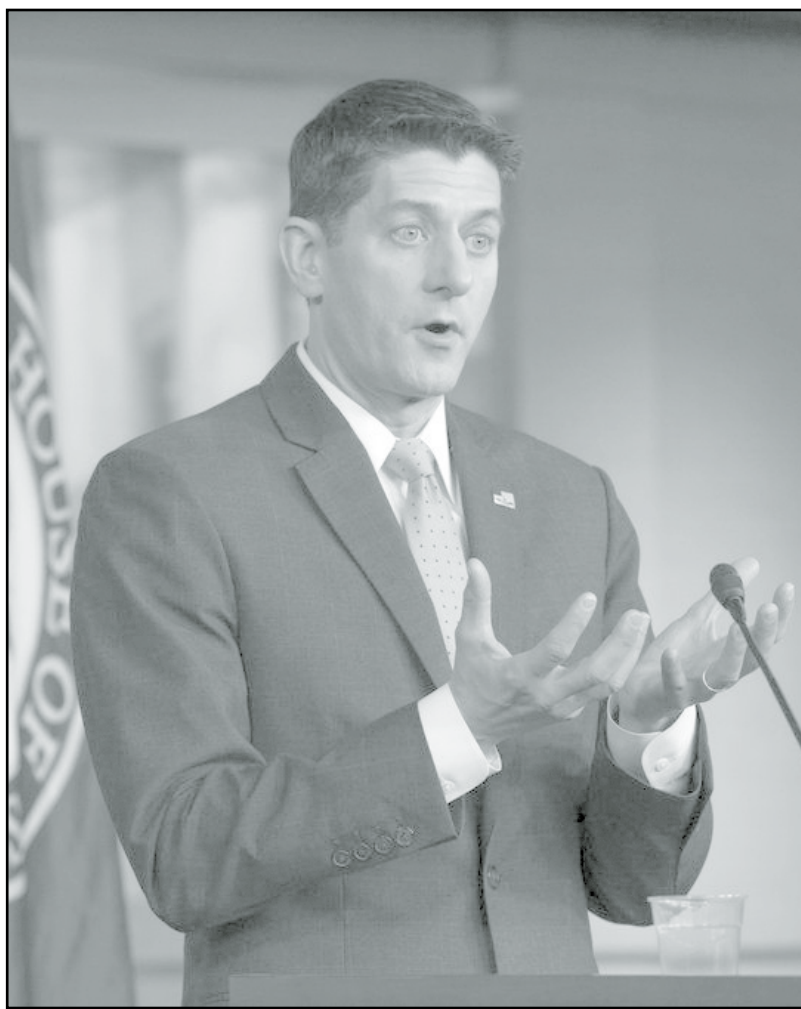
Few Republicans talk any more of retaining control of the House as a certainty. Those doubts are clear in the way they talk about the fight to replace Ryan.

Rep. Mo Brooks, R-Ala., a member of the conservative Freedom Caucus, said he won't worry much about whom he will support for the leadership post until House Republicans figure out if they'll be choosing their new speaker in fall — or simply the minority leader.

"At that point we'll know if we're going to elect a Republican or Democratic speaker," he said.

Ryan's allies insist the party's top fundraiser and champion of a crisp GOP message remains in full force.

If anything, Ryan's decision "frees up the speaker to raise more money for Republicans across the country," said Corry Bliss, executive director at the Congressional Leadership Fund, the political action committee at the forefront of Republican efforts to maintain a

House majority.

And besides, the strategist said, the GOP message heading to November is the same. "The central thematic still remains: The American people simply do not want Nancy Pelosi to be the speaker."

But a fight between two Republicans — for lawmakers' affections and donor dollars — would certainly be a distraction. Rep. Kevin McCarthy, the majority leader, is seen as a leading contender. Majority Whip Steve Scalise is viewed as the likely alternative, and his team noted Thursday that he, too, had broken first-quarter fundraising records, hauling in \$3 million.

Already discord is showing. Some conservatives are rallying behind Rep. Jim Jordan, R-Ohio, a long-shot who could inject new uncertainty to the outcome, splinter the vote so no single leader wins a majority.

One rank-and-file lawmaker, Rep. Warren Davidson, R-Ohio, said he doesn't mind Ryan's prolonged departure because it creates an opening for lawmakers to tailor their own campaign message. But he acknowledged others prefer the leadership race settled with a unified party message heading into fall. "A lot of people want it over swiftly," he said.

level except English 2 showed increases over last year's benchmark test. Some grades showed improvement on the benchmark over last year's actual STAAR test, while other grades showed declines compared to that result.

On math, every grade showed marked improvement over last year's benchmark, ranging from a 6-percentage-point improvement for sixth-grade math to a 21-point improvement for Algebra 1. Again, comparisons with last year's actual STAAR test were mixed, with most grades having performed better on the actual test than on either benchmark exam.

"Now it's all a matter of identifying the right skills with the right kids," Thompson told

the trustees. "We've gotten down to the kid level, what activities they need to work on, who needs to work on it, divided them out, and are working diligently every day to prepare them for that assessment. So, super proud of our campuses and our principals and our teachers for working very very hard in identifying those needs."

In other business, the trustees approved a project to retrofit the doors the Big Spring High School building with electronic locks and monitoring devices.

"As most of you know — a lot of you guys went to Big Spring High School — there are 111 doors on the outside of this building, the PE Gym, the Gym, and all the vocational area," said BSISD Technology Director Corey Wood. "Currently we have no way to monitor those

doors, if they're open or closed, and not a way to make sure they're locked. So that is what this project is for. It's access control."

The project, which will cost about \$250,000, will allow school administrators to monitor whether doors are open or closed, and receive an alert if the doors remain open too long. Some doors will be fitted with electronic locks, allowing them to be opened with a keycard, and be locked or unlocked remotely.

Trustees unanimously approved the project. "That's a real important first step," said board president Tony Kennedy.

Trustees also: Heard a report on the district's bilingual/English as a second language program.

Heard a report on the district's Career and Technical Education

program.

Heard a report on student and teacher attendance.

Accepted a donation from the Big Spring Economic Development Corporation to fund a robotics program at the district's elementary schools.

Approved a budget amendment for the construction of a new cooling tower at Big Spring High School.

all the things she was doing, so I decided to try it," said Workman. "I've been showing (lambs) for eight years also. I've been raising sheep for not as long, but also, raising sheep has been in my family for five generations now. I believe it's important to support the sheep industry. We eat lamb at least weekly at my house."

Workman will present a cooking school at the Howard County AgriLife Extension's G.C. Broughton Jr. Agriculture Complex, 2411 Echols Dr. in Big Spring, at 6:30 p.m. April 19.

"We're going to have a lamb cooking class," said County Extension Agent Sandy Taylor. "I'm going to need people to call ahead just to make sure we have enough food to cover it. The number is 432-264-2236. We're going to showcase Brance's lamb dish, which is Korean Barbecue; and then we're going to do some lamb tacos, and we'll have some little stuff to go with it. I'll have a little salad and a dessert, just to go with it."

Workman is an advocate for working with and eating sheep and lamb.

"It's put down a lot. It's not up there, like beef," he said. "There's a lot of misconceptions about it, and I think there should be a change in that."

Taylor agreed.

"A lot of people have a misconception about lamb," she said. "A lot of people, they think it's hard to cook with. They don't even want to try it. But I think most people would be interested to know that Texas is the number-one producer of lamb in all of the 50 states. Most of our lamb is sent overseas or back east. We don't have a huge number of people who consume it in this area."

Warrant: Former Texas nurse a suspect in 2 patients' deaths

DALLAS (AP) — A nurse who has been charged with murder intentionally caused stroke-like injuries to seven patients at a Texas heart hospital, leading to the death of two and serious injuries to the others, according to an arrest warrant.

William George Davis, 34, is seen on security video entering patients' rooms at the hospital on the campus of Christus Trinity Mother Frances Health System in Tyler, the warrant alleges. He leaves a short time later and then the patients suffered "unexpected medical emergencies."

Davis, a registered nurse, was working a night shift when each patient suffered an emergency, according to the warrant, and authorities say in at least some cases he introduced air into their circulatory systems, leading to an air embolism.

Davis was fired in February and arrested Tuesday on a murder charge. He was being held Thursday at the Smith County jail on a \$2 million bond. Tyler police spokeswoman Jenny Wells said it's not clear when he will appear in court.

Online jail records don't indicate whether he has an attorney. The office of Taralynn Mackay, a lawyer who had represented Davis earlier this year at a Texas Board of Nursing hearing, said she's no longer representing him.

Tyler police Chief Jimmy Toler said during a news conference Wednesday that Davis is facing additional charges.

He's being held in the August death of 47-year-old Christopher Greenaway who, according to his obituary, was a pilot and decorated veteran. He had surgery Aug. 3 and a day later experienced an "unexpected neurological incident," according to the warrant. He died a few days later.

Police have not identified the second patient who died and it's not immediately clear if Davis could be charged with a second count of murder.

The seven cases connected to Davis date back to June and all took place at the hospital where he worked, Toler said. The patients ranged in age from 47 to 63 and were recovering from cardiovascular surgery when they "suddenly experienced a profound incident," the warrant explains.

Two of the patients — a 58-year-old man and a 63-year-old woman — were left in vegetative conditions. The man's medical condition faltered on Jan. 25 and as of late March, when investigators went to San Antonio to observe him, he was bedridden, unable to speak and relied on others to feed him, the warrant said. The woman has limited mobility, impaired vision and continues to receive medical care.

Christus Trinity Mother Frances Health System, which includes Owen Heart Hospital about 100 miles (160 kilometers) southeast of Dallas, said in a statement that Davis began working for the system in 2013. Toler said that prior to coming to Christus, Davis had worked at another hospital for two years. Toler didn't identify that hospital.

The Texas Board of Nursing suspended Davis' license last month and is expected to revoke it.

There have been several cases nationally dating back to the 1980s of nurses or nurse's aides who have been charged with killing patients.

In San Antonio, an already imprisoned former nurse who prosecutors believe could be responsible in the deaths of 60 children in Texas is awaiting trial on more charges. Genevieve Jones pleaded not guilty in December to murder charges in the deaths of five children in the early 1980s.

Separately, an East Texas nurse is serving life in prison for killing five dialysis patients by injecting them with bleach. Kimberly Saenz was convicted in 2012 of capital murder in the deaths of patients at a Lufkin clinic where the licensed vocational nurse worked.

Volunteers build oyster reef in South Texas following Harvey

ROCKPORT, Texas (AP) — With the temperature dropping quickly on the coast, they started before the designated start time of 8:30 a.m. on a recent Saturday.

The Victoria Advocate reports the volunteers, some of whom were sleepy teens from Moody High School in Corpus Christi or just as sleepy graduate students from Texas A&M University-Corpus Christi, shoveled about 40,000 pounds of oyster shells into metal buckets.

Another pair of hands fed the shells through a tube that had a hard mesh bag on the end of it. Someone else tied the bag into a knot and stacked it.

Though theirs was a serious task, thwarting erosion at Goose Island State Park battered by Category 4 Hurricane Harvey last year, they found communing with Mother Nature fun too.

Two students challenged each other to a squat-off. They used shovels weighed down with shells as barbells, bent their knees and kept their backs straight, giggling all the while.

Joseph Lopez, 27-year-old from Waco, rewrote the folk song "99 Bottles of Beer on the Wall" to "99 Bags of Oyster Shells on the Ground" as he "picked one (bag) up and passed it around."

Lopez, who was visiting his girlfriend, a TAMU-Corpus Christi student studying marine biology, said he enjoyed wad-

ing into the bay that borders the park with the other volunteers to build a new oyster reef.

"I was like, 'Hey, why not?' We don't have a lot of volunteer opportunities in Waco," Lopez said.

This bi-annual event was founded in 2009. The Institute collects shells from restaurants and wholesalers twice weekly and takes them to the Port of Corpus Christi where they are quarantined. Until recently, no mechanism existed for them to be returned to the water. Oysters, which spawn in April and May, prefer to establish themselves on their deceased brethren. They also can't go too deep into the water column because they need the algae at the top.

Eighty-five percent of the world's oyster reefs have disappeared, said Gail Sutton, the Institute's chief operating officer.

"This is one of the few animals where you're not only taking them (to eat) but their home as well," she said.

Sutton explained that this year, the volunteers would be building upon the success of last year.

Before Harvey made landfall Aug. 25, the Institute had completed a 6-acre reef made from the shells it collected from restaurants to protect the park from erosion.

"We were disappointed at first because we had saved all that shell, a million pounds, and finished this reef that had taken years and thought it had all been wiped out in a month," Sutton

said. But they designed it with cuts, so if water came at the reef fast, the water wouldn't back wash the reef out. And it worked. The reef survived Harvey.

"Not only were we really pleased, but so was the park," Sutton said.

Every year, about 2,000 linear feet of shoreline at the park erodes, some stretches more rapidly than others. Oyster reefs cut down on the wave action that leads to that erosion.

The park is also home to live oak trees whose limbs have been twisted by the wind, one that's considered one of the biggest in the nation. It has a circumference of 35 feet, a crown spread of 90 feet and stands 44 feet tall.

"What's happening is not only is the land eroding, but also the salt water is coming underneath and getting to the roots and that will kill those trees," Sutton said.

The reef built is near the 6-acre reef that survived an almost direct hit from Harvey, but is closer to the shore.

Jarrod Boudreaux, a park ranger, said he was happy to see so many young people helping out. He recalled Harvey as a terrifying experience and said it took a while for staff to get back to the park because some lost their homes.

"We literally had to move mountains to reopen. We had tons of sand and shell to move off of some of our roadways before we could reopen (to overnight visitors) on March 1," he said.

The fishing pier and Trout Street camping areas remain closed because of due to significant hurricane damage.

Gabriella Robles, a 16-year-old environmental science student at Moody High School, hugged her teacher, Vinay Dulip, when it was all over.

"I did it!" she told him.

Gabriella had seen oysters in a touch tank when the Institute brought them to her classroom, but on that Saturday, her clothes were sopping wet from crouching down to place bags of shell on the muddy bay bottom.

"It was a great experience to see everything firsthand," she said.

Reflections: Finding Our Moral Footing

For centuries Western Civilization has embraced the Ten Commandments as the bedrock for law and conduct. But, in the twenty-first century, such an assumption no longer holds true. Bit by bit the Ten Commandments are being chiseled from their central position in our culture.

In 2001, after a two-year legal battle, a 5,280 lb. granite Ten Commandments monument was removed from the rotunda of the Alabama State Capital.

In 2004 the Sixth District Court of Appeals in Kentucky ruled that the Ten Commandments could no longer be displayed in public schools and courthouses. To do so, the court ruled, would be an endorsement of religion.

In 2014, followers of the pagan faith, Wicca, sued the city of Bloomfield, N.M. over a 3,000 pound Ten Commandments monument that stood in front of the City Hall. The court ruled the monument had to be removed as a violation of First Amendment

rights.

In June 2015 the Oklahoma Supreme Court ruled that the presence of the Ten Commandments on the capitol grounds was unconstitutional. On October 5, under cover of darkness, the 4,800 lb. slab of stone was moved from the Oklahoma State Capitol grounds to a private location.

These reflect sensitive legal issues in our nation that values freedom of religion and separation of church and state. But what is more disturbing than the removal of monuments is the removal of the Ten Commandments from our consciousness. Few can name them. Stop for a minute and see if you can recall all ten of the commandments? Can our children or grandchildren quote them? If we don't know the Ten Commandments, how can they guide us in our values and action?

Jesus said, "Do not think that I have come to abolish the Law or the Prophets; I have not come to abolish them but to fulfill them. For truly I tell you, until heaven and earth disappear, not the smallest letter, not the least stroke of a pen, will by any means disappear from the Law until everything is accomplished. Therefore anyone who sets aside one of the least of these commands and teaches others accordingly will be called least in the kingdom

of heaven, but whoever practices and teaches these commands will be called great in the kingdom of heaven." (Mathew 5:17-19).

The first four of the Ten Commandments tell us how to have a healthy relationship with God. The next six tell us how to have healthy relationships with each other.

Zhao Xiao, a leading economist in China, researched America's secret to prosperity. He concluded, "... the key to America's commercial success is not its natural resources, its financial system or its technology but its churches.... The market economy is efficient because it discourages idleness, but it can also encourage people to lie and injure others. It thus needs a moral underpinning." Xiao's conclusions are remarkably similar to Alexis de Tocqueville's in 1840.

Starting next week, this column will reflect on each of the Ten Commandments and their implications for today.

How Is Jesus Recognized

How do people react when Jesus is mentioned - anger, sadness, joy, indifference, ignorance? During his earthly ministry, Jesus was confronted by these very same types of responses. In our study through the book of Matthew, we see a great response by some when Jesus comes to them.

Matthew 14:34-36, And when they had crossed over, they came to land at Genesaret. And when the men of that place recognized him, they sent around to all that region and brought to him all who were sick and implored him that they might only touch the fringe of his garment. And as many as touched it were made well (ESV).

What a great response! Because they recognized him and trusted in him, they welcomed him, they honored him, and they brought those who were sick and afflicted to him. They knew that Jesus was the one who could do for them what they could not do for themselves.

Unfortunately, Jesus does not always get this type of response. Some respond in anger seeing Jesus as a threat to choices they have made in their lives. Some may respond with indifference thinking that they are doing

good enough on their own. Some are merely ignorant with no knowledge or understanding of spiritual matters.

As followers of Jesus, we are to be his representatives to others. To what degree might the responses of others be a reflection of my representation of Jesus?

If I represent Jesus in an arrogant and judgmental way, that could cause someone to respond in anger. If I am always confrontational in an unkind and unloving way, people will not want to know or follow the one that I am representing. But, if I show compassion to others the way that Jesus did, how might that affect their response?

Do those around me recognize Jesus because of my example and influence? Do others recognize Jesus through my words and actions? When they recognize the one I am representing, does it cause them to want to put their trust in him?

Father, help us to represent the love, mercy, kindness, and compassion of your Son to others so that they may come to recognize him and who he truly is - Lord and Savior.

Patrick Reed wins Masters for first major title

AUGUSTA, Ga. (AP) — Patrick Reed became famous playing for his country. He won for himself on Sunday at the Masters.

Rory McIlroy came after him early. Jordan Spieth briefly tied him for the lead. Rickie Fowler birdied the last hole to leave him no room for error. Reed never flinched through it all on a raucous afternoon at Augusta National, calmly rolling in a 3-foot par putt for a 1-under 71 and a one-shot victory.

Captain America is now the Masters champion.

Even as the loudest cheers were for everyone else, Reed earned all the respect with two big birdie putts on the back nine, one key par and plenty of grit.

The 27-year-old Texan is the fourth straight Masters champion to win his first major.

Spieth put up the most unlikely fight and was on the verge of the greatest comeback in Masters history. He started nine shots behind going into the final round, and was inches away on two shots from a chance at another green jacket. His tee shot on the 18th clipped the last branch in his way, dropping his ball some 267 yards from the green. His 8-foot par putt for a record-tying 63 narrowly missed on

the right. He had to settle for a 64.

Reed won for the sixth time in his PGA Tour career, though he was best known for the trophies he shared at the Ryder Cup. He is ferocious in match play, especially the team variety, and his singles victory over McIlroy at Hazeltine in 2016 led to the nickname of Captain America.

McIlroy will have to wait another year for a shot at the career Grand Slam. Trailing by three shots to start the day, he closed within one after two holes. That was as close as he came. McIlroy's putter betrayed him, and he was never a factor on the back nine. He shot 74 and tied for fifth.

OTHER TOURS

Stephanie Meadow won the Symetra Tour's IOA Championship in Beaumont, California. The former Alabama star from Northern Ireland made a 40-foot birdie putt on the first hole of a playoff with Carleigh Silvers. Meadow closed with a birdie for a 70. Silvers bogeyed the 18th in regulation for a 71 to drop into the playoff. ... Ji-hyun Kim won the Lotte Rent-a-Car Women's Open on the LPGA Tour of Korea in an event shortened to 36 holes because of rain. She shot rounds of 67-68 for a one-shot victory over Ji-Hyun Oh. ... Ai Suzuki won for the second time this year on the LPGA Tour of Japan at the Studio Alice Women's Open. She closed with a 2-under 70 for a four-shot victory over Yoshiha Rumi.

Fowler, Spieth make Reed earn his 1st major championship

AUGUSTA, Ga. (AP) — After the final putt disappeared into the cup, Rickie Fowler waited outside the scoring room at Augusta National.

Once again, he was congratulating someone else on winning their first major championship.

For Fowler, the wait goes on. "I was ready to go win," he said. "Unfortunately, I was one shot short."

This has become a familiar lament for Fowler, who now lugs around the unwanted baggage as the best player without a title in one of golf's biggest events.

He had his best chance yet on a stirring Sunday at the Masters, making six birdies over the final 11 holes — including an 8-footer at the 72nd hole that finished off a 14-under 274.

It's a score that would've been good enough to win most years.

But Patrick Reed had one less stroke on his card, claiming the green jacket by sinking a short but testy par putt at No. 18.

"Glad I at least made the last one to make him earn it," Fowler said.

Jordan Spieth did his part, too, to make Reed earn it.

The 24-year-old Texan turned in one of the greatest closing rounds in Masters history, shooting an 8-under 64 that pushed him into the mix after he started the day with a daunting nine-shot deficit. Spieth thought it would be a nice, stress-free day out on the course.

Instead, he horned his way into one of the greatest duels this place has ever seen, actually grabbing a share of the lead by sinking a 35-foot birdie putt at the 16th hole.

"Are you kidding me," Spieth mouthed to his caddie.

Reed, playing in the final group, answered with a birdie at the 14th.

Spieth's hopes ended at the 18th hole after his tee shot clipped a tree, falling to the ground just 177 yards away. He pulled off two dazzling shots to give himself a shot at saving par. But an 8-foot putt slid by the edge of hole — his only bogey of the day.

"I was pretty gutted at the finish," Spieth said. "I hit a tee shot that wasn't that bad. It just caught the last little branch of that tree. Obviously, I want to go back to that tee shot right now. But it was a phenomenal day."

Spieth sure knows his way around Augusta National, where

he won in 2015, finished second two other times, and now has a third-place showing on his resume. His worst performance in five appearances was a tie for 11th last year.

Fowler couldn't resist a little jab at his good friend.

"Solo second feels and sounds better than tied for second, so it was nice to edge out Jordan," Fowler said with a smile.

But Spieth, only 24, already has three major titles on his resume.

The 29-year-old Fowler is still chasing the first.

He's certainly had plenty of opportunities, most notably finishing in the top five of all four majors in 2014. Fowler now has eight top-five finishes in 31 majors over his career.

This one felt different than all the others.

Fowler played like a champion on the final day.

He went to the last hole with a real shot to win.

"I am ready to go win a major, but this was kind of the first major week that I understood that and knew that and felt that," he said. "I'm ready to go. I'm really looking forward to this year and the three majors that are left."

"It should be," he added confidently, "a very good major season."

Fowler will need to get off to a better start than he did in Augusta, where he was just 2 under through the first two rounds. He really turned it on over the weekend, surging into contention with a 65 on Saturday before matching the best closing round of his Masters career.

He showed his mettle by battling through a tough start Sunday — his first seven holes resulted in six pars and a bogey — but got things going with back-to-back birdies before making the turn.

Fowler added four more birdies on the back side, the best he's ever played with a major title hanging in the balance.

It wasn't quite good enough, but it left no doubt that he's got the game to break through some day.

"I gave it my all. I left everything out there on the golf course," Fowler said. "Patrick went out there and outplayed all of us this week, and he earned it. So, you've got to give it to him. He's your Masters champion."

Someone asked Fowler about his goals going forward.

"My next goal?" he said. "Win a major. We're close. That's the No. 1 priority."

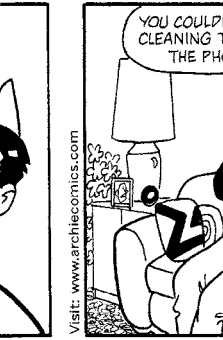

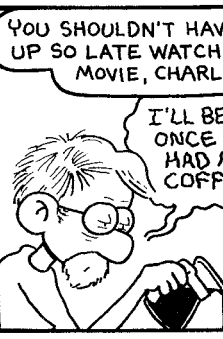

This Date In History

Today is Friday, April 13, the 103rd day of 2018. There are 262 days left in the year.

Today's Highlight in History: On April 13, 1943, President Franklin D. Roosevelt dedicated the Jefferson Memorial in Washington, D.C. on the 200th anniversary of the third American president's birth.

On this date: In 1598, King Henry IV of France endorsed the Edict of Nantes, which granted rights to the Protestant Huguenots. (The edict was abrogated in 1685 by King Louis XIV, who declared France entirely Catholic again.) In 1613, Pocahontas, daughter of Chief Powhatan, was captured by English Capt. Samuel Argall in the Virginia Colony. (During a yearlong captivity, Pocahontas converted to Christianity and ultimately opted to stay with the English.) In 1742, "Messiah," the oratorio by George Frideric Handel featuring the "Hallelujah" chorus, had its first public performance in Dublin, Ireland. In 1743, the third president of the United States, Thomas Jefferson, was born in Shadwell in the Virginia Colony. In 1861, at the start of the Civil War, Fort Sumter in South Carolina fell to Confederate forces. In 1917, American business tycoon James "Diamond Jim" Brady, known for his jewelry collection as well as his hearty appetite, died in Atlantic City, New Jersey at age 60. In 1953, "Casino Royale," Ian Fleming's first book as well as the first James Bond novel, was published in London by Jonathan Cape Ltd. In 1958, Van Cliburn of the United States won the first International Tchaikovsky Competition for piano in Moscow; Russian Valery Klimov won the violin competition. In 1964, Sidney Poitier became the first black performer in a leading role to win an Academy Award for his performance in "Lilies of the Field." In 1970, Apollo 13, four-fifths of the way to the moon, was crippled when a tank containing liquid oxygen burst. (The astronauts managed to return safely.) In 1986, Pope John Paul II visited the Great Synagogue of Rome in the first recorded papal visit of its kind to a Jewish house of worship. In 1992, the Great Chicago Flood took place as the city's century-old tunnel system and adjacent basements filled with water from the Chicago River.

"The Bridges of Madison County," a romance novel by Robert James Waller, was published by Warner Books.

Ten years ago: World Bank President Robert Zoellick (ZEL-ik) urged immediate action to deal with mounting food prices that had caused hunger and deadly violence in several countries. Trevor Immelman won the Masters, becoming the first South African to wear a green jacket in 30 years. A construction worker's bid to curse the New York Yankees by planting a Boston Red Sox jersey in their new stadium was foiled when the offending shirt from its burial spot. Physicist John A. Wheeler, who coined the term "black holes," died in Hightstown, New Jersey, at age 96. Five years ago: Francine Wheeler, the mother of a 6-year-old boy killed in the Connecticut school shooting, used the opportunity to fill in for President Barack Obama during his weekly radio and Internet address to make a personal plea from the White House for action to combat gun violence. All 108 passengers and crew survived after a new Lion Air Boeing 737 crashed into the ocean and snapped in two while attempting to land on the Indonesian resort island of Bali. Hundreds of opponents of former British Prime Minister Margaret Thatcher partied in London's Trafalgar Square to celebrate her death, sipping champagne and chanting, "Ding Dong! The Witch is Dead." One year ago: Pentagon officials said U.S. forces in Afghanistan had struck an Islamic State tunnel complex in eastern Afghanistan with "the mother of all bombs," the largest non-nuclear weapon ever used in combat by the U.S. military. Jennifer Garner and Ben Affleck filed divorce petitions, the first step in formally ending their marriage more than a year after they publicly declared their relationship was over. I really don't know what to do. My daughter doesn't want me to even talk about my relationship to her or around the grandkids. She wants me to pretend Sally doesn't exist. What can I do? -- Stuck in the Middle

Dear Stuck in the

Middle: It's unfair of your daughter to not give your partner a chance. Maybe she is having a hard time accepting your new relationship because it's with another woman and that doesn't fit with the image of who she believes you should be -- in which case, she should adjust her picture. Or maybe this is a matter of overprotectiveness and would happen even if you were seeing a man. It's probably a bit of both.

And then there's Sally. You should always strive for a good relationship with your partner's family. If a good relationship isn't possible, then you should at least go for a polite one. If even that's not possible, then it becomes about

finding some sort of peace with that. What you absolutely should not do is scream and curse at your partner's family members. Sally might rationalize it as her defending you, but really she's just making your life harder. Ask her to go to couples counseling so you can find sustainable ways of coping with the stress you face as a couple.

Dear Annie: Please tell your readers about the importance of having an optimal level of vitamin D. The majority of doctors do not include the test for D in routine labs, especially for those who are younger than 65 and have not had a problem bone scan.

Vitamin D is actually a hormone, and it

is found in every cell in the body. It is believed that a large part of the population is low in D. The reasons may not be known, but it is true that for many, just getting lots of sun does not ensure an adequate level. A low vitamin D level is often found in people having dementia, fibromyalgia, acne, depression, ADHD and many other maladies and diseases. Whether a deficiency in D is the cause or not is not known, but it is reported that the immune system improves with increased amounts of D.

Learn your D level and the level of your children. It is an easy and inexpensive way to possibly improve your health and maybe decrease your risk of

future health issues. -- L

Dear L: Always good to have a reminder to take one's vitamins (in appropriate doses).

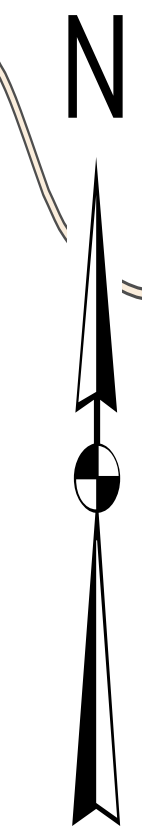
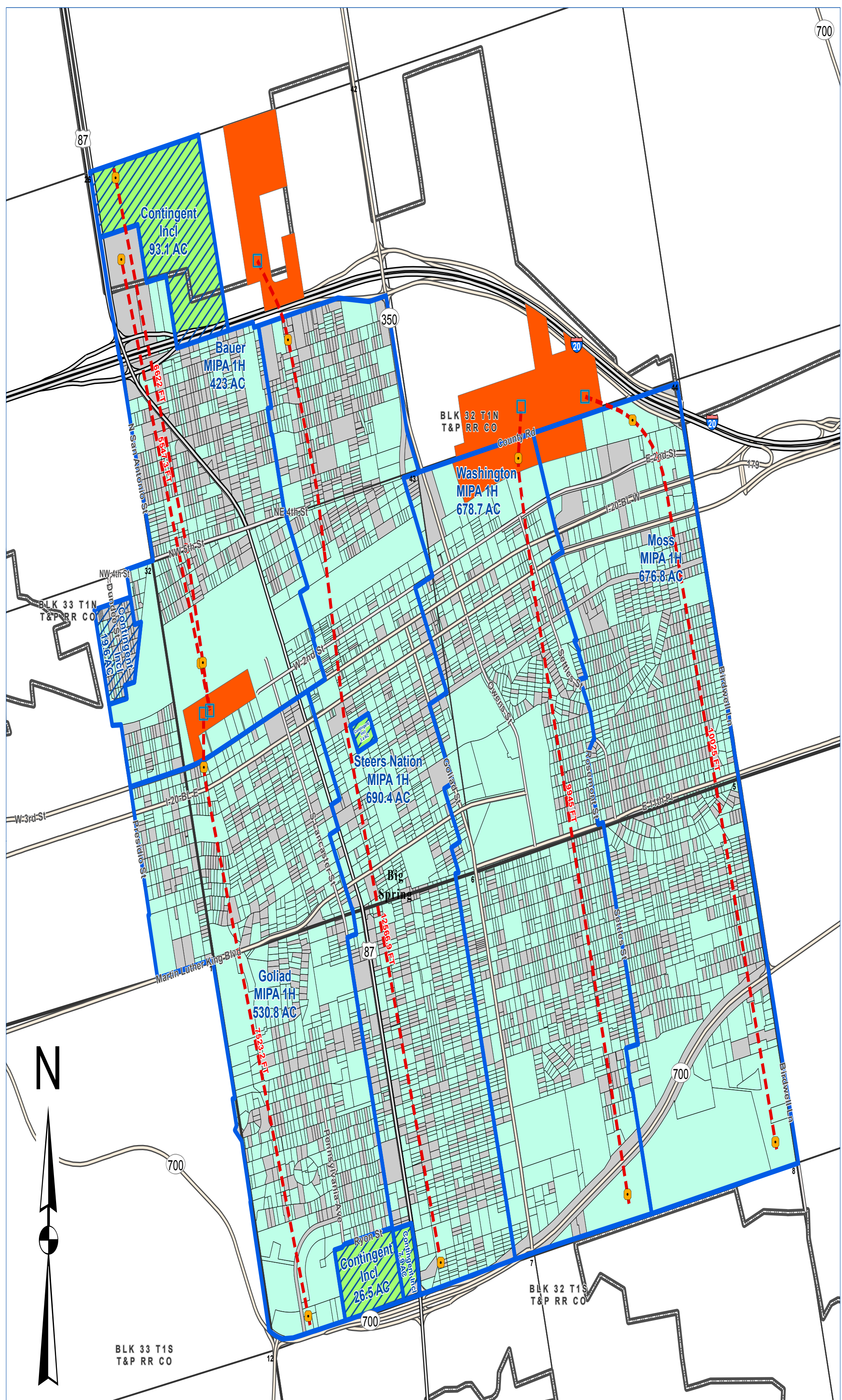



Losses mounting for Texas Rangers in lineup, standings

ARLINGTON, Texas (AP) — The Texas Rangers are mounting losses quickly for the Texas Rangers, both in the standings and their starting lineup.

By the time the Rangers finally had their first day off of the season Thursday, the last team in the majors to get a break, they were the first team with 10 losses.

They also found out they will be without No. 3 hitter and 10-season starting shortstop Elvis Andrus for 6 to 8 weeks because of a broken right elbow, though additional tests Thursday determined that he won't need surgery.

He was hit by a pitch on his throwing arm in the bottom of the ninth inning of their fourth straight loss, 7-2 to the Los Angeles Angels on Wednesday night.

"A freak deal ... not a whole lot you can do to prevent it," general manager Jon Daniels said. "Definitely an emotional one for all us to see him go down."

Andrus will go on the disabled list for the first time in his career before the series opener in Houston on Friday, when the Rangers plan to recall first baseman Ronald Guzman from Triple-A Round Rock. Guzman will be looking


to make his big league debut. Second baseman Rougned Odor (left hamstring) and center fielder Delino DeShields (left hand) are already on the DL, along with right-hander Doug Fister (right hip strain). DeShields has been out since March 31, while Odor and Fister went on the disabled list Tuesday.

"In the interim, there is a toughness that you have to have as a group, as a team, as an organization, to maneuver through things like this," manager Jeff Banister said. "Not just on the field, but off the field and where the mindset is at."
