the valuations, which many feel are unreasonably high. Ryan is the brother of Brint Ryan, owner and renovator of Big Spring's Settles Hotel.

"It makes me feel better that this lawyer is a Big Spring native," Emerson said in the Facebook post. "We will be represented by the largest property tax litigation firm in the world. Yep, on the whole planet Earth. If we group together and fight these extreme valuations of our property then we have a

chance to win. This time we are not going to picket, cry, scream, get mad at innocent employees, or storm any offices.'

Emerson said that the meeting applies even for those whose property valuations did not increase this year. "For those of you who have not re-

ceived a notice, then your values may not have been raised this year. That does not mean this meeting does not concern you," he said in the Facebook post. "If your values jumped last year, or you feel as if your current value is unreasonable, then you too should at-

In the post, Emerson notes that he has invited the board of directors of the Howard County Appraisal District, the state-directed entity that sets property valuations; and the Appraisal Review Board, a group of citizens whose job is to resolve disputes between taxpayers and the appraisal district.

The public is also invited to ask questions and air their concerns.

"It's an informational meeting," he said. "I've invited all the taxing entity representatives, I've invited the tax appraiser, the tax appraisal board. I've invited everybody, because everybody kind of wants to hear their side of it."

Although the meeting is four hours long, Emerson said it's intended as a come-and-go event.

"It's a rotating meeting," he said. "You come in and get the gist and leave when you're done. There is a PowerPoint presentation that Kory's putting on, and it will be set up to facilitate people getting signed up with

'Truth prevails': Cosby accuser hails guilty verdict

NORRISTOWN, Pa. (AP) — The woman Bill Cosby was convicted of sexually assaulting tweeted "Truth prevails" Friday, the morning after a jury came back with a verdict that could send the 80-year-old comedian to prison for the rest of his life.

After decades of whispers, lawsuits, investigations and close calls, Cosby was found guilty Thursday of drugging and molesting Temple University employee Andrea Constand at his suburban Philadelphia mansion in January 2004. The ruling was hailed by women's advocates as a turning point in the #MeToo movement and was seen as vindication by a multitude of women who doubted anyone would ever believe their word against that of America's Dad.

Lili Bernard, who said Cosby sexually assaulted her before giving her a one-time role on "The Cosby Show" in 1992, became so emotional in the courtroom gallery that she accidentally banged her forehead on the bench in front of her.

"I'm overcome with gratitude," Bernard, sobbing, said outside the courthouse. "I feel like I have to pinch myself. Am I awake? It's a miracle."

The verdict in the first big celebrity trial of the #MeToo era sealed the spectacular late-in-life downfall of an entertainer who broke racial barriers in Hollywood on his way to TV superstardom as sweater-wearing, wisdomdispensing Dr. Cliff Huxtable.

tions," Constand said on Twitter. "Truth prevails."

It was the only criminal case to arise from a barrage of allegations from more than 60 women who said Cosby drugged and molested them over five decades but whose stories were often disbelieved or ignored years before #MeToo put a spotlight on sexual misconduct by powerful men.

Cosby stared straight ahead as the verdict was read but moments later lashed out loudly at District Attorney Kevin Steele after the prosecutor demanded Cosby be sent immediately to jail. Steele told the judge they'd learned through the trial that Cosby has an airplane, and feared he could

Cosby angrily denied he has a plane and called Steele an "a--hole," shouting, "I'm sick of him!"

Judge Steven O'Neill decided Cosby can remain free on \$1 million bail while he awaits sentencing but restricted him to Montgomery County and the mansion where the encounter with Constand occurred.

Cosby was convicted of three counts of aggravated indecent assault, each carrying a standard sentence of five to 10 years in prison. The counts are likely to be merged for sentencing purposes, but given Cosby's age even a modest term could mean he will die behind bars.

Cosby accuser Janice Baker-Kinney, who alleges he drugged and raped her in 1982, told ABC's "Good Morning America" on Friday that it is essential Cosby spend time in jail. She said she wouldn't be heartbroken if he spent the rest of his life in jail and even died in prison.

Sentencing will likely be held within three months. Before that, Cosby

Cosby spokesman Andrew Wyatt told "GMA" on Friday that Cosby is feeling great on day after the verdict. He said Cosby was spending time with his wife of 54 years, Camille, is confident that he did nothing wrong and maintains his inno-

Constand, a 45-year-old Temple University women's basketball administrator, said Cosby knocked her out with three blue pills he called "your friends" and then penetrated her with his fingers as she lay immobilized, unable to resist or say no. Cosby claimed the encounter was consensual, saying he gave her the cold and allergy medicine Benadryl

Cosby waved to the crowd outside the courthouse, got into an SUV and left without saying anything. His lawyer Tom Mesereau declared "the fight is not over" and said he will appeal.

Shrieks erupted in the courtroom when the verdict was announced, and some of Cosby's accusers whimpered and cried. Constand remained stoic, then hugged her lawyer and members of the prosecution team.

The verdict came after a two-week retrial in which prosecutors had more courtroom weapons at their disposal than they did the first time: They put on the stand five other women who testified that Cosby, married for 54 years, drugged and violated them, too.

At Cosby's first trial, which ended in a deadlocked jury less than a year ago, only one additional accuser was allowed to testify.

"Justice has been done!" celebrity attorney Gloria Allred, who represented some of Cosby's accusers, said on the courthouse steps. "We are so happy that fi-

Cosby "was a man who had evaded this moment for far too long," Steele said. "He used his celebrity, he used his wealth, he used his network of supporters to help him conceal his crimes."

He added: "Now, we really know today who was really behind that act, who the real Bill Cosby was."

Since Cosby's first trial, the #MeToo movement has taken down powerful men in rapid succession, among them Harvey Weinstein, Matt Lauer, Kevin Spacey and Sen. Al Franken. During closing arguments, Cosby's lawyers slammed #MeToo, calling Cosby its victim and likening it to a witch hunt or a lynching.

Cosby's new defense team, led by Mesereau, the celebrity attorney who won an acquittal for Michael Jackson on child-molestation charges, launched a ferocious attack on Constand during the trial, calling her a "con artist" and "pathological liar" who framed Cosby to get rich.

Cosby's defense team derided the other accusers as home-wreckers and suggested they made up their stories in a bid for money and fame.

But Cosby had long ago confirmed some of the rumors about drugs and extramarital sex. In a deposition he gave more than a decade ago as part of Constand's lawsuit, he acknowledged he had obtained quaaludes to give to women he wanted to have sex with.

A federal judge, acting on a request from The Associated Press, unsealed portions of Cosby's deposition about quaaludes and sexual conquests in 2015, citing the disconnect between Cosby's private behavior and his reputation as a public moralist.

That prompted authorities to reopen the criminal investigation, and they eventually brought charges.

The Associated Press does not typically identify people who say they are victims of sexual assault unless they grant per-

Lynching memorial and museum in Alabama draw crowds, tears

MONTGOMERY, Ala. (AP) – Tears and expressions of grief met the opening of the nation's first memorial to the victims of lynching Thursday in Alabama.

The National Memorial for Peace and Justice commemorates 4,400 black people who were slain in lynchings and other racial killings between 1877 and 1950. Their names, where known, are engraved on 800 dark, rectangular steel columns, one for each U.S. county where lynchings occurred. A related museum, called The





Then the disciples came and said to him, "Do you know that the Pharisees were offended when they heard this saying?" He answered, "Every plant that my heavenly Father has not planted will be rooted up. Let them alone; they are blind guides. And if the blind lead the blind, both will fall into a pit." But Peter said to him, "Explain the parable to us." And he said, "Are you also still without understanding? Do you not see that whatever goes into the mouth passes into the stomach and is expelled? But what comes out of the mouth proceeds from the heart, and this defiles a person. For out of the heart come evil thoughts, murder, adultery, sexual immorality, theft, false witness, slander. These are what defile a perdoes not defile anyone." (ESV)

What is Jesus talking about here? His point is that God looks at your heart. The Pharisees and scribes were the religious bunch. They looked religious. They spoke religious. They acted religious. They had the external things mastered. Their checklists were longer than others' and they were all checked off. Their problem was that their hearts were not right (look back at Matthew 15:8). We can get too comfortable with just checking things off the list when it comes to religion. Is it easier to show up for worship, mumble through a few songs, pinch off a piece of cracker and take a sip of juice, put some money in the plate, and listen to some guy ramble on for several minutes, or love the Lord your God with all your heart, mind, soul, and strength? (I hope that does not describe your attitudes nor actions dur-

trying to illustrate the point.)

do good, religious things all the time but if our hearts are corrupt and evil, then all those things will profit us nothing. Paul makes that point in 1 Corinthians 13:1-3. I can say all the "right" things, believe all the "right" things, and do all the "right" things but if I don't have love, then all of it is worthless to me.

Once we submit our lives to God and Christ, then the proper actions should follow. When we give our hearts to God, we will desire to do the things God wants us to do. Titus 2:11-12, For the grace of God has appeared, bringing salvation for all people, training us to renounce ungodliness and worldly passions, and to live self-controlled, upright, and godly lives in the present age (ESV).

Just like the old hymn would ask, "Is your heart right with God, washed in the crimson flood, cleansed and made holy, humble and lowly, right in the sight of God?"

Reflections: Escaping the Image Makers

Christine Rosen, writing in The New Atlantis, stated, "Americans love images. We love the democratiz-

ing power of technologies - such as digital cameras, video cameras. Photoshop, PowerPoint — that give us the capability to make and manipulate images. What we are less eager to consider are the broader cultural effects of a society devoted to the image."

Images for idol worship have always been about manipulation, at-

tempts to manipulate gods to control our circumstances and to control others around us. Our current image culture is no different. We create images to control our destinies and to control others. Idolatry is about manipulation. But, God will not be manipulated. He will not be used for our personal advancement or the control of other people.

We have become a people controlled by images.

The recent controversies over Facebook and Russian interference through the manipulation of social media is a case in point. Images make a difference. They influence our thinking and our action. We are bombarded constantly on smart phones, tablets, TVs and laptops. Some have linked the recent rise in teen suicides with the surge in social media. This is why God gave us the second

of the Ten Commandments, "You shall not make for yourself an image in the form of anything in heaven above or on the earth beneath or in the waters below. You shall not bow down to them or worship them." (Ex-

God wants to free us from the image-make3rs who seek to control our minds and distort our values.

The image culture invades our churches when we assume that worship requires the assistance of sound systems, amplifiers, video screens, special lighting and special effects, when we create our own Christian pop-culture complete with celebrities. We ought to be reminded that in Jesus' day authentic worship took place on hillsides, seashores, and in houses where two or three were gathered together in His Name.

The author of creation made us in His own image. When we know Him we are truly free to know ourselves and others as we truly are, created in His image with unlimited potential for love and good works. For this reason God sent His Son, so that we might know the only image that can set us free. "He is the image of the invisible God, the first-born of all creation." (Colossians 1:15).

This is the definition of sin: attempting to live life on our own terms in our own image and becoming addicted to our man-made idols. N.T, Wright put it this way, "Since sin, the consequence of idolatry, is what keeps humans in thrall to the non-gods of the world, dealing with sin has a more profound effect than simply releasing humans to go to heaven. It releases humans from the grip of the idols, so they can worship the living God and be renewed according to his image."

When we believe in Jesus and place our trust in Him, we are empowered to become like Him. We are set free from the image makers that lead down paths of addiction and depression. "Those whom He foreknew he predestined to be conformed to the image of His Son." (Romans 8:29).


Singh took the loss for Anthony. She allowed 14 hits and 16 runs over four innings, walking one.



- notrump-oriented and some players might be tempted to bid two notrump. it is better to bid one heart. This is in keeping with the general principle that it is easier to make game in a major suit than in notrump if you have a combined holding of eight cards in the suit. Since partner may have four hearts, this possibility should be explored. If partner doesn't support hearts, you can bid notrump at your next turn. 2. Four spades. You'd hardly want
- to play this hand at any contract other than four spades, so you might as well bid it at once.

The leap to four indicates that your trumps are strong enough to justify a game in spades opposite a normal opening bid. Four spades is not a slam try. If you had potential slam values, you'd start by bidding one or two spades.

3. Ône diamond. You might con-

This gives you maximum space to operate in while you try to determine where the best game or slam contract lies. You plan to bid spades at your next turn if partner bids one heart over one diamond.

When you bid spades at your second turn, partner will know you have only four of them and will have a better idea of how to continue. You plan to show your club support later if the bidding develops favorably, and in that way pinpoint your shortness in hearts.

4. Three notrump. This is a "picture bid" showing 16 or 17 points, nearly always 4-3-3-3 distribution, strength in the unbid suits and no four-card major. In effect, the leap to three notrump indicates the values for an opening one-notrump bid.

There is not much point in responding one diamond when a different is available that, in one fell swoop, perfectly describes your hand. The opening bidder is free to go on or not, as he sees fit, knowing almost exactly what the hand opposite him looks like.



On April 27, 1968, Vice Hubert President Η. Humphrey declared his candidacy for the Democratic nomination for president, less than a month after President Lvndon B. Johnson said he would not run for re-election. On this date:

In 1521, Portuguese explorer Ferdinand Magellan was killed by natives in the

Philippines. In 1777, the only land battle in Connecticut during the Revolutionary War, the Battle of Ridgefield, resulted in a

limited British victory In 1822, the 18th president of

the United States, Ulysses S. Grant, was born in Point Pleasant, Ohio. In 1865, the steamer Sultana,

carrying freed Union prisoners of war, exploded on the Mississippi River near Memphis, Tennessee; death toll estimates vary from 1,500 to 2,000.

In 1925, the song "Yes, Sir! That's My Baby" by Walter Donaldson and Gus Kahn was published by Irving Berlin, Inc. of New York.

In 1938, King Zog I of the Albanians married Countess Geraldine Apponyi de Nagy-Apponyi.

In 1941, German forces occupied Athens during World

War II. In 1950, Britain formally recognized the state of Israel.

1967, In Canada's International and Universal Exhibition, also known as "Expo 67," began a six-month run as it was officially opened in Montreal by Canadian

Prime Minister Lester B. Pearson. In 1978, 51 construction workers plunged to their deaths when a scaffold inside

a cooling tower at the Pleasants Power Station site in West Virginia fell 168 feet to ground. Convicted Watergate defendant John D. Ehrlichman was released from an Arizona prison after serving 18 months.

In 1982, the trial of John W. Hinckley Jr., who shot four people, including President Ronald Reagan, began in Washington. (The trial ended

with Hinckley's acquittal by reason of insanity.) In 1992, the new Federal Republic of Yugoslavia was proclaimed in Belgrade by the republic of Serbia and its lone

ally, Montenegro. Russia and 12 other former Soviet republics won entry into the International Monetary Fund and the World Bank. Betty Boothroyd became the first female Speaker of Britain's House of Commons.

Ten years ago: Afghan President Hamid Karzai (HAH'-mihd KAHR'-zeye) escaped an attempt on his life during a ceremony in Kabul marking Afghanistan's victory over Soviet occupation in the 1980s; three other people were killed in the rocket and rifle attack claimed by the Taliban. Ashley Force, 25, became the first woman to win a national Funny Car race as she beat her father, drag racing icon John Force, in the final round of the 28th annual Summit Racing Equipment Nationals in Southern Commerce, Georgia.

Five years ago: North Korea announced that Kenneth Bae, an American missionary detained for nearly six months, was being tried in the Supreme Court on charges of plotting to overthrow the government (Bae was later sentenced to 15 years of hard labor; he was released in November 2014 along with another American, Matthew Miller). Center-left leader Enrico Letta forged a new Italian government in a coalition with former Premier Silvio Berlusconi's conserva-

tives. One year ago: David Dao, the airline passenger who was violently dragged off a flight after refusing to give up his seat, settled with United for an undisclosed sum; cellphone video of the April 9 confrontation aboard a jetliner at Chicago's O'Hare Airport had sparked widespread public outrage over the way Dao was treated. About 20 hours after he fatally shot a state trooper, a Delaware man was shot to death following an overnight standoff with police. Texas A&M defensive end Myles Garrett was picked first overall by the Cleveland Browns in the NFL Draft.

After night of QBs in NFL draft, proving ground ahead

ARLINGTON, Texas — Now that the Great QB Grab of 2018 is over, what's ahead for the five firstround quarterbacks selected might be more daunting than getting selected on opening night of the

When NFL teams get desperate at the position, they tend to reach. Or mortgage portions of their future. Or sometimes simple blow it.

Of course, in many other instances, they nail it, from top overall selections Eli Manning, Cam Newton and Andrew Luck to wise lower picks on the first night such as Ben Roethlisberger, Matt Ryan and, yes, Aaron Rodgers.

It really is a crapshoot.

"Everybody's draft board is set up differently, and when I recite to you all the best available player in this draft for the Cleveland Browns organization, this was the best available player," general manager John Dorsey said of taking Heisman Trophy winner Baker Mayfield of Oklahoma to begin proceedings. "What he brings to this organization, I couldn't be more excited to have him. Those other guys are really good quarterbacks, too, but I just felt that this was the best fit for this organization moving forward.'

As the New York Jets felt with Southern California's Sam Darnold; the Buffalo Bills with Wyoming's Josh Allen, for whom they traded up five spots with Tampa Bay to get; the Arizona Cardinals with Josh Rosen of UCLA, also by using a trade, with Oakland; and the Baltimore Ravens, who concluded Round 1 with - you guessed it - a deal with Philadelphia so they could grab 2016 Heisman recipient Lamar Jackson of Louisville.

Five QBs, the most since the 1999 draft and second to the epic 1983 first round that produced three Hall of Famer quarterbacks (John Elway, Jim Kelly, Dan Marino) of the six QBs selected.

On Thursday, as the five teams with new signal callers looked ahead, all they saw and spoke about was sunshine and success.

"We feel he has a very, very bright future," Jets GM Mike Maccagnan said of Darnold, "and really when you put the whole thing together with quarterbacks, you analyze them from an ability standpoint, you analyze them from a character standpoint, and then you see what you think they can grow into, and we felt very good about Sam from that standpoint."

So what are the challenges ahead for these five potential franchise quarterbacks?

BROWNS

History certainly plays a role here. Since reentering the NFL in 1999, the Browns haven't had anything more than stopgap QBs. That's almost two decades of searching, with the last two seasons' record of 1-31 as abysmal as it gets.

Enter Mayfield, who eventually should beat out newly acquired veteran Tyrod Taylor, if not immediately.

Dorsey adeptly evaluated the pros about May-

"It is a combination of things. I talk about hand size; he has 9 6-8th (inch) hands. ... That is good for the elements in November and December. He has feet to extend the play. He has really good accuracy. He has a quick release. He has a strong arm. His efficiency in the red zone offense is uncanny.

"You know what else separates him? He is hungry. He wants to be a really good football player, and he is going to be a really good football player."

Mayfield also is short for the position at just over 6-foot. He has to adjust to the pro-style offense of coach Hue Jackson. He must show he can take the kind of hits college players couldn't deliver but the pros do regularly.

And while teammates adore him for his leadership skills, there's also a cockiness and borderline rebelliousness that can take a player (and team) in several directions, not all of them positive.

JETS

Size is no issue with Darnold. Nor are arm strength or competitiveness.

Like Mayfield, he can sit behind a veteran, Josh McCown, who is a good teacher, though that won't be for too long, either.

What must be cured is Darnold's penchant for turnovers and sloppy plays.

"Obviously, we don't want turnovers on any level," coach Todd Bowles said, "but we think his upside and his ability far outweighs the turnovers. And sometimes just trying to do too much, sometimes trying to make the wrong reads and things he can learn from. Getting to know him, we think those things can be corrected, and I know just talking with him personally those things can be corrected."

Allen might have a higher ceiling than any of the QBs taken Thursday. He's tall and solid and won't be bothered by fall and winter weather in Western New York. He's smart, had a sensational offseason to boost his draft stock, and throws a terrific deep ball among the many spirals he unleashes.

Allen also comes from the Mountain West, not the highest level of college conferences, and his career completion percentage is a mere 56.2.

"We just think his makeup is going to help him work on his flaws," GM Brandon Beane says. "We like a lot of his strengths. And that'll be part of our

his fundamentals and the things that his so-called weaknesses are."

Buffalo has veteran AJ McCarron, an infrequent starter with Cincinnati before the Bills brought him aboard this year.

CARDINALS

All three of Arizona's 2017 quarterbacks were gone, most notably the retired Carson Palmer. Although the Cardinals signed Sam Bradford in free agency, it's conceivable Rosen will win the starting job. Indeed, many NFL personnel people rated him the most ready QB for the pros.

Rosen certainly has an edge, which cuts two ways. His competitiveness and desire to outdo anyone and everyone can be a major plus. It also can backfire and lead to impatience and bad decisions. He's also had some injury issues, including a con-

cussion. "To make a difference, you've got to be different," new coach Steve Wilks said. "I love his personality.


He's wired the right way." **RAVENS**

In some ways, this is as intriguing as any firstround selection.

Baltimore's starter, Joe Flacco, is diametrically opposite in style to Jackson. Where Flacco is anchored to the pocket, Jackson is a dynamo outside of it. Where Flacco is lead-footed, Jackson is a flash. Jackson's creativity with the ball works best in a different type offense than Flacco's strong-armed, tradition manner.

Like Mayfield, Darnold and possibly Allen, Jackson has the luxury of sitting behind a solid vet and a Super Bowl winner, don't forget — and learning the NFL game. His biggest challenge, a huge one, is adapting to a totally different scheme from the one he ran in college.

"Joe Flacco is our quarterback. That's the thing that you got to remember," coach John Harbaugh said. "Lamar is going to have a chance to develop."
