## Mom says Texas officer choked boy before aiming gun at kids

EL PASO, Texas (AP) — A mother has accused a West Texas police officer of choking her son before a video recording captured the officer pointing a gun at a group of children.

The video, which has been viewed millions of times online, shows an El Paso officer briefly pointing his weapon at a group of boys. One boy is heard cursing at the officer right before the officer draws his weapon.

Elizabeth Flores tells the El Paso Times the video started after the officer choked one of her sons and forced him to the ground. Flores says the video shows two of her sons being taken into custody.

A police spokesman previously said one minor and one adult were arrested following Thursday's confrontation.

City officials said Saturday that the incident is under investigation. The officer has been put on desk duty.

# Indiana attorney general says groping allegations are false

INDIANAPOLIS — Indiana Attorney General Curtis Hill defiantly rejected calls to resign on Monday, saying his name has been "dragged through the gutter," following allegations that he inappropriately touched a lawmaker and several female legislative staffers during a party.

The Republican said during a news conference where he did not take questions that he has been un-

fairly treated by lawmakers and the media, and stands "falsely and publicly accused of abhorrent behavior."

"These past several days and weeks, my name and reputation have been dragged through the gutter in ways that I would have never imagined. Apparently in this climate the standard is guilty and 'who cares if you're innocent?"" he said from a podium in his office. "A week ago today, I had a name.

back." The claims against Hill were made pub-

lic after an internal legislative memo detailing the allegations was leaked to the media last week. In it, a state lawmaker and three legislative staffers said Hill drunkenly groped them during a March party.

Democratic Rep. Mara Candelaria Reardon and Gabrielle McLemore, the Indiana Senate Democrats' communications director, came forward Friday saying they were among the victims.

Hill called the allegations "vicious and false" and said he looked forward to "the day when I can speak freely and answer questions." He didn't respond to shouted questions about whether he was calling the women liars.

In a statement released after the news conference, Candelaria Reardon fired back, saying that Hill was the one who had lied.

"Curtis Hill, through his actions, has betrayed the public trust and lied about his actions to the very citizens he serves," said Candelaria Reardon, of Munster. "I will continue to cooperate with any and all investiga-

# US says it will release, reunite 50 immigrant children

SAN DIEGO – At least 50 immigrant children under age 5 will be released with their parents by Tuesday's court-ordered deadline for the Trump administration to reunify families forcibly separated at the border, a government attorney said Monday.

That's only about half of the 100 or so children covered by the court order.

At a court hearing, Justice Department lawyer Sarah Fabian acknowledged the Trump administration won't meet the deadline for all the youngsters.

She said the government was still working to do background checks and confirm the relationships between the adults and children in its custody.

# Jubilation as 4 more boys rescued from flooded Thai cave

MAE SAI, Thailand (AP) – Eight of the 12 boys trapped in a flooded and labyrinth cave system in far northern Thailand are safe and recuperating in a hospital after another four were

brought out by divers on the second day of a high-stakes rescue operation, a top official said.

The boys brought out of the dark, winding cave on Monday are "safe and conscious," said Chiang Rai province acting Gov. Narongsak Osatanakorn, who is in charge of the rescue effort. Prime Minister Prayuth Chan-ocha was visiting all eight in the nearby hospital that they were helicoptered to, he said.

Monday's operation began at 11 a.m. and took nine hours, two fewer than Sunday, with rescuers helped bv the experience they've accumulated, Narongsak told a news conference punctuated with rounds of applause.

Brafman said he expects more criminal charges to be filed later, but didn't elaborate.

Weinstein previously forfeited his passport and is fitted with an electronic monitoring bracelet. He's also been ordered to stay away from the three women.

Prosecutors, saying the new charges were "significantly more serious," had sought to have Weinstein forced to move to Manhattan and placed on house arrest.

# Stocks jump again as tradewar worries take back seat

NEW YORK — Never mind the trade war. Here comes earnings season.

U.S. stocks climbed with other markets on Monday as concerns about trade tensions between the United States and the rest of the world took a back seat. The calendar for upcoming weeks is full of companies telling investors how much profit they made during the spring, and the expectation is for another quarter of gangbusters growth.

That plus Friday's report showing U.S. hiring remains strong have helped to support markets despite the world's two largest economies imposing dueling tariffs on each other at the end of last week.

The S&P 500 rose 24.35 points, or 0.9 percent, to 2,784.17. The Dow Jones industrial average jumped 320.11, or 1.3 percent, to 24,776.59, and the Nasdaq composite gained 67.81, or 0.9 percent, to 7,756.20.

It's the third straight day that the S&P 500 has climbed at least 0.8 percent. It follows a rocky few months where some investors sold stocks on the assumption that a full-blown, harmful trade war was a certainty. Others still expect negotiated settlements to be the final result.

"The market in the second quarter tried to price in this whole thing, and it was probably a little too fast for that," said Matthew Miskin, market strategist with John Hancock Investments. "There still are a lot of negative developments happening here, but before earnings season typically tends to be a sweet spot for the market. "

Stocks often rise in anticipation of healthy earnings reports, Miskin said, and the results for this latest quarter are forecast to be much stronger than usual for companies this many years into an economic expansion.

Across the S&P 500, analysts are calling for 19 percent growth in earnings per share from a year earlier, according to S&P Global Market Intelligence. Lower tax rates and stronger revenues are helping to drive the gains.

today we won this round," Brafman said afterward.

Weinstein, 66, hobbled into the courtroom with his hands cuffed behind his back. He was uncuffed for the proceeding and didn't say much other than entering his plea.

He left court a few minutes later, trailed by a bulky bodyguard. Weinstein suddenly turned back in a panic about the whereabouts of his wallet. Brafman later said he'd found it.

Weinstein's new charges include two counts of predatory sexual assault, which carries a maximum sentence of life in prison upon conviction. Manhattan District Attorney Cyrus R. Vance Jr. said they are "some of the most serious sexual offenses" that exist under state law.

Attorney Gloria Allred, who is representing the woman whose allegations led to the new charges, said her client will testify if the case goes to trial. She said she doubted Weinstein would do the same.

"Are you really willing to have your client face the jury?" Allred said outside the courthouse. "I doubt that you will take that risk, Mr. Brafman." The growth may be peaking, however. Perhaps more important than the numbers for last quarter will be what CEOs say in conference calls about how much the trade tensions will hurt their profits later in the year.

"It's hard to not see it being an issue that hurts margins," Miskin said.

Citigroup, JPMorgan Chase and Wells Fargo are among this week's headliners, and all three are reporting their results on Friday.

Bank stocks were also among the market's biggest winners on Monday. Financial stocks in the S&P 500 jumped 2.3 percent for the largest gain among the 11 sectors that make up the index.

They rose with Treasury yields, which can translate into bigger profits for banks by enabling them to charge higher rates for mortgages and other loans.

The yield on the 10-year Treasury note climbed to 2.86 percent from 2.82 percent late Friday.

On the flip side, higher interest rates can lure buyers away from high-dividend stocks because they become more interested in bonds. That led to losses for telecoms and real-estate investment trusts. Utilities were the worst-performing area of the S&P 500 and dropped 3.1 percent.

Among other market winners was Helen of Troy, which surged 12.7 percent to \$114.85 after the consumer-products company reported stronger revenue for the spring, with particularly solid growth in

On July 10, 1940, during World War II, the Battle of Britain began as the Luftwaffe started attacking southern England. (The Royal Air Force was ultimately victorious.)

On this date:

In 1509, theologian John Calvin, a key figure of the Protestant Reformation, was born in Noyon, Picardy, France.

In 1890, Wyoming became the 44th state.

In 1919, President Woodrow Wilson personally delivered the Treaty of Versailles (vehr-SY') to the Senate and urged its ratification. (However, the Senate rejected it.)

In 1925, jury selection took place in Dayton, Tennessee, in the trial of John T. Scopes, charged with violating the law by teaching Darwin's Theory of Evolution. (Scopes was convicted and fined, but the verdict was overturned on a technicality.)

Brafman identified her in court as a former film production assistant who went public last October with allegations that Weinstein forcibly performed oral sex on her in 2006 at his Manhattan apartment.

The Associated Press generally does not identify people who say they are victims of sexual assault unless they consent to being identified publicly. Allred said her client is "not going to be giving any interviews and she'd like to maintain her privacy."

More than 75 women have accused Weinstein of wrongdoing as allegations detailed in Pulitzer Prize-winning stories last October in The New York Times and The New Yorker magazine swelled into the #MeToo movement.

Only three complaints have led to criminal charges so far. In addition to the assault claim that brought him to court Monday, Weinstein is accused of raping an unidentified woman in a hotel room in 2013 and forcing a former actress, Lucia Evans, to perform oral sex at his office in 2004. Evans was one of the first women to accuse Weinstein publicly last fall.

Weinstein, who produced movies including "Pulp Fiction" and "Shakespeare in Love," has denied all allegations of nonconsensual sex, with Brafman challenging the credibility of his accusers and the reporting that led to his downfall.

"If we allow Pulitzer-driven reporters to decide this case, then it could be hopeless," Brafman said. "God help all of us if that's how the criminal justice system

from across the globe traveling to this town along the border with Myanmar to report on the ordeal.

Authorities have said extracting the entire team from the cave could take up to four days, but two straight days of success raised hopes that it could be done faster.

Monday's mission involved 18 divers from Thailand and abroad.

Narongsak said rescuers would meet Monday evening to plan for the next operation. "We believe that we can do even better and it will be a 100 percent success," he said.

"The divers that were assembled from many countries are proud to have conducted this operation until its success," Narongsak said. "Some of them had gone to

rest, some others are preparing for the next operation."

The perilous rescues have involved two divers accompanying each of the boys, all of whom have been learning to dive only since July 2, when searchers found them.

Cave rescue experts have said they consider an underwater escape to be a last resort, especially with people untrained in diving.

The death Friday of a former Thai navy SEAL underscored the risks. The diver, the first fatality of the rescue effort, was working in a volunteer capacity and died on a mission to place air canisters along the passage to where the boys are, necessary for divers to safely travel the five- to sixhour route.

There were several concerns that prompted authorities to move forward with the plan to dive the boys out. One was that it was unknown how safe and dry the area where they had taken shelter would stay as Thailand's rainy season, which lasts until at least late October, picks up pace.

The other, and perhaps more worrying, was that oxygen levels in the complex were falling close to dangerous levels.



# Montas, Piscotty help A's blank Astros 2-0

So when Oakland's starter threw a perfect first against the defending World Series champion Houston Astros on Monday night, it was just the confidence boost he needed to get back on track and turn in a strong start.

Montas and two relievers combined for a fivehitter, Stephen Piscotty homered and hit an RBI single and the Athletics beat the Astros 2-0.

It took the 25-year-old Montas just eight pitches to retire All-Stars George Springer, Alex Bregman and Jose Altuve in the first.

"You go up against Springer, Bregman and Altuve and go 1-2-3, I bet you that gives you some confidence," Piscotty said of Montas. "They're a great

yielding 17 hits and nine runs combined in his last two starts.

"He was great," manager Bob Melvin said. "He had that look about him again tonight where he was competing and he was in charge and looked like he was really confident. When he first came up he had that same look and he's had a couple tougher games along the way, but from the beginning today he had that look in his eye again like he was really competing out there."

Lou Trivino struck out three in two perfect innings before closer Blake Treinen allowed two singles in the ninth, striking out Evan Gattis for his 23rd save to help Oakland improve to 35-0 this season when leading after seven innings. It's the 20th straight save opportunity he's converted dating to May 4. Marwin Gonzalez walked with two outs in the second inning, but Houston didn't get a hit until a single by Altuve with one out in the fourth. But he was soon erased when he took second and tried to reach third on a wild pitch, and Montas struck out Josh Reddick to end the inning. Houston had just one hit in the sixth inning before Springer and Bregman hit consecutive singles. Montas was able to escape the jam when Altuve grounded into a double play. Cole retired the first eight batters before Jonathan Lucroy's single with two outs in the third inning. Cole walked Jed Lowrie with two outs in the sixth before an infield single by Khris Davis. But he struck out Matt Olson to end the threat.

# Migration, outreach means diversity is soccer's new normal

PARIS — When France's xenophobic fringes disparage the country's diverse World Cup team as more African than European, fans say, "So what?" And then respond with a resounding "Allez les Bleus!"

At a time when populist politicians are trying to choke off or reroute migration flows, what matters to fans of the teams that made the semifinals – England, France, Belgium and Croatia — wasn't the players' ancestry but that they excelled on the field.

Yes, the French team has roots stretching across borders, seas and hemispheres, tracing histories of colonization and the paths of migration that shaped today's world. But nearly all of its players were born and raised in France.

And Tuesday they face a semifinal match against Belgium, whose country took inspiration from France's multi-ethnic 1998 winning team and has used soccer as a tool for integration and a ladder out of poverty.

Belgium striker Romelu Lukaku embodies that philosophy.

"I'll start a sentence in French and finish it in Dutch, and I'll throw in some Spanish or Portuguese or Lingala, depending on what neighborhood we're in," he wrote in The Player's Tribune. "I'm Belgian. We're all Belgian. That's what makes this country cool, right?"

When England faces Croatia in the other semifinal match on Wednesday, it will field a team that coach Gareth Southgate says "represents modern England." With 11 of 23 players of African or Caribbean descent, it's the country's most diverse national team yet. Several Croatian players were also foreign-born.

Europe has been enjoying the benefits of migration for centuries, and the diverse rosters at latest example.





This approach guarantees the contract even if West wins the trick with the jack. (South would then score four diamonds, two clubs and three spades after conceding a trick to West's king.) Of course, if East covers the ten with the jack. South wins with the queen, thus assuring five diamond tricks whether West follows suit or not.



In 1890, Wyoming became the 44th state.

In 1919, President Woodrow Wilson personally delivered the Treaty of Versailles (vehr-SY') to the Senate and urged its ratification. (However, the Senate rejected it.)

In 1925, jury selection took place in Dayton, Tennessee, in the trial of John T. Scopes, charged with violating the law by teaching Darwin's Theory of Evolution. (Scopes was convicted and fined, but the verdict was overturned on a technicality.)

In 1989, Mel Blanc, the "man of a thousand voices," including such cartoon characters as Bugs Bunny, Daffy Duck and Porky Pig, died in Los Angeles at age 81.

In 1991, Boris N. Yeltsin took the oath of office as the first elected president of the Russian

overhauling rules about government eavesdropping and granting immunity to telecommunications companies that helped the U.S. spy on Americans in suspected terrorism cases. The Senate handily confirmed Gen. David Petraeus as the top commander in the Middle East. In a first, the Navy succeeded in landing a drone the size of a fighter jet aboard an aircraft carrier, the USS George H.W. Bush, off the Virginia coast. David Ortiz doubled in his first at-bat to become baseball's career leader in hits as a designated hitter and hit a two-run homer an inning later, leading the Boston Red Sox to an 11-4 victory over Seattle.

One year ago: Donald Trump Jr. acknowledged that he agreed to meet with a Russian lawyer during his father's presidential campaign in the hope that he would receive information about Democrat Hillary Clinton. Fifteen Marines and a Navy corpsman were killed in the crash of a Marine Corps refueling and cargo plane in a soybean field in Mississippi.

# Roger, Serena, Rafa bring best to Wimbledon's Centre Court

LONDON — They roared for Roger Federer just for showing up, greeting his arrival at Wimbledon's main stadium as if his mere presence were enough to justify the price of admission.

They clapped and yelled when Federer's drop volley capped a 16-minute tour de force of a first set in which he won 21 of the first 23 points.

They eventually sent him back to the locker room with a standing ovation, acknowledging the talent displayed by Federer during a 6-0, 7-5, 6-4 victory over 22nd-seeded Adrian Mannarino of France in the fourth round Monday, yes, but also his superiority over the course of a career that has produced eight Wimbledon championships and 20 Grand Slam titles, both records for a man.

Federer, who has won 32 consecutive sets at the tournament and held serve 81 games in a row, was asked whether he paused for even a moment to wonder why he wasn't being given more of a test.

"Not really," said Federer, the No. 1 seed. "I'm telling myself, 'Why didn't I break the first game of the second?"

His mastery was only the beginning of things for those who spent 120 pounds (about \$160) to be at Center Court and were afforded the rare treat of watching three of the greatest to ever lift a tennis racket.

Federer was followed by Serena Williams, she of the seven Wimbledon trophies among her 23 majors, who was hardly challenged in a 6-2, 6-2 win against 120th-ranked qualifier Evgeniya Rodina of Russia. And Williams was followed by Rafael Nadal - two titles at Wimbledon, 17 at all Slams — who dispatched 93rd-ranked Jiri Vesely of the Czech Republic 6-3, 6-3, 6-4.

The only other Wimbledon champion left in either bracket, Novak Djokovic, beat 40th-ranked Karen Khachanov 6-4, 6-2, 6-2 on No. 1 Court, then said he'd like to get as much time on Centre Court as Federer and Nadal do.

Was Mannarino intimidated by playing in that hallowed arena?

"The fact that it is the Centre Court, and the fact that it is a lot of people in the stands — it's not changing anything, actually. The only different thing is that it's Federer in front of me, and he's a really good opponent. It makes the job harder," Mannarino said. "This is what is not easy to handle.'

He showed up wearing a plain white T-shirt, bereft of any obvious sponsor's logos, looking like someone out for a casual hitting session in a public park. At least it appeared to be the right size. What a difference from a week ago, when Federer's debut of new duds after splitting from Nike drew so many headlines.

It took Mannarino so much toil and trouble to win one game, saving four break points to hold to begin the second set. He was able to tread water until 5-all, when Federer returned a 123 mph serve, quickly gained control of a baseline exchange, then hopped and screamed, "Come on!" as a backhand flew long for the break. Federer also broke, then held to end the match.

"I think," Federer said when it was over, "I can be very pleased."

The women's quarterfinals are Tuesday, with Williams vs. Camila Giorgi, two-time major champion Angelique Kerber vs. No. 14 Daria Kasatkina, 2017 French Open champion Jelena Ostapenko vs. Dominika Cibulkova, and No. 13 Julia Goerges vs. No. 20 Kiki Bertens.

On Wednesday, Federer will play No. 8 Kevin Anderson, a South African who was the 2017 U.S. Open runner-up and advanced with a 7-6 (4), 7-6 (2), 5-7, 7-6 (4) victory over Gael Monfils.

"I mean, I'm definitely going to have to look at it the right way. I think the right way of looking at it is: It's an opportunity to test myself against a player of Roger's caliber," said Anderson, who is 0-4 against Federer. "These are the matches we work so hard for, me and my whole team."

The other matchup on the top half of the draw is No. 9 John Isner against No. 13 Milos Raonic, who beat Federer in the 2016 semifinals before losing in the final.

On the bottom half of the bracket, it'll be 12-time major champion Djokovic against 2014 U.S. Open runner-up Kei Nishikori, and No. 2 seed Nadal against either 2009 U.S. Open champion Juan Martin del Potro or Gilles Simon. Del Potro was leading Simon two sets to one when their match was suspended because of darkness Monday night.

Anderson, Isner and Nishikori all reached the Wimbledon quarterfinals for the first time.

For Nadal, this marks a return. He hadn't been this far at the All England Club since 2011, losing to men ranked 100th or worse on four of his past five appearances.

"It's true, it has been a while," Nadal said. "But when I come here, I come here thinking that I can do a good result, no?"

"Football allows us to put immigration on stage, a question that is agitating European countries right now," said Yvan Gastaut, a University of Nice historian who curated an exhibit on soccer and migration. "For people who see immigration as a danger, this World Cup story won't resolve that. But it allows us to take stock of the reality of the world, of mobility, movements, multiple identities."

Soon, he predicts, European countries will reach a point where diverse team rosters don't matter, and "we can focus on something else other than what are our origins."

That seems a distant dream in some quarters. France has always been a melting pot, and today you can have a croissant for breakfast, West African maafe stew for lunch and couscous for dinner. But poverty, prison and unemployment disproportionately touch those with Arab or African last names

That's why it's worth noting the Algerian-Cameroonian roots of France's 19-year-old breakout star Kylian Mbappe, argues Laurent Dubois, a Belgian-American historian at Duke University.

"It at least offers a sense that migration is helping. Look, we're stronger because we have all these people. ... Players with all these different stories united in this kind of flow. There's nothing wrong with seeing that as a symbol and celebrating it," he said. If national teams show unity in diversity, "then maybe society can do that in other realms, too."

It's a message that reaches all the way to Africa, where many are turning far-right racist comments about non-white players in Europe on their heads, and are waving the European teams' African connections as a banner of continental pride after their own teams were eliminated.

"I think the presence of players of African origin will push some French people who are against im-



The victory of France's 1998 team — celebrated for its "black-blanc-beur," or black-white-Arab makeup — was a turning point, becoming a potent anti-racist symbol and serving as an example to other European countries.

But it didn't magically change France. Some players complain that it created an unfair pressure on minorities to win the World Cup to be accepted as a success.

# 'Ant-Man and the Wasp' **buzzes to \$76 million debut**

NEW YORK — Despite its heroes' diminutive size, "Ant-Man and the Wasp" opened with typical Marvel might at the box office, with an estimated \$76 million in ticket sales.

According to studio estimates Sunday, the "Ant-Man" sequel easily surpassed the \$57 million debut of the 2015 original in North America. The 20th film in the Marvel Cinematic Universe — and the 20th to debut no. 1 at the box office — "Ant-Man and the Wasp" comes on the heels of two mammoth Marvel successes this year: "Black Panther" and "Avengers: Infinity War."

While the first "Ant-Man," starring Paul Rudd, had a rocky road to release due to a late director change, the rollout of the sequel, directed by Peyton Reed, was smoother. Cathleen Taff, head of distribution for Disney, credited a marketing campaign that played up the film as a more modest, funny and light-hearted change-of-pace for Marvel following the grandiosity of "Infinity War."

"It came in solidly within of our range and definitely sized-up the sequel," said Taff. "Ant-Man and the Wasp," with a reported production budget of about \$160 million, may have performed well enough to firmly establish its place among Marvel's more main-line superheroes. Reviews were good (86 percent fresh on Rotten Tomatoes) and audiences gave it an A-minus CinemaScore. Ticket sales overseas added another \$85 million. Befitting the summer season, the weekend's top five films were all sequels. The weekend's other new wide release was Blumhouse Productions' "The First Purge," the fourth film in the low-budget horror franchise about an annual 12-hour period of lawlessness. With July 4th falling on a Wednesday and thus depriving Hollywood of a holiday weekend, Universal opted to release "The First Purge" on Wednesday, while "Ant-Man" waited for the customary Thursday night previews. "The First Purge" debuted with \$32 million over the five-day frame, and \$18.5 million for the weekend. Particularly following 2016's "The Purge: Election Year," the franchise has made satirical jabs at social commentary. "First Purge," a Staten Islandset prequel, focuses on the ritual's origins as a method of culling minorities.

"Blumhouse just continues to overdeliver for us," said Jim Orr, distribution chief for Blumhouse's distribution partner, Universal. "The Purge franchise continually comments on issues that are current in society, obviously through a kind of dark and distorted lens. Tying it to the July Fourth holiday made a lot of sense."

Some Los Angeles theaters overperformed, executives said, likely due to those seeking air conditioning during the Southern California heat wave. But whether due to travel- or weather-related reasons, nationwide ticket sales were unexpectedly soft on Saturday. The weekend was about 10 percent off the pace of the same weekend last year, when "Spider-Man: Homecoming" opened, according to com-Score. But the summer box office overall, up 13.5 percent from last year, remains robust.

The films that trailed "Ant-Man" hit their own milestones. Disney's "Incredibles 2" passed "Finding Dory" to become Pixar's top-grossing film domestically, not accounting for inflation. It earned \$29 million in its fourth weekend, bringing its domestic total to \$504 million and its worldwide hau to \$773 million. With \$28.6 million in its third weekend, Universal's "Jurassic World: Fallen Kingdom" crossed \$1 billion worldwide. It's done especially well internationally, which has made up 69 percent of the dinosaur sequel's global footprint. As a clear alternative to the multiplex offerings, the "Mister Rogers" documentary "Won't You Be My Neighbor" continued to perform as an art-house sensation. Ranking ninth for the weekend (in between "Tag" and "Deadpool 2"), the Focus Features release earned \$2.6 million in 893 theaters over the weekend. With \$12.4 million in five weeks, it's the year's top documentary at the box office, edging out the Ruth Bader Ginsburg doc "RBG." Boots Riley's surreal satire "Sorry to Bother You," starring Lakeith Stanfield and Tessa Thompson, made one of the year's best debuts, per-screen. The acclaimed Annapurna Pictures release opened with \$717,302 on 16 screens, good for a per-screen average of \$44,831. The directorial debut of the hiphop pioneer Riley, "Sorry to Bother You" is about a black telemarketer who's catapulted into success

after he adopts a "white voice."

Movie theaters in China were packed by a basedon-a-true-story black comedy about a man who becomes a savior to leukemia patients by smuggling cheaper generic drugs from India. The Chinese film "Dying to Survive," which has drawn comparisons to the AIDS drama "Dallas Buyers Club," opened with \$146 million in the world's second largest movie market, according to comScore. .
