## County Officials Given Pay Raises By Committee

Coke County elected officials had to present their cases before the county grievance committee last Friday afternoon in order to get their salaries set for 1979.

Necessity for action by the grievance committee was necessary because of failure to publish a notice of intent to set salaries at the annual budget hearing last September.

The 1979 budget which was adopted included a 10 per cent raise for all elected officials, but Judge D.W. Sims said last week before convening the committee that the law clearly stated that the notice had to be published in a newspaper in the county at least 10 days before the salaries were set.

Basically, the grievance committee agreed to the 10 per cent increase for the elected county officials. The raise varied in some instances, as the committee felt that the salaries should be equalized, since some officials were drawing more pay than others.

However, there were some other changes made in the adopted budget. County commissioners' salaries were raised more than the 10 per cent, but their car expense allocation was lowered to compensate for the raise.

Another change was in the salary of the county judge. He was raised to compensate for the loss of income due to abolishment of the office of county school superintendent. The committee also decided that the county judge should have no car expense and the salary was increased to make up that difference.

Judge Sims said this week that the changes were made to simplify and equalize county officials' salaries and, basically, the salaries were raised the 10 per cent which was approved last fall.

The grievance committee is made up of four citizens of the county whose names are drawn from the grand jury of the previous year. This year's committee was composed of Frank Demere, Lora Belle Brown, Joe Ash and Sue Millican. Serving with this citizen group are the sheriff, tax assessor-collector, county attorney, county clerk and county treasurer. The county judge serves as chairman but has no vote.

In order for the committee to have the final say in matters which are presented, all nine members have to vote unanimously. If one member had voted against any of the salary changes, the matter would have gone back to

the commissioners' court for action. Judge Sims said he received a 9-0 vote on every grievance presented by the county officials.

Sims said he based his decision to convene the committee on the law (39-K) which states that public notice must be given 10 days before salaries of elected officials are set.

## Weaver New FB Insurance Man

Dennis Weaver of Big Spring has taken the position of agency manager of the Coke-Sterling Farm Bureau Insurance Co. He has taken the place of Waldon Millican who has decided to devote full time to ranching.

Weaver has been an agent with Farm Bureau in Big Spring for the last two years and has been a member of the Million Dollar Club both years.

The new agency manager plans to move his family to this area as soon as housing can be found. His wife, Janice, is a teacher in the Big Spring Schools and has resigned her position there, effective this week. They have two children, Timmy, 8, and Jennifer, 8 months. Weaver grew up in Hamlin and is a graduate of Hamlin High School.

Weaver said he would like for everyone to come by the Farm Bureau office in Robert Lee and get acquainted. "I'd like to meet as many folks as possible and invite everybody to come by the office for a visit and cup of coffee," he said. He also has a 1979 calendar-almanac for his visitors.

Weaver said George Demere will continue to serve as agent for Farm Bureau in Sterling City.

**Grievance Committe Does Good Job**

The action of the Coke County grievance committee last Friday afternoon deserves the applause of every taxpayer and citizen of Coke County.

County officials were given a reasonable raise in pay, the first they have had in two years. This doesn't seem to be out of line, considering inflation.

But the best thing they did was to designate almost all the income of each official as salary for serving in an office.

Car expense accounts are out, except for \$50 a month for each of the four commissioners. They formerly had been drawing \$75 a month to operate their vehicles.

All the income of the county judge is now salary. There are no car expenses and no pay for serving as county school superintendent. He just draws a salary.

The simplification of the salary schedule will make it much easier for any citizen to go to the courthouse, take a look at the budget and see exactly what each job pays.

Another good result of the meeting was equalizing salaries of the county officials. Heretofore there were some inconsistencies in the amount drawn by various officials, supposedly based on the importance and amount of work involved in each job. We feel that all the positions are important, else we wouldn't have the office set up. And, as for the amount of work, they should all work full time and give the jobs their best efforts - all day every day.

prompted by a ruling which went into effect June 6, 1978, which states that JP's must conduct court and other official business within the boundaries of their precincts. The Precinct 1 JP office has been in the courthouse for years, but the courthouse is located in Precinct 3, which Judge Sims said makes its present operation illegal.

Sims said he had issued a memorandum, effective immediately, that conducting Precinct 1 court cases in the court house is illegal.

The commissioners are studying the use of space in the courthouse and there may possibly be no JP office in the courthouse, even though Precinct 3 now has a justice of the peace, resulting from the election of Mrs. Cova Sparks to the position in the General Election last November. Judge Sims said the court will take more time to study the space problem before a decision is reached.

In other business the commissioners officially approved salaries of county officials as set by the Coke County Grievance Committee last Friday. (See story elsewhere.) Names were also drawn for a grievance committee for 1979 and will be announced as soon as the persons have been notified and accepted.

Judge Sims was appointed as Coke County's representative on the Concho Council of Governments. Other business consisted of routine matters.

### PERFORMANCE OF FIRST-CALF HEIFERS

First-calf heifers need special attention as they often experience re-breeding problems due to stress factors, says a livestock specialist. These can be overcome by separating heifers from mature cows the last three months of gestation and through the breeding season, and breeding virgin heifers 20 to 30 days earlier than the regular cow herd to assure early calves. Early weaning and limited daily suckling also take stress off first-calf heifers.

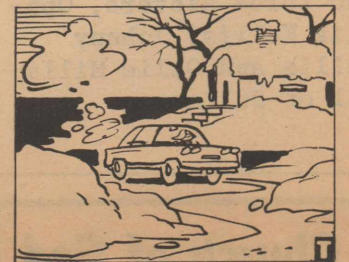
When selecting an iron, consider cord placement. Cords fitted for right-handed persons contribute to accidents when used by left-handed persons. Right- and left-handed persons can use irons with the cord centered in the middle back, the specialist suggests.

**RECYCLE POINSETTIA PLANTS**---With special care, that poinsettia plant you received for Christmas can be brought into flower for Christmas, 1979. As its color fades, reduce watering. Cut the plant back about mid-April, repot, water and place in a sunny location. Later move it outdoors. To bloom by Christmas, the plant must be kept in total darkness from 5 p.m. to 8 a.m. from early October through Thanksgiving.

## WINTER DRIVING TIPS

If you're like most people, you probably don't realize how cold weather can affect the performance of your tires.

Every time the temperature drops 10 degrees, your tires lose a pound of air pressure, and underinflation causes dangerous excess wear. Underinflation can also induce tire failure. Road checks reveal that at least one out of four cars is driving on seriously underinflated tires—4 or more psi below the vehicle manufacturer's recommendation. Check your tire pressure even more often in winter than you do the rest of the year—at the very least, once a month.



Another thing to check is your tire's "footprint"—the flattened section where the tread meets the road. It can be easy to see in snow, dirt or mud. When that footprint is worn smooth—down to 1/16th of an inch or less tread depth, your tire is dangerous. Nearly 90 percent of tire trouble happens in the last 10 percent of tread wear.

If your tires have merely worn off the original tread, they can be either retreaded or traded in for quality retreads. Retreads, like new tires, must pass Federal standards, but cost about half as much. Retreads are approved by the Federal Aviation Administration and the Air Force.

Keeping an eye on your tires this winter can help make more sure you can keep your car on the road.
