More than 400 widely-scattered highway projects, to cost nearly \$19,-000.000 have been contracted or advertised in Texas, the association reported. About \$3,000,000 of this is state money, supplementing federal funds so that every county in the state can receive road work equal to square. t least \$4 per capita.

"Jobs for more than 17,000 Texans are involved directly on the road work already sanctioned," the statement said, "and Secretary Icks' estimates of indirect employment such as preparation of materials, transportation, etc, will bring the grand total of jobs to between 40,000 and 50,000.

"National authorities advise us that the peak of highway employment under this program will come in April and May, when some 50,000 will be at work in Texas and about 1,000,000 nationally. They add that the fund will be consumed by early autumn.




