

# DISD board calls for major tax increase

The Dimmitt School Board Monday proposed a substantial increase in real property taxes to meet the needs of its 1981-82 budget. Taxpayers will realize an actual increase of 19.2%.

The board approved an increase of 16.5% over the normal 3% increase allowed annually by the state. The hike would place the new tax rate — in light of the new 100% appraised value assessments — at \$1.34 per \$100 valuation.

The rate last year was \$1.73 per \$100, assessed on 65% of appraised value. When the new uniform appraisal office opened in July, Chief Appraiser Jerry Heller announced that the DISD rate was being converted to \$1.15 per \$100, assessed on full appraised value, as required by the state's new uniform assessment law. So, although the new rate is lower than last year's, it will bring in 19.2% more in local property taxes.

Heller said that the difference between 19.2% and 16.5% is "due to tax levies needed to cover the interest and sinking rate and bonded indebtedness."

In reviewing the proposed budget, the school board discovered that 39% of that budget should come from local property taxes, 46% from state funds, 11.6% from federal funds, and 3.4% from other local sources, such as gate entries to sports events and interest earned.

That means that local taxpayers will have to come up with \$1,601,401 of the total \$4,098,085 budgeted. To do so, property taxes must be increased.

The only alternative would be to cut the school budget, Business Manager Gene King said.

"75 percent of this budget is payroll," he said, adding that other large expenses are travel and maintenance, including utilities.

The proposed budget shows an increase of 14.3% in payroll costs, including the 1981-82 state salary scale plus a higher local increment approved by the school board in February.

Board member Deanne Clark said she thought that the public would not want the school to "cut back" since doing so would affect teachers' salaries, sports events and other programs.

"\$1.34 will service this budget," Supt. Robert Ryan said, adding that it had been 12 years since the board approved any sizeable tax increase.

The proposal to increase property taxes was approved by all board members present at the meeting.

A public hearing on the increase will be held next Thursday, at 8 p.m. in the Dimmitt Independent School District Administration Building, 608 W. Halsell.

## Crops may be 'best ever'



LUSH COTTON CROP PROMISES BUMPER YIELD  
... If the weather and bollworms will cooperate

If the weather does just right, if the spider mites don't get too bad, and if the bollworms are caught in time, this could be one of the best crop years that Castro County has ever seen, according to local entomologists, crop consultants and aerial sprayers.

Castro County's corn crops, which had already been labeled by many as the best ever, have received a gently soaking rain to carry them through the last watering.

Aerial sprayers in the county say that the corn has some spider mites in it, but nothing like last year. Spider mites caused considerable damage to crops in the area last year, but Azodrin, a chemical found to be effective in combating the mites, came to the rescue when it was approved for use last year. Azodrin is helping to better control spider mites this year, too.

Prospects for this year's cotton look just as good as those for corn. The cotton is healthy, with only minor insect problems. The main insect problem aerial sprayers are dealing with is bollworms, which they say are not widespread.

As it stands now, the crops around Castro County are in excellent shape, but, as one consultant said, corn yields "will depend on the next three or four weeks of weather."

## School registration to start Wednesday

Next week, all local schools will begin their new year, with Thursday, Aug. 20, as the first day for Dimmitt and Hart students, and Friday, Aug. 21, as the first day of classes at Nazareth.

Teachers in Dimmitt and Hart report Monday, while Nazareth teachers have their first in-service day Wednesday.

Wednesday is the day of student registration in Dimmitt, with seniors registering from 9 to 10 a.m., juniors from 10 to 11 a.m., sophomores from 11 a.m. to noon, and freshmen from 1 to 2 p.m.

Ninth through 12th graders who are new to the Dimmitt system are to register at Dimmitt High School any weekday after 2:30 p.m. between now and the start of school for enrollment and transcript information.

At Dimmitt Middle School, registration will be in the library Wednesday from 9 to 10:30 a.m. for eighth graders, and from 10:30 a.m. to noon

for seventh grade students. Those who miss registration in the morning may report for a combined registration between 1 and 3:30 p.m.

Fourth, fifth and sixth grade students may register in the foyer of DMS anytime Wednesday.

Enrollment for kindergarten through third grade will be held at Richardson Elementary from 8:30 a.m. until noon and from 1 to 4 p.m. Wednesday.

## More rains drench county

For 40 days and 40 nights... Castro Countians may soon have to build their own ark if the rain continues.

Dimmitt had 3.58 inches of rainfall in three days this week, and Sunnyside recorded as much as 4½ inches of moisture for the same time period.

The 60-year rainfall average

for Castro County for the month of August is 2.29 inches. Although the last three days have more than filled the county's quota for the month, 6.38 inches recorded in August of 1966 probably still stands firm in the record books.

The KDHN Radio national weather observer reported

1.79 inches of rainfall from 7 a.m. Tuesday to 7 a.m. Wednesday. Adding this to what area sources recorded for Monday evening and Tuesday morning, three-day rainfall estimates were 2.89 inches in Hart, 4.54 in Flagg, 3.99 for Bethel, 3.09 inches at Simpson's Dairy between Dimmitt and Hereford and 3.49 at

Arney.

Though the rain has been a big help to corn and milo crops, too much of it could be disastrous for the local vegetable crop, said Manager Lee Drake of La Mantia, Cullum, Collier & Co., Inc.

"It has no beneficial effect on the vegetable crop whatsoever," he said.

Rain can delay harvest and possibly rot the vegetables, according to Drake.

"The best vegetable crops are grown in the desert, in California. The onion comes from Egypt. Rain just doesn't have any beneficial effect on the vegetable crop," Drake [See MORE RAIN, Page 13]

## School lunches will be higher

Lunch prices for Dimmitt students will increase by 10 cents, and adults eating in Dimmitt School cafeterias will pay 40 cents more than last year.

The Dimmitt School Board approved increases in school lunch prices for the 1981-82 school year at its regular meeting Monday night.

Kindergarten through third grade students will pay 80 cents, fourth through eighth graders will pay 85 cents, high school students will pay 95 cents and adults will pay \$1.25 for each plate lunch. No "a la carte" orders will be allowed this year.

Snack-bar prices will also increase to be more comparable to commercial fast-food prices.

The decision to increase lunch prices came after a study of the school food service revealed that the school district lost more than \$33,000 last year in the program.

Board member Deanne Clark commented that the increase seemed to be an awfully big jump, especially for the adults.

The additional revenue should handle the projected inflationary raw food prices, equipment prices and possible wage increases, Supt. Robert Ryan said.

"We should have bumped them (the prices) up last year," Board Chairman Charles Wales said.

Of the 221,786 meals served in the lunchrooms last year, 40% were paid and 60% were free or reduced price lunches.

"We're in limbo on the free

and reduced-price lunches," King said. Congress has yet to decide how much schools will be allowed to charge for the program this year, he added.

Reduced-price lunches presently will cost 40 cents each. Reduced-price breakfasts are 10 cents, while full-price breakfasts cost 20 cents.

"They will change" when [See LUNCHES, Page 14]

## Medicine should get hard look by consumer

When the doctor prescribes medicine, ask questions about the drug, says Beverly Rhoades, a consumer information specialist.

Asking questions — a "wise consumer thing to do" — is necessary for two major reasons: to be adequately informed and to avoid unnecessary costs, the specialist says.

Rhoades is on the home economics staff of the Texas Agricultural Extension Service, the Texas A&M University System.

Here are some "question suggestions":  
**PRESCRIPTION COSTS**  
When a doctor orders a prescription for you, ask if the prescription is for the "generic" (common) name or if it's for a "brand" name of the medicine.

If the doctor has prescribed a brand name, ask if prescribing it by its generic name or by another brand might be just as effective. In some cases, this is a more economical choice.

If the answer is "yes," ask the doctor to indicate to the pharmacist that a generic drug or cheaper brand can be substituted.

**REFILL ARRANGEMENTS**  
Also, ask the doctor how long you probably will have to take the medicine.

If the time period is longer than the prescribed amount will last, ask if the doctor will prescribe enough medicine for the expected time period — so you might avoid extra trips to the pharmacy.

In some cases, doctors prescribe a small amount purposely — to safeguard patients from taking more than they need or to prevent a large amount from becoming less effective due to deterioration.

In any case, it's wise to ask about the amount and about

refill arrangements.  
An office visit may be necessary to answer refill questions. In some cases, your doctor will want at least a "progress report" of your condition by phone before issuing refills for you.

**SPECIAL INSTRUCTIONS**  
Also ask the doctor if there are special instructions or cautions concerning the drug.

For example, some drugs should be taken with meals, some cause drowsiness, and some encourage "photosensitivity" (makes you more sensitive) to the sun.

Ask for any available leaflets about the drug and its possible side effects.

Listen to your pharmacist, too. When you pick up your prescription, he or she may caution you verbally about the drug — perhaps with instructions such as "do not drink alcohol as long as you are taking this drug" or "do not take certain other medication as long as you take this drug."

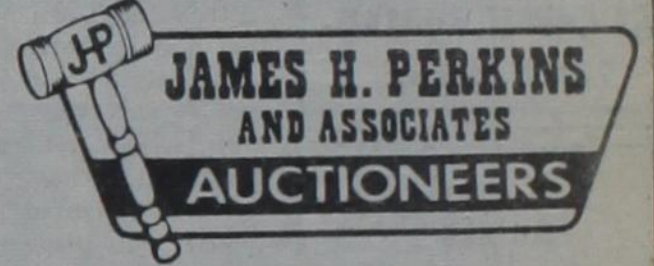

# ASCS news Sept. 1 is the deadline for certifying acreage

Sept. 1 is the final date to certify your cotton, corn, grain sorghum, and peanut acres. The acreage must be certified on a field by field basis and by irrigated or dryland.

An accurate certification of irrigated and dryland acres is a MUST, and is just as important as an accurate certification of your crops. An inaccurate certification could deprive you of program benefits.

Please measure and come on in and certify your spring seeded crops now and avoid the last minute rush.

We will be glad to help you figure those acres on irregular fields or in any other way we can.

## WHEAT RESERVE IV PROVISIONS

Congress has passed legislation governing a new Wheat Reserve Program (Reserve IV). Basic provisions are:

1. There will be \$.30 per bushel premium added to the county loan rate.
2. Interest will be charged through the first year of the three-year reserve program at a variable rate beginning with 14.5%.
3. Annual storage will be paid by Commodity Credit Corporation at the rate of \$.265 per bushel.
4. Release and Call Price

will be \$4.65 per bushel. Producers in Reserve IV will not be required to repay loans when call prices are reached unless an extreme emergency requires a call.

## Social Security in Castro County

Before the Social Security law was changed in 1977, retired people who continued to be involved in self-employment could receive a benefit check for any month they did not render what was considered to be "substantial services" in the business.

This was possible, even though the person's earnings were over the ANNUAL limit. The 1977 amendments eliminated this monthly earnings test, except for one so-called "grace year" (ordinarily the year of retirement). After that "grace year," Social Security looked ONLY at the ANNUAL earnings to see how many checks a person could be entitled to, without regard to any monthly services. (The general rule is that \$1 in benefits must be withheld for every \$2 in earnings above the annual limit.)

It later became apparent that the limitations placed on the monthly earnings test adversely affected some individuals. Persons who continued to receive reportable income from self-employment, even though retired,

could lose all their benefits under the annual test. This was true even if they had little or no actual involvement in the operation or management of a business activity.

Some examples are farmers who sell "carry-over" crops in a year after retirement, "silent" partners and retired partners who only receive a distributive share of the business income. Insurance salesmen who get renewal commissions for policies sold before retiring, and other retirees who receive self-employment income solely due to their OWNERSHIP of an income-producing property or business are also affected by this.

One of the 1980 amendments to the Social Security law seeks to make the annual earnings tests more equitable, by providing that any self-employment income a retired person received which is not the result of SERVICES performed in the business will not be counted toward the annual earnings limit. Services are defined as regular services performed in the ongoing operations or management of a trade or business activity which is RELATED to the income received from such activity.

A retired person who retains an ownership interest in a business which is being managed and operated by others can be expected to take some actions at various times, in order to protect his investment. Such actions would not be considered as performing "services" in the operation or management of the business. Similarly, if a crop were produced prior to retirement, but sold in a year AFTER retirement, the actions taken merely to sell that crop would not be considered as "services" in self-employment.

The intent of the new law is that self-employed persons not be penalized for receiving income that was earned before they became entitled to their social security benefits, nor for income after retirement which is the result of owning a business, or maintaining a ship share.

**Texas FLB's loans hit \$2 billion mark**

The Federal Land Bank of Texas has achieved a major milestone in its 64-year history reaching \$2 billion in loans outstanding, announced Thomas H. Benson, president.

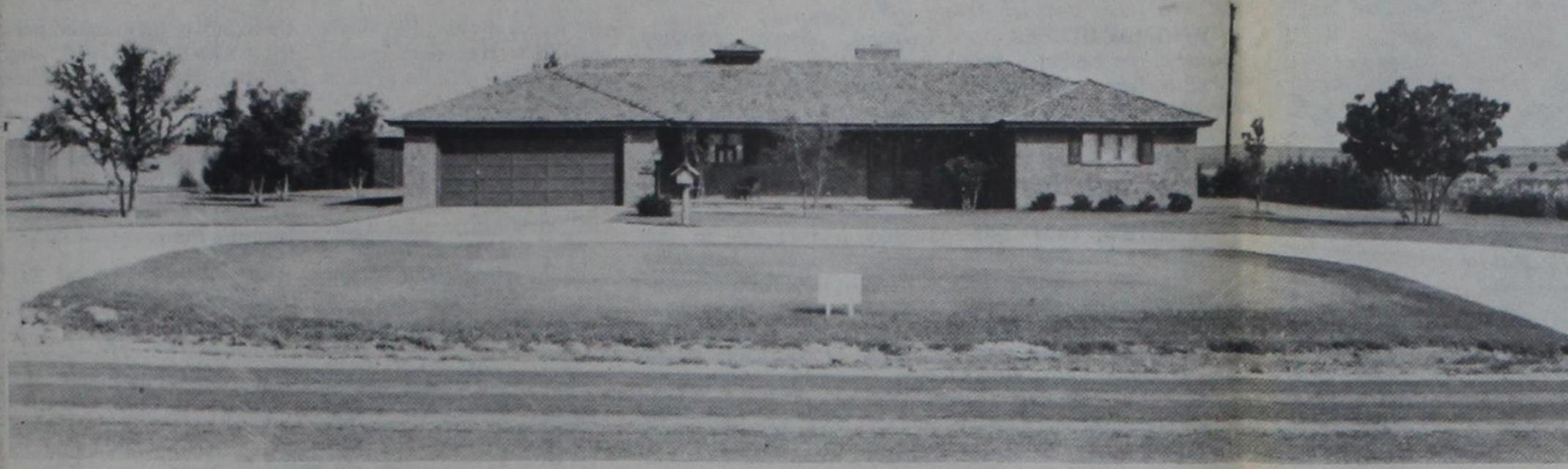

### agri-facts

Farmers are taking steps to stop providing free room and board. Insects - who hole up in stored wheat, are going to have to look elsewhere for a boarding house because of preventative measures. The measures will be used by farmers and storers since many growers are holding wheat. Measures include removing all old grain, chaff and debris from inside and around bins. Wheat held for a month or more will be treated with malathion. To control meal moths, many will hang a dichlorvos (DDVP) plastic resin strip per every thousand cubic feet of overspace in the top of each bin. These strips will be replaced every six to eight weeks until the grain mass cools down to about 50 degrees. For infestation which has already occurred, the dichlorvos strips will be used and, in addition, bacillus thuringiensis is recommended, raked into the grain surface to control larvae. Finally, grain in wooden bins will be sealed off with covers of polyethylene plastic sheeting.

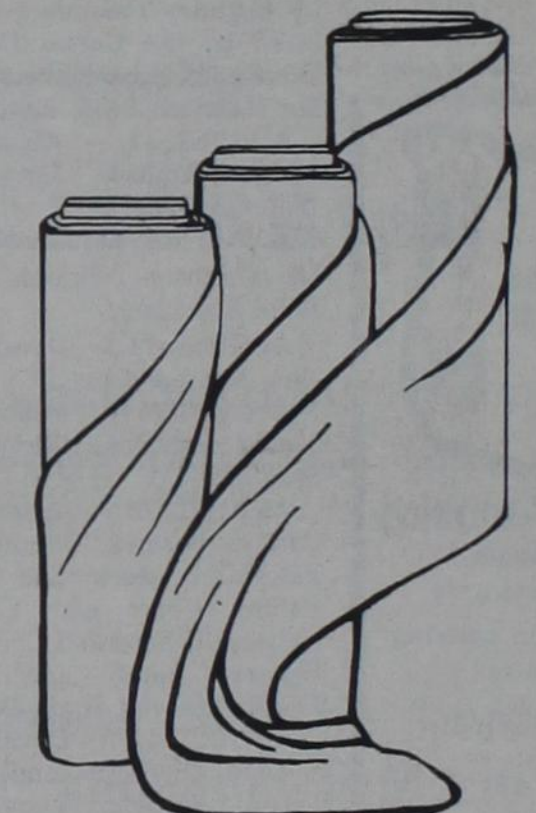

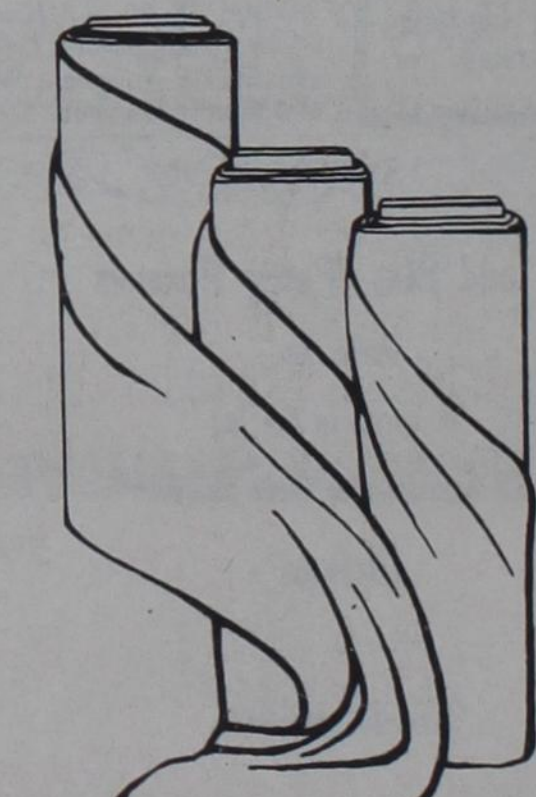

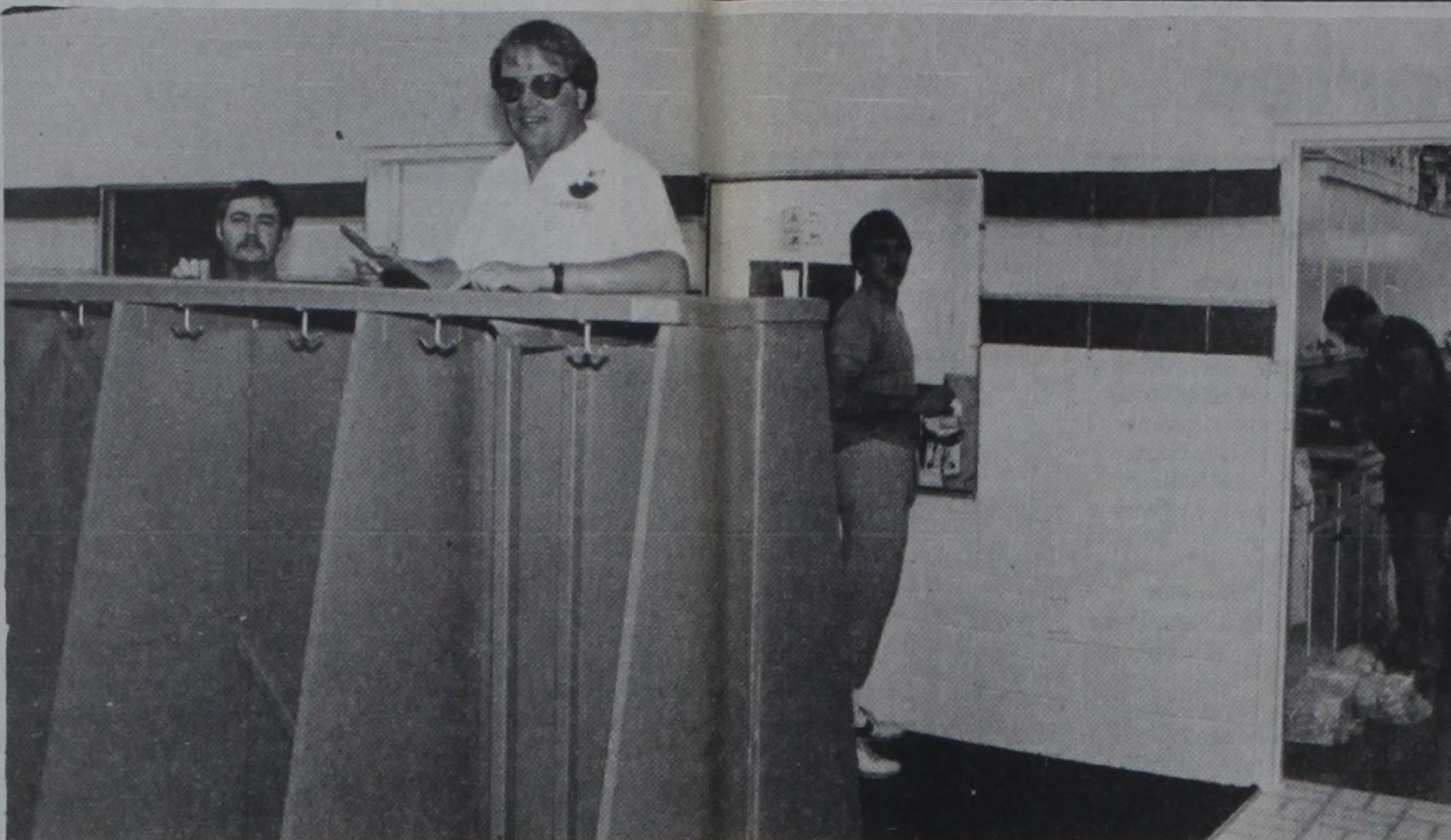

During the year a best seller came out by J.R.R. Tolkien, called "The Silmarillion." John Brooks picked it up one day and told us it was liable to be the least-read best seller. This writer agreed, and advised any interested scholar of Gaelic mythology to get in line to read it. The Gaelic scholars declined the invitation, however, and to this day, "The Silmarillion" remains what we call a shelf-sitter, because it's always on the shelf.

J.R.R. Tolkien spent 30 years developing his own private mythology based loosely upon Irish and Scandinavian tales. He was fonder of his work with it than with "The Hobbit," which eventually made him famous. Tolkien later admitted, though, that he only wrote the Hobbit books to satisfy his publisher, who had requests for more Hobbit books. His real love was writing his mythology, developing the characters, creating the literature and so on. In truth, though the work is of limited interest to many, it is a finely written one.

Now to illucidate this arcane work is a small compact volume titled "Tolkien and the Silmarils" by Randel Helms. All of you Celtic readers who wish to try again on "Silmarillion" can now do so with the help of an expert.

For those non-Gaelic

scholars out there (if any), the library has these new books: "Free Fall in Crimson" by John D. McDonald, "The Clowns of God" by Morris West and "Trade Wind" by M. M. Kaye.

"We can lose from 150,000 to 250,000 pounds of cucumbers because of this rain," he said.

"You can say that the first crop is already gone," he added. "We haven't been able to pick them for the last five days, and mold is going to start setting in pretty soon."

Cucumbers have to be picked within a critical time frame or they become too big for market.

On a more hopeful note, Kimball predicted that if the rain were to let up today, the hands could be back out into the fields picking cucumbers the same day.

Area meteorologists predict that the precipitation will diminish by Thursday.

# Commissioners asked to reconsider 'Jaws' van

Tommy Cleavinger of the Dimmitt Volunteer Fire Dept. spoke to the Castro County Commissioners' Court Monday about an "apparent misunderstanding" the commissioners had about the fire department's request for a van, for which the city had already agreed to pay half.

Cleavinger said that it had not been explained that the van would be used to house other equipment — such as a power generator, lights, smoke ejection fans, clean-up equipment, etc. — so that their already overcrowded four-wheel-drive Suburban could be used to carry the Jaws of Life tool, providing better access to emergency situations.

The fire department, said Cleavinger, had considered the commissioners' suggestion that the Jaws of Life tool be housed in some sort of a trailer, but felt that it would not be feasible to pull the trailer behind the firetruck, and it would be impossible to get the tool to a wrecked vehicle in muddy conditions if it were in a trailer.

Cleavinger requested that the commissioners keep the department in mind as the volunteer firemen were forming a committee to study the costs and feasibility of purchasing a van.

The county commissioners also opened bids Monday from three insurance agencies for a comprehensive major medical group insurance plan for county employees, and decided to place the policy

with Business Men's Insurance.

Cost of the BMI plan is \$44.75 per employee, which the county will pay, and an additional \$64.43 for dependent coverage, to be paid by the employee if he or she wants family coverage.

The \$109.18 per month basic employee and dependent coverage does not include a \$10,000 life insurance plan or BMI's double indemnity plan, the cost of which is an additional \$8.40 per month and \$1.02 per month respectively.

On the BMI plan, the insured employee would have to pay a \$100 deductible charge on all medical expenses only once a year, and for only three members of the family, then the insurance would pay 80% of medical expenses beyond that amount.

A clause in the coverage provides also for six months' free coverage for the dependents of a deceased insured employee.

The commissioners also heard from Blue Cross/Blue Shield and Banker's Life before reaching their decision to go with BMI.

Cost of Blue Cross/Blue Shield was quoted at \$125.25 per month, with the county paying \$43.09 for employee coverage.

Banker's Life insurance would have cost \$120.32 per month per family, of which \$53.44 would have been paid by the county for basic employee coverage.

The county's policy had been with Blue Cross/Blue Shield in the past.

In other action, the county commissioners:

— Agreed to allot \$1,000 for the child welfare fund from the Revenue Sharing funds after hearing a request from Angela Acker, president of the Child Welfare Board. Acker said that the Child Welfare Board was planning an informative town hall type meeting for Oct. 13 in the County Expo Building.

— Heard a request from Agnes Brockman and Christine Braddock of the Nazareth Senior Citizens for a portion of the Revenue Sharing funds to help pay for repairs on Nazareth's new senior citizens' center in an old hardware store north of Home Mercantile. The building cost the group \$10,000, financed over six years, and repair costs are estimated to run as high as \$20,000 to pay for plumbing, new restrooms and other repairs. The Nazareth Senior Citizens currently have more than 100 registered members, 30 of whom are active.

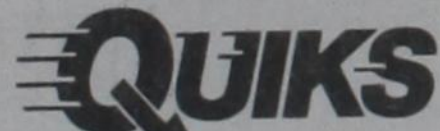
