


## Commissioners' Court

# Precinct 1 is denied material, transfers



**THIS MECAHNICAL RECOMPRESSION EVAPORATOR**, located in American Fructose Corp.'s refinery, is part of the last major system under construction at the plant. The evaporator will be put on-line today (Thursday) and officials hope that the plant will be operating at its full, increased capacity a week later. It differs from conventional evaporators, because it allows for reduced energy costs.

The 2,700-horse power turbine is driven by high pressure steam provided by a 500-PSI (pounds per square inch) boiler operating at 6,500 RPMs (revolutions per minute). The exhaust steam is used to run other conventional evaporators. AFC officials say that this was the last major piece of equipment left to be installed in the plant.

The Castro County Commissioners' Court came one vote short of approving the use of "improved road building material" in Precinct 1, as requested by Pct. 1 Commissioner Harold Smith.

Smith proposed approval of the material at Monday's meeting of the court, and Pct. 2 Commissioner Dale Winders seconded the motion after a lengthy discussion. Pct. 3 Commissioner Jeff Robertson and Pct. 4 Commissioner Vincent Gugemos voted against the measure. County Judge Polly Simpson broke the tie, voting against the motion, saying she "didn't like the motion," although she isn't against Smith's use of the material.

Robertson also said he is not against the use of the low-grade caliche, but wanted a written agreement for Smith to sign, with Smith accepting responsibility for the use of the material and agreeing to abide by the rules set out in the motion.

The motion asked for county approval of the use of improved road building material for use in Precinct 1, taken from pits in Castro County, if the material is free, and if Smith abides by county policy and stays within his budget; and if volunteer help is used, they must comply with the county insurance and have a good driving record.

The commissioners also refused to authorize line item transfers for Precinct 1, while allowing budget changes in two other precincts.

Smith asked for \$10,000 to be transferred out of the line item amount of \$15,000 set aside for seal coating, and move it to road and bridge improvement for his precinct. He also requested \$3,000 be moved from gross pay to cover part-time help.

However, Simpson said that the amount for seal coating needs to be left where it is in the budget, since seal coating needs to be done on two roads in Pct. 1. The roads scheduled for coating include the county's portion of Avenue A in Hart and "rodeo road" on the east side of Dimmitt.

Smith contended that the road in Hart is in too bad a shape to benefit from seal coating and commented that "it would be a waste of money."

Discussion continued over whe-

ther approval should be given for payment of part-time workers in Precinct 1 who continued employment after the other three commissioners told Smith to dismiss them because of no more funds in his budget for part-time workers.

County auditor Shirley Brockman said that the \$3,000 transfer could be made and still leave enough to cover payment to five full-time employees for the remainder of the fiscal year, which ends Sept. 30.

She noted that Smith's part-time help line item was already overdrawn by \$1,110.30, and the men worked another \$1,387.80-worth, which would total \$2,498.10.

A line item transfer was allowed for Precinct 3, with \$4,874 taken out of capital outlay and transferred to vehicle maintenance. A budget amendment was allowed for Precinct 2, with \$2,478 added to the budget for an outstanding statement, and for culverts and grader blades.

Winders, Robertson and Gugemos voted in favor of approving the budget changes, except those requested in Precinct 1. Smith voted against the motion.

In other business, Dimmitt Fire Marshal Rick Hunter asked the commissioners to form a committee to begin the process of assigning designations for the many county roads. He noted that the 9-1-1 emergency dialing program, scheduled to go into operation in 1991 or 1992 in Castro County, requires a designation for each rural location, as well as in cities.

State and US highways and Farm to Market roads are numbered, but county roads have no designation at this time.

Hunter suggested that he serve on the committee, along with Dimmitt Postmaster Bill Sava, Comel of Texas representative Johnny Ethridge, Sheriff Lonny Rhynes, Voter Registrar Billy Hackleman, Energas Manager Acie Boyd, and the fire chiefs of the three volunteer fire departments in the county—Dimmitt, Hart and Sunnyside.

Commissioner Winders was also named to the committee, and Simpson advised that they consult with a Deaf Smith County commissioner to coordinate designations on roads that cross the line between the two counties.

Under another agenda item, the commissioners discussed what could be done about "Coronado Acres," a rural subdivision in the northern part of the county along US 385.

Robertson asked whether subdivision organizer Charley Bell could be prosecuted for falsely representing the subdivision to the commissioners' court and if he or the property owners could be forced to meet the deed restrictions on the property, and clean up the appearance of the properties.

Castro County Attorney Jimmy Davis said one of the property owners could sue the others for not complying with deed restrictions, but added that little other recourse is left for the county, unless public property is affected.

Davis advised the commissioners to adopt regulations for any other rural subdivisions that may wish to come into the county in the future. He said he would make further recommendations at a future meeting of the court.

Sid Ham of the Rape Crisis/Domestic Violence Center in Hereford asked the commissioners to consider contributing funding to the center for the coming fiscal year, since the center also services clients from Castro County.

He noted that during the past year, 26 cases of sexual assault and 39 domestic violence calls were handled from Castro County. He said that their administrative and operating costs amount to about \$116 per case, which would place Castro County's share at about \$1,000.

Ham said that a strong volunteer program helps to keep costs down. He added that the center can also offer additional services to Castro County, including a 24-hour hotline, counselling, an emergency

# Special education revisions planned

Revised instruction procedures for special education students in Dimmitt Middle School will be adopted for the coming school year, according to special education director Kay Gfeller.

Gfeller told the Dimmitt school board members at their Monday meeting that the new program emphasizes content mastery, and was piloted in the Hereford schools this year.

Designed for use mainly with learning disabled (LD) students, the program supports the students through all subject areas, and has been well received in Hereford and Wichita Falls, site of another pilot program.

Gfeller said the program meets all state and federal guidelines and can be implemented with existing personnel and funding.

"Seventy percent of our special education students are classified as LD students," Gfeller told the board.

Curriculum Director Gainell Minnick reported to the board on Chapter I campus plans for the middle school and Richardson Elementary. She said that the plans call for increased emphasis on skills relating to details, oral definitions, context clues and finding the main idea—areas needing improvement on standardized achievement test scores.

Richardson Principal Les Miller reported that part of the plan will continue the READS (Richardson Enjoys A Daily Story) program, in which students and staff members spend the last 15 minutes of each school day reading.

Business administrator Gene King told the board that the computer system used for class scheduling, as well as student grade reporting and attendance reports, will be changed over to a new system, which will be faster in processing the information and will allow the high school system to communicate

with the system at the other campuses.

Cost of implementing the new system is estimated at \$8,651. Local terminals send information to the main frame at the Region XVI Service Center in Amarillo, and one of the problems with the old system had been the waiting time for transmission and reception of data.

King said the new system should be installed and ready to go by the

first of next school year. He added that some of the district's finance information may also be transferred to the new system.

Supt. Robert Ryan told the board that the consulting architectural firm of BGR will have some definite plans to present at the June meeting of the board, including renovations of the kitchen and wiring at Richardson.

King said that bids have also

# County cattle feeders rank third on fed cattle survey

Castro County feedlots fed the third largest number of cattle in the area during 1989, according to a survey released by Southwestern Public Service Co.

The SPS survey, entitled *Cattle Feeding Capital of the World: 1990 Fed Cattle Survey*, lists 11 feedlots with a capacity of \$5,000 or more in Castro County, shows where they are located and lists the capacity of each.

Feedlots within the area served by SPS during 1989 fed the highest number of cattle on record, according to the survey.

Castro County feedlots have a capability of feeding 247,000 head of cattle at a time, and recorded feeding 489,142 head during 1989.

Feedlots within the county rank third behind Deaf Smith County's, which recorded feeding 885,563 head in 13 lots; and Parmer County's, which fed 492,088 head in its eight yards.

According to the study, Bar G Feedyard, located in northwest Castro County, can hold the most head of cattle at one time, with a capacity of 65,000 head. Dimmitt Feedyard's pens, located west of Dimmitt, can handle 45,000 head; while Rafters 3 Feedyard, west of Dimmitt, can hold 34,000 head.

Other feedlots in the county, in descending order by capacity, are Seven X Feedyard, 24,000; Hill Feedyard, 20,000; Cluck Cattle Co., 15,000; Great Plains Cattle Feeders, Inc. S, 12,000; LS Feeders, Inc., 10,000; 3K Cattle Feeders, 9,000; Sunnyside Cattle, 8,000;

and Bridges Cattle Co., 5,000.

The survey showed that one-time total capacity of area feedlots in 1989 was 2,785,475 head, up from the one-time total capacity in 1988 of 2,758,662 head.

Feedlots in the SPS service area fed a total of 5,486,350 head of cattle, a 2.5% increase over the 1988 total of 5,335,603. The previous record was set in 1987 with 5,406,975 cattle fed.

"The 1989 study shows how important cattle feeding is to the area's economy," said Dave Krupnick, SPS manager of agricultural and wholesale marketing. "Although prices for feeder cattle remain up, 1989 was still a record year for this area."

SPS annually prepares a fed cattle survey covering feedlots in its service area. The electric utility serves a 52,000-square-mile area comprising the Texas and Oklahoma Panhandles, the Texas South Plains, eastern and southeastern New Mexico and southwestern Kansas.

Additionally, the survey found that 4,694,852 cattle were slaughtered last year at 13 beef packing plants in the SPS service area, Krupnick said. The facilities have an annual slaughter capacity of 4,818,320 head.

"Each year feedlots and packing plants are very cooperative in supplying information for this survey, and we really appreciate that," Krupnick said. "We continue to receive requests from across the United States for this survey, and it

helps highlight this area's agriculture and food-processing industries."

The report also shows that the total number of feedlots in the area has grown to 117, and the one-time capacity of these lots is still on the increase. The report also includes a chart on the 10-year history of fed cattle and the one-time capacity of surveyed feed lots, as well as information on the number of feedlots with 5,000-head capacity or above, and a county breakdown of lot capacity and numbers fed.

## We Salute Our Electric Company

Southwestern Public Service Co. has been proving lately that it is a great corporate neighbor.



## DPS chief offers safety tips

It's the beginning of summer and with it brings an end of another school year. Children will soon be filling the streets to play and parents will be planning for summer vacations.

Major Vernon Cawthon, regional commander of the Texas Dept. of Public Safety, reminds parents and motorists that safety should continue to be part of their daily routine.

Parents should instruct their children in the safe operation of all recreational equipment such as all terrain vehicles, bicycles, scooters, motorbikes and skate boards. Instruction on proper use, care of and laws applying to all such equipment should be reinforced. Safety equipment such as pads and helmets should be worn to minimize injuries. If you are going to be around water this summer, remember to never let anyone swim alone. Establish pool rules such as keeping electrical appliances away from the water, prohibiting horseplay, never leaving children alone, and never consider young children water-safe despite their swimming skills.

Motorists should use extra caution when driving in residential areas, remembering that we have longer hours of daylight. Always be looking out for children darting in and out from behind parked cars. Never assume that a child will see you. Slow down and honk your horn to get attention if needed.



Dimmitt businesses may get pre-printed sheets at the Dimmitt SPS office. Sheets with Hart's name on them are available at the Olton SPS


office.





Five local women competed in the match.





## Dimmitt, Nazareth payments drop

### Hart rebates increase

Hart enjoyed an increase in its city sales and use tax rebate for the month of March, but Dimmitt's and Nazareth's payments were down for the comparable period last year.

Hart received a check totaling \$1,694.52, up 3.36% from March 1989's payment of \$1,639.49.

Dimmitt's rebate, a total of \$25,838.88, reflected a 2.25% drop from 1989's payment of \$26,434.70. Nazareth's \$1,807.48 payment was down 8.07% from last year's rebate of \$1,966.07.

For the year to date, rebate checks to Nazareth and Hart are up while Dimmitt's remain below average. Nazareth has received a total of \$8,129.43 for the year, up 29.01% from 1989's checks totaling \$6,301.53 through the same period. Hart's payments are up 9.02%, with the city receiving \$7,237.08 this year over \$6,638.07 last year. Dimmitt's total is down 6.55% this year, dropping from \$110,407.90 in 1989 to \$103,172.31 in 1990.

This month's checks include taxes collected on March sales and reported in April by businesses

filing monthly returns, and also includes taxes reported by those filing quarterly returns for the months of January, February and March.

Merchants collect sales taxes and send them to the state comptroller's office with their tax returns. The state keeps its share and sends cities and counties their portion of the sales tax.

All local sales taxes must be approved by local voters and may be used for any legal city or county expenses. Most areas put money into a general fund and use it for operations like fire fighting, maintaining roads and law enforcement.



The Castro County Agricultural Stabilization and Conservation Service (ASCS) office will be closed Monday, May 28, in observance of Memorial Day.

Haying and grazing of Acreage Reduction Program (ARP) and CU for pay acreages (including the 8% of the permitted acreage) is not allowed during the five-month non-grazing period which begins June 1 and continues through Oct. 31.

In the past, we have been able to hay and graze these acreages due to

adverse crop conditions, but for 1990, we will not be able to graze or hay the ACR and CU for pay acreages during the five-month period.

Before grazing, plowing or otherwise destroying disaster affected acreages, you must contact your insurance agent (if you have multi-peril crop insurance); measure and certify the total acreage of the crop on the farm; and file an ASCS-574 application for disaster credit.

With the recent moisture we have received in the area, condi-

tions are ideal for the growth of weeds. Weed control measures must be carried out on Conservation Reserve Program (CRP) and acreage conservation acreages to be eligible for program benefits under the CRP program and the regular farm program, respectively. These control measures need to be carried

This year's event will begin in Amarillo at 8:30 a.m. at the Texas A&M University Agricultural Research and Extension Center, located at 6500 Amarillo Blvd. West. Participants completing the training given here by the Texas Agricultural Extension Service can receive three continuing education units toward their pesticide applicator certification, said Dr. Brent Bean, Extension Service agronomist.

Beginning at 1 p.m., tours of wheat research plots will be held at the US Dept. of Agriculture and Agricultural Research Service laboratory three-fourths of a mile west of Bushland on I-40.

Research conducted there by scientists of USDA-ARS and the Texas Agricultural Experiment Station will be explained, said Dr.

B.A. Stewart, USDA research director at the facility.

Stops will include the irrigated wheat variety nursery, research plots for integrated insect and disease management, weed control, tillage and grazing pull off.

The field day is sponsored by the Extension Service, Experiment Station, USDA-ARS and the Texas Wheat Producers.







overnight shelter in Hereford, transportation to area shelters, referrals, and assistance with medical, employment and housing needs.

Public information and professional training for volunteers are also available, Ham told the court. Simpson said the center's request would be considered for the coming year's budget.

Under another agenda item, Smith requested permission to put oil on his roads, and noted that such treatment is used on roads in Winkler County. He said the oil is free in Winkler County, but could possibly cost \$3 per mile to transport it to Castro County, a distance of

about 200 miles.

Winders suggested that Smith look into the matter further as far as what it would cost the county, and to see what Environmental Protection Agency regulations might cover such a process.

Robertson said, "I think it would work, but the EPA won't let it happen."

He noted that EPA regulations are being formulated now that would require farmers to clean up discarded oil from the soil around irrigation motors.

Castro County Justice of the Peace Marshall Young was advised to interview Dimmitt High School students to fill a secretarial position part-time in his office, because the

commissioners did not know yet whether the 1990-91 budget could be adjusted to allow for a full-time employee.

The May 28 meeting of the commissioners will be postponed until May 29, because of the Memorial Day holiday on May 28.

## Cotton Talks

The odds are good that federal crop insurance will continue to be available in one form or another in the 1990 farm bill now being developed in Washington.

That's the opinion expressed by Martin County farmer and ginner Myrl D. Mitchell, after he returned from Washington after participating in a hearing of the Conservation, Credit and Rural Development Subcommittee of the House Agricultural Committee.

Mitchell, a director and past president of Plains Cotton Growers, Inc. of Lubbock, testified in his capacity as chairman of the National Cotton Council's Producer Task Force on Crop Insurance.

"In light of the strong position taken by the administration, I had been concerned that federal crop insurance might be abandoned after this year in favor of a weak disaster program that wouldn't give the protection we need," he said. "But our statement was very well received by the committee and I came away with the impression that we have a good chance to save federal crop."

Mitchell also serves as cotton spokesman on a Federal Crop Insurance Commission created by Congress in 1988, and his state-

ment closely parallels recommendations for insurance program improvements made by that group last year.


Mitchell's statement stopped short of endorsing any one of the three bills, instead commending the committee for "reviewing proposals to develop a better program, and not scrap a very useful risk management tool." In addition, as he detailed the Producer Task Force's suggestions for program improvements he noted specific parts of each bill that would achieve task force objectives.

On the negative side, Mitchell voiced Task Force criticism of Grandy's proposal to create a "voucher system," and strong objections to all suggestions that federal crop insurance coverage be mandatory as a condition of farm program participation.

About the voucher system, he said, "We see this creating another unneeded and wasteful bureaucracy for government and producers without providing any substantial benefit."

On the latter issue, he stressed that "It is imperative that risk management decisions rest in the hands of producers and not be a mandatory requirement for program benefit eligibility."

A new bus route servicing handicapped students was approved by the board to complete paperwork needed to receive state reimbursement of \$1.80 per mile for the route. Ryan said the actual route will be worked out by the ARD (Admission, Review and Dismissal) committees of each campus.




