Honolulu Taps New Pay In NE Yoakum

Honolulu Oil Corporation has tapped a new upper Clear Fork pay in the Cobb area of Northeast Yoakum County.

It's No. 1 Towns, which missed the Glorieta pay of the discovery well of the Cobb field, has swabbed 5.7 barrels of oil per hour for 23 hours from open hole zone in the Clear Fork at 6,600-6,750 feet. Recovery was cut with five per cent basic sediment and acid water.

Operators were preparing to reacidize. The pay zone already has been treated with 500 gallons of mud acid and 6,000 gallons of regular acid

Near Glorieta Well

The No. 1 Towns originally was to test the Glorieta pay of the Honolulu No. 1 Cobb, one mile to the southwest. That zone, however proved nonproductive, and operators deepened to the Clear Fork and found the new pay.

The No. 1 Cobb was the discovery well of the Cobb-Glorieta field, which produces from 6,035 to 6,200 feet. It is the only producer so far in that field. The Honolulu No. 2 Paul Cobb, east offset to the discovery well, has been temporarily abandoned at a approximate total depth of 6,800 feet. It failed to develop commercial production in either the Glorieta or the Clear Fork.

Was A Dry Hole

The No. 1 Towns is 660 feet from north and west lines of section 382, block D, J. H. Gibson survey. This prospective Clear Fork dis-

covery originally was a dry hole drilled by King, Warren and Dye as their No. 1 Stewart in 1945. It was abandoned on a total depth of 5,510 feet at that time. Anti-Trust Action

Honolulu cleaned out the original hole and deepend it to the upper Clear Fork zone. Five and one-half inch casing is set at 6,600 feet.

Governor Warren In Spotlight Gov. Earl Warren's tremendous vote-getting perform- nce in the California primary once more stamps him as a nan with a bright future. Because he piled up almost wice as many votes as James Roosevelt, the Democratic ominee, he must be rated a distinct favorite for reelection to a third term as governor this Fall. And if Warren does capture this prize again, he will stablish himself as a big factor in the 1952 Republican residential race, whether or not he chooses to be a can- idate. By 1952 California's huge population gains will be ranslated into more than half a dozen new seats in Con-

gress, which means in turn that its delegations to party nominating conventions will be swelled by perhaps 14 to 16. It will pack almost as much weight as New York and Pennsylvania.

Should a victorious Warren decide to run for President, he would, of course, command this strength for himself and likely would have the Washington, Oregon and perhaps other western delegations in his camp as well.
