The expansion by Friona Ford Sales is just one example of the growth currently being experienced in Friona, and of the faith which local business people have in the future of our city and area.


WITH THE START of the special legislative session in Austin this week, Parmer County voters will be keeping an anxious eye in that direction, to see what becomes of the redistricting issue

A state district judge ruled this past weekend that the original plan, which had already been approved by Governor Bill Clements, was unconstitutional and would have to be revised.

The reason for the ruling, and for a challenge to the re-districting attempt, was that the new plan caused several districts to "unnecessarily cut across county lines" in setting up the new district boundaries.

An example of the problem was that a portion of Tarrant County (Fort Worth) would have been shifted into another district. The residents of this "cut off" portion, in the city of Azle, objected to the move.

"The people in Azle have always been in Tarrant County, but under the proposed plan, Tarrant County's representative would not have been responsive to us, because we wouldn't get to vote for them," said a spokesman. This is a big problem, and one we don't envy the lawmakers. And in the end, the folks in Parmer County and its meager 10,000 population, are at the mercy of the way the ball bounces during the hectic session. PERHAPS A MORE vital issue to residents of this area facing the legislators in Austin is a proposal by Representative Bill Clayton, which would set aside half of the state's treasury surplus each biennium in a fund to guarantee bonds for water projects. At one time, Clayton had the necessary backing for the program, which might help solve the state's water shortage. He had encountered very little opposition during the regular session, until opponents managed to stall the issue near the session's close, and force it into the special session. Governor Clements approves the plan, and has even set up a water task force to generate support for the issue, which would be to submit the program to the state's voters in the form of a constitutional amendment-still no sure thing.

But Speaker Clayton needs a twothirds majority on the water plan in both the House of Representatives and the Senate, before it can be submitted to the voters.

Clayton has done a lot for his area of the state during his tenture in the legislature, and as Speaker of the House. If he can pull off this last effort on behalf of the water needs, it would really be a plus for this area, whose water table has been declining at an alarming rate.

the Government from northern corn belt states is being sold in competition with grain produced by High Plains farmers.

GSPA Executive Director Elbert Harp said GSPA has been working with the High Plains Congressional Delegation for several months in an effort to prevent Commodity Credit Corporation (CCC) from selling these millions of bushels of corn as proposed.

"We have exhausted every political avenue," Harp said, "but despite our appeal, USDA officials announced last week that this grain will be sold on a bid basis for unrestricted use in the High Plains region.'

GSPA believes this action discriminates against High Plains grain farmers by concentrating a disproportionate share of the burden imposed upon all American farmers by the Soviet grain embargo. Harp estimates that these sales will lower the income of an average High Plains sorghum or corn producer by some \$5,000.00--50 cents per hundredweight.

## **City Sets Bond Sale**

The City of Friona has received an "A" rating on its municipal bonds, after a meeting with the bonding company recently in New York.

"We feel this was the best rating possible, for a city our size," said Friona Mayor B.K. Buske.

A special meeting has been scheduled for Monday, July 20, at 2 p.m. at the City Hall for the purpose of selling the bonds.

The \$1 million bond issue was passed to develop a water supply to supplement the city's current water supply.

The council was also apprised of the good bond rating the city had received on its municipal bond issue, and the date for selling the bonds was set for Monday, July 20.

The city received four bids on the sealcoating project, two from Borsberry Construction, and one each from Lipham Construction and Jake Diel Paving. Diel's bid was lowest, and was accepted in the amount of \$6,096.

The sealcoating program has been a regular maintenance program for city streets, but has been cut somewhat in recent years due to inflation.

Two bids were received for the new pit needed at the city's landfill area. The bid was awarded to M.D.

published in its entirety in this issue of the Friona Star. One reason for the increase, according to officials, was to "enhance the city's bond rating."

The city's application to Farmers Home Administration for a \$1,500,000 loan to fulfill requirements on the proposed water field and supply supplement for the city was discussed. The city engineer pointed out that engineering fees for the project would amount to \$48,000. After considerable discussion by the council, with attempts to secure a lower figure unavailing, the council passed a motion to accept the

# FRIONA FLASHBACKS

## ....from the files of The Friona Star

### 45 YEARS AGO -- JULY 17, 1936

Two political speakers were billed for Friona Saturday afternoon, representing the rival candidates for the State Senate, Clint Small and Curtis Douglass. The speaker for Mr. Small was Binford Arney of Amarillo, and the speaker for Mr. Douglass was Judge Newton P. Willis of Pampa. A heavy rain shower hampered the affair, ruining the loud speaker set-up of Judge Willis, who spoke from the bed of a truck. Mr. Arney departed for Bovina and Farwell without finishing his talk, being interrupted by the rain.

### 40 YEARS AGO -- JULY 18, 1941

The Friona Consumers Company, Inc., now has its entire stock merchandise moved from its old location south of the railroad, to its new location on Main Street, in the block north of the park. The new building recently erected here has been made commodious enough to admit plenty of room for the conduct of business, with filling station, wholesale supply and all. Elroy Wilson is manager of the cooperative.

### 35 YEARS AGO-JULY 12, 1946

The sad news, which filled the hearts of our people with sorrow and regret reached here last week telling of the tragic death of one of our most highly esteemed young men. Beldon Lawson, who came to his death at the hand of another at Alec, Oklahoma, where he was visiting. The young man lived in Friona only since the early part of this year when he moved with his family to a farm three miles southwest of Friona.

### 30 YEARS AGO -- JULY 12, 1951

Friona's new First Baptist Church building, of mission style architecture, was proudly displayed to the congregation last Sunday, and will hold its formal dedication this Sunday morning. Erected at a cost of \$100,000, the building features a slant-floored auditorium with a seating capacity of 540, ten classrooms, two choir rooms, a study and a nursery. The construction period has required 14 months.

### 25 YEARS AGO -- JULY 12, 1956

Friona's head football coach for next year will be Colie Huffman, 33, announces Supt. Dillie Kelley. Huffman has been at Springlake the past three years, and is well known in Plains football circles. In his seven years of coaching, Huffman's teams have won three district championships and tied for another.

### 20 YEARS AGO -- JULY 13, 1961

General rains, accompanied by isolated hail and some strong winds, soaked all of Parmer County during a four-day period from Friday through Monday. Amounts of moisture varied from about two inches in the extreme southern part of the county to 7.5 inches in the northern part. Only a few reports were less than three inches. Friona's official tally came to 3.55 inches.

### 15 YEARS AGO -- JULY 14, 1966

Joe VanZandt, Parmer County Agricultural Agent for the past two years, will become Moore County Agent on August 11, he disclosed this week.

Marc Houser, formerly of Amarillo, has joined his brothers C.O. and J.V. Houser as a third partner in Houser's Grocery.

### 10 YEARS AGO -- JULY 15, 1971

The Friona City Council voted to increase the city's tax base by 10 cents per \$100 evaluation at its regular meeting on Monday. City Manager Jake Outland recommended the tax increase, the first one for the city in 11 years, after work on the 1971-72 city budget showed that the city would be in the red without additional revenue.

### 5 YEARS AGO-JULY 11, 1976

An estimated 5,000 spectators viewed the fireworks display in Friona Sunday night, the climax to the city's Bicentennial celebration. The crowd was one of the largest ever assembled for an event in the city.

Merv Noah, administrator, announced this week that staff training classes will begin at Prairie Acres on Monday, July 12. Noah said that the Friona nursing facility still needs LVNs, nurse's aides, a food service supervisor, cooks and cook's helpers. Prairie Acres is shooting for an August 1 opening, providing that all the finishing touches can be made by that date.

I'll have to go back several years to remind you that donations of land and money started our hospital, one of the few in the nation that receives no government funding. And then donations of land, labor, materials at cost, and money built a Girl Scout House that is the envy of the Caprock Council. I wonder how many thousands of girls and their leaders would thank you for that?

Then the Boy Scouts and their leaders worked long and hard for their Scout House and again Friona came through. Do you realize that although we are one of the smallest towns in the Llano Estacado Council, we can boast the largest number of Boy Scouts (and that includes Amarillo)?

the location of Missouri Beef. Then in 1972, \$86,000 was raised to build a community center. (Run through your mind how many times you were out there in the past year).

When the need for a nursing home was realized, you not only voted more taxes for yourselves, but you also donated \$170,000. Since it opened, \$16,000 has been given just because you wanted to.

And look how you helped our Senior Citizens when they began their drive for the Friendship House-\$61,000. In return they have provided our town with a lovely place for "get togethers."

People don't only donate money, but also hours and hours of volunteer work. No town our size can boast a finer fire department, 29 men who donate time to train and risk their lives for us and on the side raise money for their equipment, some of which includes a step van, a rescue van and a jaws of life.







In order to determine what legal remedies, if any, are available to the farmers of the region, GSPA has consulted with three of the nation's leading law firms, one in Lubbock and two in Washington, D.C. It is the opinion of these attorneys that farmers and elevators in the High Plains do have legal grounds to initiate a lawsuit to block these sales or recover damages sustained as a result of this policy. Such a lawsuit could result in a landmark decision which would settle the question relating to the legality of the policies of the U.S. Government in implementing and carrying out the Soviet grain embargo.

"GSPA believes the action of CCC is illegal," Harp stated. "We are ready and willing to file a lawsuit against the U.S. Government in behalf of area grain producers if they and others in the grain related

industries of the High Plains feel this course is desirable. Of course the cost of a lawsuit of this magnitude would be tremendous and no one farmer, grain elevator or producer would be able to finance it alone."

GSPA has established a "GSPA Legal Fund" and is asking farmers and others who will support this suit to make their checks to that fund. If enough interest is shown by July 10, 1981, they will proceed with the lawsuit. If not, the money will be returned, less any expenses incurred by GSPA pertaining to this proposed suit.

"No action will be started," Harp said, unless adequate funds are available to take any and all actions to prosecute this issue to the Supreme Court if necessary.





Many who attended are looking forward to the next time they meet again, in five years.




