A BETTER STATE OF MIND

The state of mind of the people of the nation, it seems to us, is much better as the first day of 1962 approaches than it was a year ago at the same time.

Heretofore, during the last three administrations everything the nation started to do, especially in the State Department, "something would happen."

It may be that steps have been taken. The public sincerely and anxiously hopes so. Now they are beginning to believe so.

SETS A GOOD EXAMPLE

The gesture of the 1956 Study Club last week when they left some items needed in North Side High home economics department, is a reminder that other clubs and individuals could be helpful at the new school.

We are told gymnasium and home economics equipment are most desired at NHS, but that is not official. Get in touch with the superintendent of schools or the principal at North Side if you'd like to help out at the new school.

RAID ON COTTON TRAILERS

The need for empty trailers in the fields has resulted in a borrowing spree unequalled in recent cotton harvesting history. A fellow with a good many trailers left on the yard at the gin is likely to run across them again at most any gin in the area, loaded with somebody's cotton.

Since the situation is only temporary and everybody is hoping for open-weather the raids on trailers is not causing as much static as it would under other conditions.

GIVE US THIS DAY . . .

A customer at a public eating place in most any town on the high plains on Christmas Day is about the most frustrated person imaginable. Cafe people have their places closed for a very good reason.

This makes no real hardship for the few families who would like to eat out. But for the man on the country, or a traveler, it makes a first rate problem.

The rest of the business community closes up shop but thinks the cafe man should not or should make some kind of provision for the wayfarer, and the stranger caught in the community without so much as a hot point to make a cup of coffee.

We suggest the cafe people might draw straws every Christmas to see who will be it on Christmas Day.

WATER DEPLETION AND TAXES

Of quite a bit of importance in a direct way to the welfare of the people of the plains country is the income tax suit which is due to begin its journey through the courts next Wednesday.

The background for the suit has a simple and direct fact at stake: If, as is claimed by geologists and authorities, a land owner is "mining" his underground water to carry on his farming operations then he is entitled to a depletion allowance on income the same as any other mine operator.

STAKES ARE HIGH

The "principle" seems to be pretty well established in the minds of all concerned but everybody wants the depletion claim put to the test in the courts. The Internal Revenue Service is unwilling to take it upon itself to admit the validity of a claim for depletion credit.

The case has been months in the making, since all directly concerned want all the facts, both pro and con, completely advanced, so as to be sure all angles are considered. The assumption is that the case will go at least as far as a Circuit Judges court, possibly to the Supreme Court.

The bearing on the economic welfare of all irrigation districts in the nation that get water from under the ground will be enormous. At least in those states as in Texas where it is established in law that the water below the surface of a piece of land belongs to the man who has title to the land itself.

STILL DRILLING WELLS

Of the drilling of irrigation wells in the high plains district there is no end. Eighty-three permits were issued in the month of November in the High Plains Water District, seven of them in Floyd County. In this county all seven wells were drilled and put to use.

SCREWORMS ARE EXPENSIVE

The success of the Florida cattlemen in eradicating the screwworm in their area fired up cattle people of the southwest two or three years ago to try the same in this area.

But the southwestern cattle kingdom is so large (covering four states and parts of another or two, and in addition extending into Old Mexico) ability to "swing" the deal has been doubted. However, the try is to be made. It will take a relatively large amount of money and much of it will have to come by contribution.

The estimate is \$3 million, but the screwworm is costing stockmen in the State of Texas alone a \$100 million a year. Most all cattlemen will be willing to contribute something once they are convinced there is reason to expect success. No Screwworms!

High Voltage. Political war horses will snort with eagerness as they view the political outlook for the next few weeks. Not only is the time come for political decisions to be made and announcements for office to ring out, but also the legislature is to be convened on the third day of the new year.

Mr. Connally. Whether or not one finds himself willing or wantful to support the aspirations of Fort Worth business man and politician John Connally, he comes from Washington with imposing backing to announce for governor of Texas. Unknown in West Texas, down-state he will have strong backing and will have to be reckoned with. He is likely to be the man to beat.

Babson's Forecast. One of the things that impresses about Babson's forecast (in another column in this newspaper) is the recurrence of his thoughts about the influence of color, in connection with about every type of selling. Also he speaks of the real cause for continued rising prices, in the face of continued falling prices for food commodities and steady prices for raw materials in other consumer lines.

Moratorium Needed. It would be great for the nation's economy if we but knew that prices would remain stationary for a time. If labor and manufacturer would join in a resolution to hold the present level, as the president has suggested, it would be helpful at this time. But Labor leaders say there'll be no rest at the present level — not only a push for greater wage income but for shorter hours as well.

That was the kind of talk Big Labor was making when the roof fell in. True, conditions were much different in 1929 in other respects to what they are now. The time came when there was no demand for what the laborer and the manufacturer had to sell, and the big talk was just big talk. When you can't find a buyer you can't find a buyer.

Heel Flies. Somebody told it a good while ago that heel flies are part of the life cycle of the cattle grub. Since most of us believe what we are told, it is commonly said the heel fly lays the eggs, the eggs hatch out under the hock of the animal, work themselves through the body and emerge from the backs of the cow, then hatch out and are heel flies again.

They Do Emerge. Since everybody that handles cattle knows the grubs puncture a hole in the cow's back in the spring and fall out, we take all of the rest of the story for granted. That is, most of us do. But we saw in The Cattleman, or somewhere, a year or so ago—maybe something Calvin Steen said—where an old head in the cattle business was offering a reward for heel flies. He was willing to pay a dollar a piece for a bottle full of them. Did you ever see a heel fly hatch? If the grubs that emerge from the cow's back in the spring are going to be heel flies when they "hatch" looks like somebody would have seen one sometime in the act of being hatched. The old cattle-man may have something.

Public Service Co-Sponsoring Nuclear Study

The 1962 symposium will be held at the University of Texas June 10 through June 13. The Austin campus was also the scene of last year's meeting, attended by more than 400 students and instructors, including more than 30 from Southwestern Public Service Company's service area.

The 1962 symposium is part of the continuing program of the Texas Atomic Energy Research Foundation, of which we are members, to advance knowledge of nuclear science through research and education. It also provides an opportunity for our high school students and instructors to meet with outstanding scientists from across the country.

Damaging Fire Hits Yard Of So. Plains Gin

The Floydada fire boys were kept relatively busy during Christmas with several fires resulting in minor to heavy damage.

Christmas Day they had a call about 2:30 north of town where a grass fire was well underway. Some 40 acres of grass was destroyed but nothing else damaged.

Tuesday morning about 4:15 they were called to Dougherty where a barn on the Fred Cardinal place was burning. The gin crew at Dougherty noticed the smoke and went to the scene where they woke the Cardinal family.

The riding horse of the Cardinals was rescued from the blazing building just before it caved in.

Other than a total loss of the building, feed stored in the building also was destroyed.

One of the fireboys, Fred Lambert, had the misfortune of stepping on a rusty nail and injuring his foot quite painfully.

Cause of the blaze was undetermined. The family had been away from home all day and the building was not wired for electricity.

Later in the morning Tuesday firemen rushed to South Plains Co-op Gin where several loaded cotton trailers caught fire from the burr burner. Lockney Fire Department assisted in bringing the fire under control. Mrs. Ruth Fitzgerald, bookkeeper at the gin, said estimate of damage had not been made as late as noon Tuesday.

Cotton, Trailer Loss Heavy

Billy Joe Baker said late yesterday that some 40 loaded trailers caught at the gin with 20 a complete loss and the other 20 heavily damaged.

To cap it off Baker said, the number 1 pumps, one from Floydada and the other from Lockney, used all their water and none within a two mile radius of the gin could be located.

Only one truck from each department is allowed outside the city limits. Lockney's truck carried 500 gallons of wet water and Floydada's truck 375. Firemen made the rounds in the South Plains area looking for water but to no avail. Irrigation wells located were not in operation.

Cables were tied onto the trailers that were burning and the cotton pumped. Several chasses were saved in this manner.

The firemen worked at the blaze most of the day, their job complicated by high winds out of the northeast.

Another fire call for the local department was on Friday at 12:30 when three trailers caught fire at the Farmer's Co-op Gin. No trailers were lost but there was a loss. They were called back again to the gin about 1:20 when cotton on the yard caught. No damage resulted at that time.

CRISIS - Reporting in a current magazine, Dr. Gerald Caplan, psychiatrist and associate professor of mental health, and his associates at Harvard have made a study of why some people can stand up to trouble and strain. The important result of the study is not a help-yourself to happiness formula, but rather a way in which all of us can help those we love to face a crisis. What can we do to provide the helping hand in time of trouble?

1. Help him confront the crisis, help him talk about it, to grieve and even cry.
2. Help him to confront the crisis in manageable doses. Sometimes the need for "taking the mind off it" will be apparent but always gently lead him back to the reality that must be uppermost in his mind.

3. Help him to find the facts of the unknown is infinitely more frightening than the known.
4. Don't give him false reassurance. The kind of reassurance that he needs is not the meaningless comfort that the crisis will take care of itself, but our own statement of faith that he will be strong enough to work it out and the availability of ourselves to help him.

5. Don't encourage him to blame others - blaming is a way of avoiding trouble.
6. Help him to accept help. This is acknowledging his trouble rather than pretending it does not exist.

Committee refused, the banks would testify "under protest."

Committee had sent questionnaires to 469 national banks in Texas. Only 68 gave some or all information about the number of dormant accounts they hold and the amounts in these accounts.

Out of the 536 state banks queried by the committee, only 100 furnished the information.

Prime reason for the specially called session by Gov. Price Daniel is the enactment of laws to force banks to locate the owners or heirs of unclaimed deposits.

Some banks are even levying charges against the accounts even though the accounts are inactive, he reports.

Few, if any of the banks, have ever advertised to find the rightful owners.

Gov. Daniel feels that the banks should exert every effort possible to locate the owners, including advertising, or turn the funds over to the state for the protection of the depositors. Such steps have been taken in a number of other states.

HOPEFUL SIGN—Texas Commission on Alcoholism reports good results in its six-year-old program of rehabilitation for alcoholics in state hospitals, and progress with prison system inmates. But it is still concerned about the estimated 250,000 drinkers in Texas who need treatment.

Commission says 2,334 patients were treated for alcoholism in six state hospitals during fiscal 1961.

Improvement after six months from date of discharge was reported by about 500 out of 1,600 patients released last year.

In less than 18 months, the number of alcoholics participating in prison rehabilitation programs has grown from 800 to 3,000.

Commission now lists councils on alcoholism in 29 Texas cities, working to educate the public to recognize alcoholism as a disease. Their attempts are aimed at the 250,000 ailing alcoholics and their families—as well as the 4,000,000 Texans who use alcohol.

CHAIRMAN CHALLENGED—Governatorial candidate Will Wilson has charged State Democratic Executive Committee Chairman J. Ed Connally with reserving the committee's mailing list of 20,000 Democrats for incumbent governors, "to the exclusion of other Democrats outside the Executive Committee itself."

Wilson contended that the list is the property of all Texas Democrats. He asked the committee to adopt a resolution

making the mailing list available to all Democratic candidates for use in party primaries.

Wilson has accepted an invitation to face opponent John Connally in a debate.

Weslaco attorney Jon DeLawrence extended the invitation to both gubernatorial candidates on behalf of the Weslaco Jaycees, but Connally hasn't replied.

Principal issue of the debate would be: "Is the Governor of Texas To Be a Number One Chief Executive — or somebody else's agent?"

THE BUSINESS AT HAND—The Attorney General's assistants have been busy writing opinions on everything from a major gas company dispute to a matter of land willed to the Baptist General Convention.

The Attorney General intervened in a case in the 43rd District Court at Parker County, making a motion to set aside a default judgment voiding conveyance of 1,000 acres of land to the Baptist General Convention.

Mr. and Mrs. W. H. Stocks Sr. willed the land in Parker and Hood Counties to the Baptists in 1955, but their son John Stocks alleges his parents were not legally competent at the time.

Wilson made his motion under a statute which said the Attorney General may be made a party to any suit to annul or impair any instrument creating or affecting a charitable trust.

As representative of the Texas Railroad Commission, the City of San Antonio, the City Public Service Board and Alamo Gas Supply Company, the Attorney General filed a motion with the Supreme Court asking it to compel 128th District Judge Jack Roberts of Austin to enter judgment in San Antonio's gas contract dispute.

Motion arises from a suit filed by United Gas, which is contracted to supply gas for San Antonio until April 1, when Alamo Gas is scheduled to take over.

Judge Roberts has said the case was out of his court's jurisdiction. Railroad Commission ruled that it has no jurisdiction in the dispute.

The Attorney General also has ruled that:

1. Failure to possess a valid poll tax does not disqualify a juror in any criminal case.
2. It's unconstitutional for a court to authorize a sheriff to destroy property seized from arrested persons in county jail, even if property is unclaimed for 90 days.
3. State Education Commission has the right to audit state funds in county administration and school transportation funds.

Short Short Snorts
Speaker James A. Turman says the "staggering costs of government" could be reduced if qualified voters would take an active interest.

He estimates spending in local, state and national government has risen 156 per cent since 1950, and points to the fact that recently two state representatives were elected by less than six per cent of the qualified voters in their areas.

Capitol hostess Mrs. J. W. Beck will resign on February 1. The senator's widow, who has talked to hundreds of thousands of tourists in her 14 years at the Capitol, is staying through the special session at the Governor's request.

State Securities Commission issued permits to sell more than \$49,000,000 worth of securities during November.

Welfare Commissioner John H. Winters says the Aid to Dependent Children program is "Charged with aiding immorality," but that only 20 per cent of the 59,809 Texas children receiving ADC are illegitimate.

On the other hand, there are 131,133 illegitimate children in the eligible age bracket (under 14 in Texas today, he states, U. S. Senator Ralph Yarborough called on Secretary of Agriculture Orville Freeman to act immediately to establish a price support program on some 10,000 tons of peanuts damaged in a freeze in Texas.

Yarborough, in his Austin office, also asked Freeman to support the use of cotton wrapping for cotton bales.


