Private planes piloted by Harvey Rogers and Reginald Monroe joined in the search begun by several men from town on foot and horseback and in cars. They were aided by Sheriff Jim Nance and deputy B. F. Anderson and E. M. Rainbolt and Garland Inmon of the Border Patrol who used their cars and field glasses.

Tracks made by the children's tennis shoes were found but soon no further clues were available.

Sheriff Nance had begun to organize a searching party about 4:30 when W. T. Shurley, of Uvalde, and his son, W. T. Jr., drove up to the Goldwire ranch with the children all safe and sound. They had found the Shurleys at the Brown ranch.

Carolyn and Paul reported that when they realized they were lost, they decided to continue walking in the hope that they would arrive somewhere and by chance come to the Brown ranch headquarters. A straight cross-country hike would have measured ten or fifteen miles and in their wanderings, the children probably walked more since they were not familiar with the country. They expressed surprise that a search for them had begun and that so many people were worried about them.

A. W. Pope, Terrell County resident engineer, revealed today that plans are underway to begin work on the paving of the Pecos County end of the Sanderson-Fort Stockton highway in the late summer of this year. Plans of paving are being submitted by Mr. Pope for the first 34 miles north of the Terrell County line and the remainder will be handled out of the Pecos County office under the supervision of E. L. Pearce, resident engineer, of Fort Stockton.

The state highway commission has allotted \$12,500 per mile for paving which will include complete grading job, base for paving, asphalt surface and bridges over all big creeks. The road is to be a standard state highway of secondary class comparable to the Fort Stockton-Pecos highway and the Fort Stockton-Grandfalls highway, now under construction, Mr. Pope revealed.

According to Mr. Pope the highway will generally, and where possible, follow the road bed to Fort Stockton. This is necessary, he said, because of the limited funds available, but it will not mean that the highway will be of lesser quality than any other secondary road. He said that the difference in the secondary and first-class roads was about 4-feet to 3-feet difference in the width of the road bed and wider bridges and approaches. The road will have as good a surface as any road in the area, Mr. Pope added.

Pending approval of plans and availability of labor, work will start in the late summer on the road construction.

A. W. Pope, Terrell County resident engineer, revealed today that plans are underway to begin work on the paving of the Pecos County end of the Sanderson-Fort Stockton highway in the late summer of this year. Plans of paving are being submitted by Mr. Pope for the first 34 miles north of the Terrell County line and the remainder will be handled out of the Pecos County office under the supervision of E. L. Pearce, resident engineer, of Fort Stockton.

The state highway Commission has allotted \$12,000 per mile for paving which will include complete grading job, base for paving, asphalt surface and bridges over all big creeks. The road is to be a standard state highway of secondary class comparable to the Fort Stockton-Pecos highway and the Fort Stockton-Grandfalls highway, now under construction, Mr. Pope revealed.

According to Mr. Pope the highway will generally, and where possible, follow the road bed to Fort Stockton. This is necessary, he said, because of the limited funds available, but it will not mean that the highway will be of lesser quality than any other secondary road. He said that the difference in the secondary and first-class roads was about 4-feet to 3-feet difference in the width of the road bed and wider bridges and approaches. The road will have as good a surface as any road in the area, Mr. Pope added.

Pending approval of plans and availability of labor, work will start in the late summer on the road construction.

**KITCHEN MEMO** BY JEAN CLARKE

If your family is surfeited with rich holiday food swing a change with low-cost, nutritious *Chili Con Carne*. This recipe takes little time and fuel to cook and helps use leftovers. Melt 2 *tblsp. drippings* and brown  $\frac{3}{4}$  lb. ground beef. Add 1 large onion, 1 diced green pepper and  $\frac{1}{4}$  lb. sliced mushrooms. Cook over medium flame for 5 mins. Then add 1 stalk celery, diced, 1 can kidney beans, 2 cups tomatoes, 2 *tblsp. chili powder*, salt, pepper. Cover and bring to a boil. Then turn the flame to simmer point and cook 30 mins. Serves 6.

Butter or chocolate must be heated slowly and carefully else the butter will separate and chocolate will thicken and lose moisture. The keep-warm or melting heat of your simmer burner is ideal because its temperature goes as low as 125°-150°.

Fish is usually baked at moderate temperature of 350°, or higher if cut thick. Try putting it on a piece of well-oiled cheesecloth for easy removal from the pan after roasting. Less fatty types of fish can be browned after oven-roasting by slipping them under the broiler for a few minutes.

Leftover chopped turkey or chicken combined with vegetables, folded into condensed mushroom soup and served over macaroni, spaghetti, or noodles makes a cost-saving lunch dish.

Put peach halves in a baking pan. Sprinkle with sugar, dot with butter, bake at 400° for 15 minutes. Serve warm with plain cream.

It seems hard to believe but think it over. Take the town, for instance: some-loving people—spend an evening by a mellow glass of beer in search of entertainment.

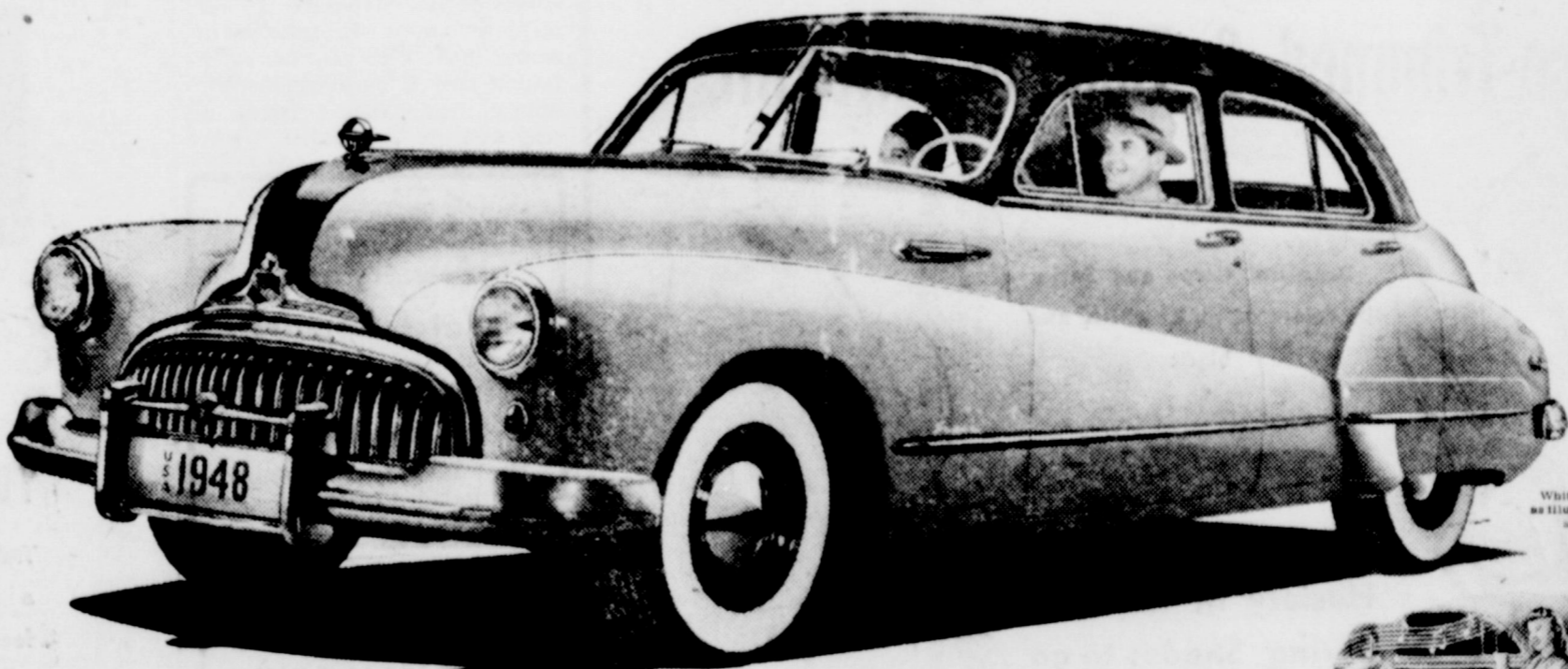
It is natural they put more money to them and their homes. They

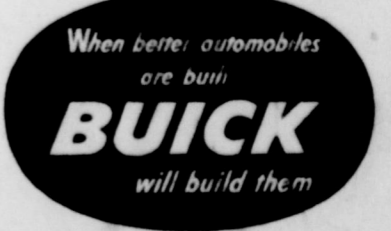

ECONOMIC HIGHLIGHTS

An understandable caution dominates the business forecasters these days. They've been wrong so often with guesses that backfired that they are hedging their current predictions with a protective fog of "ifs" "ands" and "buts". This has been particularly true in the analyses of turbulence in the commodity exchanges. No one in a responsible position has been willing to offer a really unequivocal opinion on whether basic commodity prices will keep on going down, will stabilize, or will recover strongly and resume their climb into the economic stratosphere.

Bank lending, says the News, is now becoming more restricted. Marginal borrowers, especially, are being discouraged. A bank economist is quoted as saying, "The overall situation of business is quite strong at the moment, but, under present conditions an individual could lose his shirt in 30 days." Bankers are keeping a wary watch on the price and business volume indices. They are advising their customers not to get over-extended. Some concerns, which were riding the top of the wave not so long ago, are actually on the brink of failure now, due to over-optimistic commitments. As the Chicago Federal Reserve Bank expresses it, in the jargon of finance, "an increasing number of individuals and business firms are experiencing financial stringencies and hence are becoming more and more vulnerable to any interruption or slowing down in income or production."

The inventory problem is another potential headache. Manufacturers, wholesalers and retailers all are carrying inventories that, measured in dollars, are double or more the prewar level. A sharp price break could cause an untold loss. Thus, the tendency may well be to gradually reduce inventories, and to replenish with care. The big retailers are being especially watchful, and are counselling their industry to get absolutely top value for each dollar spent. The retailers are the first to feel customer resistance when it appears, and it has been noticeable lately in some lines, such as high priced foods, and luxury and semi-luxury goods. As a general principle, practically everyone believes that a certain amount of price decline would be extremely desirable. But few believe that the country could stand a return of prices to the 1941 or any similar level, even if such a miracle were possible. The whole economic and governmental structure is based upon an enormous national income, and that can be maintained only if employment, value of business and prices all stay well up 48 a nation, we are

which may prove to be a definite influence in the near future. That is the state for business and consumer thinking. When people think prices are coming down - whether their logic is sound or full of holes - they will defer all possible purchases. The industrial purchasing agent as well as the individual will do that. This factor can be especially important in such fields as industrial and residential building.
