## Terrell Included In 9-County Area For TB Work

Ten members of the Terrell County Tuberculosis and Health Association attended a meeting at the Indian Lodge near Fort Davis Saturday for a luncheon after which plans were continued for the organization of a nine-county area of the Texas Tuberculosis Association. An effort is being made to organize all of the state into areas instead of county organizations and this was the first meeting to start the change-over for this area which will be known hereafter as the Trans-Pecos Tuberculosis and Respiratory Disease Area. The nine counties comprising the area will be El Paso, Hudspeth, Culberson, Brewster, Pecos, Reeves, Jeff Davis, Presidio and Terrell.

The final organization of the area will be at the next meeting on March 9 in Van Horn. Dr. John Shelby of Lubbock presided at the meeting until the members of the steering committee were named and then James A. Abernathy of El Paso presided at the session of that committee with Mrs. Pete Nessmith serving as secretary. Plans were made to hire an executive secretary for the area at a salary of \$9,000 and traveling expenses.

Mrs. A. J. Hahn and C. G. Riggins were named as representatives to the area board.

Also attending the meeting were Mrs. H. E. Ezelle, president of the local Association, R. S. Wilkinson, Rev. M. R. Rogers, Rev. and Mrs. M. A. Walker, Mmes. M. W. Duncan, C. P. Peavy and Clyde Higgins.

## Tax Payments, Voter Registration Due by January 31

Tax statements have been mailed from the offices of the county and school tax collectors to the property owners of Terrell County.

Discounts are available on early payment of county taxes, but not on early payment of the school taxes.

Mrs. Tol Murrah, deputy collector in the county office, stated that 68 voters had registered through Monday of this week and reminded all persons who wished to vote to be sure and register if they were otherwise eligible to complete their eligibility.

There is no charge to register to vote, but everyone must register, regardless of age or residence.

This is a change in the voter registration law which was amended to require all voters to register. It is a change in keeping with the constitutional amendment voted on at the general election in 1966.

The deadline for registering is January 31, 1968.

Persons over 60 years of age, living outside cities of 10,000 or more, who heretofore have not been required to register, are now required to register in order to be eligible to vote.

### Antlerless Deer Permits Issue To Be Nov. 8

The Texas Parks and Wildlife Department has announced the dates and locations for issuing antlerless deer permits in eight of the 10 regulatory responsibility districts.

Permits will be issued to qualified landowners or the appointed representatives between 8 a. m. and 5 p. m. on the date and location as indicated for each county. Permits must be drawn in the county where they are to be used. For Terrell County the date is November 8 and the location is the courthouse.

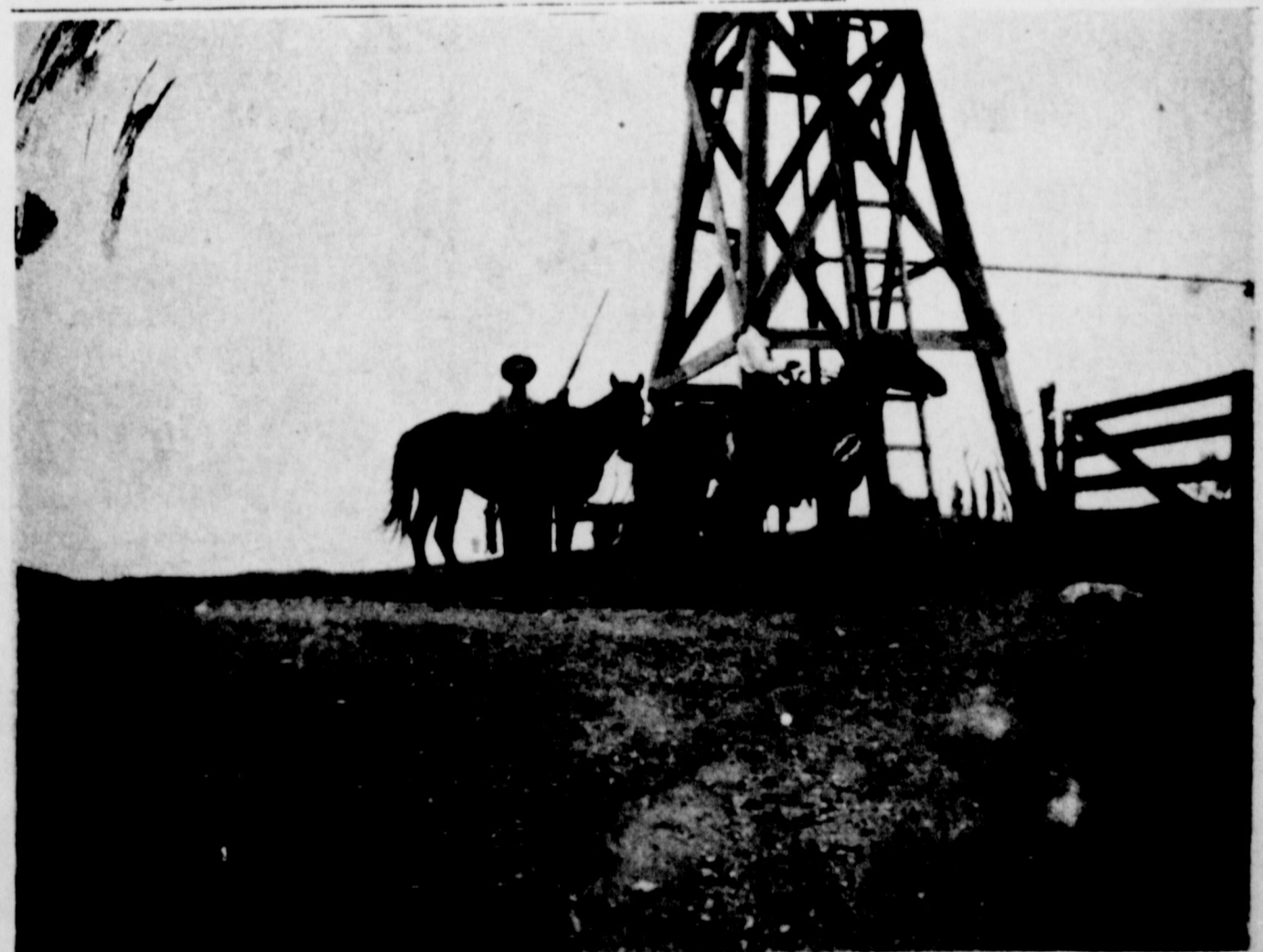
The hosts scored six points in the first quarter, 23 in the second period, 22 in the third, and slacked off in the fourth to give the Sanderson team breath to board the bus for home.

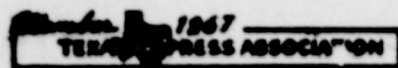

Coffee, tea, and orange Danish rolls were served during the social period.

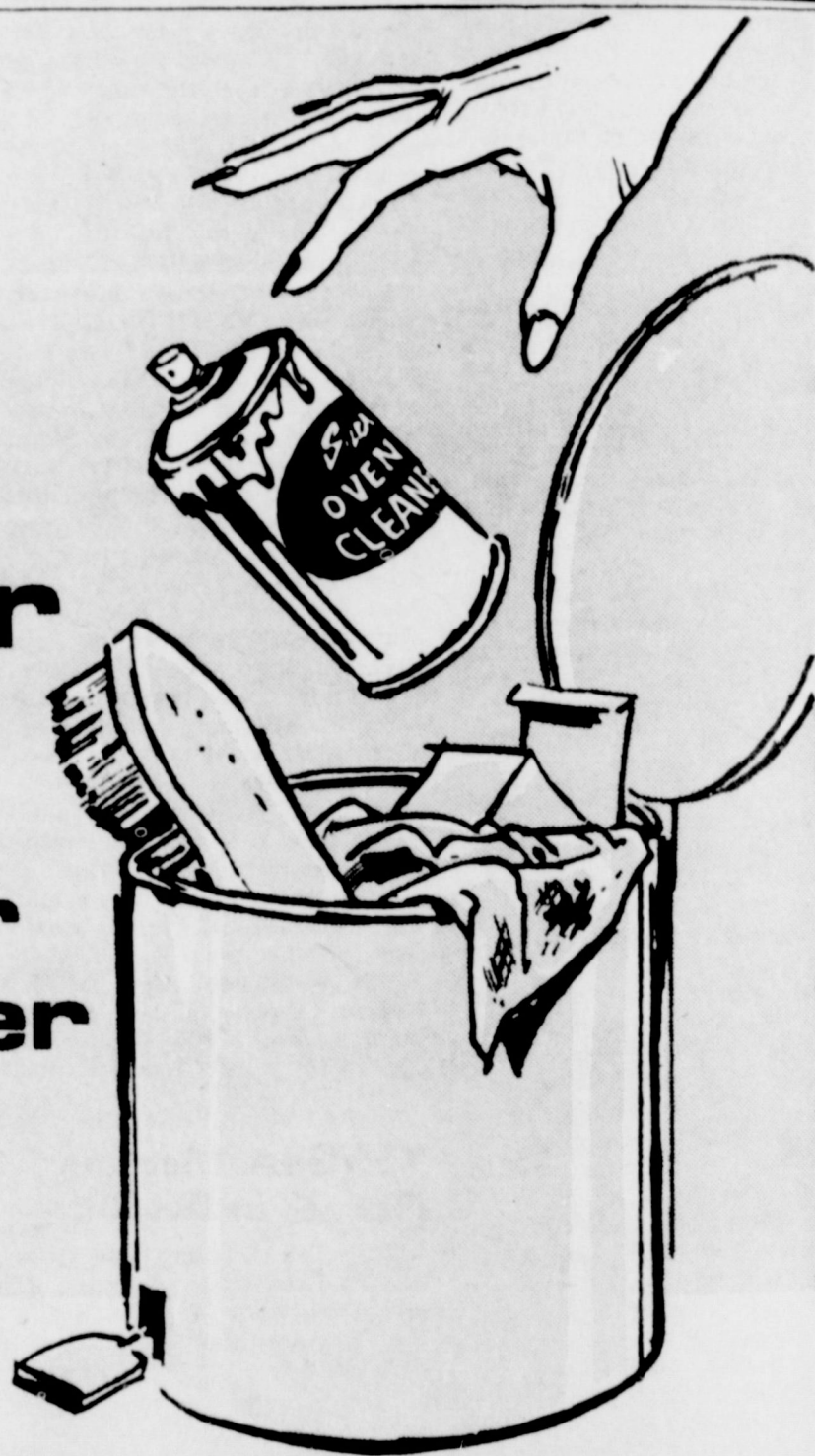

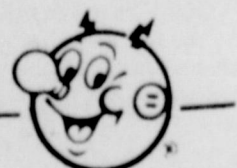

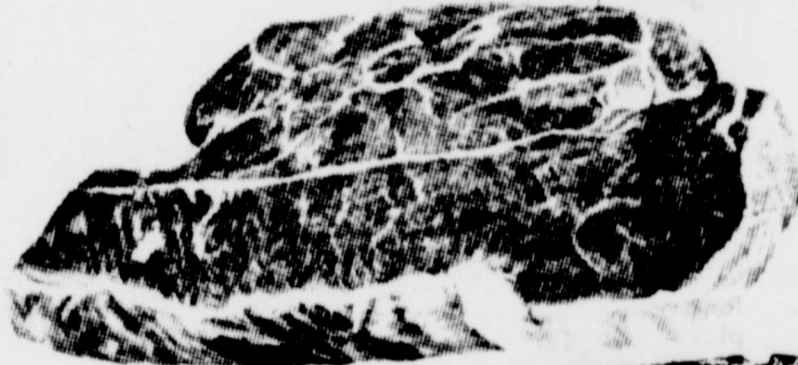

### Psychiatry---

## Know When To Seek Help

How does one know when he should consult a psychiatrist?

Today's Health, the magazine of the American Medical Association, reports that most people who should consult a psychiatrist are likely to consider themselves as someone not needing his services.

Many shun the psychiatrist, the AMA says, because they have the distorted concept that people who are under psychiatric care are "crazy."

Psychiatrists are physicians with a special training through which they are able to help people with mental illness or emotional problems, even as other physicians are qualified to assist in physical illness. Often physical and mental ills are closely related.

Depression, or what we could call the blues, is frequently an early sign of what can become a disabling mental illness. Likewise, excitement and overactivity - although often completely normal - form an abnormal sign when they occur in the wrong place or for the wrong reason.

Other suggestive symptoms include tantrums and exaggerated expressions of anger, hysterical attacks, unfounded fear, and guilt feelings which exist without an acceptable reason.

Any of these would justify discussing the need for psychiatric consultation with your physician.
