We hope that public school music will continue in Sanderson and that there will be more and more participation and more and more programs.

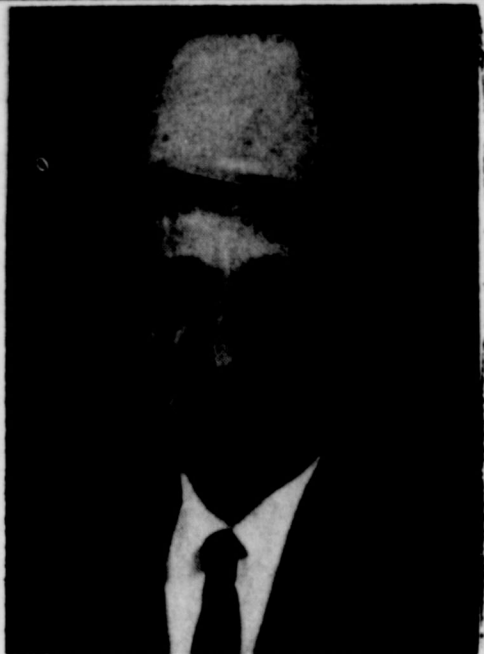

We learned, too, that some places had to have police protection for the officials at, during, and after the game and for the visiting team after the game and on leaving town. It is also recommended, we are told, to have the National Anthem played in order to aid in keeping the crowd in order.

We have seen few times in Sanderson when there was any disturbance at all at the basketball games during the past 20 years, and we hope that we see very few more during the next 20. And we would hope that all of our local fans who visit other towns as fans continue to act as they have in the

Approved payment for a new 60-passenger bus, \$6,828.

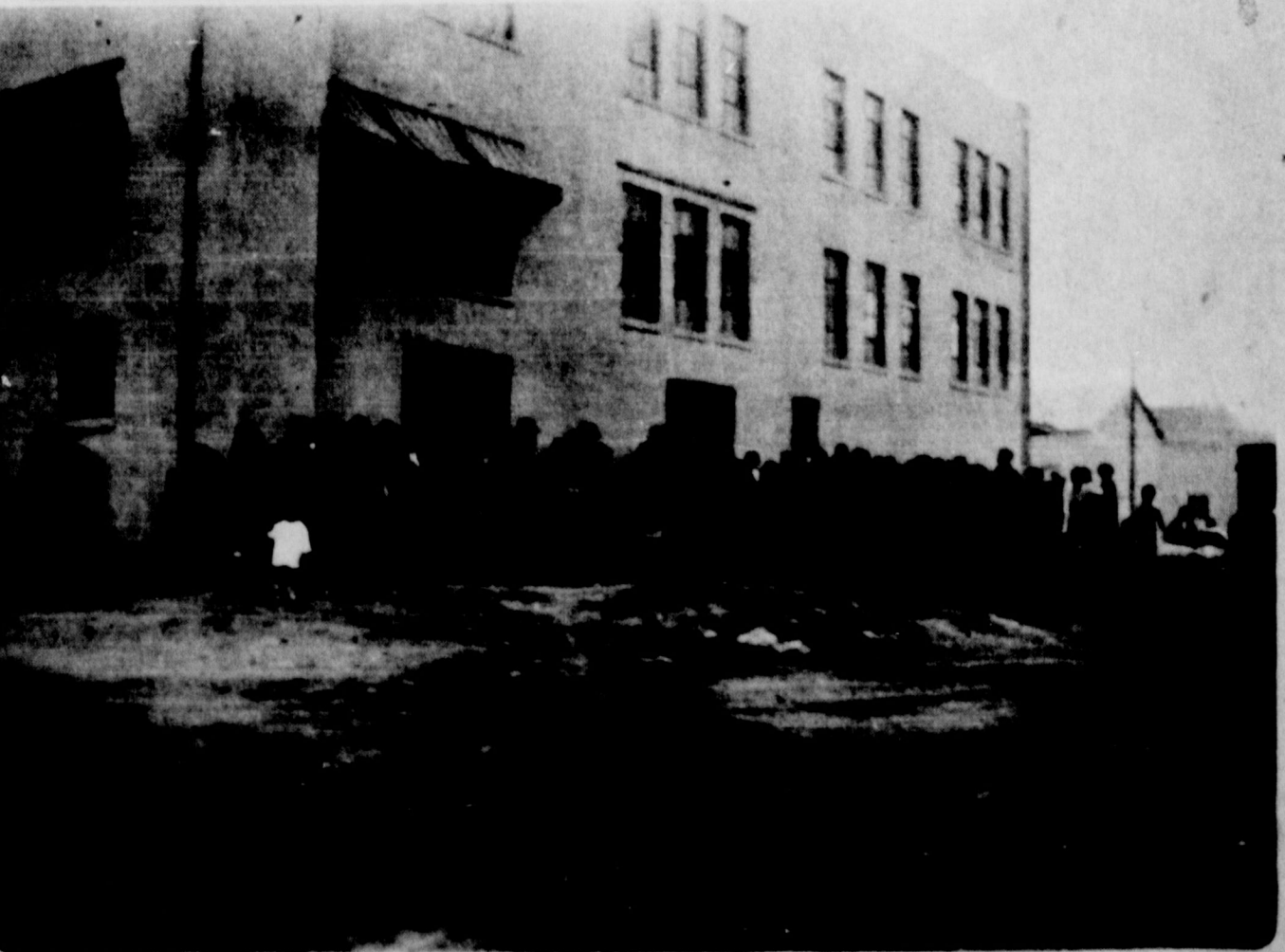
Discussed following items: financial report of football season past; enrollment and attendance report of first two six-weeks periods; tabbed plans to join Region XVIII Education centers.

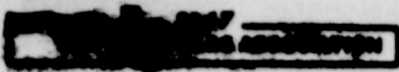

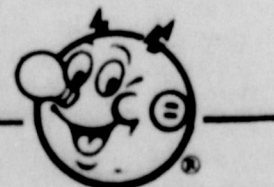

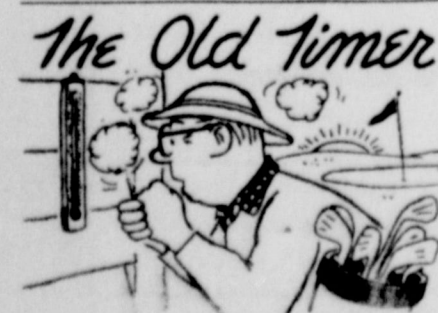
