was with a great deal of interest that we listened to the speech of Gordon McClendon, a candidate who withdrew from the race for governor of Texas because he could not support "a president" in a bid for a second elected term.

We wonder if this is a pre-scientist: for a Democratic hope for the job of governor, and it is then how many other candidates in the Democratic primary would answer that question publicly: Would he support a president in a race for a second term? It might be that the people --- I don't have an idea who! --- would like to know that about a man before an election.

We don't know that it's indicative of anything, but we know several people who would not seek county or local Democratic jobs because they said flatly that they would not be able to support a race for re-election of a president!

It might be an indication that there will be some split-ticket voting in a general election under certain circumstances.

The Terrell County Chamber of Commerce last weekend committed itself to an expenditure of \$105.00 to purchase signs that would go on US 90 and US 15 showing that this was a part of the Pecos Trail, which has been given some national and excellent state-wide publicity. Much has been done by the state to publicize these Texas Trails and to encourage the traveler to see some of the sights along the trails.

It appeared to the Chamber directors that this was an effort on the part of someone else to help us and that the least we could do would be to spend just a little bit of money to help ourselves. It was not a request of \$1,500,000.00, only \$105. There has been comparatively little done of late to help ourselves, and every citizen who is interested in the town and county knows that we all can use all the help we can get.

It is the state tax dollar that is being spent in the advertising of all of the Texas Trails and it would seem that a little bit of tax money might be spent in developing the Pecos Trail so that it will be appealing to the traveler.

We heard on television the other night and Monday there was a cartoon in the paper with the same theme: a person who leaves the keys in his car is an accomplice to car theft by not removing the temptations from people, with reference particularly to young people, or first-time offenders.

How could such a distorted concept of honesty come about? What has happened to our moral codes? What has happened to our teaching?

We were taught and we have always believed that it was wrong to steal and it should not be done because it was wrong, for another reason it was not to be done because we should have respect for the rights of others, and another reason it was not to be done was because if

Besides his widow, Mrs. Opal Wood, he is survived by a daughter, Mrs. Cecil Dean, of Albuquerque, N.M. A son, Bobby Sid Wood, died a month ago.

## Snow, Sleet, Rain For Several Days Over This Area

What is hoped to be the last wintry blast hit this area Sunday morning in the form of sleet and snow. The severe weather caught several ranchmen in some process of shearing either sheep or goats and there is expected to be a high death loss in goat herds as a result.

There was some moisture fell Saturday in the form of spring showers. Sunday morning dawned cold and dismal and a light shower began falling early after daybreak, soon turning to sleet, then to snow at about 9:30 in the morning. The large wet flakes soon covered the ground but most of the snow melted during the afternoon and about dark there was another flurry of snow which appeared might last all night, but it subsided before late. There were intermittent flurries of snow throughout the day Sunday.

Snowfall and ice were said to have been heavier to the west and north and the highway traffic was heavier through here Sunday, possibly due to the re-routing of traffic over the southern route.

A slow rain fell locally from Monday afternoon until the time of this writing late Tuesday afternoon.

## Eagle Lumber Co. Quits Business

The Eagle Lumber Co. quit business in Sanderson as of March 1 after 28 years of operation in Sanderson.

The company, first known as Alamo Lumber Co., opened its business here with R. V. Raney as manager, on the southwest corner of Oak and School Sts., in the building now used by Jolly Harkins as a warehouse. H. A. Finger, who replaced Raney as manager of the company here, built the building on the northeast corner of Oak and School Streets in 1948 and the company moved its business over there in June of that year.

Subsequent managers of the company included Don Anderson, Guss Ross, and Bill Smith.

## Dog Registration Due By April 1

Mrs. C. E. Litton, county treasurer, stated that April 1 is the deadline for registration of dogs in Terrell County. The registration of dogs in the county annually is in compliance with an existing state law which is being enforced by Aubry Harrell in an effort to control the animals.

Stray and unwanted dogs are often turned loose on the town, according to Harrell, and these animals are sometimes guilty of killing and maiming sheep and lambs and are particularly harmful to the sheep near town at this time of the year when lambs are young. The law, besides requiring that all dogs be registered, also specifies that dogs will be kept penned or leashed during the hours between sunset and sunrise, according to Harrell, and he is making every effort to enforce all phases of the law.

The cooperation of the people of Sanderson is urgently requested by Mrs. Litton in the registering of the dogs, and by Harrell in his efforts to control the animals.

## Three Seek Posts On School Board

Jack Harrell is seeking reelection as a member of the Terrell County Independent School District Board of Trustees and Ernest Harkins is another announced candidate, according to A. H. Zuberbuehler, school tax collector. Harkins previously served on the board.

The unexpired term of Carlos Dunn, who moved from Sanderson, was filled by Darwin Schrader until the election of a new trustee, but it is understood that Schrader will not be able to hold the post because of existing laws concerning federal employees. Harrell and Harkins have announced for full-term three year jobs on the board.

Will J. Murray has placed his name on the ballot for the year remaining in the term of Dunn.

O. D. Gray is the other retiring board member and he has served for one term.

Pete Snelson  
... State Senator hopeful

Pledging an aggressive, hard-hitting campaign with a full discussion of the issues, Pete Snelson this week formally announced his candidacy for the State Senate from the 25th District in the May 4th Democratic Primary.

"There will be new leadership in the Texas Senate next January and it is vital that our part of West Texas have a voice which is in step with the future, and not the past," said Snelson. "People from throughout the 21-county district have urged me to again serve in the Senate."

A native West Texan, Snelson formerly served in the House of Representatives and the Texas Senate. Redistricting resulted in the combining of parts of two senatorial districts two years ago and Snelson lost to the present incumbent by 61 votes.

"I greatly appreciate the fine support which I received in Terrell County two years ago in the race for the state senate," said Snelson, "and I am very pleased that many others have volunteered their help for the campaign this year."

Snelson reviewed some of the objectives which he plans to pursue in the Legislature.

"Foremost among my legislative goals is the passage of a conflict of interest law to prevent legislators from appearing for pay before state agencies," said Snelson. "A cure for influence peddling by legislators was recently cited by Governor John Connally as one of the greatest needs of our state government and I intend to work

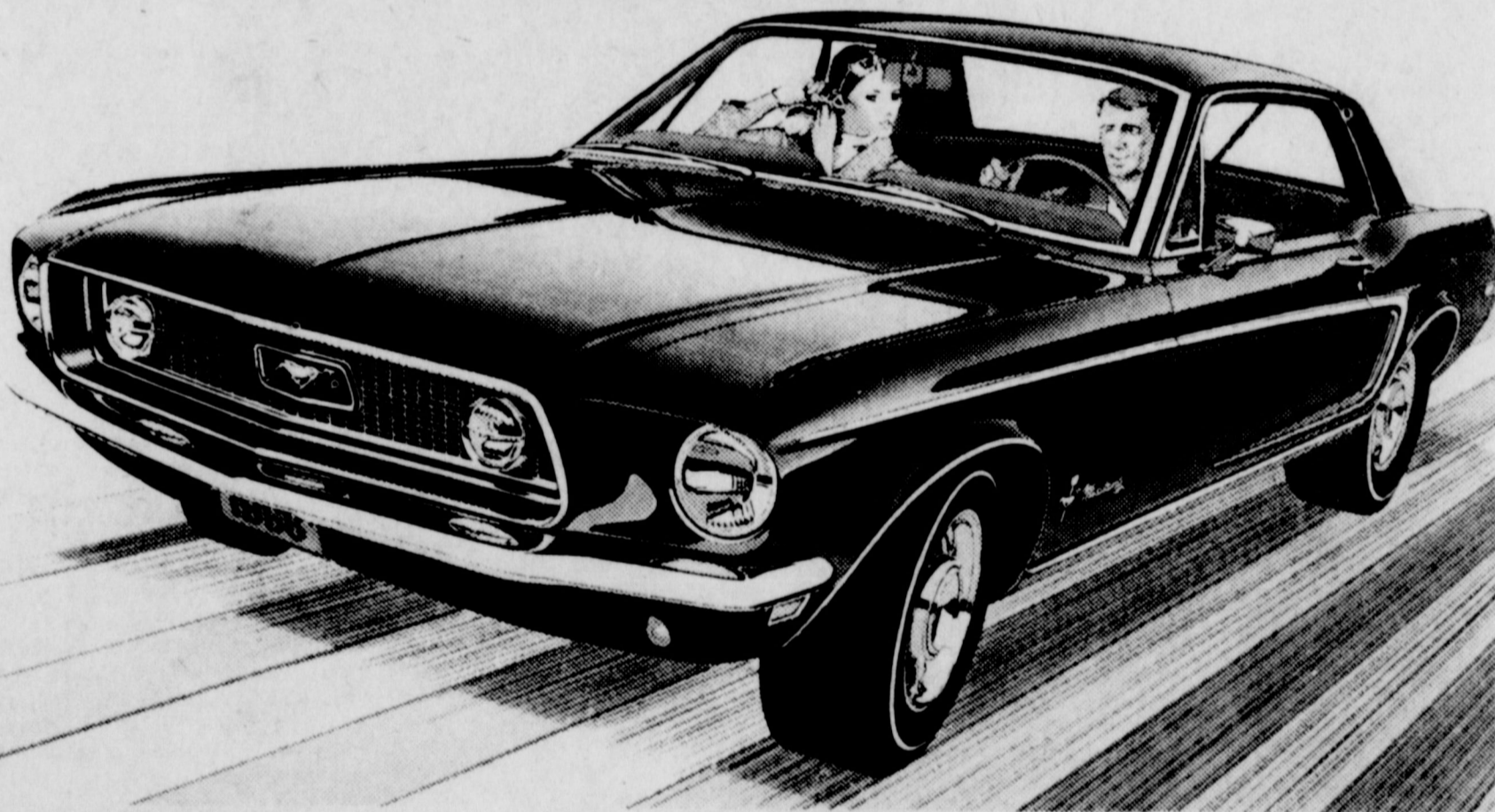
**FTAers MISS CONVENTION**

Tommy Couch, a student at Schreiner Institute in Kerrville, spent last weekend here with his

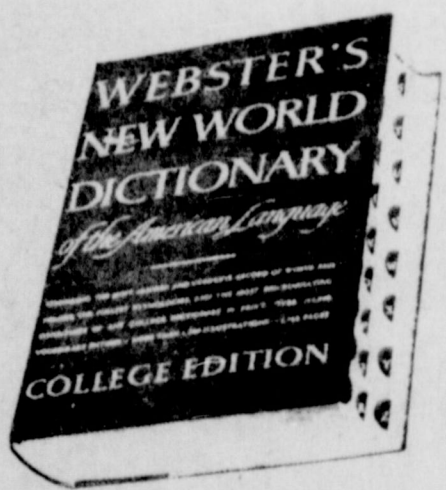
