We got a couple of written bouquets on our choice of words in this column last week and we did appreciate them. We did read the words prior to the printing and were in complete harmony with the message. We would like to be able to live up to all of it.

We have had unseasonably cold weather, it seems to us, and the temperature is a little colder than we can remember it being last year. But we always notice cold much more than heat and are awafe of the fact that the thermometer is below 75 when it is -- and we don't like it!

We keep wondering when the people of this nation and state are going to begin to do some thing about the needless loss of lives on our highways. We have heard of every kind of remedy about the necessity of courtesy, friendliness, awareness, caution, and all of them are good suggestions if they work. But they haven't worked yet!

If there was strict law enforcement all over the state in all of the traffic laws, and if there were stiff penalties applied all over the state by magistrates, it is our opinion that this would be the greatest deterrent that could be devised There was a time when the law required - and a few JPs went by the law - for all persons charged with a misdemeanor in JP court, to be at the court either in person or be represented by legal counsel in that court. And this was a very great deterrent. We know this from experience. But is has to be state-wide to be really effective, and the state-wide movement had to start some where. It just never did spread very far! The JP courts of the state got the disrespectful name of "Mickey Mouse" courts, but they usually earned that name because of the Mickey Mouse JPs who did not uphold the laws, wholet officers dictate the punishment - if any - to be adjudged the defendant and there was no respect given because there was none deserved or earned. Since the Texas Department of Public Safety has proclaimed that speed is a major factor in some large percentage of accidents - particularly fatalities the awareness of inconvenience of going before a magistrate in person or hiring an attorney to do so gives a person a cautious driving nature even if the concern for other persons' or their own lives does not make them careful, defensive, considerate, friendly, or whatever the adjective.

Alien Registration Due This Month

District Director, John W. Holland, San Antonic, of the Immigration and Naturalization Service estimated that 103.000 aliens will report their addresses in the San Antonio Area during January under the Federal Alien Address Report Program.

The Immigration official said that 102,517 aliens repor ed their addresses during January 1962.

Mr. Holland said that all non-citizens; except those in diplematic status and forein representatives of certain international organizations, are required o file the address report.

Col. Durbon is survived by his father, W. C. Durbon, of Eldorado; his mother, Mrs. Madelyn Smith of Junction; two sisters, Mrs. Maude Doran and Mrs. Willie Doran, both of Sonora; a son, Lt. William O. Durbon, stationed in Japan; a daughter, Mrs. Diana Crose of Long Beach, Calif., and a grandson.

Col. Durbon was born in D'Hanis on February 25, 1917. He was a career Air Force officer and was a veteran of both World War II and the Korean War. He returned to Junction after his release from the service several years ago.

About Half Of Vote Gas Flows From **Potential Registers**

A check with the county tax assessor-collector's office this week revealed that 343 residents had registered to vote in 1970 elections at the end of the year. There are about 700 qualified voters in the county, over 300 of whom have not registered.

Residents have until Jan. 31 to register. To be eligible to vote in the 1970 elections everyone must register without exception. There are no exemption for age as in previous years.

General elections will be held in 1970, primaries in May, run-off elections in June, and general election in November. At the local level there will be a water board trustee election as well as a school board trustee election, and possibly other issues to be voted on during the year.

Offices of county and district clerk and for county and district judge will be up for re-election in 1970. Other county offices include county treasurer, justice of peace Prec. 1 and commissioners precincts 2 and 4.

A Terrell County wildcat flowed gas on a drillstem test.

An unidentified gas discovery was indicated in Terrell County with the flowing of gas at the average daily rate of 750,000 cubic feet on a 3/8 in. choke while taking a drillstem test at Roden Oil Co., Midland, No. 1-59 Mitchell, in 59-1-CCSD & RGNG, 25 miles northeast of Sanderson, 6 1/2 miles northwest of the one-well K M (Ellenburger gas) field and five Miles west-northwest of the onewell Little Canyon (10,000 foot Strawn gas) field.

Operator was pulling tool on the test taken at 17, 930-18, 347 feet. The project recovered some of the 5,740-foot water blanket. Flowing pressure was 300 pounds.

The project, originally slated for 18,000 feet, recently was rescheduled to 19,000 feet.
