ISTEN TO LUKE

Announcement is made this week of the closing of two local cafes. This leaves two in Sanderson - Admiral's Steak House and Oasis Restaurant - available for local and traveling eaters. There is also rumor of another cafe opening where the Rancho Grande formerly was, just east of the Double T Grocery.

Times certainly change. We can recall when there was a Jimmy's Steak House, the Kerr Hotel Cafe, the Club Cafe - all "downtown", and even before that there was the Buff Cafe, VanNoy Restaurant(the Beanery), Breedings Restaurant, and Hamburger Dan's - all "downtown" and several cafes in the Latin-American section where good Mexican food was not a specialty but an "only".

We continue to get comments from local residents and readers commending us on the approach we are trying to get something done at the local dump ground. We appreciate the remarks that people make to us, but we are not running those things and all remarks should be addressed to where they would do the most good. The county owns the dump ground and it is used by precinct 1 users mainly as a refuse disposal area.

There is a small fee that is attached to the water bills each month for the pick-up of garbage from local residents. The fee - in our opinion - is far less than the cost in trouble and time involved in the individual hauling of trash and the county employees responsible have their instructions for dumping of the

Anyone who is not having their trash picked up is asked to call our precinct 1 commissioner if they would like for the local crews to begin pickup of the trash. The men who are on the truck doing this job are responsible to the sommissioner and should not be expected to take the responsibility on themselves of negotiating for the pick-up service.

In our mention of the various fund drives that were going on or expected locally, we forgot to mention the project of the band boosters who were having their annual chili supper Thursday night of this week. This is one of the main fund-raising ventures of that organization, the others being the printing of the birthday calendar and the spring concert by the band.

All of these projects are worthwhile, each one helping to promote an activity that has prime importance to someone. But each one must be considered by the many who are contacted for helping all of them.

And an outstanding responsibility for all of us always is the responsibility to support our church and their various agencies of benevolent support.

There is a good likelihood that Sanderson will have a dentist to be here on Fridays and Saturdays every other week. There was a man here last weekend looking over the town, asking about a possible office space, etc., for just such a venture.

The Sanderson Lions Club will have an all-out drive the week of Feb. 7-14 to sell light bulbs to local residents, according to Ruel Adams, president of the local club. Half of the proceeds will go to finance the all-sports banquet and half will be given to the Eagle Boosters field house project.

The light bulbs will be sold in handy packages of 4 100-watt, 2 75-watt, and 2 60-watt bulbs for \$2.09 including the tax.

The entire membership of the Lions Club has been organized to supply friends and neighbors with light bulbs delivered to their door, Adams stated, and asked for the support of local residents in their efforts to aid the two local projects.

Gas Well Assured In Terrell Field

Gas discoveries were assured in Terrell and Reeves Counties; tests continued at a Ward strike and a confirmation was indicated to a Ward field.

An Ellenburger gas discovery was assured in Terrell County with the flowing of 85 barrels of load waterto pits in an unreported time, plus gas at the rate of 2.7 million cubic feet daily at Roden Oil Co., Midland, No. 1-59 Mitchell, in 59-1-CCSD&RGNG, 25 miles northeast of Sanderson, 6 1/2 miles northwest of the one-well KM (Ellenburger gas) field and five miles west-northwest of the one-well Little Canyon (10,000-ft. Strawn gas) field.

Flow was through a 1/2 inch choke and perforations at 18, 440-42 feet, which had been acidized with 20,000 gallons.

Testing continued with 175 barrells of load remaining to recover.

Operator was preparing to move off rotary. Earlier operator perforated at 17, 930-347 ft. but was unable to acidize with 20,000 gallons.

It was drilled to 18,600 feet, where 5 1/2-inch casing was set.

It flowed gas at the rate of 4 million cubic feet daily on a test at 17,900-18,501 feet; and at the rate of 750,000 cubic feet daily on a test at 17,930-18,347 feet.

cinct 2; Clarence Chandler is a candidate for commissioner of Pre-


W. W. Sudduth is a candidate for county chairman of the Democratic Party;
