## LISTEN TO LUKE

 Times do change!  
 We were reminded just this past week of another change in practices. Time was, when we were growing up, when certain people were referred to only as Mr. So-and-so, and Mrs. So-and-so. There was nothing unfriendly about the salutation, nor snobbishness. Just respect! And the titles of Mr. and Mrs. were retained particularly for men of the cloth and school teachers, then in a "hit-and-miss" manner for some other professions or positions or people. We even knew some husbands and wives who always - at least in front of other people - called their spouse "Mr. So-and-so" or "Mrs. So-and-so". There was no lack of love intoned in this usage, by any means, nor was there any love lacking apparently between the couples who used these words. And our use of the "So-and-so" has no meaning except as a substitute for their own names.

Some of us are creatures of habit more than others, perhaps. Or maybe our habits are just different, but the use of a first name for ministers and teachers just does not come easy with us, regardless of how well we may know them or how close our association.

We can remember the root of this. It was the decision of our parents that such "familiarity" would cause one to lose respect for the position and that respect was one thing that the position should receive. And there was always the danger that even if we used a more familiar name and maintained the highest respect, there was always the danger that someone else might acquire the "familiar" habit and lose the respect.

In our humble opinion, the rules were not unreasonable to the extent that we were willing to risk the punishment or whatever in testing a violation, so we retained the habit. Or maybe it was that we respected those who made the rules to the extent that we accepted readily the habit!

Anyway, we have it, and we are not ashamed of it!

The use of a first name with acquaintances and friends does not imply or signify a lack of respect for them personally or their position, whatever it is. I have even been able to overcome, to some degree, some earlier habits and call teachers by their first names, mainly because some seem to accept the Mr. or Mrs. as an aloofness, when that is not the intent. But there are some friends who are some years older, whom I have known for a long time, and well, that I cannot use a first name in addressing them.

It just depends on how you look at it, I guess.

## Two Killed In Wreck on US 90

Two persons were killed when two cars collided head-on about 40 miles east of Sanderson early Monday morning. Rafael Longoria, 53, of Ciudad Acuna, and long-time employee of Herman Couch on his ranch north of Sanderson, was pronounced dead on the scene, as was Edward Raymond Hill, 48, of Hayward, Calif. The bodies were taken to the Janes Funeral Home in Ozona.

Alejandro Marquez of Sanderson, who was enroute to San Antonio, came upon the wreck and was unable to stop in time to avoid hitting one of the automobiles and received some broken ribs and severe bruises, but was treated locally and released.

The bodies of the two who were killed were taken to their respective homes for burial.

## Subcommittee OKs Flood Control Fund

The Senate Public Works subcommittee Thursday of last week cleared the way for legislative action on the application for \$4.8-million for flood control of Sanderson Canyon watershed. The subcommittee approved the local flood control project and two others to be done by the Soil Conservation Service, and they also approved a flood control project planned by the Army Engineers.

The subcommittee approval puts the application now in the hands of the Senate for final approval of the appropriation and another hurdle is cleared in the obtaining of funds for the construction of 11 water retaining structures on Sanderson Canyon watershed.

## 31 Cars Derailed In Dryden Sunday

Thirty-one freight cars on an east-bound Southern Pacific train were derailed early Sunday morning on the west side of Dryden. No one was injured in the derailment.

Traffic was halted for several hours while a "shoo-fly" was built around the wreckage, much of which was on the main line of the railroad. Trains began moving by the wreckage Sunday afternoon late.

It was stated that all of the freight cars were empty except one which had some furniture in it.

One person stated that further west and prior to the derailment, at least one of the cars was not on the rails and the derailment occurred when the car came to a switch that was just west of the Dryden station.

Crews began arriving early Sunday afternoon for removing the wreckage which was still underway late Monday afternoon.

### More Immunization Needed by Students

The State Department of Health has asked The Times to remind parents of students of the recently-passed legislation which makes it mandatory for all school children entering elementary or secondary schools to be immunized against specific diseases.

The new law applies to all students attending public, private, or parochial schools in the state.

The six diseases for which all students must receive immunization include: diphtheria, tetanus, poliomyelitis, measles, rubella, and smallpox.

It is specified that parents and students note that the law takes in all ages of students from kindergarten through college and that all students in any and all schools are included in the law.

Students will be allowed to enter fall and summer semesters in 1971 with the provision that their immunizations against at least one of the diseases will have been started by January 1, 1972.

The two exclusions from compliance on an individual basis are: if the physician feels that the immunizations, one or all, would be injurious to the student's health or any member of his family; and two, if there is a religious conflict.
