ASCS Office Has 'Freeze Answers

All residents of Terrell County may obtain answers to questions on operation and interpretation of the Presidential order of August 15 on prices, rents, wages, and salaries from the Brewster-Terrell County ASCS Office, according to Clarence Jessup, chairman of the County ASC Committee.

County ASCS offices throughout the United States have been chosen as information centers to answer questions from all citizens on President Nixon's executive order which is designed to stem inflation and strengthen the national economy.

The Brewster-Terrell County office is receiving official answers to questions concerning the President's action, and any person in Terrell County who wants or needs precise information should get in touch with the County Office. Jessup said.

"Ours and all ASCS offices throughout the nation, will function as information centers in all locations outside of highly urbanized areas, "Jessup said.

County ASCS offices are not to handle complaints or appeals, he said. They will serve only to provide official information. Persons with complaints will register them with the most convenient district or sub-district office of the Internal R evenue Service.

"Neither will interpretations or guesses be made by ASCS county office people. They will answer only those questions for which they have been supplied an answer. If they don't know the answer to a specific question, they will say so. If a member of the public wants the county office to obtain an answer, the question will go by phone or mail to the nearest IRS district office, "Jessup said. Normal functions of the ASCS

Normal functions of the ASCS county office are to administer farm action programs of the U.S. Department of Agriculture on the local level. County Committee Chairman Jessup said ASCS service to farmers and ranchers will continue without interruption.

Unusual Weather Noted In August

Ervin Crigsby, who is the official weather reporter for Sanderson, noted unusual weather during August this year and offered The Times the information to be passed on to the readers as a matter of interest.

During August there were four days with a high in the 70s, 19 days in the 80s, and only eight days in the 90s.

The lowest high was 72 degrees on August 3, the highest was 93 on August 23.

Rainfall during August totalled 4.21 inches officially locally.

Dove Season Is Sept. 1 - Oct 30

According to information published by the Texas Parks and Wildlife Department, dove season in Terrell County began on September 1 and will run to October 30. Shooting hours are from 12 noon to sunset and the bag limit is 10, possession limit is 20.

White-wing dove in Terrell County may be taken September 4 & 5, and 11 & 12 with the same bag limit and possession limit.


Other laws concerning the shooting of dove are available from game wardens or the Texas Parks & Wildlife Department.

Mexican Identified As Truck Thief

A burglary south of Ozona last week resulted in the identification of a man said to have stolen the pickup belonging to Bob Allen about six months ago.

A Mr. Mayfield, who owns a ranch about 50 miles south of Ozona, was accompanied to the ranch by Mr. West one day last week and when they got there, they were accosted by a Mexican who had apparently been waiting for their arrival, according to a story related by Mr. Allen. The Mexican forced the two men, at gun-point, to go into a walk-in ice box from which he had removed the inside emergency release. He ransacked the house, but finally released the men from the vault, but tied them before he pulled wires loose from all vehicles except a pick-up he used to flee from the scene.

Friends or relatives went to the ranch after the men failed to return and released the men and returned them to town and reported the burglary.

On Thursday night, the burglar wrecked the pickup south of Ciudad Acuna and he was seriously injured and hospitalized there. The U.S. authorities were notified of the apprehension of the man and Terrell County Sheriff Bill C. Cooksey and Bob Allen went to Acuna Friday where they met Mayfield and Texas Ranger Alfred Alee Jr. for possible identification of the man.

The man was identified as the Crockett and Terrell County burglar and the authorities there promised local officers pictures of the man so that area ranchers could know him in case he ever returned to this area.

The front four defensively consists of Billings, Stewart, Chriesman, and Sanchez; Cash and Raul Ybarra will play defensive ends; Louwien and Flores, line-backers; and in the secondary will be Juan Saenz, Litton, and Druse.

Coach Myers stated that these line-ups could change as there are several of the Eagles who are giving some strong competition for a starting berth.

NOTICE OF CANCELLATION OF LIVESTOCK BRANDS AND MARKS

All brands and marks on Texas livestock must be rerecorded with the County Clerks after August 30, 1971, according to a new law passed during the last session of the Texas Legislature. Producers will be given a six-month period (August 30, 1971 through February 29, 1972) in which to register these brands and marks and the location on the animal which they are currently using, after which time any unrecorded brand will be available for use on a "firstcome" basis.

The law further states that all such brands and marks must be rerecorded every 10 years. Each County Clerk records for his given county only, so many pro-

The owner shall have the right during this six-month period to file the mark and brand now recorded in his name. In the event it cannot be determined from the records who first recorded the brand and mark in the county, then the person who has been using such mark and brand the longest shall have the right to have the brand and mark recorded in his name.

It should be noted that it is illegal to brand livestock without first properly recording the brand with the County Clerk in the county in which the livestock are held.


When the brand or brands are recorded, the location on the animal on which the brand is to be applied must be designated. If the brand is to be applied to more than one location on the animal, it must be so recorded and each additional location for the brand on the animal shall constitute a separate recording of that brand.

There is no limit to the number of brands and/or marks which may be recorded in a county by a person as long as requirements of this law governing the recording and rerecording of livestock brands are met. Minors may have marks or brands separate from that of their father or guardian, which must be recorded or rerecorded as provided by the new


The County Clerk of each county shall have this act published in some newspaper of general circulation in the county for a period of 30 days. The act shall be published on the effective date, August 30, 1971, and thereafter for 30 days.

It is the obligation of the County Clerk to assure that no more than one brand of a kind be recorded on the same location of the animal in each . county. Therefore, no two people in a county may record the same brand in the same location. It is also the responsibility of the County Clerk to make certain that in recording any brand for a person, that the part of the animal on which the brand is to be placed be designated.

NOTE: Bag limits of both white-winged and mourning doves may be taken during the open white-winged season.

SHOOTING HOURS:



- No hunting permitted in game refuges, state and federal parks, game reserves, within corporate city limits or from public roads or road rights of way.
- The retention of one fully-feathered wing on dressed doves is required in those counties having a white-winged dove season when both mourning and white-winged doves may be taken. This requirement also applies when doves are imported from Mexico or any foreign country.
- Shotguns must be plugged permanently to three-shell capacity and may not be larger than ten gauge. Hunting doves with rifles prohibited.

What's in a name? In West Texas as elsewhere, place names are enticing parts of our culture. They may be clues to the past, memorials to special people, or actual descriptions of geographic features. Apparently, other Big Benders have had a special interest in place names as well. Henry T. Fletcher discussed Big Bend place names in a 1951 special supplement on Big Bend National Park in the Alpine Avalanche. Walter Fulcher's book, The Way I Heard It, appeared in 1959, and included a number of interesting anecdotes about places within the Big Bend. And in 1958, Virgina Madison and Hallie Stillwell's How Come It's Called That? appeared. These three publications stand out as the major references to places within and around Big Bend National Park.

People are curious: Park employees continuously are asked about places that are

Names File" maintained at park headquarters. So, we need to know more! It would be very much appreciated if you, your relative or friend. would drop us a line if you know anything about the following places. How did the name come about? Who named it? When? All of these questions are samples of the kind that visitors ask about such places as Buenos Aires, Loop Camp, Rooney Place, Banta Shut-In, Lone Mountain, Quail Spring, Dogie Mountain, and many others.

the southern part of the Dead Horse Mountains is known as the Marufo Vega Trail, but no one seems to know where the name came from or what it means. Kit and Goat mountains indicate an early history of goat -raising nearby, but does anyone really know? Who are Woodson, Pettit, Carlota, and Jewel? As-sumedly, Chisos Pens refers to fenced areas there, part of the Old Gano Ranch that

later was the Homer Wilson Ranch. But there must be more information than that about the place.

It is easy to guess how a number of places were named, but who and when is important too. How about Wa Dripping, Croton, and Rough springs? Crown Mountains looks like a crown alright, but when was it named? Several of the common Big Bend place names are, undoubedly, quite ancient. Places like The Chimneys, Black Knob, and Sierra Aguja are places that really are logical names that the first men to see them may have used. Then there are a few names that probably are recent, such as Huber Ridge, Lone Mountain, Tinaja Lujar and others.

If any of these names strike a bell, how about helping us to help the park visitors by sending us the correct information.
