by Albert: ----Writing a column is a presumption any way you look at it. One must feel that what he is about to put into words on paper will be of some interest to the reader or that the mental meanderings of the writer might be worth sharing. And there is always the presumption by the writer - and there must be - a presumption that what is written will not matter in the slightest to any reader. They will act as jurors in a sense to validate some of the thoughts of the writer or they reject them completely and totally.

It takes both a reader and a writer for a column to exist! What you think as you read is more important than what I think as I write. What I am thinking is not always able to be transmitted into what I

write. And what I am thinking is not always translated into what you think I am writing or thinking. All of this business of writing and thinking and reading and thinking is conditional to so many things and is not bound by anything except an effort on the part of the reader to try to under-

stand what is being written. As this year begins we thought we might set down some guidelines for our writing and for your efforts in trying to interpret our thinking.

Primarily, there is no way that one can try to read between the lines. There just is not that much room between

the lines. Secondly, everything that is written, praise or criticism, facts, or thoughts, will still be written in an effort to make something better - and our opinion of better may be dif-

ferent from yours! And thirdly, it must be our responsibility to evaluate those things that motivate our writings as to importance.

And whether or not you agree is not as important as whether or not you have been stimulated to thinking.

And whether or not you agree depends on how you look at it!

Sometimes we get to thinking that what once was, always is. And that's where we get to

thinking wrongly! We refer specifically to our former position as secretarymanager of the county's Chamber of Commerce. The position has been held by E.J. Hanson

for the past year. The position was interesting, expensive, sometimes a pleaswe, and sometimes unpleasant. The fact that something was accomplished that was good for the town or county -if there was anything accomplished - was the sole purpose

of our serving in that capacity.

The State Department of Health is sponsoring a course in emergency care of the sick and injured. Classes will be held in Sanderson Elementary School, January 10-13. Registration will begin at 6:15 p.m., January 10. Sessions will run from 6:15 p.m. to 10:45 p.m. nightly.

Ambulance attendants and others interested in emergency care are urged to attend the four-night course. It is offered free of charge.

Experts in the field of emergency care agree that ambulance personnel must be prepared to make a quick survey to determine medical priority and to perform life-saving measures. Physicians and other medical personnel throughout the state of Texas are giving their time to provide the instruction needed to reduce the number of fatalities and injuries occurring each year.







Committee members heard testimony from various members of Congress, representatives of the sheep and goat industry and environmental groups. The TSEGRA official was joined at the Washington meeting by wool grower representatives from Wyoming, Idaho, Montana, Utah, Wisconsin and the National Wool Growers Association. All members of the delegation stressed the industry's concern to control, selectively, the animals causing the problem and reiterated their position as to any further restrictions on control methods. They all expressed the hope that new and better control menthods could be developed, stated Allison.

Senators Birch Bayh of Indi-ana and Csylord Nelson of Wisconsin gave testimony to the effect that they were reluctant for the Federal Government to take part in a predatory animal control program, as it is in its present form. They recognized that the ranchmen have a problem but were against their control methods. They were in no uncertain terms against the use of poison as a means of control, as it is not selective and often kills not only the target species bus also other animals that come in contact with it. Texas Representative O.C. Fisher testified on behalf of the sheep and goat industry, stating that predator control is necessary to the sheep and goat industry of

Environmentalists had their say in a day and a half of testimony before the committee. Most of them indicated some sympathy with the ranchers in that they might have a problem, but they, too, were not at all in agreement with our present methods of controlling predators, especially in regard to the use of poison, for the same reasons as the two senators.

Allison pointed out the need for unification of efforts of the sheep and goat industry representatives and urged the environmental protection groups to enter with them into a program to develop new and better methods of predatory animal control. "No ordinary ranchman is a wanton killer of all wildlife. His only concern is protection of his livelihood. Probably he would actually prefer a repellant. It would be cheaper, easier to administer and possibly more effective in the long run. We are tired of being criticized for criticism's sake. If they want to be constructive, they can help," he stated.

It has many names - pencil cholla, slender stem cacuts, aguijilla, garrambullo, and tasajillo - but none seem to be so appropriate at this time of the year as Christmas Cactus. For it is in late fall and winter that its numerous bright red fruits ripen. Sometimes more than an inch long and half as wide, the fruits are moist and edible to wildlife and man as well. In fact, many of the migrant birds, such as the phainopepla, safe thrasher, and robin, remain near a heavy stand of Christmas cacti eating fruits for several weeks. Ground squirrels and wood rats relish the ripe fruits as well. Some plants may possess so many fruits that the entire plant may sag under the weight. It may be that at that time of the year the plant resem bles a well decorated Christmas

Botantists refer to this thinstemmed cactus as Opuntia leptocaulis. It is native from central Arizona east to south-

western Oklahoma and south to

stems usually bear long and very sharp spines that are often covered with loose tan to yellow sheaths. Although most plants are 1 to 3 feet high, those that grow among shrubs or against trees, where they are given support, may be 5 to 7 feet in height. Chollas are closely related to pricklypears. Both possess areoles (depressions on the stems) from which spines and tiny spines called glochids arise. They are also able to grow rootlets from the areoles, so broken and scattered pricklypears and chollas usually survive to form many plants.

Christmas Cactuses are usually numerous within their range, but often go unnoticed. In spring, its flowers are not as showy as most cacti but are rather small and green to yellow in color. They are often missed at first glance. When the fruits ripen, however, it is one of our most obvious plants.




