## Terrell County Is Assured Producer Of Natural Gas

The sixth current Pennsylvanian producer in a field which began in Pecos County, was assured with a flowing of natural gas at the rate of 2.1 million cubic feet daily at Texas Oil & Gas Corp., Midland, No. 1-A Noelke. The well is in section 5, Block A2, TCRR Survey, five miles southwest of Sheffield.

Flow was through a 16-64inch choke and performations at 8,494-688 feet, with tubing pressure of 1,550 pounds. Testing continued.

The field also has one Ellenburger and two Connell gas producers.

The well is in Terrell County and is a 5-8ths-mile southwest and the same distance southeast extension of the field.

## Illness Causes School Closing

Illness has caused the closing of local schools for several days. Sore throats, upper respiratory infections, and "the plain old flu" are said to be the source of illnesses, according to reports heard.

Monday of last week there were over 60 absences in local schools, and when about the same number were absent on Tuesday, Supt. C.B. Card decided to close the schools.

The average daily attendance, which affects the local financial structure of the operation of the school, was given as one of the reasons for closing the schools, and the other was to try to prevent a greater spread of illness due to the close contact of association of the students.

Monday morning of this week there were almost 70 absences and the students were again sent home and the effort to re-open the schools would be on a day-to-day basis, depending on the number of absences, according to information received.

#### **Registration Of Voters Pushed**

Voter registration is proceeding successfully, according to Sheriff Bill C. Cooksey. The number of registrations was approaching 600 on Monday and the number was expected to go well above the 700 figure before registration ends in time for voting in the school election in April.

Registration by a voter must be 30 days prior to any election to qualify him to vote in that election, and registration may be at any time in the year.

Cooksey stated that there were several groups and persons interested in a maximum registration, particularly of the 18-21-year-olds, who will be eligible to vote this year for the first time, and others were also working to get a maximum registration of all potentially qualified voters.
