# **Ranchmen Hear Referendum Info**

About 75 ranchmen were present Saturday afternoon for the meeting of District I members of the Texas Sheep and Goat Raisers' Association. The group named new directors for the district, heard details of the referendum for predator control, and nominated representatives on the predator control committee from the district and for the committeeat-large post.

The meeting which began at 11:00 a.m. was hosted by directors and members of District 1. Luncheon was served at noon and resumed following the meal at St. James Hall in Sanderson.

New directors named for the district included Jack Shely, Steven Lee Stumberg of Marathon, Louis Woodard of Fort Stockton, and Jim Espy of Fort Davis. All of the retiring directors were re-elected with the exception of Russell White of Marfa, who asked not to be considered for re-election.

Local Girl Scouts in the Junior and Cadette troops will be selling cookies to Sanderson residents beginning Friday, February 11. The cookies will be available until February 19.




### VISITING MINISTER SUNDAY AT PRESBYTERIAN CHURCH



"Growth and expansion are likely to continue for the town's communications system," Lincoln said. "Telephone engineers predict that Sanderson will have 825 telephones in service by the end of 1975."

He added that a record \$150 million construction budget has been set for Southwestern Bell's San Antonio Area, of which Sanderson is a part. The 1972 budget includes expenses for central office equip ment, buildings and additional plant facilities, such as telephone cable, in an area cover ing approximately the western two-thirds of Texas.

Richard C. White ...seeks return to Congress

Congressman Richard C. White this week authorized The Times to announce his candidacy for re-election to the U.S. House of Representatives for the 16th District of Texas for the fifth consecutive term. His candidacy is subject to the action of the Democratic Primary on May 6. Congressman White cited the value of seniority, faithful attention to his elected duties, and a long list of legislative accomplishments for the area and nation as the basis of his request for the citizens of the vast 14-County District to reelect him as their representative in the nation's capitol.

He pointed out that his Congressional group which entered the House in 1965 is approaching the mid-point in seniority, and he estimates this group will move up measurably following the 1972 general elections.

"My seniority is even more meaningful on the two Committees to which I have been appointed," the Congressman said, "and a sub-committee chairmanship is coming closer to reality. This will mean additional influence for West Texas. 



### Watershed Control Urged to Develop Natural Resources

"Watershed projects are assuring a dependable water supply to 78 communities and are providing more than 5 million visitor days of recreation annually," Under Secretary of Agriculture J. Phil Campbell told the Natural Resources Management and Conservation Committee of the National Association of Manufacturers.

Asserting that these projects have given new life to many communities by "creating thousands of new jobs," he added that it is "no more than a good beginning on the total job that must be done. Annual flood and sediment damage in upstream areas still exceeds a billion dollars.

"Action is needed and is feasible in almost 9,000 watersheds, comprising 726 million acres, or about onethird of all land in the United States," Mr. Campbell said. "Municipal and industrial water supply storage is needed in about 3,000 project areas, improved water quality is needed in about 4,400 watersheds, and recreation, fish and wildlife development is needed in about 6,500 areas," Mr. Campbell noted.

Thus far, projects have been completed in 3 per cent of the 9,000 areas and projects have been approved for about 12 per cent of the total, he said.

When all the projects are completed, the potential prevention of flood damages will total nearly \$14 billion, some 2,800 communities will be assured of a dependable water supply, and 200 million visitor days of recreation will be provided annually. "These are almost astronomical figures," Mr. Campbell said, "but they illustrate the tremendous importance of the watershed program to the American environment and the American people.
