What is the best news that we have had - in our opinion - is printed on the front page in as much detail as we knew or were able to get.

Sanderson has been designated as a home terminal for the new operation procedures for trains that will run from Sanderson to El Paso and from San Antonio here -- and will remain so for all of the foreseeable future, according to the company and organization representatives.

All of the uncertainties of the possibilities of the terminal's move have been removed as far as can be stated, according to the men representing both sides of the operation.

We stated before, and we state again, that we hope that this is for the best for those involved directly, and certainly we are happy that the idea will not be a consideration in the failure of any individual or group to consider constructive and progressive action locally in the future

We wonder if this news will be given the same area-wide publicity as the "threats of the terminal's move" have been given in the past.

Without a single exception, all of the people we have talked to since last week's paper are in more-than-strong opposition to any tolerance in activities referred to as past or threats in the letter published last week.

What some minds have not yet conceived is that the destruction or defacing of public

New Producer For Yucca Butte Field

The Terrell County portion of the Yucca Butte (Pennsylvanian detrital) field gained its second producer and a 5/8mile southwest extension with completion of Texas Oil & Gas Corp., Midland, No. 1-A Noelke, five miles south of Sheffield.

It was completed through perforations at 8-494-8,688 feet, for a calculated, absolute open flow of 8.2 million cubic feet of gas per day, with gas-liquid ration of 430,326-1. The section had been acidized with 1,500 gallons.

Location is 660 feet from the north and west lines of section 5, block A-2, TCRR survey, abstract 1041.
