## SISTEN TO LUKE

It was refreshing, indeed, to talk to a doctor like the one who was in Sanderson last week to talk to a local group about a pilot medical aid program for Sanderson. There was no motive, that we were able to detect, seen or unseen, other than trying to get some help for people who needed help, and to learn from such a program so that other communities could have something like that for the physical welfare of their community.

That program, if it is initiated, is not related in any way other than assistance, to the program that is being contemplated at the meeting in Fort Bliss on April 17. There could be a tie-in of the two programs, possibly, but even that is not known now.

Time and time again, in daily papers during the last week, we have read about something closely akin to nepotism, if it was not in fact nepotism. Legislators in Texas hiring wives and children of other legislators for heaven only knows what kind of odd jobs to boost the income of the legislative families and reduce through taxes the incomes of those who elect the

We know that it probably would not work, but we wonder if it would really be worse if we could just rub out and start all over again.

We agree with the persistence of Ted Kennedy in wanting to pursue to the very bottom all of the implications in the Sharpstown bank case, but -- of all people who want indepth investigations of someone -- Ted Kennedy.

We, as the electorate, are unpredictable, aren't we? We fuss about something, we mouth disconteat time and time again at a situation, and continue to re-elect those who continue in the same old patterns as always. Why do people think that a person, the day of his election, will suddenly do an about-face from the pattern of his life for all the previous years?

We never are surprised during an election -- any of them -- at the outcome. We have become calloused to surprises of that kind.

What is surprising is the way that campaigning is or is not done and the way that it seems at times to be connected with the outcome of a vote, and at other times there

seems to be no relationship. Another surprise is the lack of talk that we hear about the local commissioner's race. This is a very important job and a race that should demand the attention of every voter, but we hear of no real interest being expressed by voters, nor is there a lot of politicking evidenced on the part of the candidates or their backers, if they have any!

Is the real issue of the campaign the prestige of the office, taxes (higher or lower?) redistricting of the county, employment for the candidate.

A MAST (Military Assistance to Safety and Traffic) program to be developed for West Texas and Southern New Mexico and based at Ft. Bliss, was announced last weekend by Dr. John Bradley, regional director, Public Health Region 3, Texas State Department of Health.

A meeting to acquaint interested community representatives with the MAST program and procedures for establishing the MAST operations, has been scheduled at Ft. Bliss for Monday, April 17, at 9:00 a.m. Representatives from eight West Texas counties, including County Judge R.S. Wilkinson and Sheriff Bill C. Cooksey of Terrell County, as well as from the state of New Mexico, have been invited to this meeting. The MAST program is a cooperative program of the Department of Defense, Transportation, and Health, Education and Welfare with each department sharing the responsibility for overall policies, implementation, and operation. Officials from these agencies will conduct the orientation.

The MAST concept supplements the existing emergency medical service system by providing military helicopters to transport critically ill or injured persons to or between medical facilities. "This is especially important to rural and isolated areas of West Texas and Southern New Mexico whenever a serious medical emergency arises," Dr. Brad-

lev said. Dr. J.E. Peavy, Texas State Health Commissioner, has directed the Public Health Region 3 office in El Paso to coordinate the program in West Texas and to provide assistance in planning, communications systems, development, and personnel training.




## Nat'l Library Week Is April 16-22



The question is to try to determine if local residents would use the services of physicians if they were here only two or three days a week.

The answers given the questions will be compared by the Emergency Squad members at their next meeting on Sunday and then relayed to Dr. Ralph Wase of San Angelo, who is interested in the results of the telephone sur-

Dr. Chase vas here last week to tall to a hastily-conceived group at the Oasis Restaurant and tell them of his ideas for and plans to utilize the services of physicians at military installations, possibly, on part-time basis in out lying towns and communities that lack adequate facilities. The local program would be a "Pilot Program" with the backing of the Texas Medical Society to try to prove a method of aiding in giving more adequate medical attention where needed. There are many details to try to work out before such a program might be initiated, according to Dr. Chase. And he gave his assurance that he and Sanderson residents should be aware of the fact that this would not be the most desireable situation for medical attention, but that it would be second-best, possibly, and would not be designed or operated in any way to discourage a doctor's moving to Sanderson if there was such a desire indicated or expressed.

Dr. Chase's visit to Sanderson last week was arranged through a telephone conversation with Sheriff Bill C. Cooksey. His wife accompanied him here from San Angelo.

Other possible plans for parttime medical assistance for towns needing it were discussed by Dr. Chase, but the use of military physicians seemed to be the most attractive that he could conceive.

Local residents are asked to try to answer honestly their feelings about part-time medical service so that those in charge of relaying the information and for using the information may act by what is felt to be the actual sentiments of the residents.
