## Census Planned Prior To Redistricting Of Terrell County's Precinct Lines

The Terrell County Commissioners' Court passed an order Monday at their regular meeting to initiate proceedings for the redistricting of the county. The redistricting will be on a population basis, according to County Judge R.S. Wilkinson, who stated that this was the requirement of a redistricting move.  
 A block-by-block census of Sanderson will be made in

the immediate future so that the county's population may be equally divided for the new precinct lines. At the same time, there will be a census made of the students of school age in Sanderson for the information of the local system.

Judge Wilkinson stated that it appeared that the population of the county was such that it would be necessary to bring all of the precincts into Sanderson. He added that this was one of the purposes of the enumeration of all local residents, was so that an equal distribution of the residents could be made in compliance with the law.

As the plan progresses, The Times will relay any information available for the benefit of the readers.

### Oil, Gas Income In County Noted

Sale of Terrell County oil and gas production accounted for \$5,757,676 of the county's economic output for 1971, according to a study by Texas Mid-Continent Oil & Gas Association.

In producing 781 barrels of crude oil and 37 billion cu-ft. of natural gas, the county ranked 126 in Texas. Value of its crude oil was \$2,749; natural gas value was \$5,754,927.00.

The county is among 190 in Texas with oil and gas production value topping \$100,000, although 211 counties produce oil and gas.

"Terrell County oil and gas wells made a significant contribution to Texas' share of the nation's energy needs last year, but growing demand is sapping reserves in Texas faster than they can be replaced", Robert A. Buschman, Association president, said. "As fewer new fields are discovered, due to less drilling, the continuing strong economy and tax base of the many Texas counties may now depend on updating Texas oil conservation laws to encourage wider use of new recovery technology," he said.

The Association study showed that Terrell County ranchers and other royalty owners received \$719,710 as their share of the production. The county's wells generated \$126 in crude oil production taxes for state government and \$431,620 in state taxes on natural gas.

Texas Employment Commission figures showed 47 oil and gas industry employees in the county last year, with an annual payroll of \$327,372.






