We took a picture- shown at left-of the U.S. Post Office's yucca and/or dagger with a bloom shooting up, and in the background can be seen some white that is a small bloom already open. We use this as one of our heralds of springsince the first day of it was during the week and we looked all over town for a mesquite putting out, but didn't find one to take a picture of, nor did we find a pecan that had put out any fresh shoots. Last week, on a short trip out into the country, we saw a big bunch of buzzards flying, and have seen more several times since then.

We know as well as anyone that Easter is not yet, and is in fact a month away, but we know that certain signs of spring are good, and two out of four is 50%, and we had a friend tell us Sunday that mesquite in their part of the county was putting out, so that makes 3 out of 4 of the Springheralding signs that are visible. We're not trying to fool Mother Nature, but we are very anxious to have spring weather.

We used the terms "vucca or dagger" in a manner that can be termed as interchangeable in talking about the picture to the right. Our authority for this rashness is Dr. Warnock, biologist of Sul Ross University in Alpine, who used the same words in the same way in his talk on the flora of this area -- if we understood him properly -- and we think we

We have been corrected frequently when we tried to properly identify one of those things, and being by nature a person who does not like to be accused of doing something wrongly, we have since avoided any reference to the name of the plant; we just pictured it and let the picture tell the

Fire Reporting Procedures Told

The Times was asked to report to local citizens the proper procedure for reporting fires for the greatest convenience to the firemen. It is hoped that the procedure will be followed as it will give firemen a few minutes' advantage by their being able to go directly to the fire, rather than going to some place to find out where the fire is.

When there is a fire, please dial 2500. Telephones are in several places in town, and in homes of some of the firemen and when the phone is answered at Dudley's, the person there begins sounding the alarm, and others are able to hear where the fire is. Do not hang up until after the siren begins to sound! Wait a few seconds after the siren begins to sound to be sure that anyone who comes on the line will have an opportunity to hear the location of the fire.

If anyone reporting a fire will be sure to not hang up until the siren sounds, they will be sure that someone at the central location has heard the alarm reported.

Local residents are asked to please stop their cars if they are driving when the alarm sounds, so that firemen may get to the fire station or fire with a minimum of danger.

The Mesa Grande (Leonard) field of Terrell County was reopened with recompletion of Texas Oil & Gas Corp. Midland, No. 1 Allison, former opener and lone producer 10 miles southeast of Sheffield, for a cal culated, absolute open flow of 7 million cubic feet of gas per day.

Production was through perforations at 3,373-421 feet, which had been acidized with 1,000 gallons.

It was reported as plugged and abandoned June 2, 1972, at 3,800 feet.

Original completion was May 11,1963, by Humble Oil & Refining Co. through perforations at 3,393-387 feet. It was drilled to 11,324 feet and plugged back to 3,547 feet. It became depleted in July

Location is 1,980 feet from the south and east lines of 8-A4-Mrs. A. Pride.





Study Conducted On MARCH 22, 1973 Coyotes, Livestock

There's a longstanding argument between stockmen and conservationists as to what effect coyotes have on livestock.

What effect do the predators have on the Trans-Pecosregion antelope herd?

Texas Parks and Wildlife Department biologists under project leader Tom Hailey of Marfa conducted a year-long study to determine the causes and de gree of mortality of the Trans-Pecos antelope herd.

During the late fall and early winter of 1971 and 1972, 214,-000 acres north of Valentine, Texas, were treated with compound 1089 in horsemeat.

This project was carried out by personnel of the Bureau of Sport Fisheries and Wildlife in cooperation with local landowners.

It had been noted for the past several years during annual antelope census that fawn production in the particular area has been below other parts of the Trans-Pecos.

After the Valentine area was treated with compound 1080 in 1971, the fawn crop swelled to almost 25 percent more than the rest of antelope country.

The 1971-72 winter was a mild one and, all other factors taken into consideration, the control of coyotes in the treated area is the primary reason for the increase in fawn production and survival.
