## **Gas Well Outpost Staked in County**

Gulf Oil Corp., Crane, will drill the No. 1 Annie Garvin as a 5/8 mile northwest outpost to Seco Production Co. Midland, No. 1 Allison, Terrell County undesignated Pennsylvanian gas discovery, six miles south of Sheffield.

Location is 660 feet from the south and 2,110 feet from the west lines of 16-B2-CCSD & RGNG. Contract depth is 10,000 feet.

The discovery was finaled April 25 for a calculated, absolute open flow of 14 million cubic feet of gas per day, with gas-liquid ratio of 24,507-1, through perforations at 9,172-206 feet. Gravity of the liquid was 67.2 degrees.

The firm reported a dual potential as an upper Pennsylvani an gas strike of 1.34 million cubic feet daily through perforations at 9,054-060 feet, however, it was never filed at the Railroad Commission offices.

Mrs. Ruby O. Duncan, 64, died in an Odessa hospital early Friday morning following a long period of failing health. She had been a medical patient in the hospital for a month.

Burial was in Cedar Grove Cemetery with the Janes Funeral Home in Ozona in charge of arrangements. She was born in Rotan on January 10, 1909. She was married to Donald L. Duncan in Sanderson in 1929 and he preceded her in death in 1945.

# School District's Tax Rate Is Lowered By **Big Increase of Oil and Gas Properties**

The addition of certain oil and gas properties to the tax roll of the Terrell County Independent School District and the lowering of the total tax rate of the district spells "good news" for the taxpayers of the county.

A.H. Zuberbueler, tax assessor-collector for the school district, reported that the total valuation of property within the county or school district for the purposes of taxation is about \$21,500,000 following the addition of about \$2-mil-

### COUNTY VALUATIONS INCREASED BY MILLION

The increase in total valuation of taxable property on the rolls of Terrell County for the purposes of taxation amounted to about one million dollars, according to Mrs. A.J. Hahn Jr., deputy tax assessor-collector and County Judge R.S. Wilkinson. The total increase, like that of the schools' roll of taxable property, was due to the increase in oil and gas facilities and production.

The difference between the total value of the county's and the school district's taxable property increase is due to the difference in assessing the values used by the two taxing subdivisions. Each uses a different percentage of the value of the property as the basis for their separate valuations.

The county commissioners will set the tax rate for the roll of taxable property on the lion in valuation. Practically every penny of increase in valuation was from the oil and gas industry and could be accounted for principally in the new compression plant at the gas plant in the eastern part of the county, pipe lines, and increase production by additional oil and gas wells in the county. It was pointed out that there was a decrease in livestock valuations in the county since the sale of some rather large ranches in the county had occurred and all the livestock had been taken off those ranches; and there was a decrease in some local property due to depreciation, etc.

There was no increase in the value of any property in the county for tax purposes, according to the tax assessor.

The tax rate was lowered from \$1.78 to \$1.65 per \$100 valuation placed on property, according to Mr. Zuberbueler. This amount includes \$1.35 per \$100 valuation for local maintenance, and 30¢ ior interest and sinking fund.

Mr. Zuberbueler explained that it was necessary to raise the budget for the school district by approximately \$28,-007.00 for the coming year. The salary increase for teachers, as demanded by legislative action recently, accounts for approximately \$16,000.00, and the board has allocated \$10,000.00 for building repair and remodeling for the coming year, and the balance is to take care of increase in costs of such items as are used regularly throughout the year.


He is also survived by two sons, James Wright of Lamesa and David Wright, who is in military service overseas; also five grandchildren.
