

This is we bworm season again all over this part of the country and local people are anxjously looking at their trees

and wondering what to do, if anything, to fight the bugs. The problem is a good one and a real one.

We have also been hearing ome stories about rattlesnakes and copperheads being found around town. We have seen neither variety this year, the same as we have seen no webworms. But we have reasonable assurance that they -- all three pests -- are here. Watch out!

There are some observations that we have not seen, read, or heard others making about the Watergate situation that cause some concern in our thoughts. We wonder if the observations of ours are real or imaginary. In future elections, should the voters not know more about 1 who is on "the team" and not concentrate on the captain? In our perusals, we at first thought about the leader as the quarterback, but we see that this is not the right title, since the quarterback calls the plays, and up to now there is a complete denial that Nixon was calling all the plays. If we knew more about "the team" and the captain, a peron might be more able to pick the right one.

There are many disadvantages to electing only a known "captain". He conceivably could be only a "front man" with all of the polish and aplomb necessary to win an election, but not be really seriously involved in the decision-making, all of which could be done by unscrupulous characters who prob ably would act in an unscrupulous manner.

"The team" might even consist of having some other lesser or minor "front men" who would be in position to take the plaudits of the public for "the team's" accomplishments through their decisions, and also out front to take the blows of the public on "the team's" bad decisions.

There are men who love power for power's sake, omitting all the good and bad results of decision-making. These men are found in all levels of politics and they would not take for their abiliy to be in on the decisions. They, too, have an ego to be satisified.

Then the second observation is: How many decisions that have affected our lives in one way or another are decisions that the president was even involved in and were the decisions - if they were the president's - based on the actual facts as they existed or were they distorted according to the wishes of his

dvisors? Maybe these are considerations that should be given more thought, and maybe not! It just seems to depend on how you look at it!

Members of the "Friends of the Library", the Harkins family, and close friends met at the library a few minutes before 2:00 o'clock for a brief dedicatory prayer service led by Rev. David Marx, pastor of the First Presbyterian Church.

The white brick building is built on the northeast corner of the courthouse block, facing south. It has central air conditioning-heating, carpeting throughout, and new library shelving, reading and research tables and chairs for both adult and young readers, work area for the librarian and assistants, kitchen, rest room, and store room. The contribution also included vacuum cleaner, filing cabinets, desk, chair, etc., for the convenience and needs of those who are in charge of the facility.

"In appreciation for your love, guidance, and friendship. The Kids. July 1973."



The library was organized and was made operational in early 1967 by a group of interested citizens, and was initially housed on the county courthouse second floor.

After the Library Services and Construction Act was passed and federal funds to libraries were made available, the Terrell County facility became a reality. A part of the Texas library system, the facility has access to services of a major resource center, the El Paso Public Library.





RESPONSIBILITY IN GOVERNMENT

Pecan Tree Owners Are Advised About Webworm Control

Webworms have returned for an annuel picnic in homeowners' pecan trees, confronting owners with the threat of its unsightly silk webbing and foliage destruction.

"If pecan tree owners want to have a productive yield, now is the time to act," Agriculture Commissioner John C. White advises.

The web could stay indefinitely if not burned off or the branch cut off. While the webworm is not feeding on the leaves of the tree, the webbing it spins acts as its home.

"It can completely defoliate a tree if not kept under control," White said.

Some successful insecticides can be used to combat this pest. They are lindane, toxaphene, chlordane, and sevin. Directions for use of these in secticides are printed on the product label.

"It is vital that home owners use the insecticides in the quantity specified because misuse could be dangerous to other wildlife," White warned.

"The Federal Environmental Pesticides Act of 1972 set out firm rules on how they are to be applied in pest control. It's a matter of federal law

this year," he added.

During its life cycle, the webworm goes through four definite stages of development with each cycle lasting approximately 45 days.

The adult fall webworm deposits its egg on the underside of the leaf in clusters of 500-900 which hatch in seven days.

The larval stage is the destructive stage of the webworm's existence. The larva feeds for three to four weeks on the leaves, which supply nutrients to the pecan.

Other deciduous trees also fall under the webworms' attack, such as the cottonwood, mulberry, sweet gum and the Arizona ash.

Deer Lease Fraud Violator Loose

Parks and Wildlife Department enforcement personnel have learned that Larry W. Tamplin escaped from the Sugarland Unit of the Texas Department of Corrections July 2 while serving a three-year sentence on a mail fraud conviction. He had been found guilty this year for using the mails to sell leases to some 110 unsuspecting hunters for an estimated \$10,000.00.

Operating out of Livingston, Tamplin advertised bogus mule deer leases in Texas newspapers from July 1971 to December 1971. The leases were in the Sanderson and Alpine areas of far West Texas. Tamplin failed to produce any lease for the hunters.

Although it is doubtful that Tamplin would try to revive his lucrative lease operation, lease hunters are advised to be a little more cautious in finding a place to hunt this fall.

Texas Parks and Wildlife Commission Officer Burt Williams, stationed in Sanderson, stated that he had spent some time in efforts to apprehend the person guilty of fraud after hearing some complaints from disgruntled hunters who had come to this area in anticipation of hunting.

Anadarko Production Company, the exploration subsidiary of Panhandle Eastern Pipe Line Company, confirmed a new oil well in Converse County, Wyoming.




