

## Urged To Meet Aug. 16 in Uvalde

All mohair growers are urged to attend the summer directors meeting of the Mohair Council of America, to be held at 10 a.m. Thursday, August 16, at the Civic Center in Uvalde.

According to Council officials, the meeting is of vital importance as directos are expected to discuss ways and means of financing future mohair promotion, advertising and market development programs conducted by the Council in the event that mohair prices continue strong during the next several shearing seasons and there are no promotion funds available to the Council from growers' incentive payment deductions. The Council's operating funds come from a 1-1/2¢ per pound deduction made from rower incentive payments. During the past marketing year no incentive payment was made on mohair sold during 1972 because of the overall average price was higher than the government support

Q. I'm 21, and since my father died, I've been getting monthly social security payments. I've just completed my bachelor's degree. Now I'd like to work toward an advanced degree. Will social security continue to pay me monthly benefits if I go to graduate school?

A. Yes. You can continue to get monthly student payments as long as you are attending college and remain unmarried. Your last monthly check will be for the month before the month of your 22nd birthday.

Q. I'm a 19-year-old student getting monthly social security payments. I just got a part-time job and my earnings for this year could go over \$2,100. Do I wait until my earnings do exceed \$2,100 before reporting it to social security?

A. No. You should notify social security as soon as you start working at a job where your earnings could

exceed \$2,100 for the year. In the report to social security, show the month you started work and estimate your total earnings for the whole year from January 1 through December 31. If you wait until you've earned \$2,100 before reporting, you could already be overpaid and have to pay some money back to social security.

Q. Our family doctor says my father will need a hospital bed for use at home. Since my father has coverage under both parts of Medicare, who decides if he should buy a bed or rent one?

A. Your father does. However, your father should keep in mind that Medicare payments are made over a period of time, based on the reasonable rental rate for a hospital bed. These payments stop when his need for the bed ends. The length of time your father may need the bed is an important factor



### **Grant Received To Finance Radios** For Area Officers

Governor Dolph Briscoe today awarded a \$620,313 grant to the Permian Basin Regional Planning Commission, Midland, for implementing a new law enforcement radio system to serve the 17-county region.

The money will come from the Criminal Justice Council, which administers the state's block grant from the Law Enforcement Assistance Administration under the Omnibus Crime Control and Safe Streets Act.

The new radio network will eliminate overcrowded frequencies as new high-band frequencies are assigned each police agency. The result is expected to reduce police response time to emergency calls.

Contract will be made immediately, and the system is expected to be complete and operable within 300 days from contract date.

The Permian Basin application was among 52, for more than four million dollars in funding, considered by the CJC Executive Committee July 13.
