LISTEN TO LUKE

Did you ever drive around town and look at things really critically and pick out the things that you think are good and the things that you think are bad and then wonder what you could do to keep the good things that way and maybe do something to improve the things that are not so good? If someone were to make a statement: "This is not your town, you have no right to an opinion about so-and-so!" -- it would probably get your hackles up in a hurry. And it should if you live here!

But then, on the other hand, if it is your town, then aren't you and I responsible for what the town is, to some degree? The appearance of the town is not something that one person, or a small group of persons can do much, if anything, about. But everyone in the town, taking a real interest, and doing something about it, could make this one of the most attractive towns in West Texas. But you might say: "What good would that do?"

This accomplishment, of itself, would be something, but it would not be everything that would result. There would be other results, we feel, that would be benefits, also.

Every new tree that's planted, every new lawn that is established, every weed that is cut, every coat of paint that is applied to a house or building, or fence, all reflect a certain attitude of people generally, and would give us all a common cause or goal.

The town belongs to all of us! The schools are the property of the smallest tax payer who has no children in that institution, the same as they are the property of the largest family of students and/or the largest taxpayer. The church should be the responsibility of every resident, regardless of how you might really feel, or how your feelings appear to be. The county's property is your property to a degree, the fire department belongs to no one individually or group, the water district is yours, as is the dump ground, our streets, gutters. The highways, signs, and reflectors, even the property inside the right-of-way belongs to all of us.

Owning all these things and an awareness of our ownership maybe gives us a sense of pride, but there is also the responsibility of ownership and this responsibility includes a certain amount of interest and activity on our part in caring for, improving, and otherwise exercising our stewardship over things under our care.

One person recently said, during a conversation about some of these things: "But what good would it do to get all these things done, like cleaning up, hauling off, etc., when we still don't have any flood prevention dams, and it could all be wasted time, effort, and money!"

And there are those that feel that rebuilding or cleaning or concern about appearances or conditions are not only useless, but they also contend that the

Student Enrollment Down To 398

There are 398 students enrolled in the three schools of the Terrell County Independent School District, according to figures released Monday from the office of Supt. Carroll B. Card.

There are 148 students in the elementary building with the following breakdown by grades: kindergarten 24, 1st 28, 2nd 27, 3rd 35, 4th 34.

The four grades of the junior high school building have 133 students, with 25 in the 5th grade, 37 in the 6th, 36 in the 7th, and 35 in the 8th.

In the 9th grade there are 32 students, 33 in the 10th, 27 in the 11th, and 25 in the 12th, for a total of 117 in the high school building.

The beginning enrollment of the last school year was 413 students, or a decrease of 15 students this year, according to the figures available.

Man Found In Wrecked Car Monday, Dies Later of Bullet Wound In Head

Roy Starwood, 45, of Los Angeles, Calif., was found in a wrecked station wagon about 8:00 a.m. Monday four miles east of Dryden on US 90 in Terrell County. The wrecked station wagon was found in a pasture and the injured man inside.

It was discovered that the man had a bullet wound in the head and he was taken to a Fort Stockton hospital and transferred to an Odessa hospital where he died at 3:15 p.m. as a result of the bullet wound, according to reports.

The vehicle was going west on US 90 and left the road at a high rate of speed, it went through a fence and skidded 370 feet into the pasture and turned over.

Tom Lowrance, Texas Highway Patrolman who was the first officer at the scene of the accident, stated that a .38-Special pistol was found in the car. Other officers working on the investigation are Texas Ranger Alfred Allee Jr., Sheriff Dalton Hogg, Deputy Sheriff Donald Turk, and Glenn Weatherman, criminal investigator for the district attorney.

Ranger Allee is stationed in Ozona and Weatherman resides in Del Rio.

VA Loans Easier Under New Rules

The Veterans Administration has initiated new measures making it easier for married veterans to qualify for guaranteed home loans.

Administrator of Veterans Affairs Donald E. Johnson said VA regional offices have been told of the July 18 changes.

"In consideration of current social and economic patterns, VA will hereafter recognize in full the income and expenses of both the veteran and spouse in determining ability to repay a loan obligation," Johnson explained.

He noted VA is required by law to determine if the contemplated terms of repayment bear a proper relation to the veteran's anticipated income and expenses before approving a loan.

The spouse's income has always been considered for this purpose, but in the past, local rules which had the effect of discounting the young wife's income were often imposed. Under the new policy, no such local rules will be imposed and the wife's income will be given full consideration.

Benefits Paid To 238 Residents

Social Security benefits were being paid to 238 residents of Terrell County at the rate of \$27,000 monthly at the beginning of 1973, Erven Fisher, district manager for Social Security said today.

Of the social security beneficiaries living in Terrell county, 164 are retired workers and their dependents. Another 52 are receiving benefits as the survivors of workers who have died, and 19 are getting benefits as disabled workers or their dependents, according to Fisher.

Although most beneficiaries are older people, there are many younger people receiving benefits. In Terrell county 43 people under age 60 are collecting social security payments each month. About 21 are under age 18, receiving payments because a working father or mother has died or is getting disability or retirement benefits.

The broad family protection of social security is illustrated by the 5 beneficiaries between 18 and 22, most of whom are receiving benefits under a provision of the law allowing child's benefits to be continued beyond 18 and up to 22 if the child is a full time student. Some of those in the 18-22 group are children of deceased, retired or disabled workers who became disabled before age 22 and who probably will never be able to work and be self supporting. Benefits to these young handicapped individuals will continue indefinitely.

Fisher said benefits in the 15 county district served from the office at 516 First National Bank Bldg. in Odessa amount to \$3,236,000 per month and are going to a total of 24,947 people.
