Did you ever notice how the people in offices whose salries are paid by taxpayers are always talking about saving money, but seldom turn down an opportunity for a raise?

It would be more convincing at times that their efforts to ave taxpayers' money, if they would do some conserving a little closer to home.

The recent action of the legislators in voting the ridicubus amount of duplicate chairs of the original designers of the state's constitution and asking for a raise to \$15,-000.00, and talk about a short ource of revenue!

Midland and Pecos Counties have been having their trouble lately with efforts to re-align their precincts that would bring those with less than 100 voters up in voting strength to he requirements.

There are probably other counties of the state that have been beset with these kinds of problems, but we do not get nor read papers from all of the other parts of the state.

The new state law requires at least 100 voters in each precinct, according to what we have read. Some of their moblems began several months ago - in those counties men-tioned - because someone initiated legal action against the situation where the "one man, me vote" did not apply.

The "one man, one vote" reairement mandate of the laws of the state and upheld by the courts was sought by some perons or person within those counties and thus the long, trawn-out effort for realignment; probably accompanied y unnecessary expense, a sad waste of time, and a useless severance (possibly) of friend-

Eagles Win Opener More Rain Falls Over Imperial 28-6 Last Week Here, Home Game Friday Two Report Snow

The Sanderson Eagles romped over the Class B Buena Vista-Imperial Shorthorns 28-6 in their opener there Friday night of last week.

The scoring for Sanderson was in the second and fourth quarters, with the Imperial TD coming in the third frame.

Robert Kline went over from the 3-yard line in the second period for the first touchdown. Kline is the quarterback. Kendall Billings ran 18 yards for the second Eagle score, running from the halfback slot. Kline scored again on a fouryard run in the same period. Bill Mott, halfback, converted extra points on place-kicks after each of the three TDs.

Imperial's score in the third period was on a 5-yard run by Rodney Powell, quarterback. The point-after try failed.

A pass from Mott to Ricky Marquez, end, accounted for the final Eagle touchdown. The pass was good for about 35 yards and Mott again booted the extra point to wind up the scoring in the game.

Coach Willie Myers said that the players showed well during their first game in his opinion, and he awarded the following players stars for their efforts: Kendall Billings 3, Jimmy Davis 2, Carlos Munoz, Larry Hernandez, and Robert Kline.

The Eagles were able to make about 255 yards rushing as compared with 50 for Imperial, they also led in first downs 15-8. Imperial completed 8 of 12 passes for 80 yards, and the Eagles completed 4 of 8 passes for 78 yards. Sanderson's penalties amounted to 90 yards and Imperial's 30 yards.


Two local residents, who are early risers, reported to The Times that there was actually a brief and light flurry of snow early Friday morning.



Six Miles of RM2886 To Be Paved Soon

Texas Highway Commission has approved development of 6.0 miles of Farm-to-Market Roads in Pecos and Terrell Counties as a part of the 1973 Texas Farm-to-Market Road Program.

District Engineer Paul H. Coleman of the Texas High-way Department, was in Sanderson last week and gave the information to The Times. He said the estimated cost of the work in the counties is \$259,300.00.

In Pecos County, R.M. 2886 a distance of 2.2 miles north from Terrell County line to end of present improved surface, grading, structures, base, and surfacing, at an estimated cost of \$96,000.00.

In Terrell County, a southerly extension of the above for a distance of 3.8 miles at an estimated cost of \$162,700.00.

Work authorized for these two counties is part of the 559 .4 miles of paved secondary roads statewide which will be developed in this program.

The project is on the road that runs north and south between FM2400 and US290 toward Bakersfield from Fort Stockton. It goes by the Sid Harkins ranch, Hat-A Girl Scout ranch, and the northern



NUMBER EIGHT ON THE BALLOT (S.J.R. 29)

Article XI, of the Texas Constitution is amended by adding a new Section 5(a) which

Authorizes and requires incorporated cities, towns, and villages, regardless of population and notwithstanding the constitutional limitations on total tax rates, to levy such annual ad valorem taxes on the taxable property in the city, town or village as are necessary to pay the principal of and interest on, when due, the general obligations hereinafter issued by the city, town, or village. The legis-lature is empowered to limit by general or special law the total principal amount of general obligations which may be issued, but unless and until the legislature acts to do so, the limitations established by statute with respect to the total principal amount of bonds which may be issued by independent school districts shall apply as the rate limitation on cities, towns, and vil-

lages The wording of the proposed constitutional amendment as it appears on the

ballot is as follows: "The constitutional amendment to authorize cities, towns, and villages to levy such ad valorem taxes as are sufficient to pay the principal of and interest on their general obligations hereafter issued subject to the restrictions provided by law.

NUMBER NINE ON THE BALLOT (S.J.R. 25)

Article VIII of the Texas Constitution is amended by adding a new Section 2C which:

Allows the Legislature, by general law, to exempt all real and personal prop-erty used by non-profit water supply corporations or cooperatives from all property taxes. The exemption would apply only to such property as is reasonably necessary to conduct the business of a non-profit water supply corporation or

Cooperative.

The wording of the proposed constitutional amendment as it will appear on the ballot is as follows

"The constitutional amendment authorizing the legislature to exempt from property taxes certain property used by a non-profit water supply corporation or a nonprofit water supply cooperative.

PUBLIC NOTICE CONSTITUTIONAL AMENDMENTS

SPECIAL ELECTION NOVEMBER 6, 1973

NUMBER ONE ON THE BALLOT (S.J.R. 8)

Article III, Sections 5, 24 and 49a and Article VIII, Section 6 of the Texas Constitution are amended to:

Provide for regular annual sessions of the Legislature. The regular session in each odd-numbered year would be for a period not to exceed 180 days. The regular session in each even numbered year would be for a period not to exceed 60 days and would be limited to consideration of fiscal matters and any emergency matters submitted by the Governor. The 60 day ses-sion could be extended by the Governor for a period not to exceed 30 days;

Provide an annual salary for members of the Legislature not exceeding \$15,000 per year and a per diem not exceeding \$18 per day for each day of each regular session or special session;

Provide that no appropriation of money shall be made for a longer term than one year and direct the Comptroller to make annual estimates of anticipated revenue rather than biennial estimates.

The wording of the proposed amendment as it will appear on the ballot is as

> "The constitutional amendment to provide for annual regular sessions of the legislature; and to provide an annual salary of \$15,000 and per diem for the members of the legislature, effective in January, 1975."

NUMBER TWO ON THE BALLOT (H.J.R. 7)

Article XVI, Sections 50 and 51 of the Texas Constitution are amended to:

Include within the scope of homestead protection the real property of a single adult person which meets the other requirements of homestead property, and to provide that a family homestead may not be abandoned except with the con-

sent of both spouses.

Presently a single adult person is not entitled to claim a homestead exemp-tion and a married man can abandon a family home-stead without the consent

of his wife. The wording of the proposed amendment as it will appear on the ballot is as follows:

"The constitutional amendment to include within the scope of homestead protection the real property of a single adult person which meets the other requirements of homestead property, and to provide that a family homestead may not be abandoned except with the consent of both spouses." NUMBER THREE ON THE BALLOT (S.J.R. 13)

Article VIII, Sections 1-a and 1-b of the Texas Constitution are amended to:

Extend the \$3,000 ad valorem tax exemption to the residential homesteads of unmarried adults

The wording of the proposed amendment as it will appear on the ballot is as follows:

"The constitutional amendment to extend the \$3,000 ad valorem tax exemption to the homesteads of unmarried adults.

> NUMBER FOUR ON THE BALLOT (S.J.R. 1)

Article XVI, Section 59, of the Texas Constitution is amended by adding a new Subsection (e) which: Provides that no law creating a conservation and

reclamation district shall be passed unless a copy of the proposed law is delivered to the commissioners court of each county and to the governing body of each incor-porated city or town in whose jurisdiction said district or any part thereof is or will be located. Each such commissioners court and governing body may file its written consent or opposition to the proposed law with the Governor, Lieutenant Governor and Speaker of the House of Representatives. Each special law creating such a district must comply with general laws then in effect relating to consent by political subdivisions to the creation of such districts.

The wording of the proposed amendment as it will appear on the ballot is as follows:

"The constitutional amendment establishing certain requirements relative to the enactment of laws creating certain conservation and reclamation districts."

> NUMBER FIVE ON THE BALLOT (S.J.R. 12)

Article XI, Section 7 of the Texas Constitution is amended to:

Provide that all counties and cities bordering on the coast of the Gulf of Mexico are authorized to levy a tax to pay for bonds issued for the construction of sea walls and breakwaters upon a majority vote of the resident property tax-payers. Counties and cities are pres-ently authorized to levy such taxes and this amendment only changes the required vote from a twothirds majority to a simple

majority.
The wording of the proposed amendment as it will appear on the ballot is as follows:

"The constitutional

amendment authorizing counties and cities bordering on the Gulf of Mexico to issue bonds may provide that all appeals in such matters shall be to the courts of (civil) appeals." **NUMBER SEVEN** ON THE BALLOT (H.J.R. 6)

Article III, Section 49-b of the Texas Constitution is amended to:

Provide for an additional \$100 million in bonds or obligations of the State of Texas for the Veterans' Land Fund. This amendment increases the present \$400 million authorization to \$500 million;

Remove the present provision which permits buying of land only by those veterans who served between September 16, 1940 and the date of formal withdrawal of United States troops from the armed conflict in Viet Nam. This amendment would allow all veterans who serve after September 16, 1940 to buy land from the Veterans' Land Fund, provided they are otherwise



No Active TB From Recent Tests In Terrell County

The Texas State Department of Health in conjunction with the American Lung Association, Trans-Pecos Area, conducted a Tuberculin Skin Test Survey in Terrell County in October of 1972. As a result of the survey, no active tuberculosis or contagious disease was found among those tested. Some people, however, were placed on preventive treatment.

In 1965 Senate Bill 130 was passed to facilitate control of Tuberculosis in Texas. Because of the discovery of antituberculosis drugs it is no longer the dread disease it was at one time. An intense effort is being made to find all active cases and those persons at high risk of developing tuberculosis. The high risk grou includes persons who have a positive skin test and who are under 20 years of age. A positive skin test does not mean a person has active disease, but it does mean that he has picked up a tuberculosis infection at some time. As the result of a positive skin test, a chest x-ray is necessary to determine whether it has developed into disease.

Preventive treatment, for tuberculin reactors under 20, consists of the individual taking anti-tuberculosis drugs for one year and the drug will greatly reduce the individual's chances of ever developing active tuberculosis. During this year, the individual is followed closely by a physician and with periodic x-rays.

The fact that a person is taking preventing medication in no way means that this person is contaguious, but that an effort is being made to prevent the spread of this disease.
