Irion County, which includes the town of Mertzon, made the decision recently for redistricting, leaving Terrell County one of the few that has not vet complied with the state law requiring re-alignment of any precinct has fewer than 100 voters. Terrell County has three of the four precincts with fewer than 100 voters. According to information in the San Angelo Standard-Times Sunday, the precinct bundaries pretty much folbwed natural boundaries such as streets, highways, rivers.

They also have two commissioners in the same precinct and one precinct without a commissioner, according to the story.

Terrell County does not have the natural boudaries that come into Sanderson, such as that many highways, and no rivers, so section lines or just imaginary lines may have to be utilized to denote precinct boundaries.

Redistricting of Terrell County was promised by the time of the next meeting of the commissioners court on November 12.

He was a veteran of World War I, a life member and past master of the local Masonic Lodge, a past commander of the American Legion, served on the board of trustees of the Terrell County schools several years. He retired in 1960 as a passenger conductor after working on the Southern Pacific Railroad for 49 years.

Besides his wife, he is survived by two sons, W.H. Savage Jr. of Richardson and Jack M. Savage of Westminster, Colo.; and 10 grandchildren.

# Eagles Edge Marfa 7-0 Last Friday, Homecoming Friday Night Here

The Sanderson Eagles, playing without three of their starting players, edged the Marfa Shorthorns 7-0 there Friday night of last week. Kendall Billings was out with a head injury, Bill Mott had a severe bruise, and Danny Montalvo had an injured ankle. Jimmy Davis was moved from center to the backfield, Kevin Phillips, who had alternated with Mott, had the stellar job, and David Carter, reserve center, saw full-time action there.

Sanderson's lone touchdown was in the second period on a 3-yard plunge by Davis and Mott kicked the extra point. He also did the punting, but was not in the game at other times.

Statistics reported by the coaching staff, Willie Myers, Steve Burleson, and Tommy Gray, included the following: Sanderson led in 1st downs 21-8; net yards 311-115; passing yards by Sanderson were 23, with 3 of 11 completions and Marfa completed 3 of 7 for 36 yards. Each team intercepted 1 pass and Mott's punts were 3 for 35-yard average, with Marfa punting 5 times for 35yard average. Sanderson was penalized 4 times for 50 yards, and Marfa received 4 penalties for 60 yards.

The Sanderson Junior High School Eagles stomped the Marfa Junior Shorthorns here Thursday afternoon of last week. The score was 34-0. It was the second meeting of the teams this year, the first ended 24-21 in favor of Marfa.

Sanderson received the opening kick-off and the run-back to the 1-yard line set up the first touchdown by Oscar Galvan and the try for the extra point was no good. Frankie Flores scored three more in the first half with Galvan kicking all the extra points. Flores ran for 41 yards in the fourth period for the final score with Galvan adding the extra.

Flores had the offensive honors, according to Coach Larry DeVasto, by making 146 yards on 11 carries, and 72 on passing receptions. Sanderson had 13-6 edge on first downs, going 243 yards on the ground and 104 in the air. Marvin Davis was quarterback for the Eagle attack.

### Well Confirmed, Wildcat Is Set Near Sheffield

Gulf Oil Corp. filed a new potential for its No. 1 Annie Garner, as a second producer and 5/8-mile northeast extension to the Allison (detrital gas) field of Terrell County, six miles south of Sheffield, for a calculated absolute open flow of 4,400,000 cubic feet of gas per day, with gas-liquid ratio of 50,000-1. Gravity of the condensate was 62.8 degrees.

Production was through perforations from 8,759 feet to 8,878 feet, which had been acidized with 5,000 gallons.

Operator earlier filed dual potential as the second detrital producer and for the above gauge through perforations at 8,855-878 feet, and also as an undesignated Pennsylvanian gas producer for a calculated, absolute open flow of 2,000,-000 cubic feet of gas per day through perforations at 8,759-776 feet.

Location is 660 feet from the south and 2,110 feet from the west lines of 16-B2-CCSD6

The Petroleum Corp. of Dallas will drill a 9,500-foot wildcat in Terrell County, four miles south of Sheffield, two miles northwest of the Allison (detrital) field and 2-1/2 miles southwest of Pennsylvanian detrital, South oil production in the Terrell portion of the Yucca Butte multipay field. It is the No. 1-A Kennie Noelke.




