Eagles Whip Wink In Final Grid Tilt

The Sanderson Eagles blasted the Wink Wildcats 40-0 in the final game of the season here Friday night. The Wildcats were winless in district competition.

The Eagles jumped out in front early in the first period on their first offensive drive which was capped by Carlos Munoz's 10-yard touchdown run and Bill Mott added an extra point with a placekick. Munoz scored again in the first period, this time on a 34-yard run, and Mott's aim was good the second time for another PAT.

In the second period, Ricky, Marquez intercepted a pass and ran 80 yards for a score. Robert Kline threw a pass to Kevin Phillips for a 9-yard touchdown and later in the same period threw another pass to Marquez, who made a picture-book catch in the end zone for a 32-yard score. Only one of the points-after were added during the second period.

With a 33-0 lead at the half-time there was liberal use of reserves during the offensive play of the Eagles in the second half and well as defensive. The only score in the second half was in the third frame when Bill Mott ran over the goal line from eight yards out. Kendall Billings added the extra point on a place-kick.

Sanderson led Wink in 1st downs 20-7, yards rushing 296-64, and yards passing 87-0. The Eagles completed 5 of 11 passes and held the Wildcats to a futile effort in three throws. Each team had 1 interception and Sanderson had two turn-overs on lost fumbles to one by wink. The Eagles were penalized 4 times for 30 yards and Wink 7 times for 60 yards. Sanderson punted once for 26 yards and Wink 7 times for a 27yard average.

Sheriff Hogg stated that he was working on the case and had several real good finger prints which could be helpful in apprehending the culprit.


