LISTEN TO LUKE

Every week there are several interesting happenings that cause us to do some serious thinking about a variety of things. This week past was a particularly interesting week. At least that's the way we looked at it!

There were many people who expressed to us, and we heard about many more who were expressive of some doubt that an opinion by the Democratic Executive Committee or any member thereof was sufficient in keeping the name of any candidate off the ballot in the primary; whether or not their action in refusing the filing application and fee was legal.

Frankly, we were tickled to hear and know that there were so many people who are really interested in the legality of things. Now, we believe that these same people should be interested in the legality of other activities in the realm of their control.

We have long held that the means never justified the end where legal or moral issues were concerned, and this includes everything from, for example, lotteries of rifles, television sets, money, etc., by any organization or group, on up to and including any illegal act by election or party officials in the acceptance or rejection of candidates' filing fees, and other details of holding an election; or participating illegally as a voter or candidate; illegal use of any taxpayer-owned equipment or funds, etc., etc., etc.

Since we are interested in the legality of one, we should not be too choosy about our interest or lack of it in other areas.

It will be up to the courts to decide - if they are called on - whether or not a law was violated and if there should be punishment. And that is the way it should be.

Another interest was in the "right" of a person to be involved too deeply if he is not a taxpayer - for whatever reason! Our words are: we should all do our part and be fair and honest with each other. We think this is an excellent idea! We think that everyone who is interested in fairness and honesty and sharing responsibility in one area, should be interested in those qualities in all other areas.

Some people who derive all their financial benefits for living from the county's business or taxes, and who derive any other benefits of residence in Terrell County - whatever those benefits - they should do their part, be fair, and be honest, in their support of everything in the county that is helping them.

If a person does not support the county with taxes, by the first argument presented, he is not entitled to express himself in areas where county taxes are involved. So likewise, we should also have the standard that if a person does not support the business community, then he separates himself as a full-fledged citizen by

Stanley C. Hausman authorized The Times to announce his candidacy for state representative of the 70th Legislative District. His nomination is subject to action of the Democratic Primary May 4.

Hausman is 36 years old and is in the insurance business in Eagle Pass, Laredo, and Del Rio, where he also has a realty company. He is currently serving as president of the board of trustees of the Eagle Pass Independent School District.

Hausman stated: "Tourism is probably the one industry that is vital to all sections of District 70. Throughout the district, hunting and fishing plays an important part in the economy. This puts District 70 directly in the path of the energy problem we are facing today." He stated that his experience as production engineer with an oil company afforded him some background that would be helpful in dealing with that problem.

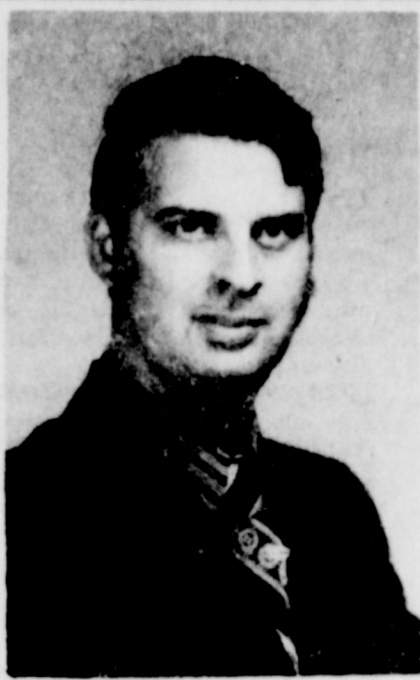
He added that he recognizes further problems in the district: financing of public education, predator control, and reasonable environmental control laws.

Hausman concluded: "What I have tried to point out in my announcement is the great variety of problems that face District 70. ...Ozonan in state race

Bill T. Williams of Ozona has announced that he has filed with the State Democratic Chairman for State Representative of the 70th Legislative District.

Mr. Williams was born and raised in Ozona and is in the ranch business and recently started a fresh water catfish farm. His interest in politics stemmed from his acquaintance with several state representatives, being the son of a former Crockett County judge, and serving as precinct Democratic chairman and attending two Democratic conventions.

He and his wife both taught school in Eagle Pass, San Antonio, and she taught in Fort Stockton while he was still in Sul Ross State University. He stated that their areas of residence and different means of earning a livelihood afforded them an opportunity to see the problems of the district from several different perspectives.

Williams stated that he felt closer to the needs and interests of the people in the nine-county district, and if elected he will try to represent everyone in the district to the best of his ability.

John D. Stutes bought the mobile home belonging to Mr. and Mrs. J.W. Sanders in Lomita Terrace and is living there. The Sanderses have moved to Troup.

Outlook Good For Nurse-Practitioner Pilot Program

The outlook is good for a nurse-practitioner in Sanderson to work with doctors of this area, according to a report by Dudley Harrison before the commissioners Monday morning.

Harrison stated that there were three women and a man from the Texas Commission on Nursing and three doctors, members of the Big Bend Medical Society, at a meeting here Friday night of last week with the local group to discuss tentative plans and look over the facilities and situation. The group noted all equipment and the Trans-Terrell Medical Center Building's facilities and will recommend what equipment, if any, is needed. They will also recommend fees to be charged, and other areas of concern where they would be helpful.

Harrison stated that nine states had been selected as areas for pilot programs for this practice, and Sanderson was the only place in Texas selected to try the program. A registered nurse, with additional training of some 44 weeks, would come to this area to work with each individual doctor for a time before coming to Sanderson to begin practice here. The duties of the nurse here would be for emergencies, as in accidents, routine first aid, and referral service and treatment after conferring with the doctor of a patient. It was stated that the doctors felt that much of their work-load might be eased by a nurse-practitioner without loss of any benefits to the patients.

The officials here from Austin stated that it would now be necessary to find a registered nurse who wanted to enter the program, receive the training, and be willing to come to Sanderson.

J.M. Davis Resigns Local Demo Post

The Times received a copy of a letter of resignation of J.M. Davis as chairman of the Democratic Party of Terrell County. The letter was dated Friday, February 8, 1974.

Davis stated that he had received numerous telephone calls from a Midland attorney threatening a mandamus suit against him if he refused to accept filing applications and fees of persons who had sought to have their names included on the ballot of the Democratic Primary as candidates for office in Terrell County. Davis stated that the party calling represented himself as attorney for two local men, and Davis' refusal to accept filing applications and fees was based on a question of qualification by residence. Davis further told The Times that he had contacted officials in the office of the Secretary of State in Austin for advice and that his actions were at first upheld, but later contacts with the Austin officials proved fruitless and previous offers of advice and assistance were withdrawn. He stated that his resignation was prompted by his feeling that he was being asked to compromise his convictions of honesty and fairness in an effort to fulfill the duties of the office and that he would resign rather than do that.

Davis was appointed to the office of Chairman of the Democratic Party of Terrell County about three weeks ago following the resignation of Charles Stavley who resigned that post so that he might enter the race for county judge of Terrell County.

No replacement of Davis has been named at the time of this writing. The action is the responsibility of the county Democratic executive committee which consists of Mrs. H.E. Ezelle - in precinct 1 - and Tommy Hayre - in precinct 3. Graham Childress, who had formerly held a post on that committee in precinct 4, resigned so that he might enter the race for commissioner of that precinct.

Commissioners Meet Monday

The Terrell County Commissioners' Court met Monday morning at 9:00 o'clock, their new convening time, in the county court room at the courthouse.

Mrs. Burt Williams, representing Alpha Theta Alpha Sorority, asked the court to invite Planned Parenthood, Inc., a branch of Health, Education, and Welfare Department, and working under the auspices of the Permian Basin Regional Planning Commission, to come to Sanderson on a regular basis. The court approved the request and officially extended the invitation.

A letter was read from J.M. Davis, Terrell County Democratic Executive Committee Chairman, quoting The Times as relating that the commissioners were considering places to hold primaries, and stating that it was the obligation of the parties' executive committees to designate polling places for primaries. He also asked for use of the ballot boxes and voting booths for use in the primary. The court noted that the minutes did not reflect the use of the word "primaries" in their discussion of elections.

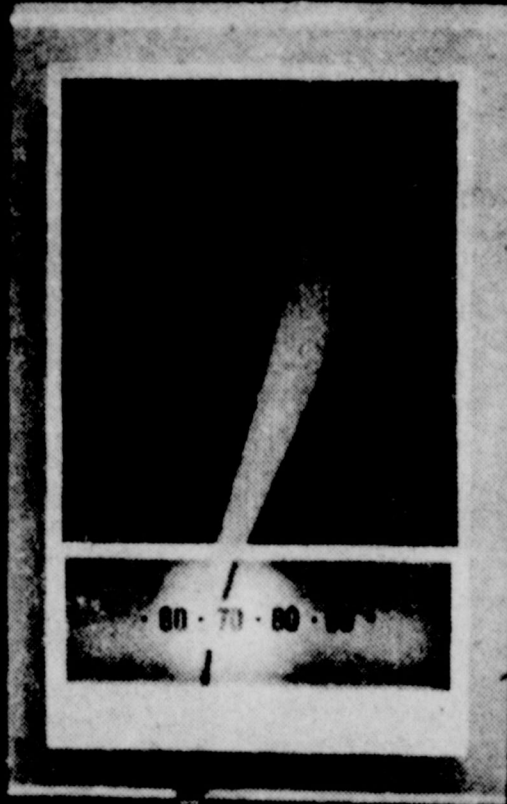

Help Available For Needy Aged

Under a new federal program, people in financial need age 65 or older, and those who are blind or disabled of any age, can now apply for monthly cash payments at the Odessa Social Security District office.

Starting in January 1974, the new Supplemental Security Income program took the place of the state programs of public assistance payments to the aged, blind, and disabled people with limited income, and resources. Those who were on the state welfare rolls in December 1973 were automatically transferred to the federal program in January.

The aim of the new program is to provide federal payments so that anyone 65 or older, or blind, or disabled can have a basic cash income of at least \$140 a month for one person, and \$210 a month for a married couple.

A person who is single can have assets up to \$1500 and still get federal payments. The amount allowed for a couple living together is \$2,250. A home generally does not count in computing assets.

Paul Taylor, in Midland, who is directing a project to inform people of the program, said that under this new program people can have some income and still get Supplemental Security payments. The first \$20 a month in retirement income, including Social Security benefits, generally won't affect the federal payment. The first \$65 a month earnings will not count against the Supplemental Security income payment, only half of the remainder of any additional earnings will be counted.
