We had some very nice compliments on the new name selected for the column and the propriety of our decision to make the change. It's very nice to have understanding friends and we do appreciate them!

We visited with dad in the nursing home Sunday afternoon for about an hour. His physical deterioration is almost unbelieveable - he's so very thin.

A recently-published book about the history of Reagan County was received about two weeks ago and there was mention in it about the Gilbreaths going to Stiles (north of Big Lake) in 1910, and I saw a picture of my grandfather for the first time in my life. I had been in his presence only as a very small boy and had no recollection of him. The book mentioned several things of interest to me that I had heard about, and had pictures of dad's oldest brother on the Stiles baseball team, and school pictures that showed dad, a brother, and a sister that were recognizeable.

We mentioned the book to dad Sunday and his eyes lit up, and he looked straight at me and said: "That's right, Albert." -- the first positive statement or action of recognition since before Christmas for any of us. I asked him if it was true that he and his brother, as teen-agers, started printing a newspaper my grandfather bought from a Mr. Hunter, who later published a paper at Fort Davis, and then with his son, began publishing historical periodicals in Bandera. He said this was true, and when I asked him the name of the paper, he said very quickly and positively: "The Stiles Journal". But he couldn't remember the name of the brother, nor the fact that mother had visited with him two days previously. Pardon our relating these personal matters, but they were meaningful to us, and we have had some inquiries about dad's condition. He's just alive, and very lit-

But there is still no complaining, no discomfort, no unhappiness; and we are so very thankful for that!

We make a little extra "welte" around town some early mornings, and it is not uncommon to see several trash barrels overturned and dogs around them, or the trash strewn around as though dogs had been looking for something to eat.

Probably ranchers in this immediate area are tickled to death that the dogs are turning over the trash and getting food there instead of coming out into the pastures and finding young -- or grown -- sheep to eat on!

New Wildcat Set On Mitchell Ranch

Coastal States Gas Producing Co., Midland, will drill the No. 1-A G.K. Mitchell, a 10,500-foot Pennsylvanian wildcat in Terrell County, 23 miles southwest of Sheffield, two miles southwest of the one-well KM (Ellenburger gas) field, 2-1/2 miles southsouthwest of the one-well LittleCanyon (10,000-foot Strawn) gas field, and 1-3/4 miles southwest of C&K Petroleum Inc. No. 1 Mitchell, active 10,500-foot wildcat.

Location is 1,09- feet from the north and 2.120 feet from the east lines of 29-1-CCSD &RGNG. Ground elevation is 2,771 feet.

C&K No. 1 Mitchell, in 12-1-CCSD&RGNG, was drilling below 8,869 feet at the last report. It flowed gas at the rate of 5.2 million cubic feet daily when drilling reached 9,206 feet.

The Little Canyon opener, Mobil Oil Corp. No. 1 G.K. Mitchell, was finaled Sept. 22, 1966, for a calculated, absolute open flow of 1.54 million cubic feet of gas per day, with gas-liquid ratio of 31,000-1, through perforations at 10,106-11,670 feet.

The KM Opener, Amoco Production Co. No. 1 Keith Mitchell, was finaled Nov. 27, 1967, for a calculated absolute open flow of 53.6 million cubic feet daily from open hole at 17,410-18,644 feet and flowed gas for 16 hours at the rate of 2.7 million cubic feet daily when drilling reached 9,365 feet.

Prospector Shows Good Gas Flow On County Wildcat

Skelly Oil Co. No. 1-18 Culbertson, in 18-2-CCSD& RGNG, Terrell County wildcat, 27 miles southwest of Sheffield, flowed gas at the rate of 125,000 cubic feet daily on a drillstem test being taken in the Strawn.

Gas surfaced in 10 minutes, flowing at the above gauge on the 10hour and 20-minute test taken at 11,880-12,036 feet. No recovery and no pressure were available.

The project, contracted to 16,200 feet, flowed gas at the rate of 112,000 cubic feet daily and recovered 368 feet of slightly gas-cut mud on a drill-stem test of the Wolfcamp at 9350-412 feet.

Registered Voters Numbers Told

The number of registered voters in Terrell County was compiled in the office of the county tax assessor-collector for the use of party officials in determining the number of ballots required by the law, and also for the use of candidates in the various locally-contested races.

Precinct 3 has the largest number of registered voters by the latest count, with 300; precinct 1 has 288, precinct 2 has 200, and precinct 4 has 250.

The total number of registered voters is up about 100 over last year, according to figures reported to Kerr.







Pork Referendum and Producer Board Election

Being certified by the Commissioner of Agriculture of the State of Texas for this purpose, the Texas Pork Producers Association, 2422 Taho, Sherman, Texas 75090, proposes a ref-erendum election on May 14, 1974 under provision of Article 55c, Vernon's Civil Statutes, on the proposition of whether or not the pork producers in the State of Texas shall assess themselves a maximum amount of 10 cents per head on all slaughter animals to be collected at the point of first pro-cessing or sale and to elect members of a 15 member commodity producers board to administer proceeds of such assessment to be used for research, predator control, disease and insect control, education, and promotion designed to encourage the production, marketing, and use of pork.

The referendum and election will be held by mail ballot which will be provided to all eligible voters not later than 15 days prior to the election. Ballots must be mailed to the polling lace at Sherman, Texas before midnight on the date of

Any person within this state engaged in the business of producing, or causing to be produced slaughter hogs for commercial purposes is eligible to vote, including owners of farms and their tenants and sharecroppers, if such person would be required to pay the assessment proposed.

Any person qualified to vote at the referendum may place his name in nomination for membership on the proposed commodity producers board by application to the above or-ganization signed by himself and at least ten other persons eligible to vote in the referendum. Such applications must be filed at least 30 days prior to the election date.

Any person qualified to vote who does not receive a ballot prior to April 30, 1974 may obtain one at his local County Agent's Office.
