Truck Resumes Sanderson-Dryden Mail Delivery

The truck delivering mail from Dryden to Sanderson was re-instated as a regular run every day except Sunday recently by postal officials in the eastern zone. The first run of the truck was Wednesday of last week.

of last week. Service had been halted between Sanderson and Dryden by the truck, thus breaking the link of delivery of mail between the two Terrell County towns and necessitating the re-routing of all eastbound mail westward to El Paso, then sent eastward. By the same reversal of direction of mail flow, all mail from the east was going to El Paso before coming to Sanderson. Thus, mail to Dryden, Pumpville, Langtry, Comstock, Del Rio, etc., was going to El Paso, then to San Antonio and westward to its destination, usually taking at least three days.

Local residents and residents of Dryden were happy over the reinstatement of the service for the six days and the rapid flow of mail into the two towns in the more-direct routing and delivery process.

New Bus Route For Students Beyond Two Mile Limit

A new bus route for students in Sanderson schools is dependent upon finding a suitable and competent driver for the bus, according to Supt. C. B. Card. The board is accepting applicants for the job.

Mr. Card stated that the new route, if instituted, would go to the turn-off for the Continental Ranch on RM 2400 and return via Lomita Terrace Addition in the town of Sanderson, picking up 18 students now living on the route, and covering a distance of 70.5 miles.

Mr. Card stated that persons who lived as far as 2 miles from the school attended by the student were eligible for the transportation consideration, and thus the trip through Lomita Terrace. He also stated that it was necessary to

Commissioners Order Seal-Coat, Set Voting Sites

The Terrell County Commissioners Court met Monday morning at the court house in regular session. County Judge R.S. Wilkinson, W.W. Sudduth, Austin Chriesman, and David Mitchell were present. The last three named are commissioners of precincts 1, 2, and 3, respectively.

The minutes of the preceding meeting were read and approved, then the bills were read and they were allowed and ordered paid after a vote by the group.

Judge Wilkinson stated that \$77,000 was on hand in the Permanent School Fund and it was ordered that this money be invested in U.S. Treasury Bonds and that until further action by the court, that upon accumulation of \$10,000, the money be invested immediately in the same way.

After some discussion about the general election in November, it was decided to name the existing commissioners' precincts as the election precincts for that election, with James Caroline, Lewis James, Monty Harkins, and Mrs. James Cooper the election Adges for precincts 1-4 respectively. The voting places were specifically named as: court house for precinct 1; for Precinct 2 the old store building on the northeast corner of the intersection of Fifth and Pine Streets; precinct 3 at the elementary school; and precinct 4 in the band hall. All the voting places are those used at the last election held in the county. It was noted in the discussion that a separate voting box could not be set up within a voting precinct for less than 100 voters, and that voting precincts could not cross commissioner continued to second page

It was interesting to hear the discussion about "unitizing" county equipment at the commissioners' court meeting Monday morning. If the commissioners were to adopt that method of operation, among other things, it would put all of the equipment under the supervision of one person or the group as a whole, rather than having a maintainer and loader, etc., in each precinct for use when needed or when operators were available. It would be our opinion that just because some have or have not tried it, means only that fact. It does not mean that it would or would not work in Terrell County. But one could hardly say that it could not possibly work until after four commissioners and a bunch of residents had tried real hard to make it work and failed to do so.

We know from bitter and sad experience that we have wanted things done a certain way and by a certain time, and it was not done sometimes that way and sometimes not by a certain time, and sometimes it was not done at all! And we know, also, that our needs are the most important needs of all. The only trouble was, we had trouble making someone else look at it the same way we

Extension of RM2886 Is Set

The Texas Highway Department in Odessa announced this week that a construction project is planned for Pecos and Terrell Counties. RM 2886 is to be extended from the end of the existing route southwest approximately 6.0 miles to a point 3.8 miles southwest of the Pecos-Terrell County Line in Terreil Coun-

The proposed project is for the construction of two ninefoot traffic lanes on 120 feet of right-of-way. The proposed project will generally follow the route of the existing county road, departing only to provide for a desirable alignment.

Maps and other drawings showing the proposed location and geometric design, environmental studies, and any other information about the proposed project are on file and available for inspection and copying at the Resident Engineer's Office at McCamey. Also, the drawings showing the proposed route and geometric design have been placed on file with Pecos and Terrell Counties.

Any interested citizen may request that a public hearing be held covering the social, economic, and environmental effects of the proposed location and design for this highway project by delivering a written request to the Resident Engineer's Office on or before September 6, 1974. In the event such a reugest is received, a public hearing will be scheduled and adequate notice will be publicized about the date and location of the hearing.







Seven Counties Are **Brucellosis Free**

Seven counties of southwestern Texas are the first in the state to be declared "Certified Brucellosis Free" by the U.S. Department of Agriculture. They are: Crane, Ector, Jeff Davis, Loving, Terrell, Winkler, and Ward.

The Brucellosis Free certifications were awarded on the basis of recommendations by Dr. E.S. Cox, in charge of Veterinary Services in Texas for USDA's Animal and Plant Health Inspection Service, and Dr. H.Q. Sibley, executive director of the Texas Animal Health Commission.

The attainment was due largely to the cooperation and diligence of local cattlemen in testing and eliminating brucellosis-infected cattle from their herds, and two veterinarians said:

Being designated Certified-Brucellosis Free," they explained, "means not more than one percent of the counties' herds and not more than 0.2 percent of their cattle were found to be infected during the 18-month testing period immediately preceding the requests for certifica-

Brucellosis, also known as Bang's disease, affects both animals and man. In addition to causing economic losses to cattlemen, largely from infertility and abortion of breeding cows, the disease can be transmitted to humans us undulant fever. Human infection is usually acquired by direct contact with infected animals or by consumption of raw milk.



DEUTERONOMY

It is easy to read any book of the Bible and come to the conclusion that it is the best book of all the scriptures. Especially is this true of Deuteronomy for the Old Testament. A careful reading shows the book to have been written as part of a great revitalization in the faith of Israel. From a low ebb there was a great surge of faith in Israel. Deuteronomy is the record of that revival.

Students of the Bible know that under the leadership of King David and his son, Solomon, Israel became a great nation; but that nation deteriorated and in war fell to the king of Babylon. All the leaders of the nation were taken into exile in the Babylonian captivity. When in turn, Babylon fell to a great nation, Persia, the Jews were allowed to return to their homeland. Under the leadership of Ezra and Nehemiah, the nation was re-established and the city of Jerusalem was reconstructed with it walls and with the Temple.

During the rebuilding of the Temple, workers found in the rubble of the old ruins a copy of the Law, the Holy Scriptures lost during the ruin of the city. The reading of that book of law spurred a revival of faith. As a second edition of the Law, Deuteronomy was written to interpret the law and to spread a revitalized faith throughout the people of Israel. When read attentively, it has that power yet today

The fall of Jerusalem was a traumatic shock to the Jews.

That God would allow its destruction was hard to understand. The question, "Why did Jerusalem fall?", was very important to the writer of Deuteronomy. The Jews wanted to avoid such a tragedy in the future. Read chapter 28, especially verses 47-57, and there you will find in gruesome detail a description of the fall of Jerusalem. The account is truly horrible. Why did it happen? What would cause it to happen again? "If you do not obey the voice of the Lord your God or be careful to do all his commandments and his statutes which I command you this day, then all these curses shall come upon you"(28:15). In the judgment of the Deuteronomist, Israel had fallen because she had not been faithful to God. Even though rebuilt, Israel would fall again if she were not faithful.

The theme of Deuteronomy is stated in 11:26, "Behold, I set before you this day a blessing and a curse: the blessing, if you obey the commandments of the Lord your God, which I command you this day, and the curse, if you do not obey the command; ments of the Lord your God." The course of future history would hinge upon faith and obedience.

From Deuteronomy we can learn much that is important today. First, see that the Law is not some ancient curiosity but the substance of a faith presently valuable for us. "Not with our fathers did the Lord make this covenant, but with us, who are all of us here alive this day"(5:3). And second, like the Israelites working to re-establish their nation, we have the opportunity for repentance. If we return to the Lord and obey his commandments, God will restore

his blessings and have compassion upon us (30:1-3).

As incredible as it may seem, there was a time during the Babylonian captivity when the Israelites had actually lost their holy scriptures. Not until the time of Deuteronomy was this vital element of the faith restored. For all practical purpose, a vital element of faith has been lost today. It, too, can be restored by the book of Deuteronomy. That vital element is the knowledge of God's activity in history. Although people no longer view history as the work of God, the writer of Deuteronomy thought God to fashion history. You ask, Why is the world in the shape it is?", or perhaps, "Why is my own life the way it is?" and the Deuteronomist would say to you that history is molded by God. The events of the day and the events of your life are fashioned by God. The context of your relationship with God is day-today history.

The question is raised in Deuteronomy: how does one teach faith to his children? (6:20). The answer given is that one must teach the history of his people. This is the method used by Deuteronomy in presenting the Law. The book begins with the story of Moses and with the story of the Hebrew people escaping the Pharoah in the Exodus. Only after the history of God saving his people does the Deuteronomist give an account of the Law. If you want to teach the faith to someone you must first show that person the history of God's blessings. If you want faith for yourself, you must first see how God has been at work in your life. Never are you asked in the Christian faith to make a leap into the dark. First you are shown how much God has already done. And then you are asked to obey his law.

Beginning with three chapters of history, Deuteronomy then gives an account and an interpretation of the Law. In essence, the law is a matter of the heart. "This day the Lord your God commands you. to do these statutes and ordinances; you shall therefore be careful to do them with all your heart and with all your soul" (26:16). "And the Lord your God will circumcise your heart and the heart of our offspring. will love the Lord your God with all your heart and with all your soul, that you may live" (30:6). "You shall be blameless before the Lord your God" (18:13). Jesus said that you must love God with all your heart and soul, that one is guilty of murder and adultery when he feels hate and lust in his heart, and that you must be perfect. Jesus was only stating the law as it is written in Deuteronomy.

Some points from the statement of Law in Deuteronomy are important to the controversy disturbing today's church. Beginning with chapter 15, it is stated that there is a social dimension to the law. One is to care for the poor (15:7). The society must preserve legal justice, for the poor and the rich alike (16: 18; 24:17). The minister is to take a hand in the exercise of law and justice (17:19). Where there is biblical faith there is social welfare and justice. Where the ministry is faithful to God, the pastor speaks about social issues.

One point in the biblical statement of the law has caused no controversy. But there is need. The Deuteronomist had a great concern which we must hear: there is to be no practice of astrology. Newspapers, magazines, books, radio, and television all publish horoscopes. They are part of the practice of astrology and are specifically prohibited by the biblical injunction

against the Asherim (12:1). How good it would be if once again people would discover and read the law of God. In chapter 8, Deuteronomy gives an interpretation

for all of life. "Know then in your heart that, as a man disciplines his son, the Lord your God disciplines you. So you shall keep the commandments of God by walking in his ways and by fearing him" (8:5-6). One is led by God into an abundant history, or to an unhappy one, according to his observance of the law.
