Supt. Card Issues Statement, Policy On New Bus Route

The following is a statement of Supt. C.B. Card concerning the new bus route and the reasons for the school board's adopting their policy concerning students eligible to ride the bus:

"In discussing the possibility of picking up ineligible bus students (students that do not live two or more miles from the school they attend) with Mr. Gabe Gilley, acting Director of Transportation with the Texas Education Agency, Mr. Gilley stated: 'If a bus stops for eligible bus students and three or four ineligible students board the bus, the consultant sent to approve the bus route would probably not say anything. There would be no way that you could leave the most direct route to the school to pick up students. It . would not be possible to unduly extend the route in distance or time nor would it be possible to overcrowd the school bus.

"The present board policy is that an ineligible bus student wants to ride the bus and he is at a regular bus stop he may ride the bus. Bus stops near the city are located at John Whistler III on US 285 and Highland Plaza and Ocotillo St. in Lomita Terrace. A stop is required on Arroyo St. before entering Highway 90."

Mr. Card also has copies of the laws concerning the operation of school buses on regular routes, a copy of which will be given to any person interested in knowing what the law is. One copy was furnished The Times along with the statement of Mr. Card and the policy adopted by the board.







JOSHUA

In war against the Israelites, King Nebuchadnezzar of Babylon captured the city of Jerusalem. He laid siege to the city and in the most terrible tragedy the Israelites had ever suffered he brought the Hebrew people down to the depths of depravity. Utterly degraded by their own efforts for survival, the Jews were forced to surrender their capital city. Their leaders were taken into captivity. No event in all history down to modern times has had so profound an effect upon the thinking of Jewish people. Only the holocaust of World War II in which six million Jews were killed is a tragedy of equal consequence. Why did it happen? Why did God allow his own city to fall? The writer of Joshua and its

editors made an effort to explain the fall of Jerusalem in their telling of Jewish history. The book of Joshua is an account of the settlement of the Promised Land. Woven throughout is an explanation of why the nation was eventually to fall. The key passage of the book is 23:6-8: "Therefore be very steadfast to keep and do all that is written in the book of the law of Moses, turning aside from it neither to the right hand nor to the left, that you may not be mixed with these nations left here among you, or make mention of the names of their gods, or swear by them, or serve them, or bow down yourselves to them, but cleave to the Lord your God as you have done to this day." This is the point upon which to develop an understanding of Joshua. The Israelites were commanded to obey God and to turn to no other. Ultimately it was a failure to keep faith with God that led to the destruction of Jerusalem.

The book of Joshua begins with the statement that after Moses had died, God began to speak to Joshua in the same

manner that he had spoken to Moses. To show that Joshua now stood in the position of Moses, the writer gives account of events which are repetitious of the experiences of Moses. For Moses, God parted the waters of the Red Sea and led the people across on dry ground. For Joshua, God parted the waters of the River Jordan and led the people across on dry ground (3:16). Moses saw a burning bush and heard the voice of God. Joshua saw a man with a sword and by the voice of this angel heard God (5:13). At the Battle of Sihon, Moses held out his rod and the people got a great victory. At the Second Battle of Ai, by the command of God, Joshua held out his rod and the people had a victory (8:18). By using this scheme of repetition, the writer is telling us that God was working with Joshua just as he had been present for Moses. For us, this repetition is important. It shows us the continuity of God's presence with his people.

This history of God at work in the midst of his people was vital to the faith of the Israelites. Upon crossing the Jordan River, Joshua took twelve stones from the river bed and set up a memorial. That heap of stones would always remind the Jewish people that God had given them a great blessing (4:20). The Jewish people kept their history as a testimony to work that God had done among them.

The Jews were not the only ones to see history as a work of God. Joshua sent spies into the city of Jericho. These men were aided in their escape from the city by a harlot named Rahab. Rahab was convinced that God directed events in behalf of the Israelites. "I know that the Lord has given you this land...For we have heard how the Lord dried up the water of the Red Sea before you when you came out of Egypt, and what you did to the two kings of the Amorites that were beyond the Jordan, to Sihon and Og, whom you utterly destroyed...for the Lord your God is

he who is God in heaven above and on earth beneath" (2:9-11). We must learn to look at life through the eyes of Rahab. The course of events in history is the activity of God. The blessings of history that have come to God's people are the foundation of our faith.

Regrettably, the Hebrews mixed sin and error with their history and lost the favor of God. They had been commanded by God to enter the Promised Land, to destroy all its inhabitants, and to make no bargains with any of the people living in that land. The people broke this commandment even before crossing the Jordan River. Because Rahab helped the spies to escape, they made an agreement promising to spare this harlot and her family. With the conquest of Jericho, Rahab was allowed to live unharmed. Later, the people of Gibeon worked a hoax upon the Israelites and brought them into a second agreement against the will of God. Seeing the history of Jewish conquest, the Gibeonites were freightened and wanted to make a treaty. They sent representatives dressed as if they had been on a long journey. Thinking them from a great distance and no threat, the Jews made a treaty. Although the story of Chapter Nine is amusing, this treaty was blatant disobedience of God. From the beginning of their life in the holy land the Jews broke the commandments of God. To the writer of Joshua it was no wonder that the Israelites would lose the blessings of God and suffer a history of tragedy.

The Hebrews had been commanded by God to destroy all the cities of the land and to kill all their inhabitants. They were commanded to avoid completely the religions of the land. The Jews did not capture every city; they did not destroy the people of the land; and they did involve themselves in local religions. They failed to keep the commandments of God and Jerusalem fell.

Surely you can apply this lesson of history to your own situation and to that of our nation.

With a story in Joshua, for the first time the New Testament becomes crucially important. From this point forward in the Bible, there will be a yearning for coming of Christ. Achan, the thief who stole the devoted goods from Jericho, confessed his sin. But there was no forgiveness. He was killed. (Ch. 7) Those who have sinned need the sacrifice of Jesus Christ and the forgiveness that comes through faith in him. The events of Jewish history now turn their direction toward a climax which comes with the Messiah.
