There are people who presume that this column's head is one which permits a copout for us, and thus they condemn the whole idea because some things are clear cut, whole truth or whole lie statements. And when they have an opinion like that, they are just like the rest of us - it depends on how you look at it.

The heading and the words printed here only point out that the reaction of people is directly related to their perception and understanding.

We know that truth is unchangeable, and we know, too, that the truth of everything is not yet perceived by all men - and by no single mortal - nor married one!

If this statement bursts the bubble of "all-knowing" of some person, we apologize, in a way by saying: "that's the way it looks to us".

Next week, if you do not receive your copy of The Sanderson Times - it's because of one or two reasons: either you have not paid for the new year beginning June 1 according to our records, or the paper was lost somehow in the mails.

In either case, please let us know that we should send you the paper.

In case you can't find a cancelled check, we'll be glad to have one cancelled for you!

Our comments on the school bus last week were our efforts to stress the need for doing things by the rules, and were not taking sides with either those who want the school bus to stop at more places, nor those who have set the rules.

If the policy for stopping only at certain places has been adopted by the school board, that possibly is amendable if there is sufficient reason for amending it - the same as the absence policy, or teacher travel pay policy, etc., etc.,

But if the stops are governed by a law of the state, handed down by the Texas Education Agency, then, as we see it, we should try to work within the law, and if it needs to be changed, then try to change it!

Another opinion that we have, based on the understanding that we have, is that it should be a simple procedure to find out just what the law says and be able to go by that and other examples and precedents tried and tested. But that is not always the case by any means. We do not know how clear-cut the operation is. It may be like the law governing elections, candidates, residence, and many others - they have to be tested individually in court to find out specifically what the law permits and prohibits.

Flood Scare Here Monday Night

Many Sanderson residents were up much of the night on Monday as the result of a warning of possible flooding conditions locally.

The flood warning was aired on television stations and by local firemen in continuous use of the fire siren downtown for several minutes and the circulation of the fire truck through the low part of the town with the siren blasting the warning to residents.

The success of the effort was evident in the number of citizens that were out on the highway to watch the approach of the water in Sanderson Canyon.

The water arrived at the bridge over the canyon near the local gasoline storage facilities before 10:00 p.m. and was soon lapping over the abutment at the west end of Downie St. and gradually increased the flow down that street.

The high mark of the water was near the floor level of the depot, but did not enter any local buildings or homes, as far as is known.

Local gauges varied in rainfall caught, ranging from 1/4-inch to 3/4-inch reported.


