Last week, with Monday being a half-holiday for us and the rains that afternoon that caused us to be occupied with helping to alarm the people living in the lower areas of town, then later staying up half the night to "help watch" the water come down, we did not get much of a chance to talk to anyone about the damage out in the country as a result of the heavy rains.

We had driven out the road to see how much water there was on the flats and in the canyon and were amazed to see how far the water was spread out and how fast it was running on the flat this side of Longfellow.

The water was running several feet deep and was running very rapidly, had taken out a lot of fencing next to the highway or railroad and much damage was done by erosion out there.

Joe Brown Wednesday estimated several thousand dollars of damage to fencing alone and possible loss of some stock due to the high water. He had not been able to get into the area where he had some of the stock. He said there was also some stock pastured on his ranch by another rancher and any loss of

#### **Easement Report** Made Monday To Commissioners

The status of the flood control dam project was reviewed at the regular meeting of the Terrell County Commissioners Court Monday. Audrey F. Baker, Area Conservationist and Larry W. Seymore, District Conservationist of the Soil Conservation Service, met with the commissioners to review the status of easements of the Sanderson Canyon Watershed.

The information indicated that all easements had been secured on Sites 1, 4, 6, and 8. Only four landowner easements remain to be secured and easements from four utility companies remain to be secured.

#### **Eagles Lose To** Balmorhea 21-13

**SEPTEMBER 12, 1974** 

The Sanderson Eagles lost their season grid opener to the **Class A Balmorhea Bears here** Friday night by a score of 21-13.

Sanderson got on the scoreboard first with a field goal by Kendall Billings from 19 yards out and in the second period, and that was the score at the end of the first half -3-0.

In the third period, the Eagles worked downfield, but were unable to move the ball sufficiently well to risk a fourth-down try for necessary yardage and went for another field goal. Billings kicked his second score and Sanderson

#### M.P. Longley. M.D. To Open Office Here on Monday

Michael P. Longley, M.D., announced this week that he would begin the practice of medicine in Sanderson Monday. Dr. Longley moved here last weekend from Garland.

Mrs. Longley is a nurse and will assist him in the treatment of patients in the office.

Dr. Longley asked The Times to announce that he would be in the office Mondays, Tuesdays, Thursdays, Fridays from 9:00 a.m. to noon and 2:00 to 5:00 p.m., and on Wednesdays and Saturdays from 9:00 a.m. to noon.

Dr. Longley stated that he came to Sanderson to serve the people here and would do his best to be available at his office at the times stated, but he asked for the cooperation and understanding of patients when it was necessary to be out of town. He said that he was planning to do very little surgery practice and obstretrics practice, but there were time when it would be necessary for him to be away, but he would try to let patients know in advance, and also have someone in the office during his stated office hours to let patients know his next office schedule.

On the Sanderson Canyon watershed, sites 1 and 3 are on the south side of the canyon and 2-6 on the north side. On the Three-Mile Draw watershed, 10 and 11 are on the cast side of the draw and 7-9 are on the west side.

Sanderson had six punts and a 21-yard average and Balmorhea junted five times for an average of 32 yards.

The Eagle coaching staff: Don Malone, George Black, Tommy Gray, and Bill Ford, stated that there were no injuries during the game with Balmorhea and barring accidents during the scrimmages this week, the Eagles would

#### TWO NAMES ADDED TO 'OUTSTANDING' LIST



After Mrs. H. H. Pipes, president, had called the meetings to order, Mrs. A.N. Farley read the names on the Birthday Calendar and led in prayer.




