Deer hunters coming through Sanderson got under way heavily on Thanksgiving Day this year and many local people who annually enjoy watching the parade of visitors and their varied vehicles missed much of the sight. There were still many vehicles on Friday of last week, but not thick enough to permit us taking a picture to show the crowded numbers. We watched several hours Friday in the cold, cold wind to try to catch that many vehicles at a given place, but we couldn't do it, and finally gave up frozen!

Since most all of the area ranchers are now leasing their places to hunters, the boom financially to both the ranchers and local businesses is some kind of boost to the county. The ranchmen found a saleable commodity and a ready market for their product and are making the best of it. No one would dare venture a guess now as to the amount of money that is spent by hunters in Terrell County, but it is quite a bit - however much that is!

This year - at this writing - we know of two bucks that were killed within shouting distance of town. This is unusual to a degree, although it has been done several times in previous years. It is something that some local hunters hope for, but do not always get.

What appears to be a morethan-normal amount of washing of gravel off our newlytopped streets has occurred with the two incidents of precipitation that we have had. We hope that this is only an apparition and not a fact. There was a lot of our money that went into this project, and we all will be very disappointed if it was not a successful job. The contractors were pushed for time after such a long wet spell that included 10 straight days of rain, and this delayed them considerably in getting all of the streets done, and there was not much warm weather since then to cause the asphalt to "bleed" and take in the rocks that were appled on top.

The work of those who had any part in the success of the deer hunters' bake sale Friday reaped benefits that exceeded all previous sales.

It was reported that more than \$750 was realized from the sale this year. This means that there were more "goodies" donated for the sale, and it meant that there were more hours put in - and this year in a very cold wind - in selling the merchandise.

There were some of the hunters that remembered that they could get baked goods here and planned on patronizing the local ladies. And that fact was appreciated!

Re-entry, Outposts Slated for County

Cabot Corp., Pampa, will reenter and plug back to 9,000 feet for wildcat tests at a 14,-049-foot wildcat failure in Terrell County, 16 miles southwest of Sheffield and three miles south of the depleted Schuler, South (Leonard) field and 3/4 mile southwest of the operator's active wildcat re-entry. It is the No. 37-14 Hunt Industries-University.

It was drilled by Hunt Oil Co. and plugged in September 1965. Location is 467 feet from south and west lines of 14-37-University.

Seco Production Co., Midland, will drill two outposts to the five-well Allison (Detrital gas) field of Terrell County, eight miles south of Sheffield. Both are scheduled to 9,600 feet.

The No. 1-19 Allison, one mile south, is located 660 feet from north and east lines of 19-B2-CCSD&RGNG.

The No. 1-B-23 Allison, one mile west, is located 660 feet from north and east lines of 23-B2-CCSD&RGNG.

Richard J. Stakem Jr. IRS dis trict director for southern Texas, said the new number (1-800-492-4830) will be used by all taxpayers seeking tax information except for those who are served by the telephone exchanges of Austin Houston, El Paso and San An-

Toll free calls in Texas statewide will be handled by the Dallas Office after that date, Stakem explained. Previously, calls from the southern part of the state were answered in the AustinOffice,

except for the four cities where local numbers were used.

The toll free system will be staffed Monday through Friday each week from 8:15 a.m. to 5:15 p.m.

AUSTIN, Tex .- Texas delegates will be heading for Kansas City, Mo., this week for a new kind of Democratic national convention.

Most of them are just as glad there has never been one like it before and hope that there will never be another.

The "mini-convention" or 1974 Conference on Democratic Policy and Organization was mandated by the 1972 Democratic National Convention.

Its job is to produce the first national charter or constitution in history for a major American political party.

It will also serve as a forum for discussion of national issues. Four panels will meet December 6 to discuss four general areas, in identifying the issues of greatest concern to the Democratic party.

The party charter will be adopted after debate by 2,038 delegates December 7, and issue panel moderators will make their reports and addresses December 8.

Gov. Dolph Briscoe is chairman of the Texas delegation, which includes as ex-officio members all members of the Democratic congressional delegation.

Texas liberals, unhappy with selection of Briscoe in a telephone poll, named Ms. Billie Carr of Houston, a national Democratic committee member, their chairwoman.

Prospective candidates for the Democratic presidential nomination in 1976-including U.S. Sen. Lloyd Bentsen of Texas-are expected to make strong bids for attention at the Kansas City ses-

VOTES €ANVASSED—Canvass of the statewide general election vote reconfirmed Atty. Gen. John Hill as the top vote-getting incumbent. He polled 1,170,253 votes to win over Republican Tom Cole, with 379,108 and the Socialist Workers Party nominee, with 30,577.

Land Commissioner Bob Armstrong came in second in the canvass with 1,136,321, and Agriculture Commissioner John C. White third, with 1,125,577.

All the incumbents scored more than a million votes.

High Republican vote-getter in the canvass was treasurer candidate Robert G. Holt, with 559,402.

Votes for governor and lieutenant governor will not be canvassed until the legislature convenes in January. The House of Representatives takes care of that. The Board of Canvassers canvasses the other races, including legislative, congressional and judicial.

COURTS BUSY - During January-June, 1,716,697 cases were filed in or appealed to county, justice of the peace and municipal courts of the state, according to Texas Civil Judicial Council.

Fifty-three per cent of the county court criminal cases and 38 per cent of the civil cases were dismissed or settled before trial.

Justice of the peace and municipal courts received \$26.4 million in revenue during the six-month reporting period.

The council reported 184 of the 254 constitutional county courts have judges who are not attorneys. Only six per cent of 934 justices of the peace are attorneys, and about 65 per cent of the 215 municipal courts (in cities over 5,000) are licensed

RATE HIKES OPPOSED -A group backing utility regulation asked Attorney General Hill to investigate allegations of irregularities in rate practices by Southwestern Bell Telephone Company.

At the same time, the chairman of the Texas Coalition for Utility Regulation said no city council should grant phone rate increases while questions raised in a suit at San Antonio against Southwestern Bell are pend-

The \$29.6 million damage suit by a fired Bell executive and the family of a deceased executive alleges the company kept a separate set of books for use in getting rate increases and indirectly channeled money into political campaigns.

State Rep. Roy Blake of Nacogdoches also advised city councils to reirain from rate increases until the charges have been proved or disproved.

NEW INDUSTRIES MULTI-PLY-Twenty-six new industries which may have a \$121 million annual impact on the economy located in Texas during October.

About 2,300 jobs will be generated, and another 2,259 indirectly created. The industries will produce \$7.4 million in federal taxes a year, \$445,-734 in state taxes and \$537,-287 in local taxes, according to Texas Industrial Commission projections.

> VETS DAY CHANGE BACKED - Veterans Day would be returned to November 11, under legislation backed by Governor Briscoe and sponsored by Rep. Lindon Williams of Houston.

Forty-two other states already have enacted similar bills. Federal legislation changed the date from November 11 to the last Monday in October.

NEW APPROACH BACKED -Governor Briscoe is backing the so-called "weighted pupil approach" to determine spending for public schools.

The formula would take the place of a specific allocation of dollars per classroom teacher unit. Money would be divided among schools in line with time of pupils spent in different types of classes. More "weight"-and moremoney-would go to the executive types of instruction.

Briscoe announced 60 meetings will be conducted over the state December 2-19 to detail tentative proposals developed for restructuring state school finance systems in 1975.



Revised Credit Legislation Aids Texas Women

Household purse strings unwound for Texas women recently with changes in credit legislation, according to one

In Texas, women 18 years or older, can no longer be denied credit solely on the basis of sex or marital status, Mrs. Doris Myers, home management specialist with the Texas Agricultural Extension Service, The Texas A&M University System, explained.

"Legal rights of women are being recognized as equal to those of men, and this law is responsible for that trend, the specialist observed.

She outlined implications of the revised law.

"In 1973, the Texas Legislature amended the Texas Consumer Credit Code to prohibit a credit grantor from denying an individual credit or loans in his or her name - or from restricting or limiting the credit granted - solely on the basis of sex.

"This gives a woman, 18 years or older, the right to apply for and get credit in her own name, if she meets the financial requirements of the credit grantor.

"Meeting those depends on her ability to be responsible for her own debts.

"This usually means having a regular income, stability in employment and residence, a checking account, and references," Mrs. Myers said.

The specialist discussed how variations in individual marital status can affect credit even with new legislation.

"The single, young woman w who has never had credit may have a problem in establish-

ing credit.
"A parent or some other responsible adult may have to guarantee the account at first.

"Credit is established once the account is handled properly for a sufficient time. Although the married wo-

man now has the legal right to credit in her own name, most firms usually prefer to handle the account as a family account, Mrs. Myers said.

"It's less expensive to service one account instead of

"However, most firms will ried woman on request, if she meets the credit requirements. Still, some firms may include her husband's name in parenthesis for identity purposes."

Married women may encounter problems if credit reporting agencies are slow to make separate reports for husband and wife, the specialist noted.

"For instance, if a married woman applies for credit in her own name, and the reporting agency shows no separate record on her, it could cause a refusal of credit.

"A visit to the reporting agency and then the firm's credit manager can help straighten out the matter; if

the woman meets all the other credit requirements."

Other credit situations involve widows, divorced or separated women.

"The widow usually has no problem in changing accounts to her name if the family has a good record of payment and her financial position meets the firm's requirements, Mrs. Myers said.

"A divorced woman who had bad accounts in her husband's name may have to reapply for accounts in her name.

"In general, she must follow the same guidelines for establishing credit as a single

"If she had accounts in her name as a married woman, she simply might have her marital status changed on her records after discussing the accounts with her creditors.

"The divorced woman, in any case, would be wise to consult each firm and change previous accounts that were family accounts or accounts in her husband's name," Mrs. Myers suggested.

Women who are separated, but not divorced, have the most difficult time with credit, the specialist said.

"Some firms suspend additional credit during this time, because funds may be tied up until a divorce is final.

"This may affect the credit records and impair future







Those under age 65 or who have received benefits less than two years will be sent a health insurance card about three months before they read one of these two points. 
