The liberal use of the word "productivity" in connection with land and taxes is as wrong as "pebbles per square foot". There is no sense in the consideration or use of that terminology until and unless the legislature changes the method of evaluating from its present form - ad valorem - on the value!

When people are talking about taxes - and lots of people are these days - they should not tolerate a consideration of "productivity" as means of taxation except in the case of gas and oil wells - which brings up another subject entirely!

While there is so much concern about re-evaluating property in Terrell County, does the price of natural gas now, compared with what it was a year or two ago, have anything to do with the value of gas wells producing in Terrell County, or with the values of minerals near producing gas wells or oil wells?

There are so many things to be considered when people start talking about re-evaluation of certain or specific properties in the county!

It would seem to us that there has been much more of an increase in the values of certain properties than of others - but maybe it depends where you are standing when you look at it!

And like we said last week -- when 100 values are put on one piece of property, the responsibility of the taxing organization then becomes totally committed to 100 valuation on every other item on the tax rolls - or an admission at intentional dishonesty and intentional discrimination!

Anyone who has a different opinion is offered free space to let their views be known, but so that readers can have the benefit of their informative source, the letter must have a valid signature!

The bureau governing companies and their advertising should have something to say about another kind of deception that is so common on TV.

You are given a beautiful view of a seacoast and a person walking along the beach singing, and there in the background is a large chorus and orchestra helping make the song more beautiful. Or a singer is introduced and with only his guitar and himself standing alone on a huge stage or setting, is able to imitate two or three voices singing in harmony and accompanied by a four or five piece group of string instrument artists.

Seco Well Is Gas Producer

Seco Production Co. of Midland is said to be a gas producing well, according to information received last week by The Times. It is the sixth producer and a one-mile south extension of the Allison (Pennsylvanian detrital gas) field of Terrell County with the flowing of gas at the rate of 1,600,000 cubic feet daily in section 19, Block B2, CC SDERNG Survey, eight miles south of Sheffield.

The flow of gas was through an unreported choke and perforations at 10,103-281 feet which had been acidized with 550 gallons. Earlier it flowed at the same rate on a 1-inch choke. Testing is continuing.

Originally slated in the Allison field, it was amended to wildcat depth of 11,500 feet, but drilled only to 10,390 feet where 4-1/2-inch casing was set.

First Aid Class To Start Saturday

A class for 20 will begin on Saturday in the "multi-media" first aid. First aid classes are being planned to accommodate the 52 persons who showed up at the Trans-Terrell Medical Center Thursday night of last week. The classes are to be under the auspices of the local chapter of the American Red Cross.

Mrs. Carlton White, local Red Cross Chapter head, arranged for an instructor from Fort Stockton to be here to explain to interested persons the courses available and to make recommendations.

It was learned that there would be several instructors come to Sanderson to work with local groups in instructing the "multi-media" course - suitable for Girl and Boy Scout leaders, day-camp workers, industrial first-aiders seeking qualification for requirements of the Occupational Safety and Health Act, etc. There will be classes also here to train instructors to renew certificates for the "multi-media" first-aiders.

Present plans are for Dr. Michael P. Longley to get certification as an instructor and he will teach the course he feels will be best for local ambulance drivers, emergency squad members, etc.

Amoco To Drill 20 Miles North Of Sanderson

Amoco Production Co. will drill an 11,500-foot Pennsylvanian wildcat in Terrell County 20 miles northeast of Sanderson, 3-3/8 miles southeast of the depleted Ellenburger opener and four miles southeast of the Wolfcamp opener of the KM multipay gas field, 4-5/8 miles southeast of the one-well Little Canyon (10,000 Strawn gas) field and 1-1/4 miles south-southwest of a 16,685-foot failure. It is the No. 1A Pakenham Ranch Co., Ltd.

Location is 1,320 feet from the south and west lines of section 67-Block 1-TCRR, Abstract 1003.

The KM field produces from the Wolfcamp at 9,185 feet and from the Ellenburger at 17,410 feet.

Testing Continues In Hytech Hole

Hytech Energy Corp., Midland, No. 1 Frank Rashap, in Section 3, Block 176, TCRR, previously reported Devonian gas discovery and a Pennsylvanian prospect, 11 miles south of Sheffield and three miles south-southeast of the Allison (Pennsylvanian detrital) field, flowed an unreported time, making gas at the rate of 271,000 cubic feet daily and decreasing to 260,000 cubic feet daily.

The flow was through an unreported choke and perforations at 10,336-427 feet. Testing was continuing.

The Devonian produced 950,000 cubic feet daily through perforations at 11,143-212 feet in previous calculations, and it was also tested through the Fusselman perforations at 11,482-521 feet, making gas at the reported rate of 700,000 cubic feet daily.

leave their names with Mrs. White if they were not present at the initial meeting on Thursday of last week.

The visitor from Fort Stockton stated that one of the requirements of the OSHA was that workers not within 15 minutes travel time of recognized medical facilities were required to have at least one qualified first-aid with each group of workmen, and specifically named agricultural workers. He stated that he was not sure of the requirements for railroad employees who had a "road job", but that the law was plain on other work crews of the railroad.

It was explained that the "multi-media" first aid course was an 8-hour course, and usually obtained in one lesson, but could be divided into two lessons for the convenience of the pupils and or instructors who were coming here from Fort Stockton. No more than 10 students are allowed in each class for the "multi-media" course.

The standard course of first aid is from 16-24 hours of instruction, and the advanced course is 40-50 hours of instruction.

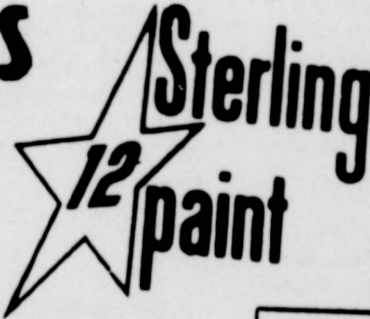

She also stated that the committee would be glad to receive any information pertaining to this project.

Mrs. E.E. Farley, historical markers chairman, proposed that a marker for the town of Dryden be secured as one of the two markers to be designated this year. Mrs. Farley and Mrs. Charles Stavley showed pictures taken in Dryden when a tour was conducted February 15. Ten members made the tour.

Mrs. W.W. Sudduth, memorials chairman, reported memorials were received in memory of L.H. Gilbreath, Mrs. Della Harkins, Mrs. A. T. Hafford, R.B. Mussey Sr., and Mrs. C.G. Riggins.

Mrs. Grigsby acknowledged the receipt of a soil survey of Terrell County from the Soil Conservation Service. This book is put out by the United States Department of Agriculture.

Mrs. L.G. Hinkle, program

chairman, introduced Mrs. Cruz Marquez, who gave the history of El Buen Pastor Methodist Church. Her father, Juan Zepeda, and Vicente Rodriguez were responsible for organizing the church in 1904. Meetings were held in the homes of members. In 1908, these two men, with the help of others, made the adobes and built the first building to house the church. After it was designated in 1963 as a historical building, a medallion was placed on it. Miguel Bustamante of Chihuahua City, Mexico, was the first pastor to serve the church, coming here in 1909.

Mrs. Marquez related many interesting events and displayed the Bible used by her father, the first hymnal which had only words with no music and also the first hymnal with words and music, record books of Sunday school activities, and business meetings. One interesting note stressed was that her father always included in the writing of the minutes, the weather conditions on that particular day.

Region-Wide Library Aid Planned By El Paso Facility

The El Paso Major Resource Center, headquartered in the El Paso Public Library, currently is spearheading a region-wide library development program which will aid Terrell County Library in its continued efforts to provide outstanding library services to Sanderson and the surrounding area. To date, the regional or "Trans-Pecos Library System" project has provided Terrell County Library with \$2,500 for the purchase of library books and has also funded a best-seller rental plan which is now providing new and popular books for local library users. The project will also assist in the development of printed materials and displays for public relations purposes.

Another portion of the Trans-Pecos System Project which will be of interest to area residents is a paperback Mail-A-Book program which is intended to give rural residents of West Texas easy access to a popular book collection. A catalogue listing titles and content description of the more than 1500 books available has been placed in the mails and will arrive in rural mailboxes in the very near future. Several copies of the Mail-A-Book catalogue will also be on hand in the library for those interested either in examining them, or in making use of the service.

Thompson Warns Of Kite Dangers

Potentially dangerous toys have been very much in the news in recent months, and parents will do well to add to the list kites containing metal, and kite strings with metal content or which have become wet.

This is a combination which can pose a threat of death or serious injury to persons who fly kites in the vicinity of electric power lines, according to Gene Thompson, Sanderson district manager for Community Public Service Company, who offered the following list of safety rules:

Always use dry string. No wire or metal in string or kite; don't fly your kite in the rain; avoid TV and radio aerials, as well as busy streets and highways; fly your kite away from power lines, but if your kite gets snagged in a power line, do not pull the string, or climb the pole. Call the power company!

Bulletin board posters listing kite-flying safety rules have been distributed to schools of this area.

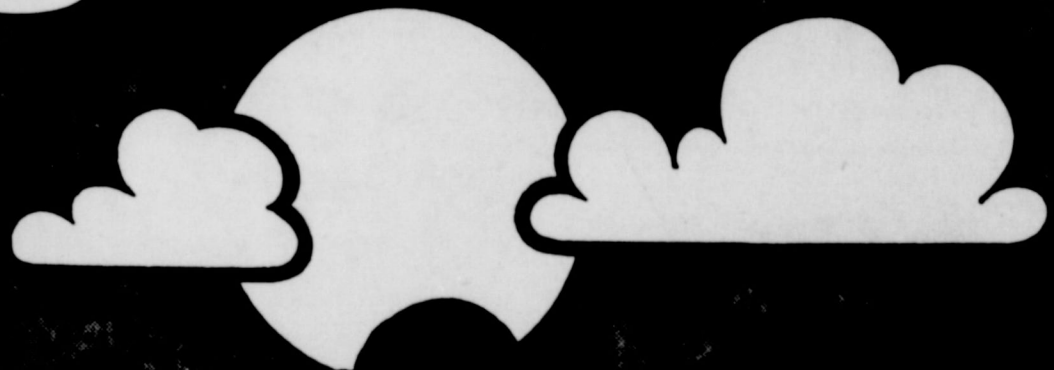

The Consumer Alert

AUSTIN—Many homeowners view the beginning of warm weather as the ideal time to get house and yard in shape for a long summer of enjoyment.

But lawyers in the Attorney General's Consumer Protection Division caution that this is also a favorite season for unscrupulous door-to-door salesmen and repairmen to solicit home improvement jobs.

These operators pop up as regularly as Texas bluebonnets each spring, selling aluminum siding, patio additions, pest control, new roofs, remodeling, and other jobs.

And while some door-to-door solicitors for such jobs are legitimate, our Consumer Protection attorneys emphasize that you should be especially careful to determine this in advance. That's because itinerant businessmen can disappear just as fast as they appeared on your doorstep. It's important to make sure you'll be dealing with someone who won't pull such a disappearing act after he has your money but before he completes your job.

Legitimate construction and pest control businesses and siding salesmen are as eager to see that consumers get a fair shake as consumers themselves, since they realize that unscrupulous practitioners of their trade can give the entire

industry a bad name.

Some complaints about fraudulent home remodeling or repair solicitors indicate that work was not completed within the stated time limit or sometimes not at all, that construction or repairs were not performed in a workmanlike and satisfactory manner, that inferior materials were used, or that the final price far exceeded the price agreed to orally.

Problems with unscrupulous door-to-door pest control inspectors include complaints about "inspectors" who carry containers of termites and rotted wood with them when they make their "free inspection" of a house. Such an inspection virtually always results in a recommendation that a complete pest control job be started immediately. In some cases, repair of "structural damage" is also recommended.

Complaints about aluminum siding salesmen sometimes come from persons who were told they would get a "special discount price" if their house could be used as a "demonstration model." The salesman indicates that a sign will be put up for a certain number of days, with the homeowner getting a \$10 discount for each day of advertising. Often the sign is never put up, and the "special discount price" usually was the regular price of the siding.

Our Consumer Protection Division recommends taking these precautions to avoid having possible problems later: Tell the door-to-door salesman

you want to think over his offer, then get three other estimates for the job he proposes. Get a written estimate from the person you pick and make sure the starting and completion dates are included, along with total cost, description of work, type of materials, any guarantees, and method of payment.

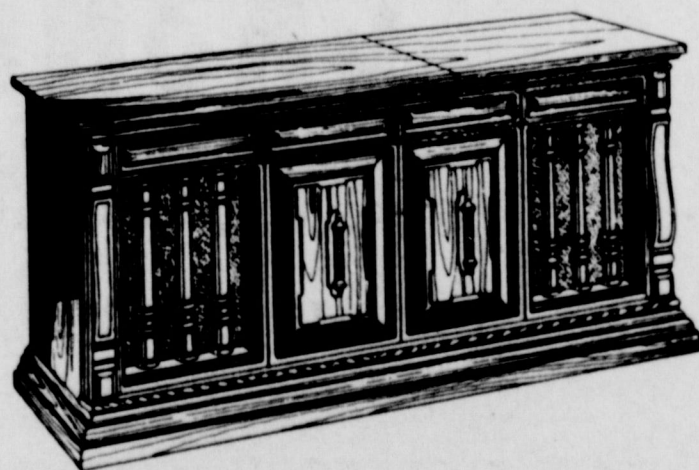

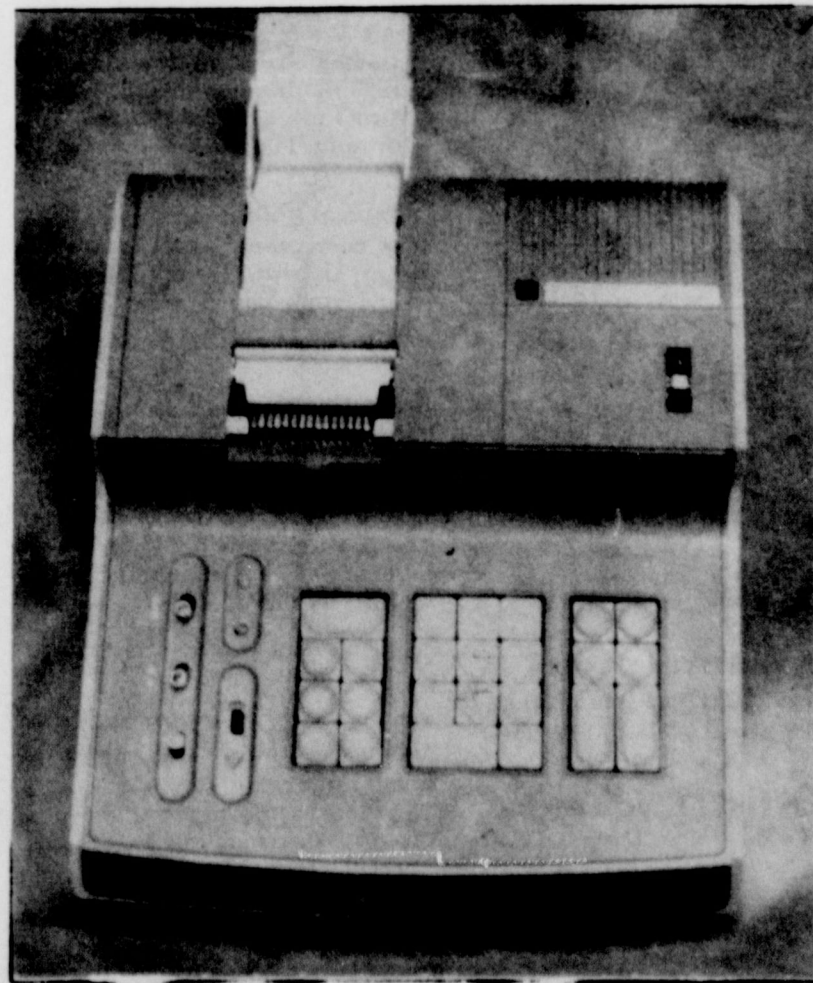
