### How You Look At It!

Last week one of the pages of The Sanderson Times that should have been printed was not printed. There were some stories on that page that were important and of which public mention should have been made, and an advertisement that should have been printed. The page is printed this week. Suffice it to say that it is a long way between here and Alpine and lots of things can happen. Not all of them have happened, yet, but with a little more bad luck we will soon have seen them all, we hope!

There are those who say that things should never change in any way, and that good things don't change!

There are affirmations and there are contradictions to this statement -- far too many, in fact, for us to even begin to mention!

Mainly, it depends on how you look at change and good and bad things!

One of the things about change - or the possibility of it - lately, concerns a change that is supposed to take place by "that young bunch" taking over -- in case they do! All the savings, the conservatism, the stability, the sameness, etc., etc., that has been enjoyed for so long will be a thing of the past! -- This is some of what's being said!

Now, let's look at some facts!

"Young" is certainly a relative thing! Young-at-heart people and emotional immaturity can be a possession of aged people. And "young" and "old" are both in the eyes of the beholder. The way I look at it, people 60 are not so old, but 30 sure is young. This concept will vary according to the thinking of the person who does the looking. A young person is not young to everybody, but middle-aged to some, and old to others!

And there are many people who have served Terrell County and the school district in years past who were "young" people when they took office; maybe about the same age as some of the people who are now elected or seeking election and being classified "young" people, and being accused - falsely, we think - of purposing to spend as much money as they can.

People above 30 years of age - and that is not the starting point - should not be classified as incapable of mature judgement and action because of their age, rather because of a fact, if it exists. And be careful of judgement there, because very few of us have the ability of making the proper judgement or doing the proper thing all the time!

Dr. George Ahlschwede, extension sheep and goat specialist at the San Angelo Research & Extension Center, will talk about wool and mohair grading; Jack Groff and Fred Campbell will talk on wool and mohair preparation and problems affecting prices on wool and mohair. Groff is extension sheep and goat specialist from Kerrville and Campbell is manager of the Sonora Wool and Mohair Co.; Milton Caroline, state supervisor of the Predator Control Division of the Bureau of Sports Fisheries and Wildlife, will talk about proper use of predator control methods; Armer Earwood will talk about current activities of the Texas Sheep and Goat Raisers' Association.

## House Passes Bill To Aid Area Voters

The House of Representatives in Austin has passed by a vote of 133-0 House Bill 784 by Representative Susan McBee. This bill is designed to give relief to those voters in sparsely populated areas of the state by allowing the smaller precincts to retain their voting boxes.

Under current law, a minimum of 100 voters is required to form an election precinct. Mrs. McBee's bill allows voting precincts of under 100 to be created by the county commissioners' court. The bill was amended on the floor of the House in order to exclude counties with over 100,000 population.

"This piece of legislation is particularly important to us in South and West Texas. I am very gratified that the House has passed it unanimously," said Mrs. McBee. She seems confident that Senator W.E. Snelson of Midland, who will sponsor the bill in the Senate, will be equally successful in getting it passed in the Senate also.

A large crowd attended both events.

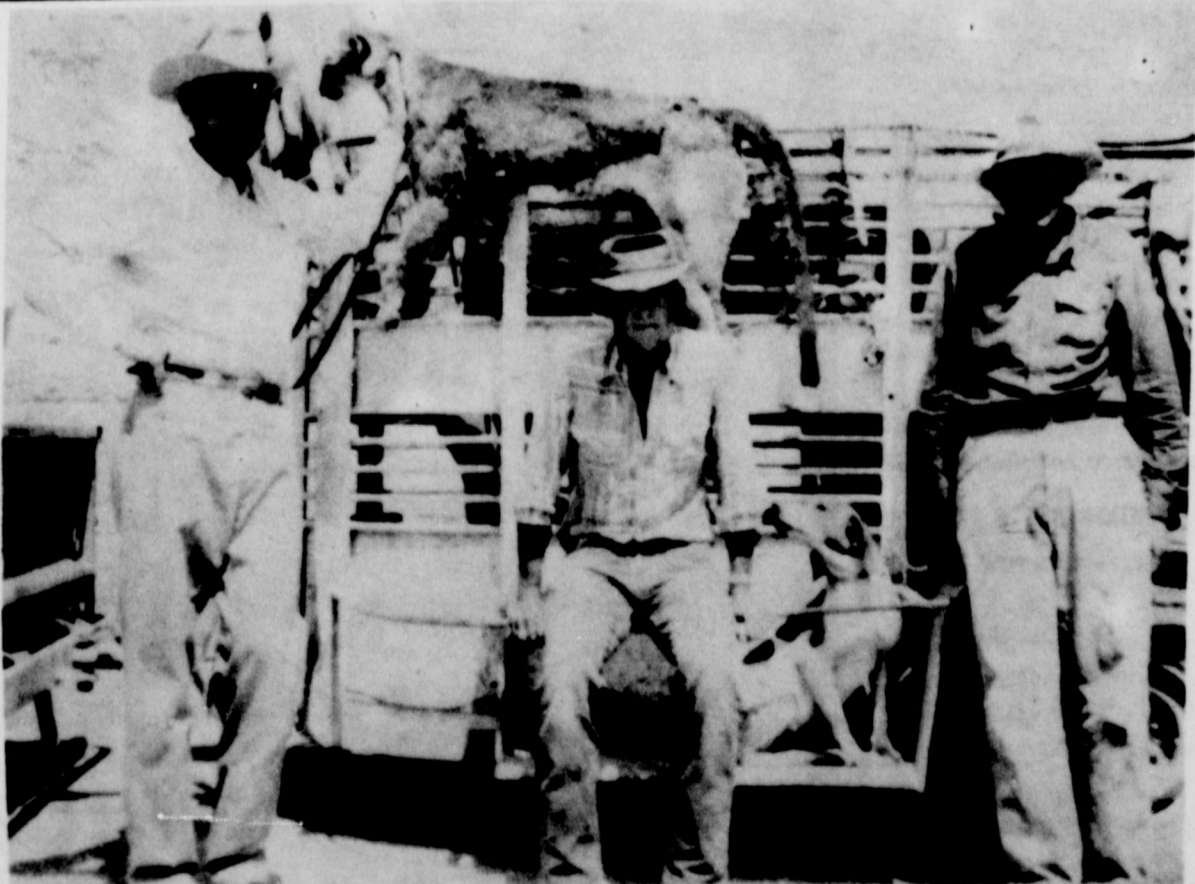
Two numbers were played by the 5th grade band and the 4th grade music class came on the stage to sing "Home on the Range" as the band played that number.

people who called to tell us, or who came by to tell us, or who just ran into us and told us that they appreciated what we had said about taxes in last week's column.

Anyone who thinks that total equalization will be accomplished in short order is wrong! It will never be accomplished -- because equalization depends on how you look at it. But there has to be some dedicated effort made for something close to equalization.

In our opinion, and we think we are right in this, that the effort has to come from a realization of what the laws say about valuations -- rather than what our opinions are concerning valuations.

Since there is no board of equalization -- known to me -- yet appointed by the school board, our comments are not directed to any individual whatsoever. That's impossible! But, in our opinion, a board of equalization needs to do some home work, some comparing, some studying of renditions, valuations, facts, figures and then come up with something they can honestly live with in facing the other taxpayers of the county.

We said so in so many words last week, and it's still our thought -- If one person pays on a 100% valuation base, then any other base for any other taxpayer is unequal, and requires action by the board of equalization who sits for the soul purpose of "determining, fixing and equalizing the value of any and all taxable property situated in the said county, school district, or government subdivision".

It was a great act initiated by Rep. Susan Gurley McBee in getting the state's laws to permit voting precincts of less than 100 in counties of less than 100,000 population. It will make lots of things easier for us in Terrell County, and it will eliminate some hard feelings that have existed because of the requirements of the law and consequential action by those responsible for holding elections. It can also prevent some confusion by the establishing of voting precincts that will stand for almost any election for some time to come.

We commend her and her action, and we hope that Sen. Pete Snelson will have as much success in getting the bill through the Senate as Rep. McGee had -- a unanimous vote -- in the House.

### Two Attend Meet About Airports

County Judge Charles Stavley and C.I. White attended a meeting in Fort Stockton Friday. The meeting was a joint planning conference called by the Texas Airport System, the Permian Basin Regional Planning Commission, and the Federal Aviation Administration.

Attending the meeting were officials from Loving, Pecos, Reeves, Terrell and Ward Counties.

Judge Stavley stated that the airport facilities of each county were reviewed and recommendations made in some instances. He said that the TAS and FAA authorities had not visited the Dryden airport recently, but were considering a trip there in the next few weeks to see what was needed to bring the airport up to standards of safety for general use by light aircraft. Stavley reported that vegetation growth on the strip was being kept down and other improvements were under consideration to meet normal safety standards.

Stavley also reported that he asked that Terrell County be put on the mailing list of airport surplus materials and equipment available to that some information would be available if needed.

# STATE CAPITAL Highlights AND Sidelights

by Lyndell Williams

AUSTIN—Legislators are getting nervous over new reform laws which restrict their political fund-raising.

House Speaker Bill Clayton has advised representatives to postpone their efforts to retire campaign debts until after the legislative session in view of warnings by a district attorney.

Travis County District Attorney Robert O. Smith told House leaders direct solicitation of Austin-based lobbyists for contributions to campaign war chests is a violation which he would feel called on to take before a grand jury.

The issue came to Smith's attention when a Texas Civil Liberties Union official, who is a registered lobbyist, complained that he had been solicited for a contribution to a representative's fund-raising reception in Dallas.

A provision of the new penal code makes it an offense for a legislator to solicit any benefit from a person known to have an interest in legislation. There are less-strict interpretations than the one by Smith, but the district attorney is the one lawmakers feel they must stay on the right side of.

### LOSS REPORTED

A Texas Education Agency indicates students lost more than 2.4 million in tuition refunds they should have received from 19 proprietary schools.

When a student quits, he is supposed to get back the unused portion of his tuition within 30 days.

Woodrow W. Bean of El Paso, State Board of Education member, called on Gov. Dolph Briscoe and Atty. Gen. John Hill for a complete audit of all Texas Education Agency financial transactions during the last four years.

Bean charged refund losses may be as much as \$5 million to \$8 million. He also claimed (while admitting he could not confirm) that about \$105 million in public funds administered by TEA has been "misused, misapplied or otherwise lost somewhere."

### SMOKE BAN VOTED

Smoking in public places could bring a stiff fine under a bill just passed by the Texas Senate and sent to the House.

The ban covers elevators, theaters, movie houses, libraries, museums, hospitals, school facilities, intrastate buses, planes or trains — except in specifically designated areas.

### SCHOOLS CRITICIZED

Some public schools and junior colleges have been criticized by House members for allegedly using emergency funds to raise teachers' pay, make investments and pave parking lots.

Rep. Tom Massey of San Angelo, House Education Committee chairman, said a

special report is being compiled on the "abuse."

Rep. Fred Head of Troup proposed to repeal an \$18 million emergency grant to meet junior college enrollment increases.

### COURTS SPEAK

The State Supreme Court again upheld constitutionality of a law permitting legislator-lawyers to delay trials in which they represent clients. The Court said the continuance provision may not be used if only enforcement of prior court orders are involved, however.

The Court of Criminal Appeals reversed a negligent homicide conviction of a Hillsboro man because the jury assessed an improper punishment of two years in jail.

Third Court of Civil Appeals upheld power of the State Finance Commission to prohibit savings and loan associations from offering premiums to lure new accounts.

In an order applauded by the Attorney General as the beginning of a statewide enforcement effort, a Bexar County district judge granted an injunction to prohibit air pollution by a rendering plant.

### AG OPINIONS

Attorney General Hill warned legislators they may be overstepping the law by accepting speech-making honorariums from groups interested in legislation.

In other recent opinions, Hill concluded:

- The open meetings law applies to hospital authorities created by city ordinance.

- Texas Coastal and Marine Council has no authority to supplement the legislatively-determined salary of its executive director.

- Port of Houston Authority may appoint and employ peace officers, and the officers may carry handguns while on duty.

- Proposed annexation of school district territory must be approved by a majority of trustees in the receiving district.

- Kidney Health Care Act benefits may not be denied to aliens.

### APPOINTMENTS

Edward P. Halbert of San Augustine was reappointed to Texas Animal Health Commission by Governor Briscoe.

Briscoe also named Mrs. Naomi Andrews of Houston, B. DuBois Brown of San Antonio and Dr. John B. Coleman of Houston to the board of regents of Texas Southern University.

Attorney General Hill appointed W. J. Murdaugh Jr. chief of his bonds and charitable trusts division, succeeding Mike Willatt who resigned to enter private law practice in Austin.

Dr. Phyllis Procter has been appointed manager of research and program development for Texas Industrial Commission.

As of mid-March, the supply situation in April is expected to look like this . . .

### RED MEATS

**Beef** . . . plentiful, with record large output about a tenth larger than a year earlier and well above 1972-74 average. Beef produced mainly on grass and other roughage, with little grain feeding, will account for all of the increase.

**Pork** . . . adequate. Supplies 10% less than a year earlier and well below 1972-74 average. But beef abundance will help stretch pork supplies.

### POULTRY & EGGS —

**Turkey** . . . adequate. Seasonally light new-crop marketings down 12% from last April, but 17% above the 1972-74 average for the month. Cold storage holdings April 1 should be below high level of a year earlier, but about one-third above 1972-74 average.

**Broiler-fryers** . . . adequate. Production 7% below last April, but about the same as 1972-74 average for the month.

**Eggs** . . . adequate. Output after Easter to be under a year earlier and about one-third less than 1972-74 average for April.

### MILK & DAIRY PRODUCTS —

**Fluid milk, dairy products** . . . adequate, although milk production will be slightly under the most recent 3-year average for the month. With production rising seasonally and at levels exceeding demand, commercial stocks of **cheese** and **nonfat dry milk** should remain relatively heavy. **Butter** supplies are expected to be near the latest 3-year average for April.

### FRUITS, VEGETABLES, NUTS

**Pears** . . . plentiful. Jan. 31 cold storage stocks, mostly D'Anjous, were 43% above both a year earlier and 1972-74 average.

**Apples** . . . plentiful. Cold storage holdings Jan. 31 were 6% larger than year earlier; 11% more than most recent 3-year average.

**Citrus fruits, juices** . . . plentiful. **Early, midseason, Navel, and Valencia orange** output is 10% above last season, 13% greater than past 3 seasons' average. U. S. **grapefruit** output is down 9% from both last season and past 3 seasons' average. Mar. 1 stocks of Florida **frozen concentrated orange juice** almost matched record holdings of year earlier. Florida **single-strength grapefruit juice** supplies were 18% larger than low level of a year earlier.

**Canned non-citrus fruits** . . . plentiful, due to 1974's greater output. Examples: **canned apples**, 74% larger than 1974,

**Raisins** . . . plentiful, with 1974 crop topping large 1973 crop by about 9%.

**Dried prunes** . . . plentiful, because of big carryover from record 1973 crop which topped 1974 production by about one-half.

**Potatoes** . . . plentiful. Fresh potatoes in storage Mar. 1 were 26% greater than year earlier and 17% ahead of the 1972-74 average. **Frozen potatoes** . . . plentiful, with Jan. 31 holdings 12% above a year earlier.

**Frozen vegetables** . . . plentiful. Jan. 31 stocks were 14% larger than a year earlier, and nearly a fourth more than 1972-74 average. **Sweet corn, green peas, snap beans, carrots and broccoli** accounted for nearly three-fifths of frozen product holdings — with stocks of each much above a year earlier.

**Canned green beans** . . . plentiful. Cannery stocks Feb. 1 were 46% larger than a year earlier, and 41% above average. **Other canned vegetables** . . . adequate except for **canned corn**, of which Feb. 1 canners' stocks were 25% under the 1972-74 average.

**Peanuts** . . . plentiful, with Jan. 31 supplies 15% above a year earlier. The 1974 crop was estimated at 8% more than 1973 record. **Walnuts** . . . plentiful, helped by carryover from record 1973 crop. **Almonds** . . . plentiful, with 1974 crop about one-third greater than record 1973 and 1971 crops.

### GRAINS & LEGUMES —

**Rice** . . . plentiful. Record-high Jan. 1 stocks were 32% above year earlier, 28% ahead of 1972-74 average. Output for 1974 was 30% greater than 1971-73 average.

**Dry beans, dry peas** . . . plentiful. Record 1974 dry bean crop was 27% larger than 1973's; 23% above 1971-73 average. Dry pea production more than doubled the 1973 crop and was 36% greater than the 1971-73 average.

**Wheat** . . . adequate for food use. Stocks Jan. 1 were 19% ahead of year earlier, but 15% under 1972-74 average.

**Corn** . . . adequate for food use. Jan. 1 supplies were 19%

less than year earlier; 23% below 1972-74 average.

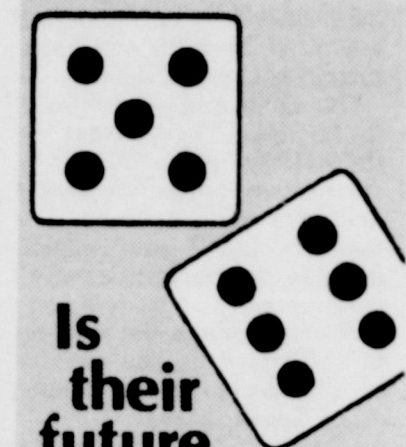

## STATE CAPITAL Highlights AND Sidelights

by Lyndell Williams

AUSTIN — A senator and a representative revived an old idea for a new reason — dividing big Texas into five states.

Sen. Bob Gammage, a Houston liberal, and Rep. Fred Agnich, a Dallas Republican, proposed a 1976 referendum on the big carve-up.

Gov. Dolph Briscoe immediately frowned publicly on their proposition, and few colleagues were expected to go along in the legislature.

Agnich recommended a division by population into Central, North, South, East and West Texas.

The late former Sen. and Rep. V. E. "Red" Berry of San Antonio regularly recommended dividing Texas, in the interest of bringing liquor-by-the-drink and horse racing to South Texas.

Gammage and Agnich want to increase Texas' clout on the national scene. With five states, they argue, the states of Texas could have 10 U.S. senators and a proportional increase in presidential electoral votes.

Sponsors claim the split-up is authorized by the articles of annexation of the Republic of Texas in 1845.

### INTEREST BILL PASSES

Governor Briscoe is pondering whether to approve (or again veto) a bill which opponents in the Senate charged would raise interest further on real estate loans.

The bill (HB 351 by Rep. Ben Munson of Denison) would provide for spreading all interest charges, including "points" now paid in advance over the life of real estate loans. It also would permit loans of \$500,000 or more for interim construction or real estate financing to individuals at greater than 10 per cent interest.

Briscoe indicated he may sign because the bill appears to be more specific on the type loan to which it applies than the 1973 bill which he vetoed.

### APPOINTMENTS TROUBLES

Trouble over appointments flared like brush fires for the Governor in the Senate.

First, he had to withdraw the nomination of Bryan oilman Ford Albritton Jr. for the College Coordinating Board in the face of almost certain rejection. Then, some liberal senators opposed confirmation of Walter G. Sterling, 73-year-old Houston manufacturer and son of former Gov. Ross Sterling, as a University of Texas regent, after Sterling admitted a brief membership in the John Birch Society.

Meanwhile, Sen. D. Roy Harrington of Port Arthur had threatened rejection of Mrs. W. Smythe Shepherd of Beaumont to the Lamar University board of regents. About the same time, two liberal senators threatened to vote against former Sen. Dorsey Hardeman of San Angelo if he is reappointed to Texas Water Rights Commission.

### COURTS SPEAK

The State Supreme Court has agreed to hear a \$10.5 million lawsuit over a collision of two horses and severe injury of a 15-year-old rider.

High Court also or-

dered a jury trial in a Port Arthur man's suit against a finance company which he claimed put out a false telephone report that his brother was dead.

A five year prison sentence of a 17-year-old boy for theft was reversed by the Court of Criminal Appeals because he was slapped and choked by a policeman before "confessing."

### APPOINTMENTS

Governor Briscoe named board of regents members for three more institutions.

Appointed to the Texas Tech University board were Don R. Workman of Lubbock, Robert Lee Pfluger of San Angelo and Charles G. Scruggs (reappointed) of Dallas. Gen. G. P. Disosway of Dallas was placed on the Midwestern University board. Homer Lee Bryce of Henderson, Joe Bob Golden Jr. of Jasper and James Irvine Perkins of Rusk were reappointed at Stephen F. Austin State University.

In addition, Briscoe reappointed Bernard G. Johnson to the Board of Regents for State Senior Colleges.

Wilmer Smith of Wilson, Grady C. Clark Jr. of Corpus Christi and Heino Stafel Jr. of Austin were reappointed to the State Seed and Plant Board.

J. D. Wendeborn of Laredo and James D. Keister of Amarillo were reappointed to the Texas Board of Physical Therapy Examiners.

### UTILITIES BILLS SLOWED

Three bills to create a state utilities commission to regulate rates and services landed in a Senate subcommittee after a hearing which stretched over a week in three separate sessions.

Utilities spokesmen attacked the measures as unnecessary, a handicap to their attracting needed capital and no assurance of lower rates.

Proponents by the score urged the proposed new state agency to help them with their rate problems.

Indications are a bill will emerge from the Senate State Affairs Committee eventually, but Chairman Sen. Bill Moore of Bryan said the vote will be "pretty close."

### SHORT SNORTS

A bill to prohibit discrimination against the handicapped passed the State Senate.

So did a measure adopting the Interstate Mining Compact, another prohibiting "child sale," and authority for all home rule cities to levy hotel occupancy taxes for tourist-recreational facilities.

Comptroller Bob Bullock said an audit uncovered a \$3 million tax liability against a gas production company.

The Senate jurisprudence committee approved a bill providing that losers in libel and slander lawsuits pay reasonable attorneys fees and court costs.

The junior high school girls also competed and Lisa Stavley placed 4th in the 220-yard dash and Roberta Bell was 5th in the 60-yard dash.

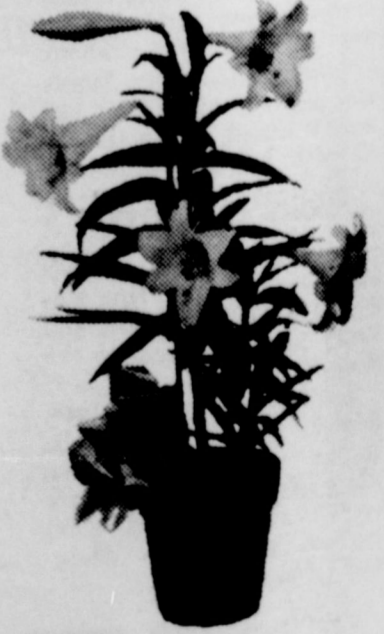

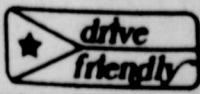
