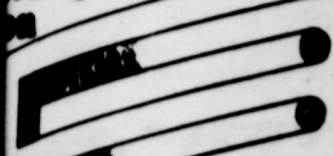

It Depends



How You Look At It!

The hassle continues and increases in intensity in Austin about the statewide system of property taxation. Now there is an accusation that Gov. Price's proposal is being given preference by the distribution of information that is considered by some to be prejudicial. The interest is growing.

Political influence has created many inequities, according to a recently-published story by Associated Press, which goes on to say: "If we are honest, we realize that one reason we have inequitable taxes in cities and counties is political influence," quoting a spokesman for Common Cause. The group favors a bill that would provide for single appraisals at the county level with the state comptroller issuing standards and auditing values to make sure they are equitable.

Spokesman for the Texas State Teachers Association said that failure of the passage of this type of legislation would jeopardize the present drive for school finance reform. It was also stated that failure to pass Rep. Wayne Peveto's bill - establishing a uniform statewide system of property tax appraisals - would continue to rob the school districts of local fund assignments for the Foundation School Program.

One of the reasons for our even mentioning the above story and situation is to show that there are those in the state - yes, and even in the county - that feel that there is some inequality in appraisals within counties and also wide differences between counties in the state. There is also an opinion that other properties - like oil and gas - should be valued more similarly between counties, rather than on a "need to value" basis. Whether the "need to value" is prejudicial to the oil and gas companies either way, is of itself unfair, according to the way we see it. If you take out the word "prejudicial", and value alike something in Comal County the same as something of equal value in El Paso County, then everything is more fair.

Someone may say, quickly, "Yes, but a como se llama in Comal County is not worth the same as a como se llama in El Paso County!" That may be. But there is a basis that is more equitable than "needed value", in our opinion.

We make sincere and humble apologies to G.C. Eggleston for omitting his name from the list of school district trustee candidates last week. This is no excuse, but there was a lot of turmoil in our office about the possibility of the size of our paper being changed, and maybe for only one week, and then possibly another change to another

A large number of electors - 655 - turned out Saturday to participate in the election of two school board members for the Terrell County Independent School District. W.E. TenEyck, incumbent, garnered the largest number of votes of any of the four candidates - 185, with G.C. Eggleston second with 178, and pending canvassing the ballots and official proclamation of the school board, these two are the unofficial new members of the board. Alex Escamilla received 152 votes and Charles Stegall netted 140.

Votes cast for school board trustees at the courthouse by voters in all four precincts were all put together for the counting, thus no breakdown in actual vote by precincts is available in the election. The figures above show the votes that were cast in the boxes in the regular precincts, but precinct 1 total contains votes from all four precincts, while the other precinct numbers indicate the votes cast at Dryden, Couch ranch, and El Paso Natural Gas Plant.

Five Easements Needed To Begin Flood Project I

Five easements are lacking in the efforts to complete the preliminary necessities for the beginning of the construction of the dams on the Sanderson Canyon Watershed Project, aimed at preventing possible future flooding to the town.

The project was begun after the flood in June of 1965 which took the lives of 26 people and caused hundreds of thousands of dollars of damage to ranch and town property.

The latest easements secured included those from Southwestern Bell Telephone Co., Rio Grande Electric Co-operative, and an amended easement from Jack Deaton.

SCOUTS TO JUNCTION

The boys participated in the various contests, races, and relays at the camporee and visited Fort Lancaster near Sheffield enroute home.

In balloting for the county school board candidates, Mrs. A.N. Farley was unopposed in her bid for the at-large post and was elected. Mike Fielding sought the post in precinct 1 and Mrs. Barry Pendleton in precinct 3, and both were elected. All are 2-year terms. In the election for directors for the Terrell County Water Control & Improvement District #1, two candidates were seeking office in two vacant posts for two-year terms: Weldon Cox, re-election, and Tommy Corbett, and both were elected with Cox receiving 89 votes and Corbett 103 unofficially. Votes will be canvassed at a later meeting of the water district board of directors. There was no break-down of absentee votes and votes cast Saturday by the electorate as all ballots were counted together.

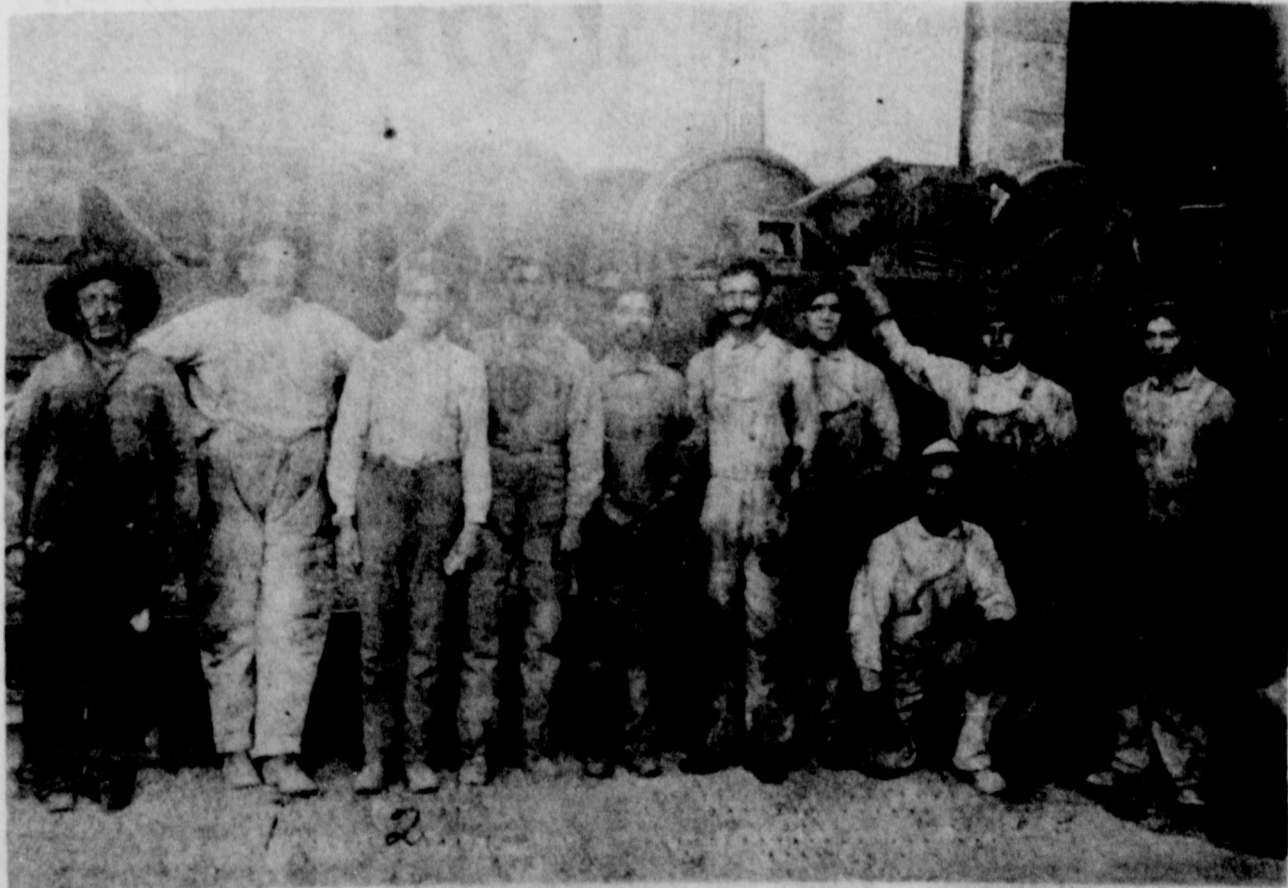

size, etc., and we just got all wound up about the whole thing, dropping to a four-page paper, and barely making that, even with the error. We are sorry it happened, but there is little that could have been done about it other than apologize, which we are doing!

All the work that is going on in town in cleaning up the drainage ditches, repairing culverts, rebuilding culvert abutments, etc., is something that should be appreciated by everyone. The neglect of the drainage problems in town by the commissioners over the past several years has caused some property owners some problems, and continues to cause some problems, and will continue to cause some problems until some of those situations are straightened out. The drainage here is, according to our understanding, the direct and sole responsibility of the commissioners, and includes seeing to it that no construction or installation impairs or diminishes existing drainage.

The deepening of the ditches so that they will carry more water - in case it rains - and cleaning out weeds and debris helps to "spruce up" the appearance of the town and as well as being very helpful, and the repair or installation of the abutments serves the dual purpose of maybe preventing someone from driving off the end of the culvert, but also gives an appearance of "finishing" to the work.

In the story about the local school's participation in the environmental program sponsored by Big Bend National Park, it is stated that the students had "a web of life" exercise concluding the outdoor activities by tying together everything discovered and emphasizing interrelationships and interdependence! And this by fourth graders! Great! Now we wonder what it was they learned.

Election April 22 Could Change State Constitution

Two proposed constitutional amendments will be voted on Tuesday, April 22, in Terrell County and all of Texas.

Voting will be in all four precincts, and according to information available to The Times, voters must vote in the precinct in which they reside for this election.

Absentee voting is possible at the courthouse until the closing hours of the office of Ruel Adams, county clerk, on Friday, April 18.

The two proposed constitutional amendments are: retirement systems for state employees and officers, and increasing the salary for members of the state legislature from \$400 to \$600 per month, and an increase in their per diem pay and travel pay.

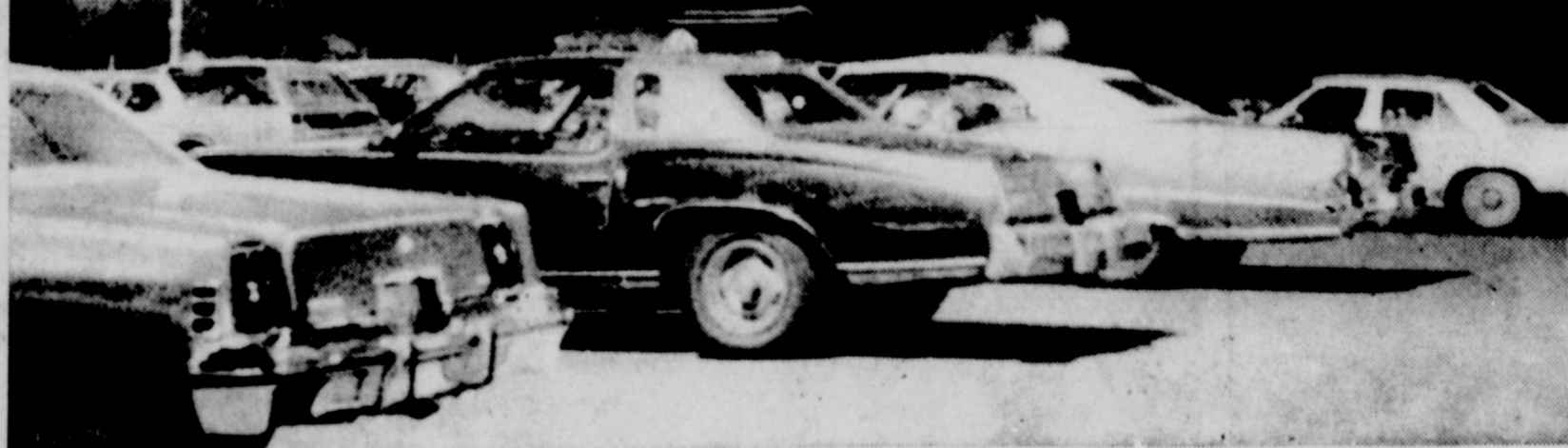

Bullock Predicts 1977 Tax Bill

Comptroller Bob Bullock said Friday that Texas taxpayers will dance to the tune of at least a \$300 million tax bill and possibly a \$2 billion tax bill two years from now regardless of how well the Legislature holds the line on spending this year.

"It's not a question of if or when. It's a question of how much we pay the fiddler," Bullock said in forecasting the state's spending and revenue for the next four years, the first such projection ever made by the Comptroller's office.

"The fat is in the fire and there's no pulling it out", he said.

Bullock said that "too often everyone forgets that most of the money which goes into our treasury must automatically be used for education, highways, welfare, children's assistance and federal programs because our constitution, statutes, and federal laws require it."

In the next two years these programs will get \$9.3 billion of the \$13.2 billion expected to go through the treasury.

The remaining \$3.9 billion available to the Legislature is \$1.5 billion more than current spending, Bullock noted, and can be used for any combination of general spending, school finance, or for setting aside a reserve fund for use in 1977.

But any way it's cut will still mean a tax bill in 1977, Bullock said. He outlined the three "most likely" ways and the tax bills which would result:

1. The Legislature can set aside a reserve fund of \$400 million and spend the rest of the \$3.9 billion and hold the 1977 tax bill to \$300 million.

2. The Legislature can spend the full \$3.9 billion, leaving no reserve fund, and the 1977 tax bill will be \$1.3 billion. That's equal to \$100 for every person in Texas, Bullock noted.

3. The Legislature can spend everything available this year and adopt a long range school finance bill with significant future increases in state aid built in and the 1977 tax bill would top \$2 billion.

"I want it understood by one and all that school finance is not to be blamed for what is about to happen -- every dollar spent on anything else has just as much future shock on our pocketbooks," Bullock said.

Bullock pointed out that the Legislative Budget Board recommendations call for a 6

per cent increase in general state spending for the next two years, but that the Comptroller's forecast for 1978-79 were based on only a 34 per cent increase.

Bullock said that there is a "far outside chance" of avoiding a major tax bill in 1977 if the current Legislature sets aside a \$400 million reserve fund and the 1977 Legislature adopts a hold-the-line budget.

Bullock said that by a "hold-the-line" budget he meant increasing salaries only seven per cent and increasing all other expenses only three per cent.

"Mathematically that might work, but as a practical matter it has never been done," Bullock said. "History tells us that overall increases of 40 per cent are more like it, Legislature after Legislature."

The present Legislature would be facing a tax bill had it not been for the windfall surplus brought in by an unexpected oil embargo and runaway inflation, Bullock said.

"Spending the surplus on ongoing programs is like spending an inheritance. When it's gone, it's gone," Bullock said. "It's like someone giving you a horse and then you find you can't afford the saddle and the oats."

Playground Becomes Science Lab For Fourth Graders

Big Bend National Park and the Big Bend Natural History Association sponsored the 1975 Environmental School Program during the week of March 10-13. This year the 4th grades participated at the Sanderson, Marathon, Alpine, Fort Davis, Big Bend, and Marfa elementary schools.

In the past years, the Park and Big Bend Natural History Association have sponsored an environmental essay contest. This year it was decided to try something a little different and work toward a new and innovative approach to environmental education. The park naturalists wanted to try a workshop program in which the students could actively participate and which would serve as a kind of "nature walk", taking class outdoors and utilizing the school grounds.

Calling the program the "Playground Workshop", park naturalists Caroline Wilson and Joe Mur presented to each 4th grade class a concentrated 1-1/2 hour session designed to stimulate awareness of the senses, life forms, environmental elements and their relationships that occur everywhere - even on a playground.

After a 30-minute indoor discussion introducing the program and laying down some basic environmental concepts, students were taken outside on playgrounds to explore one concept discussed. While outside, the students were encouraged to use their senses and look closely to see if they could discover things they had never noticed before. "A web of life" exercise concluded the outdoor activities by tying together everything discovered and emphasizing interrelationships and interdependencies.

Response to the program was great-both the teachers and the students were enthusiastic and all seemed to enjoy themselves, having fun and learning at the same time. Considering that this was the first year for this type of program, the naturalist staff felt it was a successful approach and would like to sponsor a similar kind of program next year.

The park naturalists would like to express their appreciation for the cooperation of schools, especially the school officials and the teachers; Mrs. J.A. Mansfield and Miss Linda Ball of Sanderson.

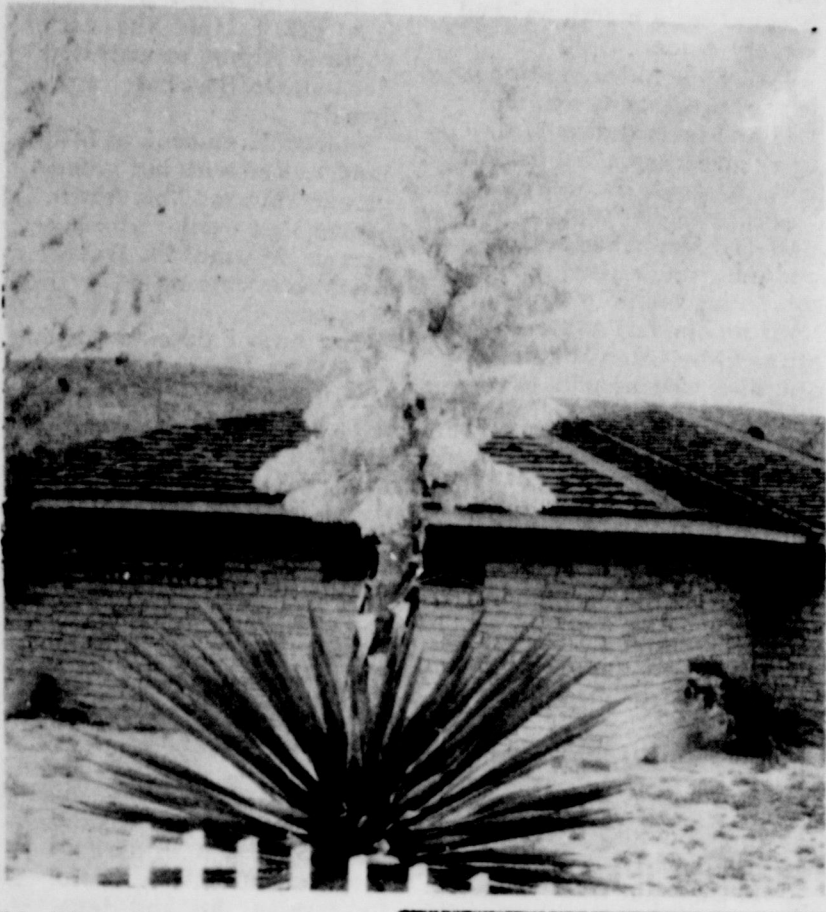

ed a bill which would require that over a five-year period, prices of "old oil" would gradually move to a market price level. Each year 20% more of the production of a field would be allowed to be sold at the world market price, until after a five-year period the entire field of old oil would sell at the world market price instead of the regulated price.

Several things could be accomplished by this: (1) the free market system will be reestablished instead of having governmentally controlled prices, and this encourages a healthy business climate; (2) the oil producers would have incentives for full production of old oil, because there would be rewards for secondary and tertiary recovery of oil; (3) the domestic oil industry would be strengthened and we could rely less on foreign oil, which currently supplies 40% of our needs.

This bill would help both industry and the American consumer. It is important for our district and for our nation that we have a secure and reasonably priced source of energy, and by phasing out two-tier pricing that should be within our grasp.

Report of BOB KRUEGER U.S. Representative

Last week, I introduced a bill in the House of Representatives to phase out the two tier system of pricing oil and thereby to help ensure better supplies of oil for America in the future.

Currently, America has two prices for oil produced in this country: oil from fields discovered and produced before January 1, 1973, sells for \$5.25 per barrel; oil from new fields discovered and produced since that time sells at the world market price, which now is considerably higher. As long as the federal government regulates the price of old oil and makes it so much less profitable to produce it than to produce oil from new fields, there will be no inducement to produce to full capacity the reserves from old fields in this country today and if we don't do that, we will have to rely more heavily on foreign oil for sure.

The way to improve this situation is to allow all oil to be sold at the market level rather than at the price set by the federal government. This means that we will need to allow old oil prices to move toward a world market price, and to allow consumers to determine the price they will pay.

If old oil were immediately to go to the price level of new oil, there would be a tremendous inflationary impact, probably more than our economy could very easily take. Further, Congress would never be willing to vote to decontrol immediately the price of old oil. The task is to phase in the change from a government-regulated price to a market price over several years. I therefore introduc-
