Summer Work **Program Set Up** 

For 20 Applicants County Judge Charles Stavley revealed last weekend that permission had been granted for as many as 20 participants in the summer youth work program for Terrell County. The program is for young people between the ages of 14 and 21 years.

udge Stavley stated that 10 of the youths would be employed by the Terrell County Independent School District, one at the library, and the other nine by the county. The original proposal was for only 10 employees in all, Stavley stated, but in a meeting with representatives of the Permian Basin Regional Planning Commission, Stavley, and School Superintendent Carroll B. Card, it was agreed to authorize 20 units for Terrell Coun-

The young people who are granted summer work must meet certain requirements, Judge Stavley stated, and all applicants will be paid \$2.10 per hour and may work only 40 hours per week.

Persons interested in the summer employment are asked to contact Judge Stavley or High School Principal Jim Payne to make application for one of the jobs.

The program comes under the sponsorship of the Permian Basin Regional Planning Commission under a grant received from the federal government to assist young people in finding gainful employment during the summer months if they qualify. Most of the duties of the youths employed in the project are "housekeeping" type duties by the school and county, with the person employed in the library having other duties commensurate with the work that goes on there.

## Kindergarten **Reigstration** Is **Needed Soon**

The school district needs an accurate census of all children who will be five years of age on or before September 1, 1975, in order to plan for the 1975-76 school year.

If you have a child who will meet the above age requirements, please bring the child's immunization records to the elementary school on Tuesday, April 22, at 1:30 p. m. All immunization records must be up to date before starting to school next fall. The school nurse will review the records and advise parents as to the immunizations needed, if any.

Birth certificates will also be needed at the meeting, according to Supt. C.B. Card, who furnished The Times information for the story about the kindergarten registration. Children will be permitted to visit the kindergarten class one day between April 22 and the end of school. The visitation day for each registrant will be decided at the time of registration.

## **Commissioners Have All-Day Meet**

The Terrell County Commissioners' Court had an allday meeting Monday. All of the commissioners were present - W.W. Sudduth, Austin Chriesman, David Mitchell, and Graham Childress, County Judge Charles Stavley, and Ruel Adams, County Clerk and secretary of the court.

The minutes of the previous meeting were read and approved and bills presented were authorized.

There was some discussion about the hiring of a county agent for a year. About 75% of the salary of a county agent would be paid by the state with Terrell County responsible for the balance. Some of the duties and possible activities of the county agent were discussed.

Flood insurance was discussed by Troy Druse and the court approved that insurance.

Bids will be sought for the leasing of the Gaines County School Land minerals.

Bids will be sought for the repair of the courthouse roof. The court heard Larry Seymore explain the Rural Conservation and Development Program and it was first rejected, but later accepted by the court.

The name of the landing strip at Dryden was officially changed from an FAA Site number to Terrell County Airport at Dryden.

There were no bids for the garbage pick-up and disposal.

Friday, April 18, is the last day for absentee voting for two proposed constitutional amendments in Texas.

The first proposition concerns revising and consolidating provisions relating to the state and local retirement systems and programs and providing programs for a maximum state contribution to . state systems of 10% of the aggregate compensation paid to individuals.

The second proposition concerns the setting of salaries of members of the legislature at \$600 per month and setting a per diem of \$30 during the legislative sessions and a mileage allowance at the same rate provided by law for state employees.





#### Report of BOB KRUEGER U.S. Representative

A lot of people criticize a great many government welfare programs, and with good reason. But it's equally important to recognize when government programs are well directed, and two bills passed by the House last week should help people in our area.

The Older Americans Act recognizes needs of some older citizens that cannot always be met by either family or local community. Its Foster Grandparents Program pays the minimum wage to certain older Americans needing financial assistance who are seeking an opportunity to give their attention and affection to young people. Foster Grandparents spend time with children in hospitals, by working with children from broken homes, and by assisting in other ways young people who, through no fault of their own, come from families where they do not get adequate attention.

We all know that young children need love, encouragement, and the attention and wisdom of older people, and that older Americans want to keep a sense of their usefulness. Here is a program that helps young and old together, to the benefit of both.

There are other useful programs in this Act: one, mealson-wheels brings hot meals to shut-in elderly Americans who are unable to prepare meals for themselves. Another gives part-time jobs to older Americans in rural areas assisting in conservation project work.

A similar bill passed this week offers continuing assistance to people with development disabilities. This act has, in the past, provided exceptionally good evaluative and organizational aid to the many state and private programs for the disabled, as well as establishing successful demonstration projects for treatment. People with cerebrai palsy, autism, dysiexia, mental retardation, and other life-long disabling conditions will stand to benefit from this legislation which is, in my opinion, a model for the appropriate role of the federal government in health and wel fare. Problems remain in the way these programs are presented. Bills are often written with automatic funding increases from year to year, and that builds in automatic inflation. These programs require continued scrutiny and the best efforts of your representative to try to keep costs under control; but they also require him to be responsive to the needs of older Americans for whom private industry still does too little and to those with special and costly needs in our society and to see to it that these people are not

#### Report of Mrs. Susan Gurley McBee Texas Representative

As we begin the last two months of the legislative session, legislators are spending less and less time in committee hearings and on office work, and more and more time on the floor debating and voting on bills. This is the critical period in the legislative session when many people would like to voice their opinions on particular pieces of legislation and often wonder how best to make their viewpoints known. The most effective way is to contact your State Representative. There are several ways to do this - the cheapest and easiest being to drop a postal card to me (at Box 2910, Austin, Texas 78767) stating that you're for or against a certain bill. If you want to go into more detail, write a letter. Or, if time is critical, call me at (512)475-2763. I welcome hearing from constituents.

By the time this column appears the House will have acted on the proposed new State Constitution, which the Senate passed earlier in only one day's time. There are many pros and cons on the actual draft; but I think the concept of salvaging something from the 3 million dollars and many months of work already spent on Constitutional revision is a sensible one. At least it would allow the voters to express themselves once and for all. Until this happens, there will be a continuous, powerful cry to call a very expensive Citizens' Convention (which we've basically already had in the Constitutional Revision Committee and its public hearings) to hask over the same items that have already been debated at length No one will ever be able to draft a constitution that is 100 per cent acceptable to everyone, and now is the time to let the citizens of Texas either adopt or reject a new constitution and then lay the issue to rest.

#### \*\*\*

A very frequent complaint, particularly in our rather isolated area of the state, is that we never hear about what state agencies in Austin are doing until it is already too late. Hopefully, the legislathat are scheduled by various segments of state government; proposed changes in rules and regulations by state agencies; and, in general, keep the people of Texas aware of and upto-date on pending action that affects them.

## Draft Registration Ended March 29

Colonel Melvin N. Glantz, state director of Selective Service of Texas, announced last week that President Gerald Ford has issued a presidential proclamation dated March 29, 1975, that terminates present registration procedures for the Selective Service System. April 1 was the last day 18-yearolds could be registered by Selective Service registrars or at the draft board area offices. This is the first time since August 31, 1948, that men are not required to register upon reaching their 18th birthday.

Glantz said that although registration is being terminated at this time, new procedures providing for periodical registration are being developed and will be tested at a later date.

The Selective Service System will continue to carry out its mission on a stand-by basis and will continue to classify men in accordance with current regulations and maintain a "pool" of available manpower of the military as a part of the overall
